To the inhabitants of the Town of Hart's Location in the County of Carroll in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Willey House in said Hart's Location on Tuesday, the 10th day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary Town Officers for the year ensuing.
- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
- 3. To authorize the Selectmen to borrow sums of money as may be necessary on the taxes due the Town of Hart's Location in the year 1964.
- 4. To see if the Town will vote to raise and appropriate the sum of \$6.34 (amount being seven cents per thousand dollars of equalized valuation) for the White Mountain Region Association
- 5. To see if the town will vote to petition the State Tax Commission to have an audit made by the Municipal Accounting Division and make appropriation to cover the expense of same.
- 6. To see if the town will vote to raise Town Road Aid, \$16.97 to be used with State Highway Department quota of \$113.12 for all town roads.

- 7. To see what sum of money the town will vote to raise for all town roads.
- 8. To see if the town will vote to accept a new right of way from Harold Burke, in exchange for the right of way now in use on the East end of the Burke Road.
- 9. To see if the town would vote to build a town building and what provisions and appropriations they would make for same.
- 10. To see if the town will vote to raise and appropriate the sum of \$100.00 for the support of the Eastern Slope Regional Airport for the current year.
- 11. To act upon any other business that may legally come before said meeting.
