Selectmen's Report

TO THE CITIZENS OF RYE

The Fire Station and Town Offices at Rye Center is nearly completed and should be in operation by April first.

Late in the summer two hurricanes struck this area, causing considerable damage to property. This cost the Town \$4,080.71 to clear the highways and \$150.76 for police. The Superintendent of the State Police assigned several troopers to assist during the emergency. Assistance was also given by the State Fish and Game Department.

The Rye Water District Improvement Association requested a life guard at Wallis Sands. Mrs. Sarah Bresnick, chairman of the Beach Committee, collected \$575.00 and turned it over to the Town Treasurer. This money was donated by residents and businessmen of the beach area. This was added to by the Town appropriation of \$200.00, making a total of \$775.00. There is a balance of \$249.42 remaining in the fund. We hope this worthwhile project will be continued during the 1955 season.

We have installed street signs at all intersections on Sagamore, Washington, and Central Roads. We hope to continue this year so that all roads will be suitably marked.

The Selectmen are at the Town Hall on the first Monday evening of each month to meet anyone who wishes to see them.

We wish to thank Judge Thomas H. Simes for his valuable advice and the residents of Rye for their assistance and cooperation during the past year.

Rye Police Department

To the Citizens of Rye:

I wish to again extend my thanks to the Telephone Operators at the Rye Beach Exchange for their help that they have given the department during 1954. Also the Wallis Sands Assoc. and residents for helping to raise the necessary money to have a life guard at the Beach.

The department has found that through the use of our town ordinances that we have had much better control of our beaches and recreational areas. The lighting of Wallis Sands State Beach had almost completely eliminated the trouble there. These lights are on from 12 midnight until daylight. The Jenness Beach Area should also be lighted after midnight. We also need a life guard at the Jenness Beach Area. The Wallis Sands Assoc. with the cooperation of the Selectmen have had a Life Guard at the Town Beach at Wallis Sands. It had worked out very well and the beach now is kept clean. Our beaches last year have grown so that on the week ends they are filled to capacity with out of town and out of state visitors.

We are now confronted with a parking problem in our beach areas on week ends. We are getting more and more complaints about cars blocking driveways and parked on lawns. We are in need of an ordinance to cover our parking problem.

The department finds that since Camp Langdon has been reactivated that the accident rate on Wentworth Road has increased. They are planning at this time to reactivate a portion of Fort Dearborn with a detachment of the Air Corps which will mean increased work on the department.

The town very shortly will have to be considering another man as the work during the summer months is too much for one man. We have our beach people in

the day time, and late at night we have another class of people using the area. Our week end patrols last year were kept busy until 3:30 to 4:00 A. M. on many week ends.

Rye Volunteer Fire Department

Rye again was fortunate that during 1954 it did not suffer any major loss by fire.

Your Fire Department responded to 27 calls involving fire, 2 false alarms, 1 call for our resuscitator and 3 requests for assistance from North Hampton and Strat-ham.

Portsmouth Fire Department responded to 9 calls from residents in Rye on the Portsmouth Telephone Exchange. Rye was at 4 of the 9 fires. The Portsmouth Department responded alone to 1 chimney fire, 2 grass fires and for an overturned automobile, involving no fire.

Eight fires in homes. Cause, if known, involved smoking in bed, burning off paint with gasoline torch, overheated pan of grease on gas stove, overheated roast in an electric oven, faulty oil supply line to a pot-type hot water heater, and one fire caused by sunshine through a jar of water.

Regarding the above fires, I wish to offer the following advice: Do not smoke in bed. If you think that you must burn the paint off the side of your home, insure the house and your neighbor's houses. It is a very dangerous thing to do. Open containers of grease left on a hot stove are dangerous. They are even more of a fire hazard if left on an open gas flame. The same thing is applicable with a meat roast in an over-heated gas or electric oven. The sudden failure of an oil supply line might be called an accident, but is it? I believe that we do not check oil burning equipment frequently enough. If you are unfamiliar with this equipment, call a trained mechanic. Fire caused by sun shining through a clear glass container can be called an accident, but we know that sun passing through a clear glass container of any transparent liquid or even an empty glass bottle or vase can start a fire. Therefore, all the above fires, origin known, were avoidable.

Five grass fires, and why? Children with matches, careless use of incinerators, and careless attention to open fires near dry grass. One fire was caused by sparks flying out of a fireplace chimney on a very windy day. Over the past years we have had several fires on roofs and on the ground where people have insisted upon throwing boxes, paper, and excessive amounts of wood into their fireplace when there is a strong wind. The present-day short chimney is more of a hazard, also.

Three chimney fires. They only occur when there is something in the chimney that will burn. Cleaning once or twice a year will help.

Two dump fires. Under the improved supervision we have had little trouble with our Town Dump.

Two false alarms. One was during a severe thunder storm, and the other during the woods fire in North Hampton when the smoke covered part of Rye. If in doubt, call the Fire Department!

One fire in a garage, shop, and hen house caused by a hot muffler on a small gasoline tractor.

One fire on the beach during a very strong easterly wind. Written permits are necessary if one wishes to have a fire on the beach and are issued conditionally upon the weather conditions from the Central Fire Station at Rye Center or by the Police Department.

I asked for assistance at one house fire in an area where there was no supply of water under the Interstate Emergency Mutual Aid Unit. Greenland responded quickly with their water tank truck. This may prove to you the value of our radio communication. Arriving at the fire I decided that we should have additional supply of water to support our two pieces of equipment. I called Portsmouth from the cab of truck No. 1, and Portsmouth contacted Greenland, the nearest water tank truck. I hope that we all appreciate the great value of this cooperation with our neighboring towns under the mutual aid.

Our present water tank truck is a converted oil truck purchased with money resulting from your generosity during our annual field day by the Volunteer Fire Department and given to the Town. I think that Rye should have a new water tank truck, and I have suggested that the Volunteer Fire Department give one thousand dollars toward the purchase of an approved piece of equipment.

After the annual Town Meeting in March, the Fire Department will operate from the Central Fire Station at Rye Center. I trust that the fine cooperation of the volunteers and the citizens of Rye that we have enjoyed in the past will continue and that the hoped-for advantages of the centrally-located Fire Station may become a reality. It was a great disappointment to me that the present type of the Fire Station was approved by the voters, but I have advocated the location of the Department at Rye Center for several years.

1955 will doubtlessly be the last year during which we will enjoy the advantage of the assistance so generously offered in all emergencies by the personnel at the Rye Beach Telephone Exchange. The value of this service can only be appreciated by the want of it in the future for in 1956 the dial system will be in operation.

As the result of our annual field day last August, you made it possible for the Volunteer Fire Department to give one hundred dollars to the Parent-Teachers Association of Rye to help purchase a new movie projector for our school.

In reviewing some of my past reports to you I think that I will repeat the instructions regarding fires.

BABY SITTERS: They may be strangers in your home. They should know that in case of fire the children should be taken to safety first, the Fire Department should be called, and that the doors and windows closed,

if possible. They should know where the fire extinguisher, an attached garden hose, or a water pail is located.

REPORTING A FIRE: Give your name, character of fire (house, chimney, automobile, woods, or grass), location as to road and which end (example: west of Rye Center on Washington Road), near some store, garage, or the home of a long-time resident. We may not know you or the location of your home. If a person is available, it can save some valuable minutes if he can be out in the road to wave down the fire apparatus. Some fires are not visible from the road.

TREES ON FIRE FROM CONTACT WITH ELECTRIC WIRES: Call the New Hampshire Electric Company, Portsmouth 1500, first. Then call the Fire Department.

See that all of your lamp wires are not frayed or badly twisted and that your fuses are of a correct size. The fuse is like a safety valve on a steam boiler. It is your electricity safety valve. Do not put a penny behind the fuse. Find out why the fuse blew out. There is always a good reason. Correct the cause, then put in the correct size of fuse.

In conclusion I want to thank all the members of the Department for their quick response to calls and untiring efforts at fires. I wish to thank the operators on duty at Rye Beach Telephone Exchange for their most efficient manner in calling the Volunteer Firemen.

Civil Defense

Even though we have not held monthly meetings of the Civil Defense organization in Rye, I feel that if the emergency does arise the necessary relief work will be carried out.

The test alerts during the past year have brought out a satisfactory number of the personnel.

The alarm for such test and for the possible air raid can only be improved at great expense, therefore I hope that you can distinguish the difference between the air raid and the fire siren.

The air raid signal is the sounding of the siren on the Department cars as they pass your house on their way to the Central Fire Station at Rye Center and six blows from the air horn repeated once at the Fire Station.

The all clear is the Department cars returning home sounding the sirens with less volume and two blows on the air horn repeated once.

Fire Warden's Report

The 1953 record of very few forest fires continued through 1954. There were two fires last year which came under the jurisdiction of the Fire Warden. The first was March 7th on South Road and resulted from an outdoor fire set without a permit. The cost of \$32.00 was paid by the individual responsible. The second was a fire in North Hampton to which local firemen and equipment responded. The \$234.70 turned over to the warden for this fire was paid out to the men who worked on the fire and to the town for the use of the equipment.

All money paid to the warden is paid out to the firemen who work on fires. The warden serves without pay except for time spent at fires.

Let me remind you again that fire permits are required for all outdoor burning except when there is snow on the ground. Do your burning evenings as much as possible and avoid the periods of heavy weekend traffic, especially Sundays.

Librarian's Report

At the end of August, Miss Marjorie Chapman resigned as the Librarian. She had served in this capacity since 1951 in a most efficient and capable manner and had endeared herself to the many patrons of the Library. Her assistance to the new Librarian has been and continues to be invaluable and is sincerely appreciated.

The Library continues to serve the community in many ways. Circulation of books shows a steady increase, keeping pace with the growth of the town and school. The total number of books circulated for the year was 19,039, an increase of 2,539 over that of the previous year. Of this total 7,992 were children's books. The peak months are July and August when a large number of summer residents make use of the Library.

During the year 609 new books have been added. These are supplemented by the 60 to 75 books which are borrowed from the State Bookmobile each time it makes its bi-monthly visits to the Rye School and Library. This service, made available by the State Library, is very much appreciated, for it adds greatly to the variety of books offered to our readers.

We subscribe to fifteen of the most popular and worthwhile magazines and are grateful for the gifts of many others. These circulate extensively.

Approximately \$35 in fines has been taken in during the year. This money has been used to pay for various and sundry supplies, extra help and for the installation of the Book Drop, which has helped a great deal in the more prompt return of books. It is hoped more people will avail themselves of this latter service.

Mrs. Earl Walker is again our very popular "Story Lady" on Wednesday afternoons from 2:10 to 2:40. All children from five to eight years of age are welcome to attend this story period.

For the past few weeks Miss Sheila Flanigan, a ninth grade pupil at St. Patrick's School in Portsmouth has been serving as a Library Aide. She is doing this as a part of her Senior Girl Scout work and has proven to be a willing and efficient helper.

School Board Report

Your School Board respectfully submits the following report:

We are faced with the need of immediately expanding our school facilities again. We have in five short years reached the peak in enrollment that we normally would have expected to reach in about fifteen years. When the new addition was added it was planned that it would take care of 375 to 400 children. We now have nearly 380 but because of unequal numbers in the various grades we must have next year 14 classrooms. This means that we must temporarily divide the auditorium and use it for 2 classrooms until more classroom space can be built. It also means that some school and sport activities must be curtailed as well as eliminate the use of the School Building for some Public and Civic functions.

What does the FUTURE hold in store for the RYE SCHOOL SYSTEM? We can only guess — but it would seem that it would be wise to build a new ONE STORY, ELEMENTARY SCHOOL HOUSE of about 14 classrooms and then bring the 9th grade back to Rye instead of paying tuition to the City of Portsmouth (which next year will amount to nearly \$11,000.00) and use the present building for a complete JUNIOR HIGH SCHOOL PROGRAM.

Ever since the new wing was added to the School House, we have at times been bothered with water in the basement. We have solved this problem by installing a relieving drain across the basement and into the sump pit, also changing the window areaways into a continuous gutter type surface drain. This has eliminated the flash flood nuisance in the basement areas. We

have also moved the Art Classes to a part of the Manual Training area and installed a series of storage closets along one wall in this room for supplies, equipment, etc. We have had asphalt tile installed on all first floor classrooms in the old part of the School House instead of refinishing the old hardwood floors. This makes for easier cleaning and less upkeep. We have also purchased a power lawn mower. It is large enough to take care of the ballfield as well as the lawns.

We wish to express appreciation for all the gifts that have been donated to the School and to the Pupils, by the various Civic groups in our Town. These include the Every Other Tuesday Club graduation gifts, the radio given by the Darning Needle Club, and several projects sponsored by the P.T.A. Among the P.T.A. projects are listed the Pre-School Round Up, the Summer Swimming Classes, the School Band and paying for the Band Instructor, the Library and Record Fund, and this year they are heading up a list of all Civic Clubs in the Town to present the School with a new Moving Picture Projector. This machine is to be made available to all Civic Organizations within the Town the same way as the old Projector was.

We wish to express appreciation to Mrs. Emery and to all who have helped her for carrying out a most excellent Hot Lunch Program in our School again this year.

Report of the Superintendent of Schools

TO THE RYE SCHOOL BOARD:

I herewith submit to you my 25th report as Superintendent of your Schools. The current year began on Wednesday, September 8th, 1954 with an initial enrollment of 342. This compares with last year's like figure of 321 and that of the year previous of 308. A realization of the rapid growth of the school is obtained from the fact that thirty-one additional pupils have entered since September. The total enrollment on December 23, 1954 was 373. This brings our total increase over last year to 52. That this growth is not confined to the present year is proven by the following September enrollments:

It will be noted that the largest increase took place within the past four months. It will also be noted that the largest enrollments are in the lower grades. While we are graduating classes of 34 and 35, we are taking in first grades of 45 and 50 pupils.

The constantly increasing enrollments mean just one thing. Rye school facilities must be increased.

At the present time our school plant is being used to its capacity. In all probability, we shall need two rooms for each of grades one to six next year. Within the present school, this is impossible if we are to offer a full program. In fact, if our rate of increase continues, which seems probable, we may need more than two rooms per grade in the near future.

A new elementary school of at least fourteen rooms would allow two rooms for each grade (one through six) with two rooms for expansion. Since entering classes are enrolling between 50 and 60 pupils, we could

expect registration between 300 and 350 pupils. With the rapid growth of our school population, and particularly in connection with the Newington Bomber Base, the need of this school is self-evident.

It is probable that our present building can easily be converted to a junior high school to take care of grades seven and eight. If, to the prospective one hundred pupils of these two grades, should be added the pupils entering grade nine, we would have a junior high school of approximately 150 pupils. For a modern program these children would occupy six rooms as "home rooms." Under this plan several needed facilities can be made available.

More emphasis is being placed upon suitable libraries in our schools. Rye has budgeted a small amount each year for library books but we have no room for such a library. This service is needed under any conditions. Our home economics classes are held mainly in the cafeteria. This is not a good arrangement. The department should have its own rooms. There is no room allotted for guidance and pupil consultation. Such room is a requirement in a modern school program.

There may be other possible solutions to the situation Rye faces but it seems to us that this is the best solution from the viewpoint of the welfare of our pupils. Rye would have a six, three, three program paralleling that of Portsmouth. Our pupils would enter the New Portsmouth High School at the same time as their local pupils and would have had comparable courses and comparable services.

Rye is entitled to federal funds because of the large number of pupils whose parents work on federal property. In the main, this applies to those working at the Newington Bomber Base and the Portsmouth Naval Base. On the basis of costs for the past complete school year, the local district received \$14,221.93 from the federal government. Application has been made for

such aid during the present school year and acknowledgement of the application has been received from Washington. It is probable that a substantial part of our entitlement will be in the treasurer's hands before the end of the present school year.

It is interesting to note that the total federal funds received in Union No. 21 amounted to \$38,139.73.

That the people of Rye may know how their school dollar is spent, the following data has been established. Figures are taken from statistics of the year 1953-1954, the last completed school year.

By legislative action, Union No. 21 was granted a Helping Teacher. He is a full-time employee of the Union serving throughout the calendar year. His work has proven of great value to the teachers of the Union. The teachers feel free to bring their problems to him and to talk over any situation which may be a handicap to efficient teaching. Mr. Sherman Lovering, a graduate of Keene Teachers College and holding a Master of Education Degree from Boston University, was the unanimous choice of the Supervisory Union Board. A former principal of an elementary school in Manchester, New Hampshire, he is familiar with the problems of the elementary grades. The State Department of Education pays \$2,500 of his salary, the remainder being divided among the seven towns of the Union.

Rye has an outstanding lunch program. Mrs. Emery is to be credited for adequate and attractive meals served in an orderly manner. The preparation and serving of 260 meals daily is no ordinary assignment. Financial records must be kept. Surplus commodities ordered as well as the regular supplies. A hot lunch at noon means much to a child. He feels better physically and is thereby so much better equipped to study and learn.

I am recommending to you, as a board, the adoption of the Rinehart Handwriting System. By this system, expert penmen will instruct our pupils in the most approved methods of writing. They will come to our school once each month, give instruction in each room to all pupils in that room, analyze each paper and give suggestions for improvement. Each teacher will be carefully directed as to the work of the class for the

days following. This system is being adopted by an increasing number of schools each year. It produces intense interest on the part of the pupils in all written work.

The Rye Parent-Teacher Association, as always, has stood ready to help the schools in a generous way. The funds which it contributes for library books are much appreciated. I am told that a motion picture machine is to be made available in the near future. This will prove of real value in our visual education program. The loyalty to the school lunch program of P.T.A. members and parents has made possible a smoothly operated program.

Rye teachers constitute a conscientious group of instructors. That they are interested in the efficiency of their work is proven by their attendance at work-shops and by their enrollment in educational courses. This is work above and beyond the call of duty. It certifies their desire to gain ever better results for our children.

One measure of their achievement is the standard of work done by our graduates during their first year in Portsmouth. Reports from that school show the following results: Our graduates of 1954 earned 148 "marks" during the first marking period. Of these, 18 were in the 90's, 64 in the 80's, 55 in the 70's. This means that but eleven marks of the 148 were below passing for the first period. Since the ranks include the period of adjustment, I believe the work of our students is to be commended.

The Supervisory Union was pleased to welcome Miss Olga Sarmiento, a visiting teacher from Mexico. She is one of a group of experienced teachers from other countries studying American education on the elementary level. She visited every district in the Union, attended teachers' meetings and several broad meetings. Both teachers and children enjoyed her visits during the five weeks she was with us.

All of the teachers of Union No. 21 attended a professional workshop conducted under the direction of the Helping Teacher. For three days our teachers studied methods of teaching Reading under the instruction of several experts in this field. Since we believe that reading is the foundation of good scholarship, it is important that our teachers receive all help possible in teaching this subject. The work of these three days will prove of value to the pupils of our school.

You, as a board, have been always helpful to me in my school work. The teachers, without exception, have been faithful to their pupil's welfare. As these conditions are true, our school must be a success.
