

## THE STATE OF NEW HAMPSHIRE

L. S.

To the Inhabitants of the Town of Croydon, in the County of Sullivan, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Town on Tuesday, the 10th day of March next, at 10 o'clock in the forenoon, (the polls not to close earlier than 6 o'clock in the afternoon) to act upon the following subjects:

ART. 1. To choose one Selectman for three years, a Town Clerk, Town Treasurer, Tax Collector, Highway Agent, two Auditors, Library Trustee for three years, one Trustee of Trust Funds for three years, and all such Officers and Agents as may be necessary for the transaction of the Town's business for the ensuing year.

ART. 2. To choose a delegate to the Constitutional Convention.

ART. 3. To see if the Town will vote to authorize the sale of sweepstakes tickets.

ART. 4. To see what sum of money the Town will vote to raise and appropriate to defray Town Charges for the ensuing year.

ART. 5. To see if the Town will vote to accept State Aid for Class V roads and vote to raise and appropriate \$480.50 for same: The State to contribute \$3,203.33.

ART. 6. To see if the Town will vote to accept State Aid for Class V Highways and Bridges and raise and appropriate such sums of money as may be deemed necessary for that purpose.

ART. 7. To see what sum of money the Town will vote to raise and appropriate for summer and winter road maintenance.

ART. 8. To see what sum of money the Town will vote to raise and appropriate for maintenance of Town Dump.

ART. 9. To see what sum of money the Town will vote to raise and appropriate to defray legal expenses acquired by tax case between the Town of Croydon V.S. Blue Mt. Forest Association.

ART. 10. To see what sum of money the Town will vote to raise and appropriate for General Expense of the Highway Department.

ART. 11. To see what sum of money the Town will vote to raise and appropriate for cutting brush.

ART. 12. To see what sum of money the Town will vote to raise and appropriate for upkeep of cemeteries.

ART. 13. To see what sum of money the Town will vote to raise and appropriate for Capital Reserve Fund to be used for new equipment.

ART. 14. To see what sum of money the Town will vote to raise and appropriate for Street Lights and Lighting Town Buildings.

ART. 15. To see if the Town will vote to install a heating unit in the Town Hall and raise and appropriate a sum of money for same.

ART. 16. To see if the Town will vote to install water in the Town Hall and raise and appropriate a sum of money for same.

ART. 17. To see what sum of money the Town will vote to raise and appropriate for Social Security on Town Employees for the ensuing year.

ART. 18. To see if the Town will vote to raise and appropriate \$98.00 for White Pine Blister rust.

ART. 19. To see if the Town will vote to use a sum of money from Capital Reserve Fund to purchase a steam culvert thawing unit.

ART. 20. To if the Town will vote to authorize the Selectmen to hire all necessary sums of money for use during the year in anticipation of Taxes.

ART. 21. To see what sum of money the Town will vote to raise and appropriate for Old Age Assistance.

ART. 22. To see what sum of money the Town will vote to raise and appropriate for Insurance.

ART. 23. To see if the Town will vote to raise and appropriate the sum of \$215.00 to defray cost of Library, including Librarian's salary, heat, etc.

ART. 24. To see if the Town will vote to raise and appropriate a sum of money for the promotion of Dartmouth Lake Sunapee Region.

ART. 25. To see if the Town will vote to raise and appropriate \$100.00 for Newport Hospital.

ART. 26. To see if the Town will vote to accept as Town road the piece of road from Newport Town Line to Keyes residence (Formerly Route 10) and give name to same.

ART. 27. To see if the Town will vote to authorize the Selectmen to appoint the Town Highway Agent.

ART. 28. To see what sum of money the Town will vote to raise and appropriate to defray expenses of Bi-Centennial celebration and hear reports of Senior Citizens appointed as Bi-Centennial Committee.

ART. 29. To transact any other business which may legally come before said meeting.

## REPORT OF THE FOREST FIRE WARDEN AND YOUR DISTRICT CHIEF

---

During the past year New Hampshire faced the greatest forest fire threat to its woodlands in more than sixty years. The continued drought brought home to our citizens, as never before, the potential threat of destructive fires to their beautiful and valuable forests, homes and livelihood. In true American tradition of meeting a common threat by volunteer effort, this fire danger was minimized by active prevention, patrol and a relinquishing of personal rights for the common good. It was the greatest demonstration of public cooperation ever experienced by those responsible for local and state fire control. The ready forces of volunteer fire services kept the losses low. For their effort and public response the general fire service expresses its heartfelt thanks for a job well done.

Prevention however, is not just an activity for the bad fire years. It must be practiced until it becomes a part of our public conscience — a habit. Just plain carelessness with fire causes too many of our fires.

The following practices and suggestions will help:

1. Always have a permit for outdoor burning and burn within the terms of the permit and in a safe place. Burn late in the afternoon when the wind is down or on rainy or damp days. Check your fire and if winds develop extinguish it promptly.

2. Carry your rubbish to the public dump — it's safer. A neglected backyard incinerator causes many fires.

3. Never discard lighted cigarette or match. Make this a year round habit regardless of the safety of your surroundings.

4. Children caused fires are now a major concern.

Keep matches away from them and teach them to respect fire and not make it a subject of play.

Let's all join with "Smokey the Bear" and "Keep New Hampshire Green" and growing in 1964.

### Building Improvements

The outside wooden trim was painted and the usual routine maintenance was carried out.

### High School Transportation

Since it was necessary to negotiate a new contract with the school bus operator, Lawrence Darling, it was possible to make a very satisfactory agreement including the transportation of high school students. Providing their own transportation has worked a real hardship on some students and their parents and has probably contributed to some dropping out prior to graduation. The need of a high school diploma today is so minimum an educational requirement that this positive support in providing transportation should serve as another indication to the young people of Croydon that the community really does want them to finish high school.

### State Aid

An increase in State Aid was received. While \$3,150.00 had been estimated, the actual figure amounted to \$4,003.80. We are estimating a similar amount in the next budget.

The manner in which State Aid is figured may be of interest. It is based on:

- a. The number of pupils in **residence**—not where they attend school.

b. Equalized Valuation—Croydon's breakdown is as follows:

You are hereby notified to meet at the Town Hall in said District on the fourth day of March 1964 at 7:30 o'clock p. m. to act upon the following subjects:

Article 1. To choose a Moderator for the ensuing year.

Article 2. To choose a Clerk for the ensuing year.

Article 3. To choose a Member of the School Board for the ensuing three years.

Article 4. To choose a Treasurer for the ensuing year.

Article 5. To choose one or more Auditors and such other officers and Agents as the voters may judge necessary.

Article 6. To hear reports of Agents, Auditors, Committees or Officers chosen, and pass any vote relating thereto.

Article 7. To see what sum of money the District will raise and appropriate for the support of schools, for the salaries of School Officials and Agents, for the payment of statutory obligations of the District, and to authorize the application against said appropriation of such sums as are estimated to be received from the state equalization fund, together with other income; the School Board to certify to the Selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the Town.
