To the Inhabitants of the Town of Goshen in the County of Sullivan in said State, qualified to vote in Town Affairs:

9. To raise such sums as are necessary for Insurance.
10. To see what sum the town will vote to raise for Civil Defense.
11. To raise such sums of money as are necessary for the Town Dump.
12. To raise and appropriate money for Highways and Bridges. (Summer).
13. To raise such sums as are necessary for Winter Roads.
14. To raise sums necessary for General Expense of the Highway Department.

15. To see if the town will raise \$266.58 for T.R.A. - State contributes \$1,777.21.

16. To see what sum of money the town will raise for the Library.

17. To raise such sums as are necessary for support of Town Poor.

18. To raise such sums as are necessary for Old Age Assistance.

19. To see what sum the town will raise for observance of Memorial Day.

20. To raise such sums of money as may be necessary for Cemeteries.

21. To raise such sums as are necessary for Damages and Legal Expenses.

22. To see what sum the town will raise for Advertising and Region Assn.

23. To raise such sums as are necessary to defray Interest charges.

24. To see what sum will be raised for the support of the Newport Hospital.

25. To raise such sums as may be necessary for County Tax.

26. To see if the town will authorize the Selectmen to transfer the Rands Pond appropriation to a Sinking Fund toward the purchase of a truck.

27. To see if the town will authorize the Selectmen to borrow money in anticipation of taxes.

28. To take up any other business that may legally come before this meeting.

When we require you to obtain a permit for out-of-doors burning or forbid you to burn on days of high fire danger or set up regulations — hours, etc., governing the use of the town dump we are simply protecting yours and the town's interests.

The ever present threat of forest fires is the concern of all of us; the responsibility for preventing them is ours and the costs of extinguishing are ours. We can do something about this problem, by being aware of and alert to the danger and by cooperating with your warden.

Do the things that are required of you—

1. Follow the warden's directions.
2. Secure the required burning permit.
3. Keep your fires under control.
4. Completely extinguish your fires before leaving them.
5. See that your children are properly cautioned.

Everyone will benefit by it.

SUMMARY OF FINDINGS AND RECOMMENDATIONS

January 29, 1962

Gentlemen:

Submitted herewith is a report of an audit and examination of the accounts of Helen A. Brigham, Town Clerk and Tax Collector of the Town of Goshen, which was made by this division. Exhibits as hereafter listed are included as part of this report.

Summary of Shortage and Cash on Hand — As of August 25, 1961:

(Exhibit A)

Exhibit A presents a summary of the shortage in the accounts of the Town Clerk and Tax Collector as of August 25, 1961, the date on which Mrs. Brigham became incapacitated and unable to further perform her duties.

As noted therein, the net amount of the shortage on that date was \$2,002.29. The shortage and irregularities in the Motor Vehicle Permits accounts of the Town Clerk covered a period of six years from 1956 to 1961, inclusive. No attempt was made to extend the audit to the years prior to 1956 because of the statute of limitations.
Shortages by Discrepancies in Motor Vehicle Permits:

As indicated by the summary presented in Exhibit A, the annual shortages during the six year period totalled \$2,008.52. This represented the difference between the actual amount of the motor vehicle permits as issued and paid for by the applicants, and the amount which the Clerk entered in her records and remitted to the Town Treasurer.

A detailed statement of these discrepancies and shortages by years, is included in Exhibit B.

Because of the fact that it was not possible to find the Clerk's copies of the 1958 permit cards, the Auditors could only take the figures as entered in the Clerk's cash book for that year.

Accounting Irregularities:

It was found that the Clerk had followed an irregular procedure in accounting for motor vehicle permits over the years, resulting in the shortage as heretofore stated.

In numerous instances, the correct amount for which the permit was issued was indicated on the copy which the applicant retained and the copy which went to the Commissioner of Motor Vehicles. Likewise, it was the amount indicated on these two copies which the Clerk actually received from the applicant.

However, on the copy which the Clerk retained there was indicated a lesser amount than that which was actually received and which was shown on the other two copies. The incorrect amount was entered in the cash book by the Clerk and it was on this basis that remittances were made to the Treasurer.

In most instances, the difference between the actual amount received by the Clerk for the permit and the amount subsequently remitted to the Treasurer was either \$10.00 or \$20.00. A complete list of the permits in which discrepancies occurred is on file in this office.

Tax Accounts:

Exhibits D-1 to G-3, inclusive, present summary statements of the accounts of Helen A. Brigham, Tax Collector of the Town of Goshen.

Verification of uncollected taxes was made by mailing notices to delinquent taxpayers as indicated by the Collector's records as of December 29, 1961. The amounts of uncollected and unredeemed taxes as indicated in this report are therefore subject to any changes which may be necessitated by the return of verification notices.

Conclusion:

The provisions of Chapter 184 of the Laws of 1955, require that the summary of findings and recommendations (letter of transmittal) of this report shall be published in the next annual report of the Town.

TEACHING STAFF

Mrs. Leila Thibault resigned at the close of the 1960-1961 school year. She felt it necessary for her to remain at home with her family.

Mrs. Hester Morrissey was appointed teacher of grades four, five and six to succeed Mrs. Thibault. Mrs. Morrissey graduated from the State Teachers College in North Adams, Mass., and has also studied at Keene Teachers College. She has had many years of teaching experience, the last ten years in the town of Walpole.

Mr. Roy Balla resigned last June after three years as Principal of the Goshen-Lempster School. He is now employed in the business field. Mr. John Nofle of Keene was appointed to succeed Mr. Balla as Principal and teacher in grades seven and eight.

Mr. Nofle is a graduate of the Eastern Nazarene College in Wollaston, Mass., with a degree awarded in 1953. He has also studied at Northeastern University and Keene Teachers College where he is working for his Master's Degree in Education. Mr. Nofle taught for three years in the Elementary School in Gill, Mass.

Mrs. Doris Newman returned this year to her regular assignment as teacher of the Primary Room. Mrs. Myrtie Starkey has been assigned as teacher of grades two and three.

CAFETERIA

Mrs. Roy Balla has again been in charge of the school cafeteria. The quality of food served and the organization of the lunch period ranks high among the Hot Lunch Programs in Union No. 5. We consider this added service of great benefit to the children. Mrs. Balla should be commended on her fine service in the interest of the school.

All children who have wished to do so, have had an opportunity to take advantage of this school service. Monthly shipments of Government Surplus Foods have helped finance the lunch program, and enabled us to serve meals at a minimum cost to the child.

MAINTENANCE

Mr. Andrew H. Currier resigned as custodian of the Cooperative Building. We appreciated very much his interest and conscientious effort in keeping our classrooms clean and comfortable.

Mr. Wesley Witham was appointed janitor to succeed Mr. Currier. His work has been most satisfactory and we are pleased with the condition and upkeep of our building.

During the summer vacation, the entire building will be cleaned, as part of our maintenance program. The floors will be waxed and some building improvements are to be considered.

REPAIRS AND IMPROVEMENTS

The following repairs were made and improvements completed during the past summer by monies voted in our current budget. We wish to list the following:

1. The duplicator machine was repaired and thoroughly cleaned.
2. A new teacher's desk and chair was purchased for Mrs. Starkey's room.
3. Plastic tops were purchased for desk tops which were worn and in need of repair.
4. Six new desk and chair units for pupils were purchased.
5. The toilet rooms and several of the classrooms were re-decorated.
6. The exterior of the building was painted one coat, and a second coat is to be added this coming summer vacation.
7. A used typewriter was purchased for the use of the teachers.

ENROLLMENT FOR 1962-1963

It is expected that we will have an entering First Grade class of eleven pupils in September, 1962. Of this number nine are from the town of Goshen and two from Lempster. Our expected enrollment in total for next fall is estimated at one hundred and sixteen pupils.

About forty-three pupils will be attending Newport High School next year, with a probable five pupils attending Claremont at Stevens High School.

I wish to thank the teachers, the School Board, and citizens of the Cooperative District for their fine cooperation and support during the school year. I commend our new teachers on their good work this first year in our local school. We will endeavor to continue to provide a program of education of which the townspeople may be proud, and working together we can expect this to be accomplished.

SCHOOL NURSE'S REPORT

In past yearly reports your school nurse has stressed the importance of good physical health in the learning and educational program for all children. In this report I would like to emphasize the importance of good mental health in a child's educational program. Needless to say, the two cannot be separated — either one has a great effect on the other. For instance, the child with a severe vision handicap may have an emotional problem directly related to the physical problem. On the other hand, emotional problems may sometimes show themselves in physical symptoms.

First of all, we should acquaint ourselves with the indications of a well adjusted child and/or good mental health. There is evidence of good mental health when the child (1) Seems happy most of the time, (2) Contributes freely in a classroom discussion, (3) Is not unduly shy, (4) Enjoys playing with other children and being a part of a group, (5) Is achieving in his studies according to his ability, (6) Attends school regularly, (7) Does not seem too often fatigued, (8) Does not day dream excessively, (9) Uses adequate self-control according to his age, (10) Is able to make and maintain friends, (11) Is interested in new experiences, (12) Does not show a pattern of stuttering or of infantile speech, (13) Does not show excessive nervous mannerisms.

If it is felt that the child needs assistance, we do have available resources within the State of New Hampshire. Perhaps the best known of these is the New Hampshire Child Guidance Clinic which functions out of Concord. In addition to the services in Concord a group from this Clinic comes to Keene once a month. At these Clinics the child is given various tests by a psychologist in order to determine the child's learning potential as well as behaviour patterns. The child is also seen by a psychiatrist who may do further tests with the child. The parents of the child discuss the child and his problems with the social worker — later a conference is held and the findings of these clinic members are discussed and evaluated. At a later date the parents have the opportunity to discuss the findings of the clinic with the persons mentioned above and to make plans beneficial to the child.

In the Claremont area a Child Guidance Clinic is made available by the Claremont Mental Health Association. This clinic is served

by a psychiatric Social Worker and a psychologist from the Hitchcock Clinic in Hanover. This clinic is available to our Supervisory Union. There is no charge for the services of the above mentioned clinics. On a private basis there is the Hitchcock Clinic in Hanover which offers a very fine service. It is extremely important for one or both parents of the child to attend with the child.

During the course of a school year several of our children attend these clinics. We feel that a great deal of benefit has been derived from the use of these services. The school and the home have a much better understanding of the child and his problems; the recommendations made through these clinics enable the parents, as well as the school, to really help the child. The children attending seem to enjoy the experience and cooperate well.

Once again I would like to take this opportunity to thank you all for your support of our Health Program.
