WARRANT FOR THE ANNUAL TOWN MEETING

THE STATE OF NEW HAMPSHIRE

(L. S.)

To the Inhabitants of the Town of Webster, in the County of Merrimack, in said State, qualified to vote in town affairs:

You are hereby notified to meet at Grange Hall in said Webster on Tuesday, the thirteenth day of March, next at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.

3. To raise such sums of money as may be necessary for the maintenance of highways and bridges.

(a) Town Maintenance.

(b) Plowing and sanding roads.

(c) Oiling town roads.

(d) General expense of Highway Department.

4. To raise and appropriate the sum of \$530.86 for Class V Road Construction.

5. To raise and appropriate such sums as may be necessary for Public Welfare.

(a) Town Poor.

(b) Old Age Assistance.

6. To raise and appropriate such sums as may be necessary for the support of the Town Library.

7. To raise and appropriate such sums as may be necessary for Patriotic Purposes.

(a) Old Home Day.

(b) Memorial Day.

8. To raise and appropriate such sums as may be necessary for the support and maintenance of the Hy-Mar Fire Department.

9. To authorize and empower the Board of Selectmen to borrow for the town by the issuance of notes, a sum not exceeding \$8,000 in anticipation of taxes for the year 1951, said notes to be expressly payable from said taxes within one year from date of issuance and to authorize the Board of Selectmen to determine the rate of interest on such notes and to provide for the sale thereof.

10. To see if the town will vote to raise and appropriate the sum of \$400.00 for use in connection with the State's program for the eradication of white pine blister rust.

11. To see what sum the town will vote to raise and appropriate for the care of cemeteries.

Given under our hands and seal, this twenty-fourth day of February, in the year of our Lord nineteen hundred and fifty-one.

REPORT OF THE FOREST FIRE WARDEN

The successful control of brush and woods fires is highly dependent upon the cooperation of all townspeople in the prevention of these fires. To the end of enlisting this help, many wardens have asked us to assist them in preparing a brief statement which could be printed in the forthcoming Annual Town Report. This statement appears below and your cooperation in seeing to its publication will be helpful. Concord, February, 1951.

John H. Foster, State Forester

FOREST FIRE PREVENTION PAYS DIVIDENDS

Most forest fires are preventable because someone is responsible for them. State records for 1950 show 94% of 632 fires resulted from human perverseness and carelessness. Refusal to secure the required warden permit before burning; failure to use good judgment, lack of equipment and assistance while burning; carelessness in smoking and poorly conditioned woods equipment (trucks, tractors, etc.) resulted in a total of 6090.6 burned acres with a loss of \$63,949.10 in valuable property.

Fortunate, these human factors can be dealt with because people can be reached. This the local forest fire warden tries to do by informing his fellow citizens that *EVERYONE MUST*:—

1. Secure a written permit to burn in or near woodlands when the ground is not covered with snow.
2. Use good judgment in burning and have enough equipment and assistance to keep fire under control at all times.
3. Be careful when smoking in or near woodlands and refrain from throwing lighted material from automobiles.

4. Make certain that all equipment used in the woods is in good condition.

His success depends entirely upon public reaction to his appeals. He does his part — the rest depends upon YOU and

YOUR compliance with burning requirements.

YOUR care with YOUR fires and YOUR smoking and

YOUR care of motive equipment you use in the woods. It all aids, materially, in reaching the desired goal, the

You will recall in the last school meeting that I told you when the present State Aid formula was changed, Webster should expect a serious cut in its State Aid. This wasn't because I did not want Webster to have the money. However, it didn't make sense to have State Aid cut by two million dollars and have Webster get more money rather than less.

The State Board of Education has now presented their new formula to the members of the 1951 General Court. In spite of the fact that the proposed amount of State Aid is increased by a million dollars, Webster will get no state aid money at all. What the new Legislature will do is anybody's guess. Unless they are ready to raise new revenue Webster will have to support their schools entirely with real estate tax money.

Last spring it looked as though prices were going to be lower, and that the teacher supply would be a little better with more men going into the elementary field. However, since the Korean situation, things have changed. I am afraid that most young men getting out of college next June will be entering service and already teachers are being called into service and some will be attracted into the defense industry by high wages. All this will naturally affect the supply of teachers and school district budgets.

Things have been going well in the Webster schools. At the beginning of the year the situation at Putney Hill was critical but quite a few families moved away so that both schools are not too large at the present time. It looks as though the crowded conditions were taken care of for a little while unless families begin moving into the small towns because of the fear of atomic bombing.

I have enjoyed my work with the people of Webster.
