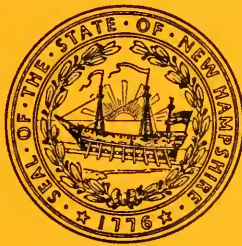

TOWN MEETING WARRANT

To the inhabitants of the Town of Benton qualified to vote in Town affairs:

You are hereby notified to meet at the Community Building in said Benton on the second Tuesday of March next (the 11th) at seven thirty o'clock in the afternoon to vote and act upon the following subjects:

Article 1. To choose a Town Clerk; one Selectman for the term of three years; one Treasurer; one Tax Collector; one Highway Agent; one Trustee of Trust Funds for the term of three years and one Trustee of Trust Funds for the term of one year; one Sexton; one Auditor; and all other necessary Town officers and agents for the ensuing year.

Article 2. To see if the Town will vote to raise and appropriate the sum of \$135.51 as the Town's share for construction of highways (Town Road Aid) as provided in Chapter 241 of the Revised Statutes Annotated, as amended.

Article 3. To see if the Town will vote to raise and appropriate the sum of \$24.94 for the White Mountains Region Association.

Article 4. To see if the Town will vote to raise and appropriate the sum of \$100.00 to help subsidize ambulance service in our area with such funds to be administered by the Trustees of the Cottage Hospital.

Article 5. To see if the Town will vote to raise and appropriate the sum of \$25.00 to the White Mountain Community Services for support of their non-profit community mental health program.

Article 6. To see if the Town will vote to make any alterations in the amount of money to be raised and appropriated for the ensuing year as recommended in the budget, and vote to raise and appropriate all sums so determined.

Article 7. To hear the reports of officers and agents and pass any vote relating thereto.

Article 8. To see if the Town will vote to authorize the Selectmen to borrow money for current indebtedness of the Town during the ensuing year in anticipation of taxes to be collected for the year 1969 and to be paid therefrom.

Article 9. To see if the Town will vote to authorize a discount on property taxes paid before a date set by the Selectmen and to set the amount of said discount.

Article 10. To see how the Town will vote on the following question: "shall the provisions of Chapter 287 of the Revised Statutes Annotated relative to playing beano be adopted in this Town?"

2. To choose a Clerk for the ensuing year.
3. To choose a Member of the School Board for the ensuing three years.
4. To choose a Treasurer for the ensuing year.
5. To determine and appoint the salaries of the School Board and Truant Officer, and fix the compensation of other officers or agent of the district.
6. To hear the reports of Agents, Auditors, Committees, or Officers chosen, and pass any vote relating thereto.
7. To choose Agents, Auditors and Committees in relation to any subject embraced in this warrant.
8. To see what sum of money the district will raise and appropriate for the support of schools, for the salaries of school district officials and agents and for the payment of statutory obligations of the district, and to authorize the application against said appropriation of such sums as are estimated to be received from the state foundation aid fund together with other income; the school board to certify to the selectmen the bal-

ance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the town.

9. To see if the District will authorize the School Board to make application for, and to receive, in the name of the District such advances, grants-in-aid, or other funds for educational purposes as may now or hereafter be forthcoming from the United States Government and/or State of New Hampshire.
10. To transact any other business that may legally come before said meeting.

Unfortunately, this year your taxes for school support have risen dramatically. The major increase can be traced to one item—tuition.

It might be a good idea at this time to give you some of the tuition charges in other school districts in this area to indicate how much per pupil tuition costs have increased in the last few years:

**SUPERVISORY UNION #23
REPORT OF SUPERINTENDENT'S SALARY**

Section 5, Chapter 243, Laws of 1953 of the State of New Hampshire requires that school district annual reports show the total amount paid to the superintendent.

One-half of the supervisory union expenses is prorated among the several school districts of the union on the basis of adjusted valuation. One-half is prorated on the basis of average daily membership in the schools for the previous school year ending June 30. The Superintendent of Supervisory Union #23, during 1968-1969, will receive a salary of \$14,000.00, which is made up as follows: \$3,500.00 to be paid by the State Department of Education and \$10,500.00 prorated among the several school districts. Allowance of \$1,500.00 for travel within the Union is also prorated as stated above.

**REPORT OF FOREST FIRE WARDEN &
DISTRICT CHIEF**

New Hampshire is the fastest growing state in the northeast in terms of population increase. It is also an industrialized state and this growth is likely to continue, all of which means more families and homes. Our growing summer population is scattered throughout the state with a phenomenal increase in vacation homes.

Many new homes and practically all cottages are being located in woodlands and abandoned fields and forests crowd into the back yards of our village streets. In a state where the forests cover 86% of the land surface, it is necessary that everyone be aware all through the season, which comes with the disappearance of the snow until the snow comes again, of the need to be careful with outdoor fires and fire sources.

The following action will help:

1. To teach our children the danger of lighted matches.
2. To never discard lighted smoking material from a car or while walking through fields or woods.
3. To safely dispose of rubbish preferably at the town dump. If you must burn—
 - a. You need a written permit from the town fire warden for *all* debris burning except when the ground is covered with snow. Cooking fires in outdoor fireplaces or in charcoal brasiers in your own back yard is permitted on notification of the warden.

- b. The warden is forbidden by regulation to allow burning of household rubbish on grass by householders between 9:00 A.M. and 5:00 P.M.
 - c. Have equipment on hand to control the fire *before* you light the match.
4. Promptly report any fire out of control to your fire warden or fire department.

Help to keep our town out of the fire occurrence column and save our tax dollars for useful purposes.
