THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Dummer in the County of Coos in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Willis School House in said Dummer on Tuesday, the 8th day of March, next at ten of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
3. To raise such sums of money as may be necessary for the repair of highways and bridges and bush cutting.
4. To raise such sums of money as may be necessary for snow removal.
5. To raise such sums of money as may be necessary for general expense of the Highway Department.
6. To see if the Town will vote to accept T. R. A. and make appropriation for the same.
7. To raise such sums of money as may be necessary for the support of Town Poor.
8. To raise such sums of money as may be necessary for Old Age Assistance.
9. To raise such sums of money as may be necessary for the maintenance of cemeteries.
10. To raise such sums of money as may be necessary for the support of town libraries.
11. To see if the Town will vote to give discount on taxes.
12. To see if the Town will raise and appropriate any sum of money for the White Mountains Region Association.
13. To see if the Town will vote to give the Selectmen the right to hire money in anticipation of taxes, and to renew notes.
14. To see what sum of money the town will raise for Social Security.
15. To see what action the Town will take toward fire protection and make appropriation for the same.
16. To see if the Town will vote to raise the wages of the Town Clerk and Town Treasurer.
17. To see what action the Town will take toward garbage collection.

18. To transact any other business that may legally come before this meeting.

8. To see what sum of money the District will vote to raise and appropriate for the support of schools, for the payment of salaries for school district officials and agents and for the payment of statutory obligations of the District.
9. To see if the District will place an amount, not to exceed \$1,000.00, from the 1965-66 unencumbered balance, into a bus capital reserve fund, to purchase a bus at a later date.
10. To see if the District, with other Districts in Supervisory Union No. 20, will vote to hire a part-time federal coordinator and raise and appropriate \$48.18 for salary and expenses.
11. To see if the District will vote to accept the provisions of Public Law 89-10, designed to improve educational opportunities with particular reference to children of low-income families, and to appropriate such funds as may be made available to the District under said federal act for such particular projects as may be determined by the school board. Further, to see if the District will authorize the school board to make application for such funds and to expend the same for such projects as it may designate, including cooperating with other school districts.
12. To transact any other business that may legally come before this meeting.

Superintendent's Report

Your School Board is recommending a budget of \$19,457.19 for the school year 1966-67. This represents a decrease of \$7,998.00 from our current budget of \$27,455.19. Excluding the bus amount of \$6,500.00 our decrease is \$1,498.00.

School Bus

I have recommended to your School Board that your new bus be ordered early this year. Prices should be substantially lower than in the summer period.

School Warrant

Three special articles are in your Warrant. One requests voters approval to place an amount not to exceed \$1,000.00 into a Bus Capital Reserve Fund from the unencumbered balance. With careful planning the next bus can be purchased from this fund. Instead of paying interest on borrowed money, the District can obtain a sizeable amount of interest over the years to purchase a new bus when needed.

The second special article requests that the District share in the costs of a part-time federal coordinator on a Supervisory Union basis. Total costs of the above is \$3,300.00. Dummer's share is \$48.18.

The third article requests voters approval to accept money under Public Law 89-10. The sum of \$207.94 has been allocated to Dummer under Title I of this act. Your School Board plans to submit a proposal to purchase books and place them in the Brown School in Berlin. Title and ownership will remain with the Dummer School District.
