TOWN CLERK'S REPORT

TOWN WARRANT FOR 1950

TOWN OF HAMPTON
STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Hampton, in the County of Rockingham, in said State, qualified to vote in town affairs:

You are hereby notified to meet at the High School Auditorium in said Hampton on Tuesday, the 14th day of March, 1950, at Ten o'clock in the forenoon to act upon the following subjects:

Article 1. To choose by Australian Ballot one Town Clerk, one Selectman for three years, one Treasurer, one Collector of Taxes, one Highway Agent, and three Auditors.

Article 2. To choose all other necessary officers for the ensuing year.

(The polls for the election of officers and on Article 16 will open at Ten o'clock in the forenoon and will not be closed earlier than Three o'clock in the afternoon of the same day.)

Article 3. To raise and appropriate such sums of money as may be necessary for Town Officers' salaries and expenses, election and registration, municipal court, care and supplies for Town Hall, police department, fire department, moth department, highways and bridges, street lighting, library, town poor, Memorial Day, parks and playgrounds, cemetery, sewer department, sidewalks, comfort station, town notes, Hampton Beach, and all other necessary charges arising within the town.

Article 4. To see if the town will give the Selectmen power to borrow money in anticipation of taxes.

Article 5. To see if the town will authorize the Selectmen to administer, sell or otherwise dispose of any real estate acquired by the town through tax deeds.

Article 6. To see if the town will vote to authorize the Selectmen to take action according to the terms of leases against certain or all lease holders leasing lands from the town of Hampton who have not paid their ground rent, or taxes or both.

Article 7. To see if the town will vote to raise and appropriate the sum of \$448.67 for State Aid Roads, if the State contributes \$1,794.67.

Article 8. To see if the town will vote to raise and appropriate the sum of \$1,000.00 for the purchase of new fire hose for the fire department.

Article 9. To receive the report of the Sewer Committee and to see if the town will vote to accept the same and authorize the Committee to proceed as outlined therein.

Article 10. To see whether the town will amend the vote adopted under Article 11 of the 1948 Annual Town Meeting, as amended by votes adopted at the Special Town Meeting held June 14, 1948, authorizing the Town to construct a system of sewers for sewerage disposal, making appropriations therefor and providing for the issuance of bonds to finance the same, by providing that the construction of such sewer system, including the rebuilding, remodeling or enlarging of the sewerage plant, etc., shall be in accordance with such plans and specifications as shall be approved by the Sewer Committee of the Town, subject to approval of the State Board of Health; and to approving and ratifying said votes as so amended.

Article 11. To see what action the Town will take relative to the land owned by the Town of Hampton located just north of the Coast Guard Station and east of the Ocean Boulevard known as the Fish House area; that is whether said area shall be divided into lots and leased or handled in some other manner.

Article 12. To see if the town will vote to raise and appropriate for economic advancement of the town through publicity and promotional services of the Sea-

coast Regional Development Association, in cooperation with other regional communities, a sum not exceeding one and one-hundredth of one percent of assessed valuation, namely \$838.00.

Article 13. To see if the town will vote to instruct the Moderator to appoint a committee of two citizens to cooperate with similar committees to be appointed by the Towns of North Hampton and/or Rye to study the advisability of creating a Water District and of any other matters in connection therewith.

Article 14. On petition of Charles E. Greenman and nine other legal voters to see if the town will vote to accept a deed from Arthur W. Brown and Charles E. Greenman of an extension of Kershaw Avenue, to be used as a public way, the same being 40 feet wide and extending easterly for a distance of 175 feet.

Article 15. On petition of Elmer King and sixteen other legal voters to see if the town will vote to accept a deed from Elmer King of a certain tract of land to be used as a public way, said tract being 193 feet long and 38 feet wide and commonly known as King Avenue and extending northerly from Ann's Lane, so called.

Article 16. To vote upon the following article:

"Shall the provisions of chapter 171-A of the Revised Laws relative to playing games of beano be adopted in this town?" (This article appears on the Australian Ballot).

Article 17. On petition of Herbert A. Trofatter and ten other legal voters to see if the town will vote to raise and appropriate the sum of \$500.00 to continue the Christmas lighting project for the business section of the town under the supervision of a committee consisting of Mr. Harold Winchester, Mrs. Ruth Perkins and Mrs. Gertrude Lougee.

Article 18. To see if the town will vote to convey for the sum of One Dollar to the School District of the Town of Hampton the land located in the rear of the Centre

School on Winnacunnet Road, said tract to be approximately 270 feet in width and having a depth in a southerly direction of 240 feet, and to authorize and instruct the Selectmen to execute and deliver a quitclaim deed thereto.

Article 19. On petition of Victor A. Bogrett, Jr., and ten other legal voters to see if the town will vote to adopt the non-partisan ballot system for all future town elections, regular or special.

Article 20. On petition of Margaret T. Barry and nine other legal voters to see if the Town will vote to amend the Zoning Ordinance adopted at the Annual Town Meeting on March 8, 1949, by adding to Appendix A of said Ordinance the following: Additional Residence "A", beginning at a point in the boundary line between the Towns of North Hampton and Hampton, which said point is 300 feet easterly from the center line of the location of the Boston and Maine Railroad, and thence continuing easterly along said Town line to a point 200 feet easterly from the easterly side of the Mill Road, so called; thence turning and running southerly by a line parallel to and 200 feet easterly from the easterly side of said Mill Road to its intersection with Residence "A" District, "Hampton Village"; thence turning and running westerly along said Residence "A" District to a point 300 feet easterly from the easterly sideline of the Lafayette Road; thence turning and running northerly by a line parallel to and 300 feet easterly from the easterly sideline of the Lafayette Road to the point of beginning, and that the zoning map dated February 2, 1948, be amended accordingly.

Article 21. On petition of Frank B. Robinson and ten other legal voters to see if the town will vote to accept the street known as Boar's Head Terrace, located on section known as Boar's Head, at Hampton Beach as an accepted street.

Article 22. To see if the town will vote to raise and appropriate the sum of Five Thousand Dollars for sewer extensions at Hampton Beach.

Article 23. To see if the town will vote to authorize the Selectmen to request the State of New Hampshire to guarantee the Sewer Bonds in the aggregate principal amount of Two Hundred and Fifty Thousand Dollars (\$250,000) and the interest thereon as authorized at the 1948 Annual Town Meeting and the Special Town Meeting held June 14, 1948, in accordance with Chapter 247 of the Laws of 1949.

Article 24. To see if the town will vote to amend the Zoning Ordinance adopted at the Annual Town Meeting on March 8, 1949, as follows:

A. By adding the following at the end of Article III, Section 1:

“4. Municipal use.

5. Woodshed or storage building for private use of owner or occupant of premises.

6. Any of the following uses provided the Board Adjustment shall find that such use in the given case and location and under the conditions specified in the permit therefor is not detrimental, injurious or offensive to the neighborhood:

a. Bathhouse or boathouse for private use.

b. Cemeteries.

c. Public utility building or public utility use necessary for public welfare.

d. Any accessory use customarily incidental to any of the above uses.”

B. And by adding at the end of Article VI, Section I, the following paragraph:

“A statement of all permits issued hereunder shall be filed within five days of the date of issuance with the Town Clerk and said permits shall be available for public inspection at the Town Office.”

Article 25. On petition of Douglas E. Hunter and ten other legal voters to see if the town will accept the streets in Fairfield Park known as Fairfield Drive and Ruths Lane.

Article 26. To transact any other business that may legally come before said meeting.

Article 9. Report of the sewer committee was given by Ernest Underwood.

Your committee, at the Annual Town Meeting held on March 8, 1948, recommended the building of the sewer and the rebuilding and enlarging of the sewerage disposal plant according to the plans submitted by Burns and Kenerson. As you know, we have not been able to construct the system because the bids have exceeded the money appropriated.

We have been in contact with Mr. Haley of the firm of Haley & Ward. Mr. Haley is an engineer who worked on the original treatment works at the time it was installed by Mr. Barber. It now appears that by remodeling and enlarging the resent treatment works rather than rebuilding the same as originally planned that a considerable saving can be effected. We have been assured that this method will meet with the approval of the State Board of Health.

Your Committee recommends that it be authorized to engage the firm of Haley & Ward or any other competent firm of engineers and that your Committee be authorized to have the plans redrawn to remodel and enlarge the present treatment works rather than to rebuild them, all to be subject to the approval of the State Board of Health. In connection with this, no changes are contemplated in the area to be serviced by the sewerage system, although, of course, savings may be effected by installation methods.

Motion: by John W. Perkins that the report of the Sewer Committee be and hereby is accepted and the committee is authorized to continue in office and to proceed as outlined in the report, after being duly seconded.

To authorize the selectmen to keep and maintain as free public property forever that area known as "the fish house area." In order to make effective this motion all buildings shall be removed within six months of this date except those used by fishermen whose principal means of livelihood is fishing from the waters in front of said buildings. And further, nothing in this motion shall be construed as to prohibit the use of this property for the purpose of fishing. No private buildings shall be placed or allow to remain on this property for the purpose of living quarters.

Article 11. This motion was seconded by Mrs. Wingate.

Amendment by Ed Langley, Jr.:

I move that the land owned by the Town of Hampton located just north of the Coast Guard Station, south of the Nason property and east of the Ocean Boulevard be divided into equal lots and that present owners of the fish houses or other buildings now in the area be permitted to lease the lot on which their buildings stand and that a 40 foot graveled roadway be constructed through said area for public access to the beach, all division into lots, leasing and other use to be subject to the control of the Selectmen and all leasing to be on such terms and rentals as the Selectmen may determine.

Article 1. To choose by Australian Ballot one Town Clerk, one Selectman for three years, one Treasurer, one Collector of Taxes, one Highway Agent, and three Auditors.

Article 2. To choose all other necessary officers for the ensuing year.

Article 3. To vote upon the following article:

“Shall the provisions of chapter 171-A of the Revised Laws relative to playing games of beano be adopted in this town?” (This article appears on the Australian Ballot).

Article 4. On petition of Victor A. Bogrett, Jr., and ten other legal voters to see if the town will vote to adopt the non-partisan ballot system for all future town elections, regular or special. (This Article appears on the Australian Ballot).

(The polls for the election of officers and on Article 3 and Article 4 will open at Ten o'clock in the forenoon and will not be closed earlier than Three o'clock in the afternoon of the same day).

“To see if the Town will vote to amend the Zoning Ordinance adopted at the Annual Town Meeting on March 8, 1949, by adding to Appendix A of said Ordinance the following: Additional Residence “A”, beginning at a point in the Town line between Towns of Hampton and North Hampton, which said point is 200 feet westerly from the westerly sideline of the Little River Road, so called, and thence running in a south-westerly direction in a line parallel to and 200 feet westerly from the said westerly sideline of said Little River Road to a point 200 feet south westerly from its intersection with the North Beach Road; thence turning and running in a straight line 200 feet to a point on the westerly side of the Little River Road, which said point is 200 feet southerly from the southerly sideline of the North Beach Road; thence turning and running north-easterly along the westerly side of said Little River Road to said Town line; thence turning and running westerly by said Town line 200 feet to the point of beginning, and that the zoning map dated February 2, 1948, be amended accordingly.”

Article 17. On petition of Charles F. Butler and ten other legal voters to see if the Town will vote to raise and appropriate the sum of \$3,000.00 for the purpose of developing a new parking area at Hampton Beach on land owned by the Town of Hampton on the southerly side of Island Path, so-called, and to authorize the Selectmen to proceed with the development thereof, to make such parking charges as they shall deem reasonable and to take all steps necessary to enable the Town to operate the same.

Article 18. On petition of Ernest R. Underwood and

ten other legal voters to see if the town will vote to rescind the motion passed at the last annual town meeting with regard to the property known as the FISH HOUSE AREA.

Article 19. On petition of Donald S. Murray and thirteen other legal voters to see if the town will vote to extend the present sewer system to include Ann's Terrace, and to raise and appropriate the sum of \$6,5000.00 necessary to accomplish said extension.

Article 20. On petition of Donald S. Murray and ten other legal voters to see what action the town will take regarding the lighting on the streets in the center of the town i. e. Dearborn Ave., High St., Winnacunnet Road, Ann's Lane, Mill Road, Academy Ave., Exeter Road, and to instruct the Selectmen to take necessary action regarding the installation of additional lights.

Article 21. To receive the report of the Committee appointed at the last Annual Town Meeting to study the advisability of creating a water district.

Article 22. On petition of Thomas O. Moore and eleven other legal voters to see if the town will vote to accept the road leading off from Dearborn Ave., sometimes called Moore Ave., continuation of Kershaw Ave.

Article 23. On petition of William J. Thompson and twelve other legal voters to see if the Town will accept the street known as Locke Lane in the Town of Hampton.

Article 24. On petition of Laurice Brown and twelve other legal voters to see if the town will vote to accept from Ida P. Rice a deed of a certain tract of land to be used as a public highway. Said tract being forty feet

wide and extending Southeasterly from Lafayette Road for a distance of 444 feet then Northeasterly 219½ feet and commonly known as Rice Terrace.

Article 25. On petition of J. Walter Hollis and eleven other legal voters to see if the Town will accept the street known as Hackett's Lane in the Town of Hampton.

Article 26. On petition of J. Walter Hollis and eleven other legal voters to see if the Town will vote to accept the streets in the section east of Moulton Road known as the Great Lots, as public convenience will require.

Article 27. To see if the Town will vote to raise and appropriate the sum of Two Hundred Dollars to be used for the purposes of civilian defense.

Article 28. To transact any other business that may legally come before said meeting.

THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the School District in the Town of Hampton, in the County of Rockingham, State of New Hampshire, qualified to vote upon District Affairs:

You are hereby notified to meet the High School Auditorium in said Hampton, on Friday, the ninth day of March, 1951, at three o'clock in the afternoon, and to cast ballots from that hour until at least eight o'clock in the evening of said day for candidates for the following district officers:

1. Moderator (for the ensuing year).
2. Clerk (for the ensuing year).
3. Member of the School Board for the ensuing three years.
4. Treasurer (for the ensuing year).

You are also notified to meet at the same place at eight o'clock in the evening of the same day, to act upon the following subjects:

1. To determine and appoint the salaries of the School Board and Truant Officer, and fix the compensation of any other officers or agents of the district.

2. To choose Agents, Auditors and Committees in relation to any subject embraced in this warrant.

3. To see what sum of money the district will raise and appropriate for the support of the schools, for the salaries of school district officials, and agents, and for the payment of statutory obligations of the district, and to authorize the application against said appropriation of such sums as are estimated to be received from the state

equalization fund together with other income; the school board to certify to the selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the town.

4. To see if the district will elect to approve of inclusion of its officers and employees (other than those eligible under the Teachers' Retirement system) in the Employees' Retirement system of the State of New Hampshire, which system is provided for by Chapter 27-A of the Revised Laws as inserted by Chapter 183 of the laws of 1945, and as provided by Chapter 201 of the laws of 1945 and any subsequent amendments thereto.

5. If the district votes in the affirmative on the preceding article, to see if the district will vote to raise and appropriate the sum of \$503.37 for the purpose of providing funds for the district's contribution to said retirement system for the coming year.

6. To see if the School District will vote to empower the moderator to appoint a committee of four to serve with the School Board to study present and future housing of the Secondary school program in Hampton and bring in its report at the next regular school district meeting.

7. To transact any further business that may legally come before said meeting.

REPORT OF SUPERINTENDENT OF SCHOOLS

To the School Board of Hampton :

I herewith submit to you my annual report as Superintendent of your schools. Included will be the reports of the Principals of the Academy and High School and the Centre School. The heads of the various departments have also been asked to summarize the work of their respective programs. Their reports will be of interest to the people of Hampton. The statistics presented are those of the last completed school year, except that the September pupil enrollment is that of the current year.

The present year began Wednesday, September 6, 1951 with an initial enrollment of 596. This compares with last year's figure of 606 and with that of the year previous of 539. Late registrations have added to this number. The critical figures are those of the lower three grades, which enrolled 106 pupils in September 1948 and 138 in 1949. In September 1950, the same three grades registered 150 pupils. As these grades move up and continued increase is noted in the new classes, the need of new facilities is evident.

Because of this need, the school district at a special meeting held December 18, 1950, voted to construct an addition to the Centre School and a building committee was voted. This committee is now working and has reported its progress at the meeting. The Educational Service Associates was employed to make a survey of the needs for the school system. Their report was printed and distributed to the people of the town. This report was comprehensive, including not only immediate needs, but those of a longer period of time. The two plans suggested were outlined in the school report of last year. These two recommendations for immediate action were outlined in the following sentences.

1. The purchase of additions to both existing school sites.
2. The immediate addition of elementary school classrooms and special facilities to the Centre School.

The Building Committee voted upon these two recommendations. It is planning an addition of six classrooms at the rear of the present building together with an activity room of sufficient size to accommodate the pupils in physical education, health and special activities. This room, together with an enlarged auditorium, will give us a school plant equipped for a program for the development of the whole child, physically, socially and mentally.

This building will allow us two rooms for each of the first four grades and the kindergarten. As these grades move up, there will be a further problem of caring for the Junior High (grades seven and eight). It will be well to consider these grades immediately, rather than to wait until overcrowding becomes a fact. Would it not be well to appoint a committee to take under advisement a situation which will develop in the not too distant future? With increased activity in the Portsmouth Naval Shipyard, we must expect additional families to move into Hampton. Two plans suggest themselves immediately, although there may be others — the construction of a Junior High School building to house grades seven, eight and nine, or enlarging the present Academy building into a six-year high school. Either plan has its advantages which must be weighed carefully before a definite decision can be made.

The so-called six-three-three plan is now considered preferable to the former eight-four system. Grades seven through nine form a distinct group of children apart from those below or above them. It is a transition period. In the lower grades a feeling of comfort and security comes

to the children from being told what to do. The children feel that the teacher is right and are not confused by reasons or doubts. This is as it should be since little children must feel secure to do their school work well. The small pupil who loses faith in his teacher is tremendously handicapped in his school life. In the Junior High grades, however, independence of thinking comes to the fore and motivation must be made clear. Variety of approach based upon the natural interests of the pupils must be utilized. Social consciousness develops in these grades and to a degree, supplants desire for security. A school plant constructed for these grades is the right of these children.

Hampton Academy and High School is fortunate that the Trustees of the Academy continue an active interest in the school. The Principal of the school has called attention to the two hard surfaced basketball courts which the trustees presented the school. The Trustees have continued their policy of equipping the commercial department with new typewriters as they are needed and also a bookkeeping and calculating machine. A room has been excavated under the south wing for the physical education department as additional locker and storage room. All of these services are in almost constant use throughout the year.

A Summer School for the teachers of the union was conducted in Hampton last year. This was a three weeks' intensive course bringing to the teachers the most modern and approved methods of instruction. Under the direction of Keene Teachers College and approved by the State Board of Education, it was arranged under a workshop system, whereby practical problems were studied in a practical way. Forty-two teachers attended this school. At the present time, an in-service course is being conducted in Hampton by an instructor from the University of New Hampshire. This is of college level and requires fifteen weeks of intensive work. Several of the Hampton

teachers are also attending Boston University and the University of New Hampshire during the current year. It is to their credit that they are willing to devote additional time to their studies that they may serve better our children.

Two additional teachers were employed by the school district this year; Miss Arlene Cormier in the second grade and Mr. Gordon Johnston in the High School. It is the present plan to divide the third and fourth grades next year, requiring two new teachers. The necessity of this is proven by the fact that there are now registrations of forty-seven and fifty-five in these grades.

Hampton Schools have two moving picture projectors for use in the various departments of the system. These are necessary and are used considerably. The best visual aid to the modern program is the film-strip. These strips are made by educators and are definitely tuned to instruction in subject matter. All subjects and all grades are served by these films. Furthermore, they are so inexpensive that they may be purchased in as limited or as complete amount as may be usefully employed by each particular school. Because of their close alignment with actual school subjects, there is no waste space in them. I am recommending that Hampton purchase such equipment as an added means of instruction.

The Parent-Teachers Association is, as always, a motivating force in our school system. The Federal Lunch Program recommended by this group is continuing under the direction of local school officials as outlined by the Federal regulations. Because Federal aid was reduced this year, as well as because of increased cost of food, we were compelled to increase the cost to the children from 15 cents to 20 cents per meal. We were sorry to do this, but could see no alternative. Various other services to our children have been considered in Parent-Teacher Association meetings with results all to the good for the schools.

It is our plan to consider the children and their welfare in all our decisions. Schools are established for this purpose. This will be reflected in increased budgets. As the numbers of people in town increase, so do the numbers of children in our schools.

The national situation requires recognition in daily plans. Our teachers will be trained to protect the pupils in case of danger. For this reason, teachers are now attending classes in First Aid and are receiving directions as to their procedure in case of attack, either immediate or nearby. This requires added time for such training, but it, we believe, entirely necessary. The cooperation of the parents is asked for any inconvenience which they may experience thereby.

HIGH SCHOOL PRINCIPAL'S REPORT

Dear Mr. Gillmore:

I herewith submit my annual report as Principal of Hampton Academy and High School.

There has been a slight decrease in the enrollment of our school. Last year we opened with 224 pupils while this year we have 217. Many of our problems have come from a gradual increase in the size of the school, which caused us to expand our facilities. This year we have been free from that. Also, the granting of an additional teacher relieved the congestion and we have the best balanced program we have enjoyed for some time. Judging from the size of the classes in the schools that send us pupils, there will be no decided change next year, unless something unforeseen happens. Tuition rates are changing, but as long as ours is about the same as similar schools around us, our enrollment will remain about as it is now.

Since my last report, we have conducted an evaluative study of our school in cooperation with the New England School Development Council and the Cooperative Study of Secondary School Standards. In brief, it consisted of the various phases of our school program using the materials prepared by the Cooperative Study. The teachers met from thirty to fifty times after school to do this work. Then a visiting committee consisting of nine administrators and teachers from the schools around us spent three days in our building checking our work. They made an oral report to our teachers and later a written report with graphic material. I have already submitted them to you for examination. It is gratifying to note that the commendations far exceed the criticisms. It shows our strong points as well as our weaknesses. We are using

the report this year as a means of improving our school. To us it has been an excellent improvement project. I feel that our teachers should be commended for giving so much of their time in order that we might improve our school. It was the general opinion of the visiting committee that we have a good school.

The addition of two hard surface basketball courts on our grounds by the Trustees has been much appreciated by the young people of the town. During the fall they were in constant use until cold weather drove them indoors. The Trustees also increased our dressing rooms on the boys' side. They are much appreciated by those who use them.

This year we required some form of insurance for boys playing football. It has worked out better for us, but caused considerable individual expense. We have learned, however, that there is no such thing as complete coverage.

Last June we graduated a class of forty-nine. Thirteen are attending college, three Preparatory schools, two business schools, one art school, one nursing school, one is taking a post-graduate course, and six are in the Armed Services. Sixteen are employed. Three of the class are married.

Our building is still in excellent condition and we appreciate it. I feel that it would be wise to paint a couple of rooms each year. The visiting committee felt that we should place a partition between the library and the English room. I don't feel that it would be wise until we have a librarian. There is need for improvement in the shower facilities for girls.

Our auditorium-gymnasium presents something of a problem during the winter months. If we arrange it for basketball it takes considerable work to rearrange it for use as an auditorium. Our custodian does the best he can, but he cannot keep up with it at times. I would suggest some help during basketball season.

As you know, we run an active athletic program. Some feel we should do more, others that we over-emphasize it. We have found that we are caught between decreasing income and increasing costs. On our present budget we cannot provide busses to all our games, nor can we provide expensive trips for players. We are seldom able to give transportation to our cheerleaders. Our system of awards is extremely modest. The friends of the school have helped with many of these things, and we appreciate it. At present we receive revenue from three sources, namely, dues in the athletic association, gate receipts, and a subsidy of one thousand dollars from the school board. Most of our men teachers either assist in the coaching or in the management of athletics.

Our music department still finds itself in competition with other activities for the time and interest of our pupils. Since most of our other activities are on a full-time basis, by one or more people, they are at a disadvantage. If we want them to make a good showing, they should have equal support. I would recommend the use of the building for private lessons.

As the schools have developed in the last few years, we use more and more equipment. We have been fortunate in having a Board of Trustees with funds to help us. However, projectors, typewriters, office equipment, etc., are expensive. Our needs seem almost endless. At present we need a strip film projector, a micro-projector, considerable science equipment and files for the office. There is need to increase the appropriations for text books, supplies and maps. I hope clocks can be placed in the rooms which are not provided with them.

Because I have called attention to some things we do not have I don't want to give the impression we are not appreciative of the many things we do have. My purpose is to better serve the youth of our community.

I want to commend our teachers for their whole-hearted cooperation. They often devote their time after school and evenings on extra-curricular activities and projects of student interest.

I have not tried to give a complete report for it would be too long for this purpose. I have called your attention to things which need cooperative effort. I want to thank you for past assistance and earnestly ask for your continued help.

PRINCIPAL'S REPORT

To the Superintendent of Schools:

I herewith submit my Annual Report of the Centre School for 1949-1950.

The Centre School has made excellent progress during the past year and school has been a profitable experience.

Mr. Clayton did not return after spring vacation and we were fortunate in obtaining the services of Mr. Salomon to complete the year. He should be commended for his public spirit in leaving his business to help out the school.

There were several changes when school began in the fall which should be noted. Mr. Green and Miss Cormier were added to the staff, he to teach Junior High School Social Studies and she the other half of grade two. They have both proven to be excellent teachers. Mrs. Simmons was retained this year on a full time basis to work with reading groups of various abilities. She takes them where she finds them, according to ability, and continues from there. This has been a very valuable addition to our staff and one which has been needed. This completes our full staff though a very capable Home Economics teacher in Miss Harwood was added to the staff of both schools. The girls like her and she is doing a fine job. Miss Garland, a practice teacher from Keene, has also helped a great deal. She has been of much assistance in the Junior High School and her work has been appreciated.

The crowded conditions exist as they did last year, but we are very glad to see that perhaps by next year many changes will have been made. Our hopes are that partial war-time restrictions will not hinder the building program to the point where it will be impossible to do the work outlined. Mrs. Simmons has had to teach her classes

in the teachers' room all year and any individual testing has had to be done under the rather poor conditions in the cafeteria. The auditorium and seats available now will not seat much more than one third of the school, which is an administrative problem.

If the building program goes through as planned, there should be two new staff members added to the Centre School next year. We shall have to continue with the practice of splitting the grades which will make the first three grades divided and by all rights, next year's grade four should be divided also. Mrs. Carter is doing an excellent job with the forty-four youngsters she has, but it is too much to expect of any teacher, and cover the required work as it should be covered. Even without splitting grade four unless the building program is completed, there is no room in which to put half of grade three for next year.

It has been necessary that the Junior High boys go to the High School for Manual Training. It has been somewhat of a problem, but the increased value derived from being able to work in a better equipped shop has more than offset the inconvenience. We also must consider that next year with our building program the Home Economics room here will be eliminated and the girls also will have to go to the High School.

Physical Education has run very smoothly this year. Children have worked on skills which increase motor ability and coordination while group social relationships have been stressed. At present, we are inside and using the auditorium almost continually. It is not large enough nor adapted for many things we would like to do, and we are awaiting the time when construction will be completed and we shall have a suitable room to do the things which now have to be curtailed.

Our Guidance Program is progressing satisfactorily. The Cumulative records on each child are up-to-date and

contain much valuable information to aid the school in guiding the pupils. Achievement tests, Mental Ability tests and some Personality Inventories have been given this year, the results tabulated and used. Through our efforts, several children who are inexplicably not doing the work have been referred to the State Mental Hygiene and Child Guidance Clinic but their schedule is so crowded, appointments are very hard to get. This is a valuable service furnished by the state free of charge, and should be used much more than it actually is. It is too bad that so many people attach a stigma to having a child visit a clinic of this type. The fact of the matter is, that these clinics are prepared and adequately staffed to greatly facilitate school adjustment where the program cannot be solved at the school.

It was arranged to have two boys who would have terminated their schooling with completion of the eighth grade here, attend the Dover Trade School this year. There they found courses of interest and value to them. They like it very much and are doing well. When school opened in September, all graduates of the Junior High School last June were in school. School is at its best when the drop-out rate is at a minimum.

During the past year the Centre School has engaged in its normal activities. Mr. Eastman, as he usually does, produced better than average athletic teams and Miss Nelson, with the assistance of Miss Garland, gave the annual eighth grade production which was one of the best. In the spring the whole school participated in a Pageant that was held in the High School. It proved to be very successful. Members of the staff put a great deal of work into it, and though it was interesting throughout, we found that we had tried to do too much in one evening. Another year, we would try to divide such a program into two evenings. The money realized from this Pageant has been used to purchase a portable Estey organ, which may

be carried to each room and used for music there. It has proven to be a great asset to the Music Department. We are now planning something of like nature to be held this spring, but at this writing it is not known just what form it will take.

We are continuing to use the Rinehart Functional Handwriting System with excellent results. Improvement in handwriting is practically universal and we have received many favorable comments upon the quality of the handwriting. This seems to be a valuable addition to the school curriculum.

This past year has been a profitable one and as indicated by present plans, our expanding school plant will become an even more valuable place in which to educate our children. The town's people deserve much credit for their cooperation and insight into the total educational picture.

We thank everyone for their work and cooperation which has made the year educationally successful.

REPORT OF THE DIRECTOR OF PHYSICAL EDUCATION

Dear Mr. Gillmore:

Following is the annual report of Physical Education and Athletics:

Probably no other thing counts as much to a child's feeling of adequacy as to be able to play games well with his group. Usually the child who lacks skills will avoid vigorous activities. The program of Physical Education attempts to draw these pupils out of their reserve, and through active participation during school years, give them adequate skills. Also, in an attempt to eliminate the fear of many for vigorous activity and to teach body control, stunts and tumbling have been introduced into grades 1 and 2.

In the Junior High School, the program has consisted of teaching skills in all team sports that are practicable with the facilities available. A beginning was made in intramural touch football, but the conflict with varsity football proved too much. During the winter season, the activities include modified games, combatives, wrestling, and tumbling. Several tests have been given which measure strength and agility.

For the second year, pupils from grades 4 through 8 participated in a Track and Field Meet with schools in the vicinity at Greenland.

The program at the High School has been more fully rounded out by the construction of a hard surface area by the Trustees. We appreciate the addition very much. The area has had almost constant usage since its completion. A grassed area is still a necessity to carry on the majority of team sports.

Another project completed by the Board of Trustees was the extension of locker room and storage facilities.

In addition to tumbling mats received from war surplus, we have weights and stall bars. I recommend the installation of the weights in the new locker room and the consideration of placing the stall bars in the planned activity room at the Center School.

The activities of the program were again presented on Parent-Teacher night by boys and girls from both schools.

ATHLETICS

Our athletic program continues on a wholesome scale with nearly 50 percent of the boys enrolled participating in one or more interscholastic sport. The equipment and facilities are good.

Looking back to spring sports, the baseball team was undefeated during regular season play and participated in the state play-offs. The track team was runner-up in the the state meet, falling short of the championship by two points.

Hampton again participated in the winter meet and placed second. Two boys participated in the New England Meet and placed.

The football team, following victories in the first three games, lost their remaining games due to many injuries.

In basketball, the team at this date has won 6 and lost 4.

GIRL'S PHYSICAL EDUCATION

Dear Mr. Gillmore:

The activities presented this year in girls' physical education at the High School have been essentially the same as last year — ballroom dancing, touch football, badminton, paddle tennis, basketball, volleyball, stunts and tumbling, and softball. A modern dance club has been started which meets once a week and a basketball class, open to sixth through twelfth grades, that meets every Saturday.

The hockey team played eight games, winning two and tying two. The basketball team has a thirteen game schedule and as of January 17, has won four and lost three.

Two special events have occurred, one a master class in modern dance at the University to which I took twelve girls, and the other a playday at the Alvirne High School in Hudson, N. H., to which I took ten girls.

At the Junior High School, the schedule was arranged last fall so that the girls had double periods once a week. However, when we had to plan to stay inside, the inadequacy of the auditorium forced me to split the groups into two sections so that each girl now only gets one period a week. For activities, we have ball games, field hockey, touch football, relays, deck tennis, stunts and tumbling, ballroom dancing, softball and track and field events.

We had field hockey classes after school during the fall season. The cheerleading squad started again in November and is composed of seven eighth graders and two seventh graders, plus a manager from the eighth grade. The High School cheerleaders gave us their old white and blue uniforms and two of their old megaphones. The

girls look quite nice and do a very good job, but I hope that next year something can be done to dress them in their own school colors, navy blue and gold.

MUSIC TEACHER'S REPORT

Dear Mr. Gillmore:

I submit the following report of the music activities in the schools of Hampton, during the year 1949-1950.

Our music activities in the elementary grades include singing, playing, listening and dancing. A public performance including all these phases of music was presented in the High School auditorium the last of May, in which each child in the first six grades had a part, and also many of the pupils in the Junior High School. Two pageants were presented: "In the Garden of Singing Flowers" by grades one through three, and "America the Beautiful" by grades four through eight. This was a school activity, and all the teachers worked very hard to make these productions a success.

Last year, in grade five, a group of twelve boys made several public appearance as a chorus, winning recognition in the Scout Talent Show. This group has done, and is doing, exceptionally good work, and is now organized as the Junior Boys' Acappella Choir. They have appeared once on radio.

Physical activities relating to the music program in the grades have necessarily been curtailed because of lack of space.

During the last school year, at the High School, the Gilbert and Sullivan complete edition of the Operetta H. M. S. Pinafore was presented by the High School Mixed Chorus. Although an ambitious undertaking, it was successful, all the High School teachers assisting in its production.

During last spring, we attended and participated in two Concert Festivals. Six pupils were accepted to attend the

West Springfield All-New England Concert Festival, and two were accepted to attend the All-State Concert Festival at Manchester.

A small Ensemble of girls has been formed at the High School; also an ensemble of Mixed voices, and a Freshman Girls' Chorus. In spite of little time for practice these groups do well. Boys' and Girls' Glee clubs and large Mixed Chorus are continued.

Our groups have performed as usual for our local organizations.

I wish to thank all of the teachers for their support and cooperation. I am also very grateful to you, Mr. Gillmore, and our Board of Education, for the excellent material with which to carry on the work in Music.
