# WARRANT FOR ANNUAL MEETING THE STATE OF NEW HAMPSHIRE

#### To the Inhabitants of the Town of Mont Vernon in the County of Hillsborough in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Mont Vernon on Tuesday, the eighth day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the ensuing year.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.

3. To see if the Town will vote to allow a discount on property taxes of three percent if paid in full before July first and two percent if paid in full before August first.

4. To see if the Town will authorize the Selectmen to borrow money in anticipation of taxes.

5. To see if the Town will authorize the Selectmen to administer or dispose of any real estate acquired through Tax Collector's deeds.

6. To see if the Town will vote to accept Town Road Aid for construction of Class 5 roads, and raise and appropriate for said purpose the sum of \$515.32. (State will add \$2061.29.)

7. To see if the Town will vote to discontinue a section of highway which has been commonly known as the Old Milford Road from the top of Mont Vernon Hill on Route 13 to where it meets the highway leading from Route 13 to Wilton, said road lying between the properties of George D. Kittredge and Herman Hacker, agreeably to Chapter 90, page 9, section 1 of the Revised Laws of New Hampshire as inserted by Chapter 188 of the Laws of New Hampshire 1945.

8. To see if the Town will vote to raise and appropriate the sum of Ninety Dollars (\$90.00) for the purchase of a piano from the Independent Dance Committee.

9. To see if the Town will vote to withdraw from its Capital Reserve Fund the sum of One Thousand Dollars (\$1000.00) and accrued interest, which sum has already been designated for Town Hall Maintenance and Improvement, said sum to be expended at the direction of the Selectmen for the following purposes: (a) To paint the exterior of the Town Hall; (b) To make such repairs as are necessary to have the building conform to the safety and fire laws of New Hampshire; (c)To make such other minor repairs as may be deemed necessary.

10. To see if the Town will, in accordance with Chapter 188, Public Acts and Joint Resolutions of the Legislature of 1945 and Special Sessions of 1944, part 3, request the Highway Commissioner to grant T. R. A. for the repair and tarring of Kendall Hill Road. Also to see if the Town will vote to approve the sum of Two Thousand Dollars (\$2000.00) in addition for the same purpose. (By petition.)

11. To transact any other business that may legally come before said meeting.

#### **REPORT OF THE FOREST FIRE WARDEN**

Your local organization to prevent and extinguish brush and woods fires is glad to report a good year of forest protection in 1948. In spite of danger conditions nearly equalling at times those of 1947 when great losses were suffered in New Hampshire and New England, fire damage and loss this year have been gratifyingly low.

With the continuing cooperation of all the people, we can hope to have another successful year in 1949. Let us remember that in any year, over 90% of all fires are caused by carelessness and that all of these man-caused fires are preventable.

Today, we have more slash and uncut grassland than for many years in the past. Smokers, campers and tourists who use our outdoors are also more numerous than ever before. We must therefore be ready for fires which might occur but, above all, prevention by everyone is the greatest need.

A few simple precautions taken by every citizen will help, as follows:

- (1) Always get a written permit from the warden before kindling a fire outdoors when the ground is not covered with snow.
- (2) If you smoke, always extinguish matches and tobacco before dropping or throwing them down. In automobiles, always use the ash trays.
- (3) Report fires and smokes to the warden without delay.

The observance of these and other simple rules will go far to insure safety from fire damage and your cooperation in this way is earnestly solicited.

#### **REPORT OF SUPERINTENDENT OF SCHOOLS**

To the School Board and Citizens of Mont Vernon:

I herewith present my tenth annual report, the thirtieth in the series. It not only consists of the statements immediately following, but many of the others, statistical and financial, which are combined in this School Report. I commend them to you as worthy of your careful reading and study.

#### 1. School Calendar

I desire to call attention to the school calendar printed elsewhere. Under a ruling of the State Board of Education, schools must be in session a full thirty-six weeks or 180 school days. Institute Days and Teachers' Convention are counted toward the 180 and up to five more days may be counted for approved workshop for teachers. All other days lost must be made up. Without workshop time counted, the normal school year must be 177 days of teaching.

During the course of a year, I hear many remarks about the early opening in September, too short a vacation at Christmas, the late closing in June, going to school on this rainy day and no holiday for Columbus Day. I am certain that many of these questions would be answered if you took a calendar and, starting with Labor Day, marked off the school days possible to June 15th. This, considering the first paragraph above, allows but few days before the end of June to make up days lost.

#### 2. Teachers

From the list of teachers printed elsewhere, you will note that Mrs. O'Neil continues in grades 4-6 and Miss Jenkins retired with Mrs. Elizabeth Scully of Milford succeeding in grades 1-3. Mrs. Scully is a teacher of many years experience in Milford and Brookline. The teaching staff changes; the need for teachers remains acute.

B. Need I call your attention to the shortage of teachers, especially in the Elementary field? The situation grows worse with each added year and now is so acute that only about one-tenth of qualified candidates are available for grade-school positions. The remaining nine-tenths must come from the ranks of the lesser qualified, from former teachers returning to help during the emergency, from re-training high school teachers, from closing and consolidations of schools and even from willing volunteer workers with little or no training beyond high school. This school department needs to know prospective candidates now, if all services are to be continued next year. You are asking for more and better schools. We would like to give them to you but the personnel is not now available. Will you help?

For long-term planning, there should be one candidate going to a teacher training institution for every 120 pupils in your school system. These should be in the ratio of three candidates for elementary work to every one for secondary work.

C. Closely akin to the above is the subject of salaries. Some of our citizens point to the increase in salaries over the past few years as equal to and greater than the cost of living increase. Others say teachers are not paid enough and their working conditions are poor, that they receive poor salaries and suffer unjust demands on the part of the public, that they have to be different from workers in other employment and have to have more training. To me, both groups are honest in their thinking and are correct in part; However, that doesn't produce teachers when we need them. What should we pay? What can we afford?

The teaching profession has said that the minimum salary for a fully qualified teacher should be at least \$2,400 per year. The maximum should be approximately twice that sum. Not a budget in this Union meets this minimum or the maximum.

#### 3. Improvements

The greatest improvement has been effected by the opening of the upstairs room. You will recall that, under the law, it could not be used until a second means of exit had been built. This was accomplished by opening the wall for a rear door at the rear and a stairway built down to the ground. Special exit lights were installed and the heating arrangements adjusted. So, now the hall can be used, and is used, for all kinds of school and community activities. The latest improvement has been the purchase and installation in a cabinet, of an electrical record player.

So now, we feel that the Mont Vernon School is one of the best equipped elementary schools in this vicinity. I am very grateful to all those who have contributed to this accomplishment; the school district, the McCollum Trustees, and other donors and workers.

There remain, in my opinion, major items to be accomplished in the next few years: Redecorating the second floor, shingling the south side of the roof, repainting the outside of the building, finishing the floors, and improving the playground space.

#### 4. Appreciations

I am very grateful to the serious and honest thought the School Board has given to school problems. They have spent much extra time this year — what with added problems of extra enrollment, teacher shortage, new building plans, and the consolidated school district study.

I am very appreciative of the efforts of every teacher to improve the work of his pupils. The cooperation this year has been splendid, morale - good.

I would not forget the parents and pupils. This has been a busy and profitable year. Your interest has been keen and helpful. To the new Parent-Teacher Association, I express my sincere hope for a successful career. This organization can and, I hope, will prove a most valuable adjunct to the school.
