THE STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Piermont, in the County of Grafton, in said State, qualified to vote in Town affairs:

You are hereby notified to meet at the Town Hall in said Piermont on Tuesday, the 8th day of March next, at nine o'clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriations of the same.

3. To raise and appropriate money to maintain Highways and Bridges.

4. To raise and appropriate money to maintain street lights.

5. To raise and appropriate money for snow removal.

6. To raise and appropriate money for poor relief.

7. To raise and appropriate money for support of Library.

8. To raise and appropriate money for Memorial Day.

9. To raise and appropriate money for Town maintenance of highways, with State Aid, or State Aid new construction on Lake Tarleton road.

10. To raise and appropriate money for Pine Blister Rust control with State Aid.

11. To see if the Town will authorize the Selectmen to distribute the inventory blanks at the time they examine the taxable property.

12. To see if the Town will authorize the Selectmen to administer or dispose of any real estate acquired by the Town through Tax Collector's deeds.

13. To see if the Town will authorize the Selectmen to borrow money in anticipation of taxes.

14. To see if the Town will vote to raise and appropriate a sum not to exceed \$66.00 for co-operative advertising in the White Mountain Region Association.

15. To see if the Town will vote to accept the bequest to the Town contained in the will of Herbert A. Clark; to instruct the Selectmen or the Trustees of Trust Funds, or both, to receipt for the same to the Administrator of said Herbert A. Clark's estate.

16. To determine if the trust fund received from the Herbert A. Clark estate shall be controlled by a joint board composed of the Selectmen and the Trustees of Trust Funds, and if such funds shall be withdrawn only by such joint board, and to pass any other vote relating thereto.

17. To determine the amount of the bond which shall be furnished by the Trustees of the Trust Funds.

18. To raise and appropriate money for the support of the Fire Department.

19. To transact any other business that may legally come before said meeting.

Because of a convenient transportation arrangement it has been possible, this year, to have all the eighth grade pupils come to the village school. This has relieved a somewhat congested condition in the Brook Road School and has caused no overcrowding in the village. There also seem to be advantages for the pupils in being together in one group during their last year.

At the present time there are ten pupils living in East Piermont and attending school at Atwell Hill. While this number might be large enough to make a school, it would cost more to fit up a building and employ a teacher than it does to pay the tuition and transportation. More state aid has been approved for this year by the State Board to help offset this added expense.

The buildings are in good condition and will probably require only such repairs as are called for by ordinary usage and weathering.

The loyal support of the schools by the parents and other residents of the district has been appreciated by the Board and Superintendent. Any suggestions for the good of the schools and the welfare of the children will be welcomed and given careful consideration.
