TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Sharon in the County of Hillsborough, in said State:

You are hereby notified to meet at the Brick School House in said Sharon on Tuesday, the tenth day of March next, at ten of the clock in the forenoon, to act upon the following subjects:

Art. 1. To choose all necessary Town Officers for the year ensuing.

Art. 2. To raise such sums of money as may be necessary to defray Town Charges for the ensuing year and make appropriation of the same.

Art. 3. To hear the reports of Agents, Auditors, Committees, or officers heretofore chosen and pass any vote relative thereto.

Art. 4. To see what sum of money the Town will vote to raise and appropriate for the care of cemeteries for the ensuing year, or take any action relative thereto.

Art. 5. To see if the Town desires to vote to raise and appropriate a sum of money for Forest Fire purposes, or take any action relative thereto.

Art. 6. To see if the Town will vote to adopt the provisions of the Municipal Budget Act, or take any action relative thereto.

Art. 7. To see if the Town will vote to instruct the Selectmen to borrow a sum of money not exceeding Two Thousand Dollars (\$2,000.00) or take any action relative thereto.

Art. 8. To see if the Town will vote to petition the state tax commission to have an audit made by the division of municipal accounting and to make an appropriation to cover the expense of such audit.

Art. 9. To see if the Town will vote to establish the amount which shall be paid the Town officers for their services, or take any action relative thereto.

Art. 10. To see if the Town desires to raise and appropriate a sum of money for the celebration of Old Home Day, or take any action relative thereto.

Art. 11. To see what sum of money the Town will vote to raise and appropriate to provide for additional fire protection due to the war emergency.

Art. 12. To see what sum of money the Town will vote to raise and appropriate to provide watchmen and additional police protection due to the war emergency.

Art. 13. To see what sum of money the Town will vote to raise and appropriate for the use of the town health officer and board of health due to the war emergency.

Art. 14. To see if the Town desires to raise and appropriate the sum of \$204.00 to be spent on the Turnpike and the State will contribute \$2,500.00, or take any action relative thereto.

Art. 15. To see if the Town desires to raise and appropriate a tax of fifty cents on each one hundred dollars of assessed valuation of the preceding year, and the Commissioner will allot to the Town a sum sufficient to equal ninety dollars for each mile of Class V Highway in the town, or take any action relative thereto.

Art. 16. To see what sum of money the Town will raise and appropriate for the purpose of plowing and removing the snow, and sanding the highways in winter, or take any other action relative thereto.

Art. 17. To see what sum the Town will vote to raise and appropriate to the Monadnock Region Association of Southern New Hampshire for the issuance and distribution of printed matter, newspaper and magazine advertising, calling attention to the resources and natural advantages of the Town, in co-operation with the other thirty-seven towns in the Monadnock Region.

Art. 18. To transact any other business which may legally come before said meeting.

Given under our hands and seal this twenty-first day of February in the year of our Lord nineteen hundred and forty-two.
