7. To see what sum of money the town will vote to raise and appropriate for the Police Department.

8. To see what sum of money the town will vote to raise and appropriate for the Fire Department.
9. To see what sum of money the town will vote to raise and appropriate for the Health Department.
10. To see what sum of money the town will vote to raise and appropriate for Vital Statistics.
11. To see what sum of money the town will vote to raise and appropriate for Town Maintenance—Summer.
12. To see what sum of money the town will vote to raise and appropriate for Winter Maintenance.
13. To see what sum of money the town will vote to raise and appropriate for Town Road Aid, necessary to obtain State Aid.
14. To see what sum of money the town will vote to raise and appropriate for Libraries.
15. To see what sum of money the town will vote to raise and appropriate for Town Poor.
16. To see what sum of money the town will vote to raise and appropriate for Old Age Assistance.
17. To see what sum of money the town will vote to raise and appropriate for Memorial Day.

20. To see what sum of money the town will vote to raise and appropriate for the Old Meeting House Assn.

23. To see how much of the Parsonage Funds the town will vote to spend for preaching for the ensuing year.

24. To see if the town will vote to authorize the Selectmen to hire money for the use of the Town in anticipation of taxes.

25. To see if the town will vote to authorize the Selectmen to sell Tax Title Property.

26. To see what sum of money the town will vote to raise and appropriate for having had State Tax Commission assessed property in the town of Danville.

27. To see what sum of money the town will vote to raise and appropriate for defrayin expenses involved, for a committee of three to work with the Selectmen in regards to locating an industry in the town.

28. To transact any other business that may legally come before the meeting.

TOWN MEETING — March 13, 1956

The meeting was called to order by the Moderator at 2 P. M. for the purpose of acting upon the, Articles in the Town Warrant and Direct Primary, including Delegates at Large, Alternate Delegates at Large, District Delegates, Alternate District Delegates, also Delegate to the Constitutional Convention and preference for President and Vice President.

The warrant was read by the Moderator who then declared the polls open for the election of officers for the ensuing year.

BUSINESS MEETING

The Business Meeting was called to order at 8:15, Prayer by the Rev. Karl J. Hislop.

The Warrant was read by the Moderator.

It was voted to take up the Report of the Budget Committee Article by Article.

Article 2. Voted to pass over Article 2 and take up the other Articles.

Article 3. Voted to raise and appropriate \$1,600.00 for Town Officers Salaries.

Article 4. Voted to raise and appropriate \$900.00 for Town Officers' Expenses.

Article 5. Voted to raise and appropriate \$350.00 for Election and Registration Expenses.

Article 6. Voted to raise and appropriate \$1,500.00 for Town Hall and other Town Buildings.

Article 7. Voted to raise and appropriate \$250.00 for the Police Department,

Article 8. Voted to raise and appropriate \$800.00 for the Fire Department.

Article 9. Voted to raise and appropriate \$25.00 for the Health Department.

Article 10. Voted to raise and appropriate \$20.00 for Vital Statistics.

Article 11. Voted to raise and appropriate \$2,000.00 for Town Highway Maintenance Summer.

Article 12. Voted to raise and appropriate \$1,115.73 for Town Maintenance Winter.

Article 13. Voted to raise and appropriate \$190.27 for Town Road Aid.

Article 14. Voted to raise and appropriate \$300.00 for Libraries.

Article 15. Voted to raise and appropriate \$2,200.00 for Town Poor.

Article 16. Voted to raise and appropriate \$1,700.00 for Old Age Assistance.

Article 17. Voted to raise and appropriate \$60.00 for Memorial Day.

Article 18. Voted to raise and appropriate \$100.00 for Soldiers and their families.

Article 19. Voted to raise and appropriate \$300.00 for Cemeteries.

Article 20 Voted to raise the amount recommended by the Budget for County Tax Est. \$2300

Article 21. Voted to pass over the Article on Schools.

Article 22. Voted to expend the Income and Interest of the Parsonage Fund for preaching.

Article 23. Voted to authorize the Selectmen to hire money for the use of the Town in anticipation of Taxes.

Article 24. Voted to authorize the Selectmen to sell Tax Title Property.

Article 25. Voted to authorize the Selectmen to hire custodians of Town Buildings and fix salaries of the same.

Article 26. Voted to have the Tax Commission asses property in the Town of Danville.

Article 27. Voted that the Selectmen be authorize to look into the matter of Tax valuation. The Committee appointed in 1955 to interview the Underwriters on Insurance gave a report. There was a discussion on the Play ground but no action.

It was announced by George W. Shattuck that on May 2, there would be a banquet in honor of Agnes H. Collins who is retiring after 31 years service as Town Clerk, with the Governor, Lane Dwinell present.

Voted to adjourn the business meeting at 9:15 P. M.

SCHOOL WARRANT

THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the School District in the Town of Danville, New Hampshire, qualified to vote in district affairs:

You are hereby notified to meet at the Town Hall in said district, on the seventh day of March, 1957, at eight o'clock in the evening to act upon the following subjects:

1. To choose a Moderator for the coming year.
2. To choose a Clerk for the coming year.
3. To choose a Member of the School Board for the ensuing three years.
4. To choose a Treasurer for the ensuing year.
5. To determine and appoint the salaries of the School Board and Truant Officer, and fix the compensation of any other officer or agents of the district.
6. To hear the reports of Agents, Auditors, Committees, or Officers chosen and pass any vote relating thereto.
7. To choose Agents, Auditors, and Committees in relation to any subject embraced in this warrant.
8. To see what sum of money the district will raise and appropriate for the support of schools, for the salaries of school district officials and agents, and for the payment of statutory obligations of the district, and to authorize the application against said appropriation of such sums as are estimated to be received from the state foundation aid fund together with other income; the school board to certify to the selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the town.

9. To see if the Danville school district will vote to petition the State Board of Education to become a part of a cooperative school district for the education of the secondary school children (grades seven through twelve) with other districts in the area, including the districts of Newton, Plaistow, Kingston, Brentwood, or any two of the districts in addition to the school district of Danville.

10. If the preceding article is adopted, to see if the district will elect two representatives to serve on an intrim committee who shall prepare a financial budget for the operation of the proposed cooperative school district, and to include in the organization warrant an article calling for an appropriation for the proposed cooperative school district during the first year and such other items of business as need to be acted upon at the organization meeting.

11. To transact any other business which may legally come before this meeting.

REPORT OF MUSIC SUPERVISOR

I have the honor to submit a report on the music activities in the town of Danville.

In Danville the music work is now being carried on by Mr. Donald Russell. He visits the school weekly and prepares a music lesson for each of the teachers.

Among the activities planned for the various towns in the Union are the following:

1. A new vocal curriculum guide is now being prepared. A copy of this guide will be placed in the hands of each teacher. It will be in loose-leaf form so that additional materials may be added from time to time. It is expected that this guide will be of great value to the teachers, not only in the preparation of their work, but in the continuing growth and development of the music program in the various towns of the Union.

- . A series of special music festivals are now being planned for each of the towns in the Union. These festivals will form a climax for the years work. Included on the program will be vocal selections by all of the pupils in each school. As a special feature the bands of the various towns in the Union will be combined and will appear at each of the local festivals. This will make it possible for the schools which do not have an instrumental music program at the present time to observe what has been done during the first year of the instrumental program. It is expected in this way that additional interest in instrumental music may be developed.

At this time I would like to express my personal appreciation to the superintendent of schools, the members of the various school committees, the principals and teachers for their unqualified support of our music program. I feel that we are moving forward in the direction of developing a very well rounded and outstanding music program for the boys and girls in the various schools of Supervisory Union No. 14.

REPORT OF THE PUBLIC HEALTH NURSE

The State Health Department through the public health nurse in cooperation with the local School Dept. and volunteer workers sponsored two Polio Clinics, 96 attended the first clinic to receive their first injection against polio, 77 attended the second one, 13 received first shots, 64 second shots.

During the past year I visited your town several times, calling on new babies and doing whatever follow up work necessary. Physical defects found were either referred to private physicians or to facilities existing in our state for correction.

NURSE'S REPORT

To the Superintendent, School Board members
and Citizens of Danville:

The school health program of 1956-57 was off to a busy start with the replenishing of first aid kits, checking of vaccinations of first graders, acquiring of health histories, and a general appraisal of each child. This latter in no way supplants your doctor's regular checkup, as any number of serious conditions may go undetected by the nurse.

Heights and weights were obtained and compared with last year's.

The Snellen eye test, which is required annually by state law, has been done, and defects reported to the parents. Where necessary, follow-up home visits will be made.

The hearing testing program is now under way. Because of the large enrollment in the Union, and because of the lack of a quiet place in which to test ears, I feel it will be better to confine the testing to children of certain grades, namely the 1st, 4th, 7th, and 8th. Children who have a known hearing loss, new children, and any whose teacher suspects a hearing loss, will be done regardless of grade.

Polio clinics were held in May and October. Preparation for these clinics is time-consuming and hard work, but well worth it when one sees the number of people who are eager to avail themselves of the opportunity to be immunized. Third shots will be given in the Spring, provided vaccine is available.

Congratulations are in order to those who have worked so hard to get the lunch room in operation. You are most fortunate to have Mrs. Hewitt, and much credit is due the volunteers who come in daily to help.

Teachers, parents, and co-workers have been most helpful in making the health program a success.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the School Board and Citizens of the Town of Danville:

We have heard a great deal about reading in our schools. I believe that you parents will welcome the opportunity to come behind the scenes with me in order to gain an insight into what our reading program is endeavoring to do for our children.

A child's success in school, as well as the pattern of his personal and social adjustments later on in life, will be greatly affected by the success with which he makes adjustments in reading during the early years of his life.

When children enter school they differ in many ways that can be measured. They differ in height, weight, strength of grip, emotional control and ways of working and playing with other children.

They differ in their preception skills, their ability to follow direction, their language powers, their home backgrounds and their readiness to read.

When they face their first teacher in school they differ in their capacities, achievements, attitudes, abilities and interests. The teacher is confronted with the problem of adopting materials and methods to the needs of each child.

The problems of providing for the range of abilities tend to multiply as the children grow older. In a typical upper grade classroom, children may vary five or more years in reading ability. The range tends to increase as the number of school years increases.

The teacher must have ways of determining how efficiently each child reads so that appropriate reading material may be selected. It should be realized that all pupils cannot be brought up to a single standard of reading achievement in any grade. Various materials are used by the skilled teacher in dealing with reading needs

of children. Grouping of children in certain classes according to their achievement level as well as into groups within classes helps reduce the range of reading in each group. Such groupings need to be flexible to allow for differences in the rate of growth of children.

Elementary teachers face the necessity of providing quiet activities for the children not in the particular group engaged in intensive reading. These activities may be related directly to reading, such as reading a library book silently or drawing pictures to illustrate some part of a story which has been read.

Reading materials of various levels of difficulty are needed to meet the abilities found in each group. Free reading periods may be used to stimulate interest in reading.

Teachers at all levels are alert to teach the reading skills needed in their subjects. The reading skills needed in mathematics class are different from those required in reading a current magazine.

The teacher who is responsible for a particular subject is in the best position to provide help in overcoming difficulties for many pupils because through practice and training he is able to identify the need at an early stage and to provide some special help.

This teacher understands the kinds of reading skills needed to do effective work in his subject and helps pupils develop the particular one which will be of greatest value at the time of need.

Instead of further reading practices of the kind of which the pupil has been failing she offers specific help, directed toward a particular need. New reading material is used and the teacher uses additional tests to help in planning the individual's program.

In order to plan the pupils program, a diagnostic and

remedial program based upon the work of the regular classroom teacher is a fundamental part of an effective reading plan which provides for the individual differences in the reading abilities of the children.

Looking Toward the Future

Never in the history of education has the shortage of schoolhousing been so acute, serious and confusing. This year marks the greatest number of registered children in our schools. In the near future, a serious shortage of classroom facilities will be in the upper four or six grades. Making the situation more difficult is the rising cost of bond interest due to federal policies, the continuing shortage of building materials, and the increasing rise in labor costs.

Because of the present and future housing difficulties in our schools, I urge the serious need of studying building plans with other educational groups in our area thinking in terms of educational efficiency and ultimate economy. Only through determined study with representative groups of our neighboring communities, can a solution be reached.

I wish to thank the school board, parents, friends, teachers and pupils for having made the year one of success.
