




COMMISSIONER'S REPORT

To the Citizens of Grafton County:

Your Commissioners herewith present their report, together with the reports of the Sheriff, Solicitor, Clerk of the Court, Jailer and Auditors, and the Superintendent, Physician and Chaplain of the County Farm, for the year ending December 31, 1927, and a statement of the financial standing of the County at the close of the year.

Appropriations are made for a period of two years and are largely based on what expenses have been dering the two years preceeding. We are herewith submitting a statement of appropriations covering the years 1927 and 1928 and payments covering the year 1927.

The buildings in which are housed the inmates are built of wood with the exception of the jail which is built of brick, these wooden buildings are very old and expensive to maintain and are a dangerous fire hazard and should be replaced with fire proof buildings which will do away with the fire hazard and reduce the cost of maintenance

The Commissioners wish to extend their thanks to Mr. and Mrs. Alvah H. Parker who on Apirl 1st resigned as Superintendent and Matron, for the faithful and efficient manner in which they performed their duties as Superintendent and Matron of the County

SELECTMEN OF TOWN AND OVERSEERS OF

THE POOR

Your attention is called to the following extracts from the laws of 1903:

CHAPTER 42, SECTION 1

SECTION 1. Any town or county furnishing any assistance to any person within six years preceding his death shall be entitled to recover from the estate of such persons the sum or sums paid out for such assistance the said claim to be a preferred claim against his said estate after payment of funeral charges, expense of last sickness and expenses of administration, provided he leaves no widow or minor children living at his decease.

CHAPTER 106, SECTION 1, as amended

"SECTION 1. No town shall be liable for the support of any person unless he, or the person under whom he derives his settlement therein during the ten years preceding the last date of application for support provided that no person having a settlement in any town in this state upon arriving at the age of seventy years shall lose that settlement on account of being exempt by law from paying a pole tax, if he resides in said town."

ASSISTANCE TO PERSONS IN QUARANTINE: PUBLIC STATUTES, CHAPTER 110, Following SECTION 6

SECTION 1. Whenever any person or family is placed in quarantine by a board of health, to protect the public against small pox, scarlet fever, diptheria or any other dangerous, infectious or contagious disease, it shall be the duty of said board to assist such person or family while in quarantine in such manner as in the judgment of the board may be deemed wise and necessary.

SECTION 2. All expenses thus incurred, or such part thereof as the board may determine, shall be deemed a legitimate expenditure for the protection of the public health and shall be charged to the account of incidental expenses, but not to any indigent pauper account, nor shall such expenditure be construed to mean a public aid to the person or persons so quarantined and assisted unless such person or persons are aheady paupers as defined by the Public Statutes.

The whole number of persons supported and partially supported for the year ending December 31, 1927 was 148. The number of weeks board is ascertained by taking the number of days between the day of admittance and the day of departure of each individual and dividing that number by seven which gives the total number of weeks each was supported.

The whole cost of supporting paupers at the Farm for the year ending December 31, 1927 was \$29,695.48 This sum divided by the whole number of weeks furnished vis. 3899 weeks, 5 days gives \$7.61 plus as the price per week.

In concluding my report I wish to thank the Commissioners, Chaplain, Physician, and former Superintendent and Matron Mr. and Mrs. Parker for their assistance and courtesy through the year. Thanks are also due other friends, who with musical programs, flowers and in many other ways have contributed to the happiness of the inmates.

REPORT OF COUNTY PHYSICIAN

To the Honorab'e Commissioners of Grafton County: Gentlemen:—

Many of the patients admitted to the hospital have keen far advanced in chronic disease and most of these with acute illness were also struggling with the infirmities of old age. With its modern equipment the hospital now serves both surgical and medical cases as well as can be found in any other like institution.

There are twenty beds in the hospital proper and they are comfortable ones. The rooms are well lighted and ventilated and always scrupulously clean. The operating room is modern and well equipped for any kind of surgery, even the most difficult.

It has been the policy of the Commissioners to a'low any surgeon in the County, who brings in a surgical patient, to himself do the operation. This wise provision on the part of the Commissioners has brought about a feeling of fellowship and support from the doctors of the County as well as satisfaction to the patients themselves, for it is easy to understand how any patient will enter the hospital with his own surgeon and with a confidence that could not otherwise be o'_tained.

Whereas said Foster, in the performance of his duty received a shot through his body which greatly endangered his life and seriously injured his health, and Whereas your committee believes that said Foster is entitled to substantial recognition by the citizens and taxpayers of said county, now therefore be it

Resolved that in consideration for his distinguished service and bravery your committee reommends that said Delegation appropriate for the use and benefit of said Foster the sum of three thousand dollars (\$3 000.00) to be raised by said county during the present fiscal year and paid by the Treasurer to the Lisbon Savings Bank and Trust Company to be held in trust by said bank for the purpose here in defined and to be distributed by said bank for the sole benefit of said beneficiary in the following manner:

First, the interest to be paid to said beneficiary semi-annually.

Second, such sums from the principal as in the judgment of the Treasurer of said bank may be needed from time to time by the beneficiary to secure to him, in his declining years, the comforts and support that his faithful service for the County and his remarkable fidelity to duty so justly entitle him, and be it further

Two years ago the Grafton County Delegation voted \$8,000 for each of the years 1925 and 1926 to carry on co-operative extension work in Grafton County in agriculture, home-making and boys' and girls' club work. Afterward House Bill 60 was passed which made available \$1,800 from sources outside the county. The County Extension Executive Committee then brought the matter before the County Delegation, explained the situation and requested that our county appropriation be reduced by this amount-\$1,800-or from \$8,000 to \$6,200. The reduction was made and the county appropriation for each of the years 1925 and 1926, was \$6,200.

Grafton County is the largest agricultural county in the state.

It is the largest in area, with the exception of Coos County.

The size of the county and the size and importance of the agricultural industry makes for a greater expense to the county and of energy by the agents in carrying on extension work.

These facts we believe should be brought to your attention in connection with the work in our county.

For instance, Grafton County boasts of 17,100 cows. It's nearest competitor is Coos County with 12,100 cows. The production per cow has increased
