## State of New Hampshire

### TOWN WARRANT

To the Inhabitants of the Town of Hillsborough, County of Hillsborough in said State, qualified to vote in town affairs:

You are hereby notified to meet in Hillsboro-Deering High School Auditorium in said Town on Tuesday, the 8th day of March, next, at ten o'clock in the forenoon. Election of officers will take place between ten o'clock in the forenoon and six o'clock in the afternoon. Articles 2 through 29 will be taken up at 7:30 p.m.

Article 1. To choose one Selectman for three years; Town Treasurer, Tax Collector, Highway Agent, Town Clerk for one year; Trustee of the Fuller Public Library for three years; Trustee of Trust Funds for three years; Trustee of Trust Funds for one year; and all other necessary Town officers or agents for the ensuing year.

Article 2. To hear the reports of the town officers to the Auditors, the reports of the Auditors, Agents, Committees or other town officers heretofore chosen or appointed and to pass any vote relating thereto.

Article 3. To raise such sums of money as may be necessary for Town Officers' salaries, Town Officers' expenses, Town Building, appropriations for Street Lights, and all current expenses of the town. — Sponsored by the Selectmen.

Article 4. To see if the Town will vote to raise and appropriate the sum of Thirty-seven Thousand, Eight Hundred Eighty-four Dollars and Twenty-six Cents (\$37,884.26) for the building and repairing of highways, bridges, culverts and sidewalks. — Sponsored by the Selectmen and Highway Agent.

Article 5. To see if the Town will vote to raise and appropriate the sum of Two Thousand Dollars (\$2,000.00) to be applied to the Capital Reserve Fund for the future purchase of Highway Equipment. — Sponsored by the Selectmen and the Highway Agent.

Article 6. To see if the Town will vote to raise and appropriate the sum of Two Thousand, Eight Hundred Dollars (\$2,800.00) to be applied upon the account of the Hillsboro District Nursing Association. — Sponsored by the District



Nursing Association.

Article 7. To see if the Town will vote to instruct and empower the Selectmen to borrow such sums of money as may be necessary to meet current expenses of the Town and in anticipation of taxes. — Sponsored by the Selectmen.

Article 8. To see if the Town will vote to raise and appropriate the sum of Eight Hundred Dollars (\$800.00) for the support of Band Concerts for the coming season. — Sponsored by the Selectmen.

Article 9. To see if the Town will vote to authorize the Board of Selectmen to sell and convey by deed, under such conditions and to such persons as the Board may consider proper, the title to real estate taken by the Town in default or redemption from tax sale. — Sponsored by the Selectmen.

Article 10. To see if the Town will vote to raise and appropriate the sum of Five Hundred Twenty Dollars (\$520.00) to aid Concord Hospital in Concord, New Hampshire. — Sponsored by the Concord Hospital.

Article 11. To see if the Town will vote to raise and appropriate the sum of Fifteen Hundred Dollars (\$1,500.00) for operating a recreation program for children. — Sponsored by the Park Board.

Article 12. To see if the Town will vote to raise and appropriate the sum of Three Hundred Dollars (\$300.00) for the purchase of equipment for the Hillsboro Civil Defense Program. — Sponsored by the Civil Defense Director.

Article 13. To see if the Town will vote to raise and appropriate the sum of Five Thousand Dollars (\$5,000.00) for the reconstruction of Church and Brown Streets, Wyman Street, and Whittemore Street. — Sponsored by the Selectmen and the Highway Agent.

Article 14. To see if the Town will vote to adopt as an ordinance of the Town of Hillsborough for the purpose of maintaining the general property values, atmosphere and well being of the Town, the following: "No trailer or mobile home shall hereafter be located within the Town of Hillsborough; unless the same shall be in a duly established and licensed trailer or mobile home park, or unless a person desiring to locate a trailer or mobile home not in such a park, shall, upon petition and public hearing, obtain the permission in writing of the Selectmen of the Town; said party shall have a right of appeal as set forth in Revised

Statutes Annotated, Chapter 31, Section 74 and following, as if said Selectmen were a board of adjustment," or to take any other action in relation thereto. — Sponsored by the Selectmen.

Article 15. To see if the Town will vote to adopt as a local ordinance governing the licensing and regulation of trailer or mobile home parks, the regulations proposed by the Selectmen as posted and published with this warrant, or to take any other action in relation thereto. — Sponsored by the Selectmen.

Article 16. To see if the Town will vote to accept as a public highway a new portion of the Bucklin Road, approximately seven hundred fifty (750) feet long, located in front of the residence of Charles W. Allen and Edna M. Allen, and to discontinue as a public highway that portion of said Bucklin Road, approximately six hundred fifty (650) feet long, running from a point west of said residence to a point east of said residence, and further, to authorize and empower the Selectmen to accept a gift from said Charles W. Allen and Edna M. Allen, of that land over which the new portion of the Bucklin Road now runs, and to convey by deed any interest the said Town of Hillsborough may have in the old portion of the Bucklin Road to said Charles W. Allen and Edna M. Allen, or to take any other action in relation thereto. — Sponsored by the Selectmen.

Article 17. To see if the Town will accept as a Class VI highway, subject to summer maintenance only, that portion of Mountain Side Drive running from Barden Hill Road to the Antrim Town Line, or take any other action in relation thereto. — Filed at the request of ten voters.

Article 18. To see if the Town will vote to accept as a Class VI highway, subject to summer maintenance only, from Charles F. Morgan of Hollis, N.H., all that certain tract, a parcel of land known as Morgan Road and Old McClintock Road, as shown on plan No. 3200, as recorded in Hillsborough County Registry of Deeds. — Requested by Charles F. Morgan.

Article 19. To see if the Town will vote to raise and appropriate the sum of Five Thousand Five Hundred Dollars (\$5,500.00) for the purpose of purchasing a Truck for the Highway Department, or take any action relating thereto. — Sponsored by the Selectmen and the Highway Agent.

Article 20. To see if the Town will vote to raise and appro-



priate the sum of Fourteen Hundred Dollars (\$1,400.00) for the purpose of purchasing a Police Cruiser for the Police Department, or take any action relating thereto. — Sponsored by the Selectmen and the Chief of Police.

Article 21. To see if the Town will vote to authorize the Selectmen to appoint a Zoning Commission for the purpose of studying the needs of the Town of Hillsborough in connection with zoning and to make a report at the next annual meeting, or to take any other action in relation thereto. — Sponsored by the Planning Board.

Article 22. To see if the Town will vote to authorize and empower the Planning Board of the Town of Hillsborough to prove or disapprove, in its discretion, plats showing streets or the widening thereof, or parks, and upon adoption of this article, it shall be the duty of the Town Clerk to file with the Registry of Deeds for the County of Hillsborough, a certificate or note showing that said Planning Board has been so authorized, giving the date of authorization, as provided in Sections 19 through 29 inclusive, and Section 32, of Chapter 36, of New Hampshire Revised Statutes Annotated, as amended. — Sponsored by the Planning Board.

Article 23. To see if the Town will vote to establish the Center School, so-called, as an historic landmark, and to raise and appropriate a sum, not in excess of Four Hundred Dollars (\$400.00) for the repair and improvement of said Center School, or to take any other action in relation thereto. — Sponsored by the Planning Board.

Article 24. To see if the Town will vote to authorize and empower the Board of Selectmen to contract with the State Tax Commission for a re-appraisal of all real estate in the Town of Hillsborough, or take any action relating thereto. — Sponsored by the Selectmen.

Article 25. To see what action the Town will take in connection with the regulation for the use and maintenance of the Town Dump, and to take any further action in relation thereto. — Filed at the request of ten voters.

Article 26. To see if the Town will vote to accept as a public road, Gay Ave., so-called, being 40' wide and running from School Street to Park Street as shown on plan recorded in Hillsborough County Registry of Deeds, or to take any other action in relation thereto. — Sponsored by the Selectmen.

Article 27. To see if the Town will vote to appropriate the

proceeds from the sale of the Schoolhouse lot, so-called, for the grading and surfacing of the remaining area to be used as a municipal parking lot, or take any other action relating thereto. — Sponsored by the Selectmen.

Article 28. To see if the Town will vote to raise and appropriate the sum of One Thousand Dollars (\$1,000.00) for repairs on the grandstand on Grimes Field, or take any other action relating thereto. — Sponsored by the Selectmen and the Park Board.

Article 29. To transact any other business that may legally come before said meeting.

**Town of Hillsborough**  
**ORDINANCE REGULATING TRAILER OR**  
**MOBILE HOME PARKS**

WHEREAS, the Town of Hillsborough, in the interest of protecting the public health and safety of its inhabitants, and in the interest of insuring adequate fire and other municipal protection for inhabitants residing in trailer or mobile home parks within said Town of Hillsborough.

Now therefore the following regulations are hereby adopted as a municipal ordinance for said Town of Hillsborough.

Section 1. DEFINITIONS. The definitions and regulations adopted by the State of New Hampshire Department of Health and Welfare in connection with mobile home and trailer parks, designated as regulations 1-57 through 13-57, being adopted, pursuant to the general authority to make regulations found in New Hampshire Revised Statutes Annotated, Chapter 147, Section 2, and said definitions and regulations as they may be amended from time to time by said State of New Hampshire Department of Health and Welfare, are herein incorporated by reference and made a specific part hereof, and adopted by the Town of Hillsborough, in the County of Hillsborough and State of New Hampshire as part of their ordinance regulating trailer or mobile home parks.

Section 2. LICENSE REQUIRED. It shall be unlawful to establish, maintain or operate any trailer or mobile home park in the town without first having obtained a license therefore. Application for such license shall be made in writing to the Board of Selectmen on such forms as they may supply, and shall contain the name of the applicant, the location of the proposed park and the number of trailers or mobile homes to be accommodated.

Section 3. PLANS. Each such application shall be accompanied by a plat or sketch showing; the size and location of all buildings and structures, either in being or proposed for future construction, the location of streets and driveways in being or proposed, and the sites for location of trailers or mobile homes.

Section 4. FEE. The annual fee for such licenses shall be Twenty-five dollars (\$25.00) plus Five dollars (\$5.00) for

each trailer or mobile home over the number of ten (10). If the number is increased, this shall be reported to the selectmen and the additional fee, if any, necessitated by such increase shall be paid before the additional spaces are put to use. When a license is applied for, or accommodations are increased during the license year, the fee shall be prorated on the basis of the number of months remaining in the license year.

Section 5. CHARACTER. No such license shall be issued to any but a person of good character, nor to any corporation if any officer thereof is not a person of good character.

It shall be unlawful to hire or keep as manager, superintendent or person in charge of a trailer or mobile home park any person who is not a person of good character.

Section 6. PERMANENT USE. It shall be unlawful for any person to maintain any trailer or mobile home, used for human habitation, upon any plot of ground in the Town, except in a licensed trailer or mobile home park, PROVIDED NEVERTHELESS, that this provision shall expressly not apply to any trailer or mobile home which is used as a dwelling and located within the Town of Hillsborough on the effective date of this ordinance.

Section 7. EXCEPTIONS. Nothing in this ordinance shall be construed to prohibit the storage of any trailer or mobile home for any length of time when said trailer or mobile home is not used for living or sleeping purposes.

Section 8. PENALTY. Any person, association, or corporation, violating any of the provisions of this ordinance or otherwise refusing to comply with the provisions of this ordinance, shall be fined not more than Ten dollars (\$10.00) for each day of such violation or neglect or refusal to comply with the provisions of this ordinance.

Section 9. EFFECTIVE DATE. This ordinance shall take effect as of the 1st day of May, 1966.



## SELECTMEN'S REPORT

Following the withdrawal of Disogrin Industries from further consideration of locating a plant in Hillsborough, negotiations were undertaken to recover some of the costs to the Town in preliminary site preparation and legal expense. This resulted in a payment to the Town of the \$2,001.00 originally paid for title to the land being considered, and an additional \$1,300.00, thus recovering our basic out-of-pocket expenses, and concluding our relationship with this firm.

The Town Meeting of a year ago instructed the Selectmen to consider the regional association best suited for Hillsborough. We believe that at the present time, it would appear that membership in the Monadnock Regional Association would offer more advantages to the Town, and it is our recommendation that the proper approaches be made to obtain membership.

The necessary preliminaries have been completed in connection with the survey for sewerage treatment and extension of a sewage plant, and application has been filed with the Housing and Home Financing Administration, under which the interest-free loan is to be granted for the work to be done by Anderson-Nichols as outlined in the summary included in this Town Report.

We have found it necessary to increase our Highway Department budget this year to cover more adequately our anticipated expenses for the year. Our plan during the past two years of developing a street sealing program, indicated that a specific allowance must be made in the budget each year for this item, and we are earmarking \$3,000.00 for this purpose this year. Much greater snow removal costs this year have already been incurred and in addition, major repairs on one of the Town trucks has been necessary. We recommend replacement of the present Ford truck this year.

In the late fall of 1965, the Post Office Department contacted your Selectmen as to available land for the site of a new post office building, following which, an option was given for the purchase of a portion of the School lot, so called, for this specific purpose, at a price of \$5,000.00. The Post Office Department has approved this site at the corner of School St. and Myrtle St., and is now in the process of



completing plans and specifications for a building to be put out for bids and erection during 1966.

## SEWAGE DISPOSAL SURVEY

### Anderson-Nichols Summary:

1. Compilation and review of available information concerning existing sewers, utilities and topography in general.
2. Planning for and obtaining field survey data to supplement existing information, including topography, ground elevations, utilities, and the locations of existing publicly-owned sewers, manholes, and outfalls with mean sea level elevations of inverts and frame tops. Access to manholes would be provided by the Town.
3. Planning for and obtaining borings necessary to determine sub-surface soil conditions and ground water levels.
4. Determination of population trend, including estimate of design population.
5. Investigation of existing liquid industrial wastes with regard to treatment requirements.
6. Estimation of sewage design flows for collection and treatment.
7. Preliminary design of sanitary sewers. This would include the size and preliminary layout of sewers, manholes, interceptors, pumping stations and force mains as may be required to collect the sanitary sewage and deliver it to the treatment plant.
8. Preparation of profiles of all proposed interceptor sewers.
9. Consideration of the requirements of the New Hampshire Water Pollution Commission relative to the receiving waters.
10. Selection of a suitable method of sewage treatment, preliminary design of the facility, and the determination of the most desirable site for the sewage treatment plant.

Primary consideration will be given to the Town-owned fairground property.

11. Preparation of a plan showing existing sewerage and associated facilities with mean sea level elevations of inverts and tops of manholes.

12. Preparation of plans showing the proposed improvements.

13. Preliminary construction cost estimates of the proposed improvements, including estimates of financial aid from available grants.

14. Suggested methods of financing the proposed construction.

15. Conferences with representatives of the New Hampshire Water Pollution Commission to insure compliance with their current design criteria.

16. Preparation of a report summarizing the investigations findings, and recommendations, together with construction cost estimates, available grants and methods of financing. The completed report will contain charts, tables, and diagrams as required to supplement the text and plans showing the proposed improvements, boring logs and profiles of proposed interceptors.

We would furnish 20 copies of the completed report for your use and for submission to the agencies concerned. During the course of the investigation, we would work closely with your representatives and keep you informed as to the progress of the work.

Our fee for this work has been established in accordance with the American Society of Civil Engineers' Manual 45, dated April 1964, and entitled-Consulting Engineering - A Guide for the Engagement of Engineering Services - and is itemized as follows:

## REPORT OF CIVIL DEFENSE DIRECTOR

The Civil Defense unit of Hillsboro has been relatively inactive during the year 1965. Fire, Police and Communications units have continued to operate and practice separately. The principal reason for our inactivity has been the lack of interest on the part of most people in this subject. Civil Defense needs the addition of enthusiastic volunteers and a reawakening of those in the present organization who remain interested.

During the coming year it is hoped that the necessary revised Town Primary Plan can be completed and that current Program Papers can be prepared. These can be accomplished only with the cooperation of the present officers and/or new volunteers.

Our two greatest needs in the manpower field are for an Administrator and a Radiological Officer.

During the year 1966 we hope to complete our Communications. For that reason we are asking, by an article in the warrant, for an appropriation of \$300.

The importance of Civil Defense well organized for both a nuclear attack and a catastrophe can not be over-emphasized.

## PLANNING BOARD REPORT

**Fiscal Year Ended December 31, 1965**

During 1965, the Planning Board continued its study of a variety of the conditions presently affecting the growth and development of our community.

Several items represented continuing work on projects initiated in prior years:

1. A sizeable portion of voters attending the 1965 Town Meeting supported the article which proposed authorizing the Planning Board to approve plans for new subdivisions. The Board has made further study of this project and intends to represent the motion to the 1966 Town Meeting.

2. The 1965 Town Meeting authorized the Selectmen to apply for a Federal advance for a preliminary report and plan of sewerage and sewerage treatment facilities for the Town. Subsequently, the Planning Board and Selectmen have met with C. R. Metcalf of the Water Pollution Board staff and the Planning board has toured the sewerage treatment facilities in Jaffrey. Contractual arrangements have been completed between the Town and Anderson-Nichols Co., consulting engineers to perform and preliminary studies.

3. The Planning Board has continued its study and search for solutions to the downtown traffic congestion. At our request, the Traffic Division of the N.H. Department of Public Works and Highways conducted a 12-hour "directional traffic analysis" of vehicles using Central Square. Their negative conclusion was that "traffic signals are not warranted at this intersection." The Planning Board hopes that additional recommendations of a more positive nature may be obtained from the State in the near future.

4. Continuing contact with administrative and elected officials in the Federal government has contributed to imminent construction of a new Post Office in Hillsboro.

To the 1966 Town Meeting the Planning Board will present motions of the following subjects:

1. Zoning Commission. New Hampshire Statutes, Chapter 31, Section 65, provide for the establishment of a zoning commission to explore the question of what zoning regulations might be appropriate for a community. The Planning Board recommends that the Town vote to appoint such a group to conduct public hearings and report to a subsequent Town Meeting, its findings regarding any zoning regulations



which might benefit our community.

2. As indicated above, the Planning Board feels that the support given to the proposed subdivision ordinance by the 1965 Town Meeting, warrants the resubmission of the motion to the 1966 meeting.

3. In Hillsborough Center is located the last one room schoolhouse still owned by the Town. Its condition is deteriorating and repairs should be made now, if the building is to be preserved. It seems appropriate to make a modest expenditure to maintain this example of Hillsborough's yesteryear, and the Planning Board therefore is recommending the appropriation of \$400.00 for renovation of the Center School.

Further study in the coming year appears warranted in the following areas of community concern:

1. In the matter of regional areas, investigation of the possibilities of establishing a new region incorporating the towns of Hillsboro, Henniker, Windsor, Washington, Deering, Hopkinton Weare, Antrim and Bennington seems to deserve further study, prior to committment of Hillsboro to any existing regional association.

Most of us appreciate these values, but still there were enough careless people among us to cause over 880 grass and woodland fires to start in 1965. True this was a much dryer than normal year but this should have meant the use of extra care. Fortunately the fire fighting forces have held the line against such careless acts. It is up to each one of us to be ever mindful that a spark or flame is a potential fire.

### WE MUST ALL BE CAREFUL:

1. To teach our children the danger in lighting matches.
2. To never discard lighted smoking material from a car or while walking through fields or woods.
3. To safely dispose of rubbish preferably at the town dump. If you must burn rubbish or brush;
  - a. Always get a permit to burn from the warden.

- b. Start your fire late in the day after 5:00 p.m.
- c. If burning a field or brush have equipment and adequate help on hand. The heat from your fire creates it's own draft to spread fire.

Our carelessness with fire is costing our State and Towns thousands of wasted dollars in suppression and hundreds of acres of destroyed woodlands. Yours never to enjoy.

To the Inhabitants of the Hillsborough Bridge Village Fire Precinct in the Town of Hillsborough, qualified to vote in Precinct affairs:

You are hereby notified to meet in the High School Auditorium in said Precinct on Monday the 14th day of March, 1966, at seven-thirty o'clock in the afternoon. Election of officers and balloting on Articles 1-4 will take place between 7:30 p.m. and 9:00 p.m. Articles 5 through 12 will be taken up at 7:30 p.m.

Article 1. To choose a Moderator for the ensuing year.

Article 2. To choose a Clerk for the ensuing year.

Article 3. To choose one Water Commissioner to serve five years and one Water Commissioner to serve three years, one Fire Commissioner for three years.

Article 4. To choose a Treasurer, Auditors and other necessary officers for the ensuing year.

Article 5. To hear the reports of the Fire Commissioners, Water Commissioners, Clerk, Treasurer, Auditors and other Officers and Committees heretofore chosen and to pass any other vote relating thereto.

Article 6. To raise such sums of money as may be necessary for paying the current expenses of the Precinct, the debt of the Precinct, and any other charges arising within said Precinct.

Article 7. To see if the Precinct will vote to instruct and empower the Fire Commissioners to borrow such sums of money as may be necessary to meet current expenses of the Precinct and in anticipation of taxes.

Article 8. To see if the Precinct will vote to raise and appropriate the sum of one thousand five hundred dollars (\$1,500.00) for the purchase of Fire Fighting Equipment.

Article 9. To see if the Precinct will vote to raise and appropriate the sum of One Thousand Five Hundred Dollars (\$1,500.00) for the repair and maintenance of the Fire Alarm System.

Article 10. To see if the Precinct will vote to raise and



appropriate the sum of One Thousand Dollars (\$1,000.00) to add to the Capital Reserve Fund for the acquisition of Fire Equipment.

Article 11. To see if the Precinct will vote to raise and appropriate the sum of Five Thousand Dollars (\$5,000.00) to add to the Capital Reserve Fund for the building of a New Fire Station.

Article 12. To see if the Precinct will vote to appropriate the sum of Fifteen Thousand Dollars (\$15,000.00) from the Water Department income for the purpose of operating the Water Department for the year 1966. Or to take any other action in relation thereto.

Article 13. To see if the Precinct will vote to appropriate the sum of Two Thousand Dollars (\$2,000.00) from the Sewer Department income for the purpose of operating the Sewer Department for the year 1966. Or to take any other action in relation thereto.

Article 14. To see if the Precinct will vote to establish a capital reserve fund for the purpose of capital improvements to the Water Department and to appropriate to said capital reserve fund the surplus held by the Water Department as of December 31st 1965, in the amount of Three Thousand Four Hundred Ninety-One Dollars and eighty-nine cents (\$3,491.89). Or to take any other action in relation thereto.

Article 15. To see if the Precinct will vote to establish a capital reserve fund for the purpose of capital improvements to the Sewer System and to appropriate to said capital reserve fund the surplus of said Sewer Department as of the 31st day of December, 1965, in the amount of Two Thousand Three Hundred Sixty-Six Dollars and fifty-seven Cents (\$2,366.57). Or to take any other action in relation thereto.
