## THE STATE OF NEW HAMPSHIRE

---

To the inhabitants of the Town of Piermont, in the County of Grafton, in said State, qualified to vote in Town affairs:

You are hereby notified to meet at the Town Hall in said Piermont on Tuesday, the 14th day of March next, at nine o'clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriations of the same.
3. To raise and appropriate money to maintain Highways and Bridges.
4. To raise and appropriate money to maintain street lights.
5. To raise and appropriate money for the support of the Fire Department.
6. To raise and appropriate money for poor relief.
7. To raise and appropriate money for support of Library.
8. To raise and appropriate money for Memorial Day.
9. To raise and appropriate money for Town maintenance of highways, with State Aid, or State Aid new construction on Lake Tarleton Road, to continue on from where they left off last fall.
10. To see if the Town will raise and appropriate \$50.00 for forest fire work, to be matched by an equal State amount.
11. To see if the Town will authorize the Selectmen to distribute the inventory blanks at the time they examine the taxable property.

---

12. To see if the Town will authorize the Selectmen to administer or dispose of any real estate acquired by Town through Tax Collector's deeds or otherwise.

13. To see if the Town will authorize the Selectmen to borrow money in anticipation of taxes.

14. To see what action the Town will take relative to the expenditure of the income of the Herbert A. Clark Trust Fund for the ensuing year, and thereafter.

15. To transact any other business that may legally come before said meeting.
