

WARRANT

THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Stewartstown, in the County of Coos, in said State qualified to vote in Town Affairs:

You are hereby notified to meet at the town house in said town of Stewartstown on Tuesday, the 14th day of March next, at ten o'clock in the forenoon to act upon the following subjects:

- 1. To see if the town will vote to accept State Aid.
- 2. To see if the town will vote to accept the budget, and raise money for the same. If not, to see what sum of money the town will vote to raise to defray town charges for the ensuing year as follows:
 - (a) Town Officers' Salaries
 - (b) Town Officers Expenses.
 - (c) Election and Registration.
 - (d) Municipal Court Expenses.
 - (e) Town hall, office and other buildings.
 - (f) Damage and Legal Expenses.
 - (g) Health Department.
 - (h) Town Dump.
 - (i) Vital Statistics.
 - (j) General Expense of Highway Department.
 - (k) Civil Defense.
 - (l) Interest on Temporary Loans.
 - (m) County Tax.
- 3. To raise such sums of money as may be necessary for support of poor.
- 4. To raise such sums of money as may be necessary for support of Libraries.
- 5. To raise such sum of money as may be necessary for care of cemeteries.
- 6. To see if the town will vote to raise one thousand nine hundred dollars (\$1,900.00) for street lighting.
- 7. To see what sum of money the town will vote to raise for the following departments:
 - (a) Police Department.
 - (b) Fire Department.
 - (c) Sewer Department.
- 8. To see what sum of money, if any, the town will vote to raise in addition to that required by law for the town road maintenance.

- 9. To see what sum of money the town will vote to raise for winter roads.
- 10. To nominate and elect two members to serve three years on the Municipal Budget Committee.
- 11. To see if the town will vote to instruct the Selectmen to sell the old town water pump and electric motor.
- 12. To see if the town will vote to borrow \$10,000.00 to be used to lay water mains etc., in West Stewartstown Village. With the understanding that both the interest and principal will be paid from the receipts received from the rent of town water.
- 13. To see if the town will vote to authorize the Selectmen to incur debts for temporary loans in anticipation of taxes of the Municipal year and pay out of the tax money when it is received.

To see if the town will vote to instruct its Selectmen to appoint all other officers as required by law not elected by Non-partisan Ballot.

To choose by Non-partisan Ballot the following Town Officers:

- (a) Town Clerk.
- (b) Selectman for the three years ensuing.
- (c) Town Treasurer.
- (d) Two Road Agents.
- (e) One or more Auditors.
- (f) Overseer of Public Welfare.
- (g) Collector of Diamond Pond Rent.
- (h) One or more Sextons.
- (i) Trustee of Trust Funds.
- (j) One Library Trustee for the three years ensuing.

To transact any other business that may be legally brought before this meeting.

You are hereby notified to meet at the Town Hall in said District on Saturday, the 11th day of March, 1961, at 2 o'clock in the afternoon to act upon the following subjects:

1. To choose a Moderator for the ensuing year.

2. To choose a Clerk for the ensuing year.

3. To choose a Member of the School Board for the ensuing three years.

4. To choose a Treasurer for the ensuing year.

5. To determine and appoint the salaries of the School Board and Truant Officers, and fix the compensation of any other officers or agents of the district.

6. To hear the reports of Agents, Auditors, Committees, or Officers chosen and pass any vote relating thereto.

7. To choose Agents, Auditors, and Committees in relation to any subject embraced in this warrant.

8. To see what sum of money the district will raise and appropriate for the support of schools, for the salaries of school district officials and agents, and for the payment of statutory obligations of the district, and to authorize the application against said appropriation of such sums as are estimated to be received from the state equalization fund together with such other income; the school board to certify to the selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the town.

9. To see if the district will vote to authorize the school board to make application for and to accept, on behalf of the district, any or all grants or offers for educational purposes which may now or hereafter be forthcoming from the State of New Hampshire and/or United States.

10. To see if the school district will vote to adopt a nonpartisan ballot system for the election of school district officers pursuant to revised statutes annotated, Section 59:73, 59:77, and 59:79, the same to take effect upon the annual election of school district officers for the year 1962.

11. To transact any other business that may legally come before this meeting.

Superintendent's Report

To the School Board and Citizens of the Stewartstown School District:

It is interesting to note that although there is no abatement in the general demand for a further shortening of the already greatly shortened work week, more and more is being heard about the need for "Johnny" to spend both more hours each day and more days each year in school. It is noted, also, that in spite of less and less being heard about the craftsmanship of his dad in this age of automatism, there is an increasing demand that this boy, particularly if he is gifted, be made to confine his work more to the so-called solid subjects, and that he be given a real told, the question might well arise to what extent is it going to be rough time even with the stretch in hours. In light of what he certainly is going to observe as contrasted to what he is being possible to convince this youngster that it is good.

When one stops to ponder over the stated means by which it is said better schools will result, old time basic educational principles of long standing come to mind. In particular, the focusing of the attention primarily upon intellectual training to the utmost ability rather than upon the "whole child" stands out. Recognition, too, that the rare qualities of character such as aspiration, determination, and purpose are perhaps caught as much as, if not more than taught, indicates a greater awareness of the imponderables and intangibles in human behavior. And the growing conviction that there is no substitute for challenging work whether done in the classroom or at home in developing ability to think, points to the urgency of the provision of schools with a balance that will hang on to that which has continued value, delete that which is unessential and emphasize that which is most vital.

Teachers

With the prolonged teacher shortage continuing year after year, with no indication of conditions improving in sight, we are indeed fortunate to have veteran teachers in all positions. Mrs. Gladys M. Brackett, who received her training at Plymouth Teachers College, and who has had extensive experience outside as well as in this state in different types of schools, is principal and teaches Grades 6-7-8 at the West Stewartstown School. Other teachers in the same school are Mrs. Henrietta W. Jackson, who teaches Grades 3-4-5, and Mrs. Cleora M. Richardson, who teaches Grades 1-2. At the new Hollow Elementary School, Mrs. JoAnn M. Davis teaches Grades 1-4 and Mrs. Claire G. Owen teaches Grades 5-8.

School Nurse-Health

With ever more conclusive evidence gathered to the effect

that with other things being equal, the effectiveness of work done in school by the pupil is directly proportional to his or her over-all health, the importance of the stellar work done by our school nurse, Mrs. Ethel S. Sturgis, becomes increasingly more apparent.

Aided as she is with modern up-to-date equipment and the "know how" through many years of experience, such professional services are rendered as the administering of periodic immunizations, the giving of complete physical examinations every four years, and the conducting of annual X-ray and pre-school clinics as well as the many and varied constant check-ups conducted from time to time during the year.

Alterations-Repairs-Equipment

In keeping with the recommendations of the state fire marshall for geater safety, extensive repair and alteration work was done during the summer vacation period at the West Stewartstown School Building. A covered wood fire escape, with a door at the top and at the bottom, each equipped with a crash bar, was constructed on the rear of the building leading from the second floor to the ground; all wall surfaces from the floor to wainscoting height and all window sashes, casings, and doors, on all three floors were painted with two coats of fire resistant paint; and the large front double door and the two side entrance doors were equipped with crash bars and door closers. Maintenance work at the building included painting the basement floor with rubberized paint; painting the upper portion of the wall surface in the kitchen area of the School Lunch Quarters light pastel yellow; and the refinishing of the desk tops in the upper grade room.

At the new Hollow Elementary School Building, shelves were installed in the storage room; a steel rod grating was put on the rear entrance doors to protect the glass when opening or closing; a louvre was installed in the window in the boiler room; and additional bulletin boards were fastened to the walls in the classrooms.

Outside the purchase of additional fire extinguishers for the building on the West Side of the district, again in conformity with the recommendations of the state fire marshal, such items of equipment as have been added since a year ago have consisted, for the most part, of those customarily purchased for instructional purposes.

School Lunch

Performing as she is the very difficult task of conducting the lunch program in a small school year after year, for the most part on a self-supporting basis, a great deal of credit is due the school lunch operator, Mrs. M. Eva Day, at the West Stewartstown School. This health-giving activity contributes much in the maintaining of morals and to the over-all happy life of the school.

Notes on the Budget

The School Board's budget to cover the estimated cost of the operation of the schools for 1961-62, which is the same as that of the Budget Committee, is \$66,491.00 as compared to the \$60,875.00 voted for the current year. This amount is reduced by an estimated income of \$13,000.00 which leaves a requested appropriation of \$53,491.00 to be raised through taxation by the town in comparison to the \$47,875.00 for this year.

The increase in the budget for next year is explained, for the most part, as will be noted in its breakdown found on subsequent pages in this report, by provision of salary raises, increased cost of tuition and fuel, and the conversion from a coal to an oil burning heating unit at the West Stewartstown School.

Enrollment and Attendance

Although the enrollment of pupils in our schools at the present time of 120 is somewhat less than the 124 a year ago, it is larger than at any time during the preceding six years when it was 113, 112, 113, 117, 113, and 110 respectively. A breakdown of the present enrollment shows that there are 73 at the West Stewartstown School and 47 at the new Hollow Elementary School. The average percentage of attendance at these schools during the past year in the same order as listed was 97.36, and 96.43, while the average number of tardiness per pupil for the period was .86 and .25.

Tuition Pupils

In contrast to the drop in enrollment of pupils attending school inside the district this year, the number attending school outside of 47 is an appreciable increase over the 39 of last year, and is the largest of any time during the past six years of 45, 37, 35, 38, 31, and 37 respectively. A breakdown of this year's number of tuition pupils shows that there are 21 at Colebrook Academy; 23 at Canaan High School, Canaan, Vt.; 1 at Pittsburg High School; and 2 at Colebrook Elementary School.

Conclusion

May I again express my deep appreciation to the members of the School Board, parents, teachers, and citizens for all the assistance and cooperation received as we have worked together in an effort to provide the best possible education for our boys and girls. It is only with the help of you all that high standards can be achieved and maintained.
