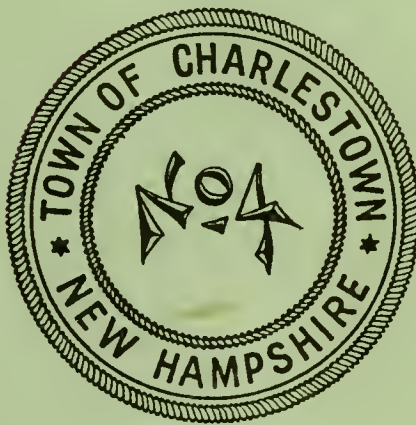

## TOWN WARRANT 1969

---

### The State of New Hampshire

To the inhabitants of the Town of Charlestown, in the County of Sullivan, in said State, qualified to vote in town affairs:

You are hereby notified to meet at the Charlestown Elementary School Gymnasium in said Charlestown on Tuesday, the eleventh day of March next, at 10:00 o'clock in the forenoon to act on the following subjects. Polls are to be open from 10 o'clock in the forenoon until the beginning of the business session at 7:00 P. M.

Article 1. To choose the necessary town officers for their respective terms.

Article 2. To see what action the Town will take respective to the provisions of R. S. A. Chapter 37, authorizing a Town Manager. By ballot.

Article 3. To see what action the Town will take respective to the Referendum vote abolishing the Board of Water Commissioners in the Town of Charlestown. By ballot.

Article 4. To see if the Town will vote to authorize the Selectmen to borrow notes on the credit of the Town such sums of money as may be necessary to meet current expenses in anticipation of taxes.

Article 5. To consider the budget. To raise such sums of money as may be deemed necessary for the maintenance of the poor, laying out and repairing bridges, street lighting and for the necessary charges arising within the Town.

Article 6. To see if the Town will vote to authorize the Selectmen to sell real estate acquired by Tax Collector's deed.

Article 7. To see what action the Town will take in respect to electing three members of the Finance Committee, and one member of the Highway Advisory Committee for the ensuing three years.

Article 8. To see what action the Town will take in respect to electing three members of the Recreation Committee for the ensuing two years.

Article 9. To see if the Town will appropriate the sum of \$1,000.00 to help support the Charlestown Visiting Nurse Association. By petition.

Article 10. To see if the Town will vote to name the section of old Route 12 south of the old underpass, from the former Adams place south to the present Route 12, Almar St. By petition.

Article 11. To see if the Town will vote to install a street light at the junction of the old Bellows Falls Road and the new Route 12, south of the overpass. By petition.

Article 12. To see if the Town will vote to raise and appropriate the sum of \$100,000.00 for the purpose of financing and constructing a municipal sewage disposal system, including sewerage, interceptors, pumping stations, treatment works, and such other related facilities inclusive of land acquisition, easements and rights of way as are required, such sum to be raised by the issuance of not exceeding \$100,000.00 in serial bonds or notes under and in compliance with the provisions of the Municipal Finance Act (Chapter 33 of the New Hampshire Statutes Annotated 1955 and any amendments thereto) and to authorize the Selectmen to issue and negotiate such bonds or notes and to determine the rate of interest thereon, and to take such other actions as maybe necessary to effect the issuance, negotiation, sale and delivery of such bonds or notes as shall be in the best interests of the Town of Charlestown, and pass any vote relating thereto.

Article 13. To see if the Town will vote to authorize the Selectmen to apply, negotiate and do all things necessary to obtain Federal, State, or other assistance as may be available in the construction of a sewerage disposal system, and pass any vote relating thereto.

Article 14. To see if the Town will adopt Chapter 36A of the New Hampshire Revised Statutes Annotated, 1963, setting up a Conservation Commission for the Town.

Article 15. To see if the Town will raise and appropriate \$500.00 to pay out of pocket expenses involved in making a map for taxing purposes of Charlestown.

Article 16. To see if the Town will approve of the Town Planning Board applying to the Soil Conservation Service for technical and financial assistance in making a Land Use Map, and Soil Survey, and appropriate funds for a share of the cost.



Article 17. To see what action the Town will take pertaining to the suggested regulations of the Town Planning Board regarding Entrance Approach Construction, New Sidewalk Construction, and New Street Construction. (A copy of these regulations may be found elsewhere in this report.

Article 18. To see if the Town will vote to install a street light on Coolidge Road, near the residence of Ralph Stoddard. By petition.

Article 19. To see if the Town will vote to recognize the United Electrical, Radio, and Machine Workers of America (UE) as the Collective Bargaining Agent for the employees in the Town of Charlestown, N. H.

Further that said Town make and enter into Collective Bargaining agreements with the United Electrical, Radio and Machine Workers of America (UE) regarding hours, wages and working conditions for said Town employees. By petition.

Article 20. To see if the Town will appropriate a sum of \$2,000.00, (two thousand dollars) to be used to lay out and construct a hard surface sidewalk on the east side of Main Street from St. Catherine's Church southerly to Paris Avenue and from Main Street easterly on the south side of Paris Avenue to East Street Extension. By petition.

Article 21. To see if the Town will vote to raise and appropriate \$35,000.00 for the construction of a new Town Garage.

Article 22. To see if the Town will vote to authorize the Trustees of Silsby Free Public Library to apply, negotiate and do all other things necessary to obtain such Federal, State or other assistance as may be available in the construction and furnishing to, and alterations to Silsby Free Public Library, and pass any vote relating thereto.

Article 23. To see if the Town will vote to raise and appropriate the sum of \$75,000.00 for the purpose of financing and constructing an addition to Silsby Free Public Library, including equipment and alterations to existing building, such sum to be not over 60% of the total cost and to be raised by the issuance of not exceeding \$75,000.00 in Serial Bonds under and in compliance with the provisions of the Municipal Finance Act (Chapter 33 of the New Hampshire Statutes Annotated 1955 and any amendments thereto) and to authorize the Selectmen to issue and negotiate such bonds

and to determine the rate of interest thereon, and to take such other actions as may be necessary to effect the issuance, negotiation, sale and delivery of such bonds as shall be in the best interest of the Town of Charlestown, and pass any vote relating thereto.

Article 24. To transact any other business that may legally come before said meeting.

Art. 1. To choose the necessary town officers for their respective terms.

Art. II Article accepted as presented in warrant with the exception of school taxes.

Art. 3. To see if the Town will vote to authorize the Selectmen to borrow on notes on the credit of the Town such sums of money as may be necessary to meet current expenses in anticipation of taxes.

Art. III Article accepted.

Art. 4. To see what action the Town will take in respect to electing three members of the Finance Committee, and one member of the Highway Advisory Committee for the ensuing three years.

Art. IV Nominated and elected by voice vote from floor:  
Finance Committee — for 3 years  
David P. Conant, Frank Fish, Charles White  
Highway Advisory Committee 3 years  
Paul St. Pierre.

Art. 5. To see what action the Town will take in respect to electing three members of the Recreation Committee for the ensuing year.

Art. V Nominated and elected by voice vote from floor:  
For 1 year — David Dower, Leonard Gray, Irene Baker  
For 2 years — Wellesley Shaw, David Conant, Margaret Spaulding

Art. 6. To see what action the Town will take to raise and appropriate the sum of \$50,000, to be matched by State Funds of \$50,000, to repair or replace bridge #068/108 over the Little Sugar River in North Charlestown, or to close and remove said bridge.

Art. VI Motion made, seconded and accepted to close and remove bridge #068/108.

Art. 7. To see if the Town will vote to allow the Charlestown Water Department to borrow up to \$25,000, to be used for the replacement of hydrants not in workable condition, said amount to be paid for out of Water Department revenue.

Art. VII Accepted.

Art. 8. To see what action the Town will take to accept the road leading from Lovers Lane Road to the Industrial Park Area in which the MPB Corporation is now located. By petition

Art. VIII Accepted.

Art. 9 To see if the Town will vote to authorize the Selectmen to sell real estate acquired by Tax Collector's Deed.

Art. IX Accepted.

Art. 10. To see what action the Town will take regarding a request to it's Representatives to the General Court for the introduction or co-sponsorship of Legislation at the next session, leading to the change in status of the Charlestown-Acworth Highway from that of a Town road to a numbered State highway originating in Charlestown and ending in South Acworth.

Art. X Unanimously accepted.

Art. 11. To see if the Town will vote to raise and appropriate \$1,000.00 for the Selectmen to hire a Board of Assessors to assess the property in the Town. On passage of this article the Selectmen's salaries shall each be reduced from \$800 to \$700 for 1968.



Art. XI Declared an affirmation vote by count from floor.  
123 Yes 111 No.

Art. 12. To see if the Town will appropriate the sum of \$20,000 for the construction of a swimming pool and appurtenant structures. By petition.

Art. XII Defeated.

Art. 13. To see if the Town will raise and appropriate the sum of six thousand dollars (\$6,000) for another full time police officer. By petition.

Art. XIII Dismissed.

Art. 14. To see what action the Town will take to instruct the Water Department to discontinue the use of the artesian well in North Charlestown until further needed. This request is made by water consumers due to the disagreeable taste of the well water. By petition.

Art. XIV Defeated.

Art. 15. To see what action the Town will take to install street lights at the following locations in North Charlestown: Near the residence of Donald Ferland, and 2. Just above the former residence of Hayes Stager. By petition.

Art. XV Accepted.

Art. 16. To see if the Town will vote to raise and appropriate the sum of \$1,200 for the Charlestown Medical Building Assoc. Inc. to enable it to provide for ambulance service for residents of the Town of Charlestown. By petition.

Art. XVI Accepted.

Art. 17 To see if the Town will vote to appropriate the sum of \$1,000 for the Visiting Nurse Association. By petition.

Art. XVII Accepted.

Art. 18. To see if the Town will vote to authorize the Board of Selectmen to enter into agreements and contracts with the applicable agencies of the United States Government and the State of New Hampshire for construction grants or reimbursement of local funds and to raise a sum of money by borrowing or otherwise under the terms of Chapter 33 of the Revised Statutes Annotated entitled "The Municipal Finance Act", and any amendments thereto, said grants and or sum of money to be used for the construction of additions to the sewerage system and sewage disposal facilities for the Riverview section of the Town.

Art. XVIII Accepted — unanimous vote from floor.

Art. 19. To see what action the Town wishes the Selectmen to take regarding the Swan Common.

Art. XIX \$2,500 voted to have concrete slab put in for general recreational use for children and improvement thereof.



Art. 20. To transact any other business that may legally come before said meeting.

Art. XX At this time the meeting reverted back to Article VI. It was decided that Mr. Frederick Blaine and the Selectmen confer on an approach road to the bridge through Mr. Blain's property, which would terminate in a legally satisfactory agreement.

Business meeting adjourned by Moderator at 11:15 P. M.

Tabulation of voting finalized at 4:00 A. M.

To the inhabitants of the Town of Charlestown, in the County of Sullivan, in said State, qualified to vote in Town affairs.

You are, hereby notified to meet at the Town Hall in said Charlestown on Wednesday, the sixteenth day of October next, at 7:00 o'clock in the evening, to act on the following articles:

Art. 1. To see what action the Town will take in regards to using a portion of monies appropriated for hydrant replacements to install a new water main.

Art. I Proposed — That the town authorize the Water Department to use the sum of \$6,000. in conjunction with other funds it may receive, to install a 12 inch water line to Lovers Lane Road, using funds appropriated at the March 1968 Town Meeting for replacement of hydrants.

Proposed amended to change the sum of \$6,000 to \$8,000.

Standing floor vote: 55 Yes 41 No.

Amendment amended to read "Use unspecified amount of the \$23,000 left in hydrant fund.

Article accepted by standing floor vote:  
60 Yes 41 No.

Article to read:

"Authorize the Water Department to use and unspecified amount of the \$23,000 available, to use in conjunction with other funds it may receive, to install a 12 inch water line to Lovers Lane Pond, using funds appropriated at the March 1968 Town Meeting for the replacement of hydrants".

Art. 2. To see if the Town will reconsider the action at the March 1968 Town Meeting whereby it adopted Article 10 in regards to the change in status of the Charlestown-Acworth highway.

## ANNUAL REPORT OF HEALTH OFFICER 1968

This year brought forth the usual number of complaints and corresponding number of inspections, by your Health Officer, of infractions of the health laws governing the town. The problems were all solved through various means, to the satisfaction of all parties concerned.

There were two new statutes enacted in the year 1968 which have a bearing on the town. An air pollution bill which involves burning in large quantities, and a new law in regards to the installation of a septic system that will be within 1000 feet of any waterway. Both of these laws, being relatively new have caused some confusion in the enforcement of them, but your Health Officer feels that the intent of the laws is very clear and I will enforce them in this vein. I urge everyone that is constructing a new septic system to contact this office first to prevent any duplication of labor.

The usual number of water samples were taken in Charlestown and North Charlestown, and all reports were returned as satisfactory. The Swimming Pool was tested this summer several times, and the usual draining and cleaning procedures were followed to insure safe swimming. It is the feeling of the State Department of Health, and I concur with them, that several measures will have to be taken

in the future if this pool is to remain open. This pool is no longer adequate for the number of people involved in swimming in it, under the present sanitary conditions being used.

The annual rodent extermination program was conducted in the spring instead of the fall because of the number of complaints received by this office. The results were very satisfactory, and it must be remembered that no matter how successful this program is it is only temporary and must be repeated annually to keep the rodent population reduced.

I wish to thank the Town Officers, Water Department and citizens of Charlestown for their cooperation in the past year.

## Charlestown Silsby Library Librarian Report

73 years ago in February, 1896, Silsby Free Public Library opened with a total of 3,800 volumes, serving a population of 1,466. The above report points to the increase in the number of volumes housed in the library which is now serving a population which has nearly tripled that of 1896. In the beginning the library was maintained largely for adults. During the years the library has increased the area of service to include children of pre-school age to adult. The lack of space this increase has made is a serious problem in bringing to the town the service it deserves.

The library personnel appreciates: the services of the Friends of the Library in providing story hours and puppet shows for the children the attractive floral arrangements donated throughout the year by the Garden Club; the gifts from patrons of books and records and the gift of the record player by the Rotary Club.

## TOWN PLANNING BOARD REPORT

The Charlestown Planning Board has passed another year in existence trying to develop a plan for the Town of Charlestown. The Board set a group of aims for the year and have completed them to a point of bringing them to the voters of Charlestown at their annual Town Meeting. The Board listed these aims in the following order:

1. Town Manager Form of Government
2. Street Regulations
3. Water Department

It is not an easy task to determine what should come first and what is best for the Town as a whole. There are other aims that the Board will consider in the future with the Town of Charlestown utmost in their minds.

## REGULATIONS FOR ENTRANCE APPROACH CONSTRUCTION

- a. Application for entrance approach (driveway) construction shall be submitted to Planning Board for a permit.
- b. Permit for construction will be granted by Planning Board.
- c. The entrance approach (driveway) within the road right-of-

way shall slope from shoulder of road a distance of six (6) feet dropping one (1) inch to the foot.

- d. Drainage structures as are necessary to maintain new or existing drainage shall be furnished by landowner and shall be not less than fifteen (15) inches in diameter.
- e. No water shall discharge from entrance approach (driveway) upon the paved surface of street or road.
- f. Residential entrance approach (driveway) shall be not more than eighteen (18) feet in width
- g. Non-residential entrance approach (driveway) considered on an individual basis by the Planning Board.
- h. Certificate of approval will be issued upon completion and inspection of the above requirements by the Planning Board.

#### REGULATIONS FOR NEW SIDEWALK CONSTRUCTION

- a. Sidewalks shall be constructed upon acceptable subgrade of well-draining subsoil consisting of a minimum of eight (8) inches of gravel
- b. Sidewalks shall be four (4) feet in width and slope one-quarter ( $\frac{1}{4}$ ) inch to the foot toward the curb.
- c. Curbing for sidewalks shall be not less than four (4) inches high from paved road, nor shall be not more than six (6) inches high from paved road.
- d. Oil treatment, hot road-mix, or concrete are acceptable materials.
- e. Concrete sidewalks shall have divider strips of not less than one-half ( $\frac{1}{2}$ ) inch every four (4) feet.
- f. If possible a medium strip shall be between curb and sidewalk for snowplowing, this may vary due to topographic conditions.

#### REGULATIONS FOR NEW STREET CONSTRUCTION

The Charlestown Planning Board, in order to promote the safety and growth in the Town of Charlestown, has set up the following regulations for new street construction.

- a. Street right-of-way widths shall be not less than forty (40) feet in width.
- b. Gravel base shall be upon an acceptable subgrade of well-draining subsoil and shall be a minimum of eight (8) inches of gravel base compacted and crowned  $\frac{1}{4}$  inch to one (1) foot on paved area.

- c. Minimum width of gravel shall be to the full paving width of twenty-two (22) feet with adequate drainage where necessary.
- d. Streets shall be laid out so as to intersect as nearly as possible at right angles and no street shall intersect any other street at less than sixty (60) degrees.
- e. Street layouts shall include acceptable access into abutting properties unless such action is not deemed necessary by the Board due to the location or nature of abutting land.
- f. Street grades shall not exceed eight (8) % over a distance of six hundred (600) feet ten (10) % over a distance of five hundred (500) feet twelve (12) % over a distance of three hundred (300) feet. No street grades shall be less than  $\frac{1}{2}$  of one (1) %. Variations may be permitted by the Board where advisable due to topographic conditions.
- g. Dead-end or cul-de-sac streets, designed to be permanently closed at one end, shall be provided at the closed end with a turn-around having a minimum radius to the outside curb or roadway of at least sixty (60) feet.
- h. If sidewalks, curbs, or edgestone are installed, a storm drain system including culverts and catch basins will be required.
- i. If street or road with oil treatment or hot road-mix are applied to surface, it shall be a minimum width of twenty-two (22) feet.
- j. If water and sewer services are to be installed, it shall be installed prior to completion of street or road.
- k. Upon completion of the above requirements and receipt of the deed to the street or road right-of-way, the Planning Board present and recommend for acceptance such street or road to the next annual Town Meeting.

## REPORT OF RECREATION DEPARTMENT

After the last town meeting had appropriated \$2,500 for recreational area on the Swan Common, several meetings were held with the full committee and occasionally with the selectmen to plan the development of this area which was at this time a mess of loose sand and discarded sheet plastic from a previous skating rink project.

A contract was awarded Dufresne and Henry, as low bidder, on a black-top slab roughly 100 feet square.

Preparatory work of grading was done by Hodgkins of Bellows



Falls, who later came back to re-grade the salvaged loam. The town drew a lot of gravel and Norm Beaudry leveled the area with his bulldozer.

A quality chain link fence was provided by the Trustees of trust funds, to keep children and tennis balls out of the road. The black-top slab was outlined, nets erected, and the area seeded by the recreation committee. Tennis was played from August through October, as well as basketball and badminton.

Skating started in December and both that sport and hockey are now proving very popular.

The area has been a great success and can be used profitably by children and adults alike, except perhaps, in November and in April when we are in our "in-between" seasons.

The town swimming pool was opened shortly after school closed, and was kept open all summer until school started. Two teenage girls did a good job as life guards and no serious problems were reported. The pool needs a re-paving of the bottom and the swamp above the Pool, needs filling with gravel, as we are at the mercy of each sudden shower which sends silt into the pool. If, in future years, we can replace and re-pipe this pool with a new one, a filter can be added and ideal conditions more nearly approached.

The present pool location is ideal from many standpoints. Some which are: easily accessible, good parking facilities, good road, no thru-traffic dangers, adjacent to the ball field and elementary school as part of a future multi-purpose recreational program. It is also an area of great beauty and the adjacent abandoned tennis courts have been cleaned up pending some useful development.

In co-operation with the Fall Mountain School District, a program of steady improvement in the local ball field, has been initiated. During the summer, the field is busy with one or two games every nite and more space is needed. A convenient solution would be to purchase metal culvert pipe for the brook for about 250 feet and open the huge ravine there for "clean fill." This would enlarge the main ball diamond at no cost, and secure for the school district, about two acres of flat clear land that is now absolutely worthless.

The recreation committee wishes to thank the many citizens who gave of their time and money to make Charlestown a better place for children. The town is indeed fortunate to be able to offer so much in the way of public recreation for so little money.

## **TOWN MANAGER GOVERNMENT**

We, the Planning Board of the Town of Charlestown, have in the past year, as one of our projects, made a study of the feasibility of having a Town Manager form of government for the Town. In the course of our study and discussion we have—

1. Studied the State Statutes as to the organization of a Town Manager system and the duties of the Town Manager.
2. Obtained literature from the New Hampshire Municipal Assn. relative to town and city managers.
3. Held a public discussion meeting with James Hobart, city manager of Keene, regarding his duties as city manager, and obtained his ideas on a Town Manager for a town of our size.
4. Planned at least one additional public meeting on this prior to town meeting in March.

### **What is the Town Manager system of government?**

The town manager system of government may be likened to that of a business corporation. The stockholders are the taxpayers, the elected board of directors are the Selectmen, and the general manager hired by the board to run the business is the Town Manager hired by the Selectmen to run the town. The selectmen would formulate the policies of the town and the Town Manager would see that they are carried out.

The Town Manager is the administrative head of all town departments and he is the general supervisor of the town's property and its business affairs. He exercises no legislative or judicial functions and his authority does not include that of the Town Clerk or Town Treasurer. He is at all times under the direction of and responsible to the Selectmen. His authority supersedes that of any board of commissioners or other local agency except the duties and authority of fire engineer, state highway agents, and any police commission created by the state legislature.

### **What are the powers and duties of the town manager?**

The town manager is responsible for the administration of departments determined by the Selectmen. Those specifically mentioned in the law include the town's water, lighting, and power systems; the public works department; the police and fire departments; the sewer systems and the parks department. He is also responsible for purchasing all supplies for the town and for the letting, making, and performance of all contracts to which the town is a party. In these areas, the manager may appoint, remove, and fix the compensation of employees and supervise their work. He must also prepare regular reports on the activities of the departments under him and he must keep the Selectmen fully informed con-

cerning the operation of all departments under his direction. This includes submission of a budget to the Selectmen prior to Jan. 31.

While in office, the town manager is prohibited from holding any other public office except Justice of the Peace, Notary Public, or, is specifically authorized by the town meeting, Tax Collector. He may fill positions which normally come under his supervision.

His powers and duties are fully specified in the state statutes (RSA: Chapter 37).

### **How do we adopt town manager government?**

State law requires that the town manager form of government be adopted by the town meeting, voting on an appropriate article in the warrant (by printed ballot). Upon the adoption of the article, the Selectmen are authorized to appoint a Manager to serve under their direction. The town meeting has no direct authority over the selection or the removal of the manager. But it does have the power to vote out the form. In brief, the Selectmen have the power to appoint or remove him; the town meeting has the power to adopt or rescind the system.

To be appointed, the Manager doesn't need to be a resident of the town or state. He must take an oath and execute a bond in favor of the town. The Selectmen set the size of the bond and also determine his compensation. If he resigns, the Selectmen either temporarily or permanently fill his position.

### **What are the advantages of a town manager system for the Town of Charlestown?**

1. Consolidation of all departments under one administrative head.

2. More efficient operation of all departments—and in particular the highway, water, and sewer departments.

3. Town office open full time—we advocate having the Town Clerk's office in the town office with her assisting the town manager with clerical work (at an additional salary) along with some other part time clerical help.

4. Assistance to the police department by having someone available to answer phone calls during the day when the officer is on patrol.

5. Central purchasing of all supplies for all departments instead of having each department purchase its own as is now done.

6. Manager's knowledge of state and federal funds available to assist the town with future needs.

7. Lessening of Selectmen's work which would encourage more citizens to seek the office.

8. Placing of a person full time in a position so that citizens would have more knowledge of what is going on within the town.

### WHAT MUNICIPALITIES COMPARABLE TO US HAVE TOWN MANAGERS?

Conway, N. H. (Pop. 4500); Lancaster, N. H. (Pop. 3200); Meredith, N. H. (Pop. 2750); Newport, N. H. (Pop. 5675); Northumberland, N. H. (Pop. 2600); Chester, Vt. (Pop. Approx. 2800) Ludlow, Vt. (Pop. Approx. 3000); Cavendish, Vt. (Pop. Approx. 2000); and Bellows Falls, Vt.

### WHAT IS THE RECOMMENDATION OF THE PLANNING BOARD?

In light of the following facts, we recommend that the Town of Charlestown adopt the Town Manager system of government at its next town meeting and that it be voted that he assume the duties of Tax Collector:

1. That Charlestown is a growing town (Pop. growth since 1960—22.3%; 2275 to 3350 NHMA Estimates) and needs full-time management.
2. That municipal expenditures for 1969 will be in excess of \$150,000 which certainly needs more than part-time supervision.
3. That the net cost of the system should be made through

efficient management of tax monies — if not we would be more apt to at least get our money's worth.

4. That the town is in need of more efficient management which can be gained only with someone in a full-time position.

We further recommend that the man selected for this position be one with an education in public administration, some experience such as an assistant manager in a larger municipality, and be a younger man who has the ambition and energy to fully carry out the policies required of him in this office.
