# WARRANT

## State of New Hampshire

*To the Inhabitants of the Town of Deering, in the County of Hillsborough in said State, qualified to vote in Town Affairs:*

You are hereby notified to meet at the Town Hall in said Deering on Tuesday, the tenth day of March, next at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the ensuing year.
2. To see if the town will vote to authorize the Selectmen to appoint the Road Agent, instead of election by popular vote.
3. To see if the town will vote to raise and appropriate the sum of \$3,000.00 for Town Officers' salaries and expenses.
4. To see if the town will vote to raise and appropriate the sum of \$150.00 for election and registration.
5. To see if the town will vote to raise and appropriate the sum of \$400.00 for the upkeep of the Town Hall and other buildings.
6. To see if the town will vote to raise and appropriate the sum of \$350.00 for the Police and Fire Departments.
7. To see if the town will vote to raise and appropriate the sum of \$300.00 for Blister Rust Control or pass any vote relating thereto.
8. To see if the town will vote to raise and appropriate the sum of \$750.00 for insurance.
9. To see if the town will vote to raise and appropriate the sum of \$8,000.00 for summer and winter roads.
10. To see if the town will vote to raise and appropriate the sum of \$922.72 to secure Town Road Aid.
11. To see if the town will vote to raise and appropriate the sum of \$300.00 for street lights.
12. To see if the town will vote to raise and appropriate the sum of \$1,300.00 for Old Age Assistance and Town Poor.

13. To see if the town will vote to raise and appropriate the sum of \$30.00 for the Monadnock Region Association, or pass any vote relating thereto.

14. To see if the town will vote to raise and appropriate the sum of \$50.00 to apply towards the expense of Old Home Day.

15. To see if the town will vote to raise and appropriate the sum of \$2,571.00 to cover overdraft for 1952.

16. To see if the town will vote to raise and appropriate the sum of \$300.00 for interest.

17. To see if the town will vote to raise and appropriate the sum of \$2,250.00 for note on Grader and P.W.A. Bond.

18. To see if the town will vote to raise and appropriate the sum of \$3,200.00 for County Tax.

19. To see if the town will vote to authorize the Selectmen to borrow money in anticipation of taxes.

20. To see if the town will vote to pay the Collector of Taxes two per cent (2%) for his services in collecting the State Head Tax. The proposed new bill will allow the town to retain ten per cent (10%) for its work and expense in assessing and collecting said tax.

21. To see if the town will vote to raise and appropriate the sum of \$75.00 for the purchase of a typewriter for use in the Selectmen's office.

22. To see if the town will vote to raise and appropriate a sum not exceeding \$1,100.00 for the purchase of a Bulldozer Blade for the D-4 Tractor, such sum to be raised through the issuance of serial bonds or notes under and in accordance with the provisions of the Municipal Bonds Statute, and amendments thereto, and to authorize the Selectmen to issue and negotiate such notes, and to determine the time and place of payment thereof, under such terms and conditions as they may deem to be in the best interests of the town.

23. To see if the town will vote to raise and appropriate the sum of \$2,500.00 for the purpose of a new Tractor and Loader, such sum to be raised through the issuance of serial bonds or notes under and in accordance with the provisions of the Municipal Bonds Statute, and amendments thereto, and to authorize the Selectmen to issue and negotiate such notes, and to determine the time and place of payment thereof, under such terms and conditions as they may deem to be in the best interest of the town.

24. To see if the town will vote to permit the use of town equipment for private and state hire.

25. To see if the town will vote to authorize the Selectmen to deliver inventory blanks to residents when assessing.

26. To see if the town will vote to adopt the non-partisan ballot system.

27. To see if the town will vote to close from October 15th to May 1st the following roads and portions of roads:

(A) No. 91, Falls Road from Second New Hampshire Turnpike as far as Gingras Farm, so-called.

(B) No. 79 and 80, Tubb's Hill Road from Duval's Road to the Driscoll Road and from Buzzell's house to Tubb's Hill Road.

(C) No. 81, Clement Hill Road from Duval Road to Sparks Road.

(D) No. 94, from Foster's dwelling to McNally drive.

(E) No. 63, Cleveland Road from McConnell's to Bartlett Road.

(F) No. 68, from Community Center corner to East Deering Road.

(G) From Sodom Hill Road to Henniker line.

(H) No. 65, from Lester Adam's house to Ida Hart Farm.

(I) No. 87, from Olson's to Route 149 at Duttons.

(J) No. 90, from 84 to 89 Potash Hill Road.

(K) No. 76, from Sparks place to Ernest Johnson's place.

(L) No. 82, from Poling's house to Arthur Ellsworth's Farm.

(M) No. 98, from Second New Hampshire Turnpike (Cork Hill) to Bennington line.

(N) No. 70, from Call's place to Weare line.

(O) Codman Hill Road from Bennington Road (opposite Durkee house) to Bennington line.

(P) New Road, West Deering, from Colburn house to Bennington road.

28. To see if the town will vote to close 500 feet, more or less, of Road No. 76 at Valentino's house.

29. To see if the town will vote to appropriate \$250.00 to cover cost of Fales lot below Town Hall, purchased May 17, 1952.

30. To see if the town will vote to authorize the Selectmen to auction property taken by Collector's Deed.

31. To see if the town will vote to authorize the Selectmen to repair and paint the Horse Shed on the Deering Church grounds.



32. To see if the town will vote to adopt a plan for extending to employees of the town the benefits of title II of the Federal Social Security Act (Old Age and Survivor's Insurance) as authorized by Chapter 234 of the Laws of 1951 and to raise and appropriate such sums of money as may be necessary to defray the town's share of the cost thereof.

33. To see if the town will vote to raise and appropriate a sum equal to the five year average of monies which the town has raised and appropriated and which the State has contributed for Town Road Aid, for the purpose of completing in one year the five year program for the use of Town Road Aid funds, such sums to be raised through the issuance of bonds or notes under and in accordance with the provisions of statute, and to authorize the Selectmen to issue and negotiate such bonds or notes and to determine the time and place of payment thereof, under such terms and conditions as they may deem to be in the best interests of the town. Such sums to be repaid during the five year period from State Town Road Aid funds.

34. To raise such sums of money as may be necessary to defray town charges for the ensuing year and made appropriations of the same.

35. To transact any other business that may legally come before the meeting.

## REPORT OF THE ANNUAL TOWN MEETING Deering, N. H., March 11, 1953

A legal meeting of the inhabitants of the Town of Deering, N. H., qualified to vote in town affairs, was called to order at 10:20 o'clock in the forenoon of March 11, 1952, by the Moderator, Howard E. Whitney. The Warrant was read by the Moderator. Prayer was offered by Dr. Whitney Yeaple.

Upon a motion made by Arthur O. Ellsworth, it was voted to keep the polls open until 6:30 p.m.

### Article 1.

Ballots were cast for the officers on the Australian Ballot as follows:

Selectman for 3 years: H. Lothrop Herrick had 54 votes; Harvey C. Stimpert had 83 votes and took the oath of office.

Town Clerk: Marguerite L. Dutton had 132 votes and took the oath of office.

Town Treasurer: Marguerite L. Dutton had 133 votes and took the oath of office.

Tax Collector: Joseph M. Carew had 135 votes and took the oath of office.

Highway Agent: Percy L. Putnam had 53 votes; Carroll E. Greene had 85 votes and took the oath of office.

Overseer of Poor: Carroll E. Greene had 119 votes and took the oath of office.

Auditors: Marjorie A. Heath had 125 votes; Eunice E. Willgeroth had 128 votes and they each took the oath of office.

Library Trustee for 3 years: Mary B. Holden had 127 votes and took the oath of office.

Trustee of Trust Funds for 3 years: Alice A. Andrews had 124 votes and took the oath of office.

Chief of Police: Harold G. Wells had 55 votes; William J. Dumais had 80 votes and took the oath of office.

Police Officer: Fred C. Greene had 38 votes; Gordon B. Rich had 92 votes and took the oath of office.

Surveyor Wood and Timber: Everett H. Abbott had 125 votes and took the oath of office.

Upon a motion made by Arthur O. Ellsworth it was voted to take up articles 17 and 18 first.

Article 17. After a discussion of the article, upon a motion by Arthur O. Ellsworth it was voted to dismiss the article.

Article 2. Upon a motion made by Arthur O. Ellsworth it was voted to raise and appropriate \$3,000 to defray town charges.

Article 3. Upon a motion made by Arthur O. Ellsworth it was voted to raise and appropriate \$6,000 for summer repair of highways and bridges and \$2,000 for winter maintenace.

Article 4. Upon motion made by Arthur O. Ellsworth it was voted to rais eand appropriate \$927.31 for Town Road Aid.

Article 5. Upon a motion made by Arthur O. Ellsworth it was voted to raise and appropriate \$400.00 for interest.

Article 6. Upon a motion made by Arthur O. Ellsworth it was voted to raise and appropriate \$250.00 to apply towards the P.W.A. Bond.

Article 7. Upon a motion made by Marie G. Wells it was voted to raise and appropriate \$3,000.00 to apply towards the truck and grades notes.

Article 8. Upon a motion made by Arthur O. Ellsworth it was voted to raise and appropriate \$300.00 for street lights.

Article 9. Upon a motion made by Chester P. McNally it was voted to raise and appropriate \$300.00 for Blister Rust Control.

Article 10. Upon a motion made by Rev. Reidt it was voted to raise and appropriate \$55.00 for the Monadnock Region.

Article 11. Upon a motion made by Marie Wells it was voted to authorize the Selectmen to deliver inventory blanks when assessing.

Article 12. Upon a motion made by Arthur O. Ellsworth it was voted to raise and appropriate \$1,200.00 for Old Age Assistance and Town Poor.

Article 13. Upon a motion made by Marie Wells it was voted to instruct the Selectmen to borrow money as may be needed in anticipation of taxes.

Article 14. Upon a motion made by Arthur O. Ellsworth it was voted to raise and appropriate \$550.00 for insurance.

Article 15. Upon a motion made by W. R. Griffiths it was voted to raise and appropriate \$10.00 for flags.

Article 16. Upon a motion made by Rev. Reidt to adopt the Citizens or Non-Partisan Caucus.

Article 19. Upon a motion made by Marie Wells it was voted not to permit the use of town equipment for private hire and state hire.

Article 20. Upon a motion made by Harvey Stimpert it was voted to lay the article on the table until next town meeting; the Selectmen to investigate in the interim.

Article 21. Upon a motion made by Marie Wells it was voted that the Honor Roll be removed from the outside of the Town Hall and kept under cover until such time as money can be raised for its repair.

Upon a motion made by the Rev. Reidt it was voted that a committee of three be appointed by the Moderator to see about a permanent Honor Roll.

Upon a motion made by Robert Johnson that the road from the Community Center corner to East Deering road be kept open and passable.

A report was made by the Rev. Reidt in regard to the town dump possibility.

Upon a motion made by Marie Wells it was voted to have Stuart Michie remove the stove he sold the Town, refund the money received and return the stove he had in exchange. change.

Upon a motion made by Marie Wells it was voted that the Clerk write a note of appreciation to Arthur O. Ellsworth for his faithful services as Selectman for so many years.

It was voted to adjourn without date.

10. To see if the district will raise and appropriate the sum of \$538.00 to cover the deficit caused by the increase in the number of High School pupils.
11. To see if the District will vote to indicate its interest in becoming a member of a proposed Cooperative School District, organized to provide efficiently elementary and secondary school education for the youth of Deering and Hillsboro.

12. To transact any other business that may legally come before said meeting.

If you note the geographical distribution of these children it will be easy to see why it seemed wisest to discontinue the East Deering School. Unless 27 students in grades 1 to 6 could be collected for this school it would be cheaper to pay their tuition in Hillsboro. The quality of instruction is another factor which had to be taken into consideration.

The Deering students have fitted into the Hillsboro schools very nicely. It is interesting to note that the presidency of the student council, freshman, junior and senior classes are all held by Deering boys.

Two changes have occurred since last March which have upset the school budget. First, we had 5 new high school students move into Deering since the last school meeting which increased our high school tuition cost \$1,375. Second, our state aid was reduced from \$464.50 received last year to \$221.61 for this year. Although some children have moved out of town a careful study of the accounts show that the school district will need a deficit appropriation of \$538.00 to balance its accounts this year.

This year an effort has been made at all grade levels to stress the moral and spiritual values that have made this a great nation. Many of us were deeply impressed by the words of our President when he said, "America is great because she is good, and if ever America ceases to be good she will cease to be great." The school must take its place along with the

church and home in teaching the love of truth, justice, freedom, and peace if we wish to preserve the way of life we now enjoy.

During the remainder of this year the faculty is going to re-examine the ways we teach reading to see how we can become more efficient in this field. Movies, radio, and TV have reduced the time we have left for reading but ability to read quickly and accurately is still the basis for many occupations.

In closing I would like to express my appreciation to the school board, and parents for their cooperation in making this a successful school year.

**REGULATIONS PERTAINING TO THE  
SANITATION OF PUBLIC OR OTHER WATERS**

**Pollution Prohibited**

(A) No privy, cesspool or septic tank shall be constructed or maintained at such distance from the edge of a body of water within the scope of these regulations as, in the Board's judgement, to entail likelihood of material pollution thereof. In general, and except where the Board may otherwise permit, a minimum distance of seventy-five feet to be understood.

(B) No sink water, urine, or water that has been used for washing or cleansing of food shall be permitted to run into said waters.

(C) No dead animal, or food, or refuse therefrom, kitchen waste, swill, garbage, or manure shall be thrown into or deposited in said waters, or on the ice thereof, or so left or permitted to remain on the shore as to wash thereinto. Provided that this shall not apply to the necessary fertilization of the soil, where effected in such way as to entail no gross or unnecessary degree of pollution.

(D) No automobile or other vehicle shall be washed in or driven into any lake or pond whatsoever.
