

#### THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Ellsworth in the County of Grafton in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town House in said Ellsworth on Tuesday, the 13th day of March, next at 7:30 of the clock in the afternoon to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.

3. To see how much money the town will vote to raise and appropriate for the support of Highways and Bridges.

4. To see if the town will vote to qualify for T. R. A. and raise and appropriate \$65.52 for same.

5. To determine and appoint the salaries of the Town Officers and make appropriation of the same.

6. To see if the town will vote to support the White Mt. Regions Association and raise and appropriate \$6.80 for same.

7. To see if the town will vote to have the inventory blanks distributed at the time of taking inventory. 8. To see if the town will vote to authorize the Selectmen to borrow money in anticipation of taxes.

9. To see what action the town will take relative to town house and raise and appropriate the necessary amount for repairs.

10. To transact any other business that may legally come before said meeting.
