# Warrant For Town Meeting

1974

Town of Hart's Location

State of New Hampshire

To the inhabitants of the Town of Hart's Location in the County of Carroll in said State, qualified to vote in Town affairs:

You are hereby notified to meet at the former Willey House Post Office in said Harts Location on Tuesday, the fifth day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary Town Officers for the year ensuing.
- 2. To raise such sums of money as may be necessary to defray charges for the ensuing year and make appropriations of same, including town officers salaries, town officers expenses, election and registration expenses, fire department, damages and legal expenses, health department and ambulance service, dump and garbage removal, town maintenance of highways (summer), lighting, town road aid, Planning board, and advertising and regional expenses.
- 3. To authorize the Selectmen to borrow sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of same.
- 4. To see if the town will vote to raise and appropriate the sum of \$32.52 (amount being seven cents per thousand dollars of equalized valuation) for the White Mountain Region Association.
- 5. To see if the town will vote to raise and appropriate the sum of \$20.33 Town Road Aid, to be used with. State Highway Department quota of \$135.56 for all Town roads.
- 6. To see if the town will vote to petition the State Tax Commission to have an audit made by the Municipal Accounting Division and make appropriation to cover the expense of same.
- 7. To see if the town will vote to raise and appropriate the sum of \$100.00 for all town roads.
- 8. To see if the town will vote to raise and appropriate \$300.00 for fire expenses.
- 9. To see if the town will vote to raise and appropriate \$260.00 for dump and garbage removal.

- 10. To see if the town will vote to raise and appropriate \$300.00 for Health Department and Ambulance Service.
- 11. To see if the town will vote to raise and appropriate \$50.00 for the Planning Board.
- 12. To see if the Town will vote to reclassify that section of old Rte. 302, between Sta. 96 and Sta. 163, from a Class V to a Class V1 road.
- 13. To see if the town will vote to approve the provisions for absentee voting for the election of town officers for the Town of Harts Location.
- 14. To bring in your votes for a Delegate to the 1974 Constitutional Convention.
- 15. To act upon any other business that may legally come before said meeting.

## Planning Board Report

At the 1973 Town Meeting, held on Mar. 13th, the voters passed Warrant Articles #12 and #13, thereby creating a Planning Board for the town.

At the same meeting the four following persons were appointed to serve on the Board:--Frank Patrick, Jr., Paul Kelly, Doris Jones and Robert Miller. Subsequently, the Selectmen appointed Selectman Benjamin W. English Jr. to be the fifth member.

Several Board meetings were held, resulting in the creation of a Land Use Ordinance. Copies of the original draft were sent to all voters and land owners. As required by statute, two public hearings on the proposed ordinance were held on Aug. 4th and Sept. 15th. A Special Town Meeting was warned for Oct. 20th. Fifteen days prior to this Special Town Meeting, the proposed ordinance was printed in its entirety in The Reporter, as required by law. At the Special Town Meeting on Oct. 20th the voters voted in favor of the Ordinance and it was passed into law, as of that date. Also as required by law, a Board of Appeals was created on Nov. 17th. Its members consist of Mr. Lyle Richardson, Mrs. Linda Richardson, Florence Morey, Harold Burke and Mildred Burke.

With this moderate Land Use Ordinance in effect, the Town should, in the future, be well protected from most of the troubles that have beset many other small New Hampshire towns which have neglected to enact such a law. It is hopefully expected that it will prove to be a great boon to both residents and visitors alike.
