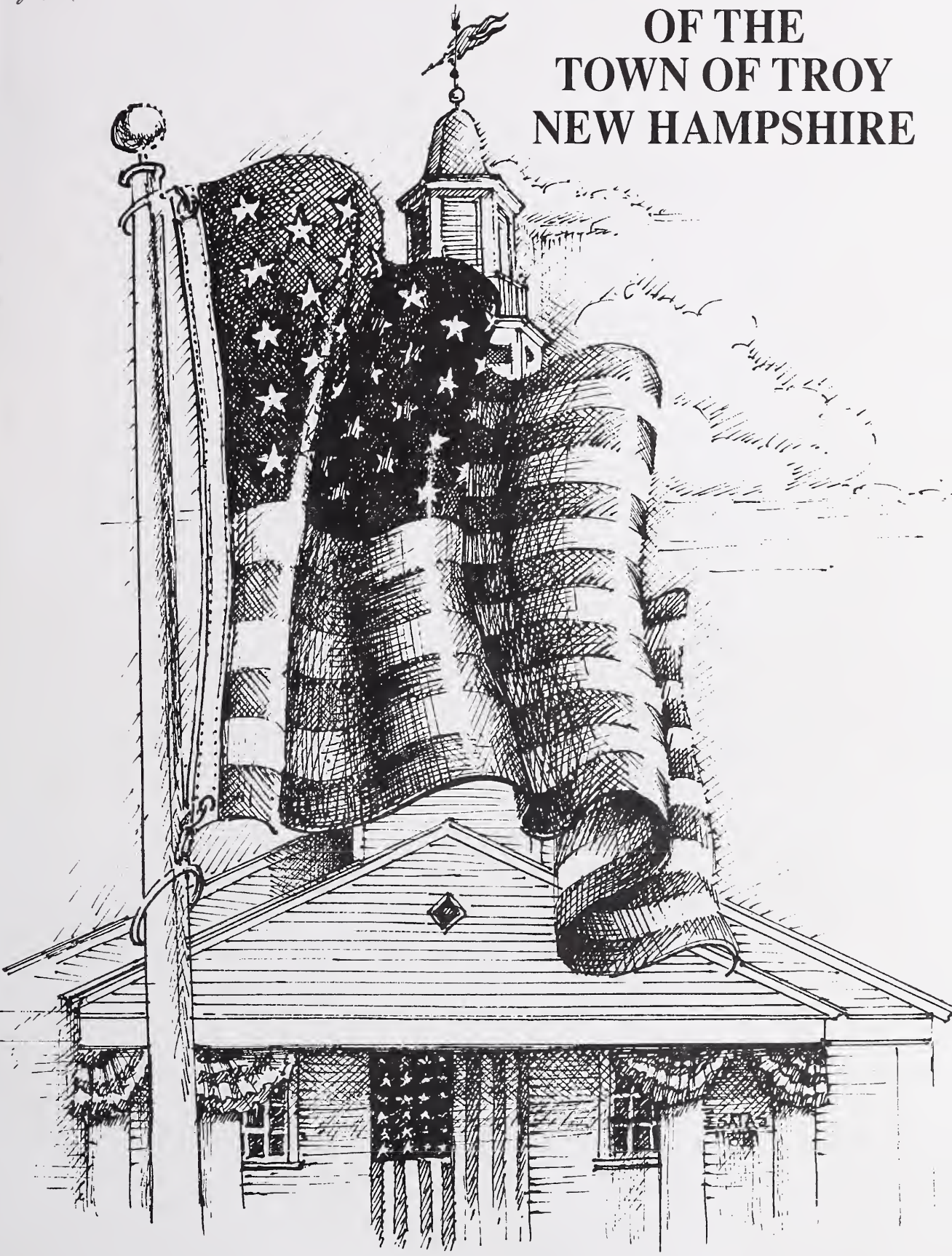

BOARD OF SELECTMEN'S REPORT

The year 2001 is probably considered, in a phrase as "Trying Times". We have dealt with more problems and issues, than the past several years prior, combined have. The residences of Town of Troy have had to deal with a lot of extraordinary issues.

An application for an adult bookstore to be located in our town is one of these issues. There is a moral and as well as an impressionable concept. As people come in and out of our town, is this the first or last image we want them to see?

Troy Mills in bankruptcy, has an unpaid debt to the town of Troy for over \$900,000.00. Our concert is; what is going to happen to the complex? Are their environmental concerns surrounding the complex? What recourse does the town have? Those are a few of the many questions we are asking and trying to get answers to. The unforeseeable future has us all wondering what is going to happen to Troy's largest and oldest employers.

Avitar assessments for view tax: These is a lot of controversy surrounding the assessed valuation of the view tax and other assessed valuation of homes, land and mobile homes. Are these unjustified assessments? Does a house with a nice view enhance the value of a home? We are currently evaluating if the appropriate amount is being properly assessed.

The Environmental Protection Agency (EPA) is in the final phase of the investigation with the water/sewer department. The town employees and town officials have complied and cooperated to the fullest extent to try and resolve this matter. Everyone is working hard to get a resolution surrounding this controversial issue.

The Rockwood, Troy Mills landfill has been deemed by the EPA to have serious environmental concerns pertaining to the amount of "Varsol" (a type of petroleum cleaning fluid) seeping into the test wells at the dump site. More studies are being done and different options are being looked at.

The Sand Dam recreational area is going to receive a new building for food service and equipment storage near the ball field. The old recreational building will be torn down.

Department of Environmental Services (DES) has tested the Sand Dam area for pollutants including water, sand and soil. All levels tested were well within normal limits. The water samples for bacteria for the summer programs tested well also.

STATE OF NEW HAMPSHIRE
TOWN WARRANT

To the inhabitants of the Town of Troy, in the county of Cheshire in said State, qualified to vote in town affairs, you are hereby notified to meet at Troy Elementary School, the 12th day of March, next at 10:00 AM in the forenoon for balloting upon matters specified in Articles 1 and 2, listed below, and you are hereby further notified to meet at the Troy Elementary School on Saturday, the 16th day of March at 10:00 AM to act upon the remainder of the listed warrant.

ARTICLE 1. To bring in your vote for one Selectman for three years and other Town Officers elected by ballot as passed by Town Meeting or State Statute for the specified number of years.

ARTICLE 2. Are you in favor of the adoption of **Amendment No. 1** as proposed by the Planning Board for the Troy Zoning Ordinance, as follows:

To delete individual district references to Bed and Breakfast Establishments, and place the language in Article III, General Provisions (Article III, R.)

Are you in favor of the adoption of **Amendment No. 2** as proposed by the Planning Board for the Troy Zoning Ordinance, as follows:

To remove the restriction on fast food or drive-through restaurants in the Village District (Article IV, A.6).

Are you in favor of the adoption of **Amendment No. 3** as proposed by the Planning Board for the Troy Zoning Ordinance, as follows:

To make clear that conversion of single family homes permitted by special exception in the Village District may be converted into two-family or multifamily apartments (Article IV, B.2). (Conversions into mixed commercial and residential are already permitted.)

Are you in favor of the adoption of **Amendment No. 4** as proposed by the Planning Board for the Troy Zoning Ordinance, as follows:

To add restaurants and other eating establishments to the list of permitted uses in the Highway Business District (Article VIII).

Are you in favor of the adoption of **Amendment No. 5** as proposed by the Planning Board for the Troy Zoning Ordinance, as follows:

To add to the permitted uses in the Industrial District any use authorized in the Village or Highway Business District (Article X).

Are you in favor of the adoption of **Amendment No. 6** as proposed by the Planning Board for the Troy Zoning Ordinance, as follows:

To reorganize Article XIII, Board of Adjustment, and add language that addresses new standards by which a variance is judged (based on a January 2001 NH Supreme Court case) as follows:

- I. The zoning restriction as applied to his/her property interferes with his/her reasonable use of the property, considering the unique setting of the property in its environment;
- II. No fair and substantial relationship exists between the general purposes of the zoning ordinance and the specific restrictions on the property; and
- III. The variance would not injure the public or private rights of others.

Are you in favor of the adoption of **Amendment No. 7** as proposed by the Planning Board for the Troy Zoning Ordinance, as follows:

To add a minimum of 600 square feet to the creation of a conversion apartment (Article XIII, D.2.).

Are you in favor of the adoption of **Amendment No. 8** as proposed by the Planning Board for the Troy Zoning Ordinance, as follows:

To increase the penalty for violations of the zoning ordinance from \$100 to \$275 per day, consistent with changes to the applicable statute (Article XIV,F).

Are you in favor of the adoption of **Amendment No. 9** as proposed by the Planning Board for the Troy Zoning Ordinance, as follows:

To add a definition for "unregistered vehicle", as follows: **Vehicle, Unregistered** - A motor vehicle that does not have the proper vehicle plate registration by the State of New Hampshire in order to operate on public roads.

ARTICLE 3. To see if the Town will vote to raise and appropriate such sums of money as may be necessary to defray the following expenditures:

ARTICLE 6. To see if the Town will vote to raise and appropriate the sum of one thousand five hundred dollars (\$1,500) to purchase a computer for the selectmen’s office. Recommended by the Selectmen and the Budget Committee.

ARTICLE 7. To see if the Town will vote to raise and appropriate the sum of three thousand five hundred dollars (\$3,500) for appraisal software. Recommended by the Selectmen and the Budget Committee.

ARTICLE 8. To see if the Town will vote to authorize the treasurer, with the approval of the selectmen, to appoint a deputy treasurer, RSA 41:29-a, and to raise and appropriate one thousand dollars (\$1,000) to fund this position. Said deputy shall be sworn, shall have the powers of the treasurer, and may be removed at the pleasure of the treasurer. Recommended by the Selectmen and the Budget Committee.

ARTICLE 9. To see if the Town will vote to raise and appropriate up to the sum of five thousand dollars (\$5,000) for repairs to the town clerk/tax collector's office and equipment replacement form a plumbing leak January 10, 2002. Reimbursement from NHMA property/liability insurance will cover all but the \$1,000 deductible which will come from general taxation. Recommended by the Selectmen and Budget Committee.

ARTICLE 10. To see if the Town will vote to raise and appropriate the sum of five thousand dollars (\$5,000) to paint the town hall. Recommended by the Selectmen and the Budget Committee.

ARTICLE 11. To see if the Town will vote to raise and appropriate up to the sum of one hundred ten thousand dollars (\$110,000) to purchase a new ambulance and authorize the withdrawal of forty thousand dollars (40,000) from the Capital Reserve Fund created for that purpose. The balance of up to seventy thousand dollars (\$70,000) is to come from Troy Ambulance Service, Inc. This ambulance is dedicated for use by Troy Ambulance, Inc. In accordance with the contract between the Town of Troy and Troy Ambulance, Inc. Recommended by the Selectmen and the Budget Committee.

ARTICLE 12. To see if the Town will vote to raise and appropriate the sum of eighteen thousand dollars (\$18,000) for the care of the cemeteries and authorize the withdrawal of seventeen thousand five hundred dollars (\$17,500) from the Cemetery Trust Funds created for that purpose. The balance of five hundred dollars (\$500) is to come from general taxation. Recommended by the Selectmen and the Budget Committee.

ARTICLE 13. To see if the Town will vote to raise and appropriate the sum of six thousand eight hundred ninety-eight dollars (\$6,898) for the town's share for the regional prosecutor. Recommended by the Selectmen and the budget Committee.

ARTICLE 14. To see if the Town will vote to raise and appropriate up to the sum of twenty seven thousand dollars (\$27,000) to purchase a 2002 Ford Crown Victoria police cruiser and authorize the withdrawal from the Police Department Capital Reserve created for that purpose. Recommended by the Selectmen and the Budget Committee.

ARTICLE 15. To see if the Town will vote to raise and appropriate up to the sum of thirteen thousand dollars (\$13,000) to refurbish the 1997 Ford Crown Victoria police cruiser and authorize the withdrawal from the Police Department Capital Reserve Fund created for that purpose. Recommended by the Selectmen and the Budget Committee.

ARTICLE 16. To see if the Town will vote to raise and appropriate the sum of one thousand two hundred sixty dollars (\$1,260) to be placed in the Fire Department Capital Reserve Fund. This sum to come from fund balance (surplus), the amount received from the sale of the 1971 Ford truck (34-M4), at the State of NH Surplus Property Auction, may 19, 2001, no amount to be raised by taxation. Recommended by the Selectmen and the Budget Committee.

ARTICLE 17. To see if the Town will vote to raise and appropriate the sum of twenty thousand dollars (\$20,000) for sand sealing new pavement on town roads. Recommended by the Selectmen and the Budget Committee.

ARTICLE 18. To see if the Town will vote to raise and appropriate up to the sum of forty thousand dollars (\$40,000) to purchase a 2002 Ford F350 with plow and authorize the withdrawal of up to (\$32,100) from the Highway Department Capital Reserve Fund created for that purpose. The balance of (\$7,900) to come from the sale or trade-in of the 1994 Ford F350. Recommended by the Selectmen and the Budget Committee.

ARTICLE 19. To see if the Town will vote to raise and appropriate the sum of forty two thousand one hundred eighty four dollars (\$42,184) which will be received from the Highway Block Grant from the State of New Hampshire during 2002 for the maintenance, construction, and reconstruction of class IV and V highways. Recommended by the Selectmen and the Budget Committee.

ARTICLE 20. To see if the Town will vote to raise and appropriate up to the sum of ten thousand dollars (\$10,000) for monitoring/installation of additional wells on Dort Street subsequent to the gasoline spill at the highway garage 07/17/2000. Recommended by the selectmen and the Budget Committee.

ARTICLE 21. To see if the Town will vote to raise and appropriate up to the sum of forty thousand dollars (\$40,000) to purchase scales and site work for the Transfer Station/Recycling Center and authorize the withdrawal from the Landfill/Recycling Expendable Trust Fund created for that purpose. Recommended by the Selectmen.

ARTICLE 22. To see if the Town will vote to raise and appropriate up to the sum of two thousand five hundred dollars (\$2,500) for the purchase of transfer station bags and authorize the withdrawal from the Landfill/Recycling Expendable Trust created for that purpose. Recommended by the Selectmen and the Budget Committee.

ARTICLE 23. To see if the Town will vote to raise and appropriate up to the sum of thirty thousand dollars (\$30,000) for the construction of a recreational building at the Sand Dam War Memorial and authorize the withdrawal from the Samuel E. Paul War Memorial Expendable Trust created for that purpose. No funds would be expended to construct a new building if the Town does not own Sand Dam. Recommended by the Selectmen and the Budget Committee.

ARTICLE 24. To see if the Town will vote to raise and appropriate the sum of two hundred sixty thousand eight hundred ninety five dollars (\$260,895) for the Water/Sewer Department operations. Income comes from collections of water and sewer rents. Recommended by the Selectmen and the Budget Committee.

ARTICLE 25. To see if the Town will vote to raise and appropriate the sum of sixty thousand dollars (\$60,000) to bring Olsen Road in compliance with Department of Environmental Services, Wetlands Bureau standards and to authorize the issuance of not more than \$60,000 of bonds or notes in accordance with the provisions of the Municipal Finance Act (RSA Chapter 33) and to authorize the Board of Selectmen to issue and negotiate such bonds or notes and to determine the rate of interest thereon. The annual payment will be from user fees. No amount to be raised by taxation. Recommended by the Selectmen and the Budget Committee. (2/3 Ballot Vote Required)

ARTICLE 26. To see if the Town will vote to establish an Expendable Trust Fund pursuant to RSA Chapter 31:19-a for the Water Department for

the purpose of maintenance and operation purposes of the water facilities including buildings, equipment and water lines and to raise and appropriate up to the sum of four thousand five hundred dollars (\$4,500) from Water Department Savings Account established under Article 28 of the March 1988 Town Warrant. No amount to be raised from taxation. This will close out the Water Department Savings Account established in 1988. Furthermore, to appoint the Selectmen as agents to expend from this fund. This fund to be entirely funded by user fees. Recommended by the Selectmen and the Budget Committee.

ARTICLE 27. To see if the Town will vote to establish an Expendable Trust Fund pursuant to RSA Chapter 31:19-a for the Sewer Department for the purpose of maintenance and operation purposes of the sewer facilities including buildings, equipment and sewer lines and raise and appropriate up to the sum of three hundred eighty thousand dollars (\$380,000) from the Sewer Department Savings Account established under Article 28 of the March 1988 Town Warrant. No amount to be raised from taxation. This will close out the Sewer Department Savings Account established in 1988. Furthermore, to appoint the Selectmen as agents to expend from this fund. This fund to be entirely funded by user fees. Recommended by the Selectmen and the Budget Committee.

ARTICLE 28. To see if the Town will vote to raise and appropriate the sum of sixty thousand dollars (\$60,000) to purchase a dimmutator and for electrical repairs to the Wastewater Treatment Plant Headworks building and authorize the withdrawal from the Sewer Department Expendable Trust Fund created for that purpose. Recommended by the Selectmen and the Budget Committee.

ARTICLE 29. To see if the Town will vote to raise and appropriate the sum of sixty thousand dollars (\$60,000) for legal fees and authorize the withdrawal from the Sewer Department Expendable Trust Fund created for that purpose. Recommended by the Selectmen.

ARTICLE 30. To see if the Town will vote to raise and appropriate the sum of seven thousand nine hundred dollars (\$7,900) for the water/sewer department to purchase the highway department's 1994 Ford F350 truck and to authorize the withdrawal from the Sewer Department Expendable

Trust created for that purpose. Recommended by the Selectmen and the Budget Committee.

ARTICLE 31. To see if the Town will vote to rescind Article 21 from the March 11, 1992 town meeting which restricted the use of landfill user fees and recycling fees for expenditures for the purpose of capital projects, emergency repairs and closing the landfill. Such revenue was accounted for in a special fund known as the Landfill Capital Fund. Recommended by the Selectmen and the Budget Committee.

ARTICLE 32. To see if the Town will vote to adopt the provision of RSA 31:95-c to restrict the use of revenue from recycling fees, for the purpose of Transfer Station/Recycling Center expenditures. Such revenue and expenditures shall be accounted for in a special revenue fund to be known as the Transfer Station/Recycling Center Special Revenue Fund, separate from the general fund. Any surplus in said fund shall not be deemed part of the general fund accumulated surplus and shall be expended only after a vote by the legislative body to appropriate a specific amount from said fund for a specific purpose related to the purpose of the fund or source of the revenue. Ballot vote required. Recommended by the Selectmen and the Budget Committee.

ARTICLE 33. To see if the Town will vote to raise and appropriate the funds listed to be donated to each organization as specified:

We have audited the general purpose financial statements of the Town of Troy, New Hampshire as of and for the year ending December 31, 2001, and have issued our report thereon dated January 31, 2002.

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the general purpose financial statements are free of material misstatement.

The management of the Town of Troy, New Hampshire is responsible for establishing and maintaining an internal control structure. In fulfilling this responsibility, estimates and judgments by management are required to assess the expected benefits and related costs of internal control structure policies and procedures. The objectives of an internal control structure are to provide management with reasonable, but not absolute, assurance that assets are safeguarded against loss from unauthorized use or disposition, and that transactions are executed in accordance with management's authorization and recorded properly to permit the preparation of general purpose financial statements in accordance with accounting principles generally accepted in the United States of America. Because of inherent limitations in any internal control structure, errors or irregularities may nevertheless occur and not be detected. Also, projection of any evaluation of the structure to future periods is subject to the risk that procedures may become inadequate because of changes in conditions or that the effectiveness of the design and operation of policies and procedures may deteriorate.

In planning and performing our audit of the general purpose financial statements of the Town of Troy, New Hampshire for the year ended December 31, 2001, we obtained an understanding of the internal control

structure. With respect to the internal control structure, we obtained an understanding of the design of relevant policies and procedures and whether they have been place in operation, and we assessed control risk in order to determine our auditing procedures for the purpose of expressing our opinion on the general purpose financial statements and not to provide an opinion on the internal control structure. Accordingly, we do not express such an opinion.

We noted certain matter involving the internal control over financial reporting and its operation that we consider to be reportable conditions under standards established by the American Institute of Certified Public Accountants. Reportable conditions involve matters coming to our attention relating to significant deficiencies in the design or operation of the internal control over financial reporting that, in our judgment, could adversely affect the Town of Troy, New Hampshire's ability to record, process, summarize, and report financial date consistent with the assertions of management in the general purpose financial statements.

TAX COLLECTOR RECORDS

Observation

As part of our audit, we obtained the tax collector's report. We noted that the cash receipts reported o the tax collector's report did not reconcile to the treasurer's receipts. The tax collector prepared the tax collector report (form MS-61) using the computer generated reports. However, the computer balances were not reconciled on a regular basis. The cash receipts remitted to the treasurer were actually greater that the remittances on the tax collector's year end report by approximately \$11,500. As a result, not all of the deposited cash receipts have been accounted for.

Implication

State laws and regulations provide strong internal controls over the tax collection function. Compliance with these controls is demonstrated by the reporting function. Failure to reconcile the underlying date for reporting purposes greatly increases the risk that errors may occur and not be detected.

Recommendation

We recommend that the tax collector periodically reconcile his records within his department and with those of other Town officials. Accurate financial reports should be completed at year end.

A material weakness is a condition in which the design or operation of one or more of the internal control components does not reduce to a relatively low level the risk that misstatements in amounts that would be material in relation to the general purpose financial statements being audited may occur and not be detected within a timely period by employees in the normal course of performing their assigned functions. Our consideration of the internal control over financial reporting would not necessarily disclose all matters in the internal control that might be reportable conditions and, accordingly, would not necessarily disclose all reportable conditions that are also considered to be material weaknesses. However, we believe that the reportable condition described above is not a material weakness.

We also noted other matters involving the internal control structure and its operation that we have reported to the management of the Town of Troy, New Hampshire in a separate letter dated January 31, 2002.

This report is intended for the information of management and the Board of Selectmen. However, this report is a matter of public record, and its distribution is not limited.

ANIMAL CONTROL

During the year 2001, over 190 complaints regarding both domestic and wild animals were handled. The Town of Troy employs a part-time Animal Control Officer. When this officer is unavailable, police officers respond to these complaints

Effective January 1, 2002, long-time Troy Animal Control Officer, Alan 'Sonny' Grimshaw retired from service. Sonny gave the Town of Troy many years as their ACO. It takes a special person to be the ACO. The individual needs to have a love of animals. The ACO is required to use their own vehicle, not only to respond to calls but to pick up stray, injured and even dead animals and transport them to the appropriate destinations. The ACO is on-call all the time. The ACO position is not a highly compensated one. Most ACO's have full-time jobs elsewhere as their primary source of income. This makes it difficult to have the ACO available at times when you need them.

I would like to publicly thank 'Sonny' for his years of service to this community.

We are in the process of filling the vacant ACO position. Kim Smith, the ACO for the Town of Fitzwilliam has been offered the position. Kim will handle the ACO responsibilities for both towns and brings with her, experience, a good work ethic and a professional approach to handling animal complaints and concerns.

We realize that animal complaints, especially barking and roaming dogs, are quality of life issues. We attempt to handle these calls as quickly and efficiently as possible.

**COMMUNITY FOREST FIRE WARDEN
AND
STATE FOREST RANGER REPORT**

Your local Forest Fire Warden, Fire Department, and the State of New Hampshire division of Forests and Lands cooperate and coordinate to reduce the risk of wildland fires in New Hampshire. To help us assist you, contact your local Forest fire Warden or Fire Department to find out if a permit is required before doing ALL outside burning. Fire permits are mandatory for any open burning unless the ground where the burning is to be done (and surrounding areas) is completely covered with snow. Violations of RSA 227-L:17, the fire permit law and the other burning laws of the State of New Hampshire are misdemeanors punishable by fines up to \$2000 and/or a year in jail. Violators are also liable for all fire suppression costs. Open burning is a privilege, NOT a right. Help us to protect you and our forest resource! Build small brush piles that can be quickly burned and extinguished.

New Hampshire experienced over 940 wildland fires in 2001. Most of the fires were human caused. Due to dry conditions fires spread quickly impacting more than 20 structures. TROY CONSERVATION COMMISSION

This past year has been a very busy and active year for the Troy Conservation Commission. It is our sincere desire to continue to expand our work in this coming year for the residents of Troy.

During the year 2001, the Troy Conservation Commission sponsored two (2) town cleanup days. One in May and the second this past September. Both were most successful and we would like to thank all of the volunteers and local businesses that contributed to the effort. Additionally, last April the Troy Conservation Commission sponsored a "Troy Fishing Derby" for children. Over seventy (70) children participated and prizes were awarded to all participants. We plan on continuing this event with a second annual Fishing Derby next April.

The Troy Conservation Commission also sponsored a discussion, followed by questions, regarding the proposed Route 12 by-pass with NH-DOT representatives in late May and with NH DES representatives in August regarding water quality. We are continuing the conservation with a proposal to NH-DOT regarding a "Thoreau Trail" beginning here in Troy and leading to Mount Monadnock. Keep an eye on future Troy Town News for updates!

We planted a lilac at our Town Library and with the help of Troy Elementary School students, planted additional "wildlife shrubs" at the school to continue the development of a wildlife garden.

Finally, we have been keeping current with town issues regarding growth and development. Members of our commission have assisted with wetland analysis requests and reviewing site plans for possible development.

This coming year we hope to increase our support to the various Troy Town Committees and Troy Elementary School conservation projects. As always, you are most welcome to attend our monthly meetings (usually held the last Tuesday of each month at 4:30 in the Town Library - check The Troy Town News' calendar).

GAY-KIMBALL LIBRARY 2001 LIBRARIAN'S REPORT

The Gay-Kimball Library continued to grow in 2001. The efforts of the staff, volunteers, and trustees have contributed to a year of achievement. The following statistics are indicative of the high priority we place on public service:

- Materials circulation surpassed 19,000.
- The number of patron visits totaled 11,571.
- We borrowed 262 items via interlibrary loan for our patrons.
- We loaned 539 books to other NH libraries.
- Patrons used library computers 1,170 times.
- Town organizations utilized the meeting room 125 times.
- 153 new borrowers registered.
- Library open hours expanded 18%

In 2001 the Library greatly increased programming. We held 78 events for children, including story and craft sessions, game nights, class visits, a drama group, and a career exploration workshop. Forty children attended our Halloween costume party, and 75 children participated in our summer reading program, capped off by a live puppet performance funded in part by a grant from the state library.

We also expanded our adult programming. We held 20 events for adults, including a book discussion series funded by a \$650 grant from the New Hampshire Humanities Council. In December sixty people attended our annual Holiday Party, which featured ensembles of Troy musicians.

The Library owes much of its success to the dozens of volunteers who support its smooth functioning. Kathleen Marrotte and Darcy Doyle spearheaded fundraising efforts. John Gove maintained our computer network. Judy Mentzer, Lynn Smith, and Bernadette Quinn were faithful evening volunteers. And the library trustees -- Marilou Bisaccio, Gus McLeavy, and Bernadette Quinn - dedicated their time and talent to the care and progress of the Library.

TROY HERITAGE COMMISSION

Several significant happenings marked the Heritage Commission calendar in 2001.

The Heritage Commission Speaker Series began on March 28th and continued on April 11th and May 16th. The first speaker, David Proper, addressed "Lucky Terry Smith: Singer of History." Judith Moyer, well known U.N.H. Professor, led a lively program "Number Please: Predial Telephone Operators." Tom Burack, a talented Concord attorney, presented a Chautauqua type program "An Evening with John James Audubon." All three speakers were well attended by area Troy residents. These events were funded by a \$525.00 grant from the NH Humanities Council.

On June 8th, the Heritage Commission and Troy Elementary School experienced the first "Hike for History." This was a school wide event which enabled each grade level to visit 5 or 6 historic sites in town. Older students acted as historians at each site.

On July 28th, the Heritage Commission table at the Craft Festival featured an exhibit "Troy Crafts of Yesterday and Today."

On September 12th, we had an opportunity to showcase the proposed National Register Historic District when we hosted a guided tour for the Cheshire Walkers.

Throughout the year we have continued to distribute "Troy, the way it was" and "Troy, NH: A New Hampshire Mill Town."

We have continued work on documenting the Village Cemetery and organizing a large number of photos by Lynn Smith. Thanks to Chet Priest and Jay Blanchard for their work completing many much needed repairs.

Much progress is being made toward completing our application to the National Register for Historic District designation. Our financial goal was realized in May when we received a \$1400 grant from the Putnam Foundation Badger Monadnock Fund. Thanks too, to the many Troy residents who have made financial contributions to this effort.

The last Heritage Commission event of 2001 was "Carols on the Common" on December 16th. This festive gathering of Troy residents and friends welcomed the Christmas season. This event was cosponsored with the Troy School PTO and Bridge of Joy.

INDUSTRIAL DEVELOPMENT AUTHORITY

The Industrial Development Authority (IDA) has maintained an active Internet web site during the calendar year 2001. The web page about Troy at <http://www.town.troy.nh.us> provides a broad spectrum of information about our Town, including direction to businesses in Troy, historical and travel information and the text of articles from the Troy Town News each month. A count of "hits" or calls to read the web site shows as many as 50 per day with subject interests spread uniformly. You are welcome to contribute material to be included in the web site.

The IDA has created and updated a census of businesses - the number of Troy currently stands at about 90. Troy residents are urged to be mindful of the many businesses offering goods and services conveniently here in our Town. The IDA has provided information and directions to businesses interested in management procedures and prospects for business expansion, calling for advice from local agencies. The reorganization of Troy Mills is expected to bring new enterprises to the mill property, and the IDA stands ready to work with these developments.

Long term planning continues, focusing on the improvement of business in Troy through the attraction of the village for tourists. The IDA supports the project for the restoration of our historic railroad depot - a central element in building this attraction. It is expected that contracts for the restoration work can be undertaken with completion in 2002.

MONADNOCK ADVISORY COMMISSION

The Monadnock Advisory Commission is charged by the State of New Hampshire under RSA 258:1 to advise and guide the Department of Resources and Economic Development (DRED) on the management of their lands and leased lands of the Society for the Protection of New Hampshire Forests (SPNHF) and the Town of Jaffrey. The lands are located on Mount Monadnock, Gap Mountain and Little Monadnock Mountain (Rhododendron State Park).

The main focus of the Commission this year, as it was last year, is the creation of a new Master Plan for Monadnock State Park. A Steering Committee, composed of many members of the Advisory Commission, as well as others from the surrounding towns, have been very busy, dedicated and focused on delivering a plan that will maintain a level of vitality for Monadnock and the entire region.

The future health of the Park and the surrounding open lands rests in the hands of all that use the resources. Respect for the land is critical. Recognition of our role as stewards of the land is equally critical. To that end the former Eaves property, located on the eastern slope of Monadnock, a parcel of some 220 acres, was purchased by the Forest Society in late spring. This acreage now fills in the gap that has long been outstanding in its relationship to surrounding conservation land and enhances a goal of contiguous open space.

It is an historic source of inspiration and great memories and continues, as such, for the 132,000 people who visited this year. More importantly, the small and large mammal population including moose, bear, bobcat and deer have staged a tremendous comeback to the area, due in part to the management practices of the SPNHF, the great work of the State Park Rangers and more private land remaining open using conservation easements.

MONADNOCK FAMILY SERVICES

As you know, Monadnock Family Services is active in your community, providing quality mental health services to anyone who needs them regardless of their ability to pay. As part of this mission, we feel it is important to let you know the extent of our work, and are pleased to give you the enclosed census report which outlines services provided to residents in your town during 2000-2001. Over the past year, MFS provided services to over 3,800 adults, children and older adults, of which 135 were residents of Troy.

Once again, MFS is asking for your financial support to help underwrite the cost of services we provided to the uninsured and underinsured individuals in your town. Based on the figures from the 2000 population estimates from the NH Office of State Planning, we are asking for the equivalent of \$1.25 per capita, which for the town of Troy, amounts to \$2,453.

We ask for your consideration and support of the .25 per capita increase in our request. MFS has not increased its request to towns for many years. However, the cost to MFS to serve the uninsured has increased steadily with rising treatment costs and more people seeking subsidized services. The cost of serving the uninsured and underinsured residents of the Monadnock Region has averaged a half a million dollars annually for the past three years. United Way funds and town subsidies cover about a third of this significant expense. Our services to uninsured adults are further jeopardized as state regulations prohibit us from supplementing non-funded or under-funded services with state funds.

Your ongoing support of our work is deeply appreciated, and we hope that our partnership in caring for the residents of Troy will continue. We work very hard to keep our costs down, and to identify, whenever possible, alternate sources of funding for this population.

In addition to the census report, materials are on file in the Selectmen's Office describing the services we provide.

Again, your support is very important to us. By working together, we help to insure our communities remain healthy and vital places to live, work and grow.

TROY POLICE DEPARTMENT

2001 proved to be a year that will be remembered forever. The tragic events of September 11th provides a haunting reminder of just how precious life is and how we sometimes need to put things in our lives and in our community in perspective.

For those residents not familiar with the Troy Police Department, we are a department comprised of three full-time Police Officers (including myself), four part-time Police Officers, a part-time Secretary, and a part-time Animal Control Officer.

In the fall of 2000, the Town of Troy partnered with the Towns of Swanzey, Chesterfield, Walpole and Sullivan in hiring a Regional Prosecutor to assist in handling the ever-increasing case load of adult and juvenile criminal cases. Attorney John Vorder Brugge served in this capacity until November 1, 2001 when he resigned to take a similar position in Hanover. Money was a key factor in his decision as he was offered thousands of dollars more. The Regional Prosecutor concept has been very valuable to us. It helped in reducing the amount of time our police officers have to travel to Keene to handle court cases and increased the amount of time our officers were available to patrol the Town of Troy. One can also see the merits of having a trained attorney go head to head with defense attorneys during court proceedings. A search was launched to identify a competent replacement and as of this writing, (1/16/02), a conditional offer has been made to an individual. It is believed our new Regional Prosecutor will begin on or about February 1st.

The following is a brief overview of notable improvements to the Police Department and to the Town. We re-established the police bicycle patrol program. Our department made several informative presentations to community members and groups including the 55-Alive Program, for drivers over the age of 50, and Home and Personal Safety and Security programs. Our officers attended numerous professional development and advanced training programs to help us stay on the leading edge of law enforcement technology and concepts. I have become actively involved in several county and state law enforcement committees and I believe this involvement will help benefit the Town of Troy. We worked closely with the New Hampshire DOT to get improved signage along Route 12 in our continuing efforts to keep our roadways safe. We also continued our

involvement with the Skate Park Committee. Our goal is to help coordinate funds and efforts to provide a recreational activity that can be enjoyed by many of our youths. The Troy Police Department believes strongly in being a 'team player'. We have continued to work harmoniously with other Town Departments to improve the quality of life in Troy. This past year we developed a new schedule that improved the overall police coverage of the Town. We were successful in acquiring an Intoxilizer to use during DWI investigations. Having this unit at the PD saves officers significant amounts of time during DWI investigations. Instead of having to drive the subject to Keene and performing tests at another local police agency, the officer can do it at our own PD. This also will benefit other local agencies that do not have an Intoxilizer, such as Fitzwilliam. This past Spring we secured a grant for a hand-held thermal imager and subsequent training with the unit. This was obtained through the federal government with absolutely no cost to the Town of Troy. The unit and training is valued at approximately \$20,000. This unit has a host of applications for Troy PD use. It was used by one of our officers in the middle of the night to locate a bleeding and unconscious man who had collapsed along an area near the old railroad bed. Due to the complete darkness and area where he was lying, he couldn't be spotted with a conventional flashlight.

I would also like to briefly touch on a few significant criminal matters that the Troy Police Department handled during this past year. We arrested 3 fugitives who were wanted by other states for serious drug offenses and for several violent crimes. Our officers conducted a drug investigation at a residence on the Common and we executed a search warrant and marijuana and 116 hits of LSD were seized. We also had a successful resolution to a barricaded subject incident at a local residence.

I am very proud to be a member of The Troy Police Department. Troy is fortunate to have caring and conscientious personnel in their Police Department. I would like to thank each and every one of our officers and support staff for their work ethic and job performance.

I encourage members of the community to get to know their police officers. Stop in to the station, ask questions, and learn what we do. I

think it is important for us to have a partnership with the community we serve. I think you'll like what you see and hear. Our officers help keep Troy a safe community to reside in and to do business in. It is however, a very busy community with regards to police activities.



During the past year we have delivered a variety of direct services to 419 citizens of Town of Troy. The value of these services totaled **\$299,715**.

These were comprised of Head Start, Women Infants & Children (WIC), Fuel Assistance, Weatherization, Housing, and The Commodity Food Program.

SOUTHWEST REGION PLANNING COMMISSION

The Planning Commission, with a service area covering 36 municipalities in Cheshire, Hillsborough and Sullivan Counties, is one of New Hampshire's nine regional planning agencies established by the State Legislature and the Region's towns. - Assistance in establishing the NH Land & Community Heritage Investment Program (LCHIP)
- Assistance to the Region's towns with local hazard mitigation planning

Fred Lawrence, Water Sewer Commissioner, stated that since Municipalities could borrow up to \$100,000 without it being a bond issue this article could be changed to a loan and the 2/3 majority ballot vote would not be required.

ARTICLE WAS AMENDED TO READ: To see if the Town will vote to raise and appropriate the sum of Twenty-Five Thousand Dollars (\$25,000) for the Olsen Road Project and to authorize the Board of Selectmen to negotiate for a note and to determine the rate of interest thereon. The annual payment will be from user fees. No amount to be raised by taxation.

ARTICLE 31. No amount to be raised from taxation. This will close out the Water Department Savings Account established in 1988. Furthermore, to appoint the Selectmen as agents to expend from this fund. This fund to be entirely funded by user fees. Recommended by the Selectmen and the Budget Committee.

Motion made to pass over indefinitely. MOTION PASSED

ARTICLE 32. To see if the Town will vote to establish an Expendable Trust Fund pursuant to RSA Chapter 31:19-a for the Sewer Department for the purpose of maintenance and operation purposes of the sewer facilities including buildings, equipment and sewer lines and raise and appropriate up to the sum of Five Hundred Thirty Thousand Dollars (\$530,000) from the Sewer Department Savings Account established under Article 28 of the March 1988 Town Warrant. No amount to be raised from taxation. This will close out the Sewer Department Savings Account established in 1988. Furthermore, to appoint the Selectmen as agents to expend from this fund. This fund to be entirely funded by user fees. Recommended by the Selectmen and the Budget Committee.

Motion made to passover indefinitely. MOTION PASSED

ARTICLE 33. To see if the Town will vote to raise and appropriate the sum of Three Thousand Eight Hundred Dollars (\$3,800) for fencing at the Marlborough Road softball field. Recommended by the Selectmen and the Budget Committee.
