*To the Inhabitants of the Town of Epsom in the County of Merrimack in said State, qualified to vote in Town Affairs:*

You are hereby notified to meet at Town Hall in said Epsom on Tuesday, the eighth day of March, next at ten of the clock in the forenoon until six of the clock in the afternoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To see what action the Town will take upon the Budget submitted by the Budget Committee.

3. To see if the Town will raise and appropriate the sum of \$630.16 for the maintenance, construction or reconstruction of Class V Highways, the State to contribute \$4,201.05 as provided in Chapter 83, Laws of 1951 as amended by Chapter 31, Laws of 1953.

4. To see if the Town will vote to authorize the Selectmen to borrow such sums of money as may be necessary in anticipation of taxes.

5. To see if the Town will vote to authorize the Selectmen to distribute the inventory blanks at the time of taking the annual inventory.

6. To see if the Town will vote to raise and appropriate a sum of money for the Concord Hospital to help offset an estimated operating deficit for the year 1955.

7. Pursuant to the provisions of the Laws as revised, Chapter 292, Section 7, 1949. The following Article is submitted: Shall the provisions of Chapter 171-A

of the Revised Laws relative to playing games of Beano be adopted in this Town?

8. To see if the Town will authorize the Selectmen to relocate the Town Dump. Said Dump to be owned, used and maintained jointly by the Towns of Chichester, N. H. and Epsom, N. H.

All expenses and liabilities to be shared equally by both Towns.

9. To see if the Town will vote to discontinue as an open highway and make subject to gates and bars the road leading from Center Hill to Eleanora C. Nutter's residence as provided in Section 2, Part 9, Chapter 188, Laws of 1945 or take any other action relating to said road.

10. To transact any other business that may be legally brought before this meeting.

REPORT OF EPSOM VOLUNTEER  
FIRE DEPARTMENT

For Year Ending December 31, 1954

---

Following is submitted the annual report of the Epsom Volunteer Fire Department.

Total number of calls — 30

With — 2 bad building fires

1 small building fire

4 chimney fires

2 electrical fires

1 car fire

7 wood fires

3 grass fires

3 dump fires

3 false alarms

4 investigations

There were 12 regular and well attended meetings held.

The June meeting was held jointly with the Chichester Fire Department in the form of a field day at Webster Park. There were tug-o-wars for the men and women — rolling pin contests, horse shoe pitching, etc. Rides on the Fire Trucks for the children, water and fire demonstrations and a hose laying contest between the two towns — won by Epsom, whereby we laid 350 feet of hose, laid suction to pond and had water on fire in one minute and 15 seconds — with a five man crew. Everyone was invited and tonic and ice cream were sold at cost to the children. We are looking forward to the continuance of this program to acquaint the people with the Department — its workings and progress.

All the Fire Equipment is now housed in the new Fire Station, which is estimated by contractors and architects to be a \$10,000 building as it now stands — but which the Department has built at a cost of only \$3,500 to the taxpayers — \$800 of the Department's money — \$525 (approximately) generous donations — and a heating plant and installation given by C. N. Huckins which would have cost \$1,200 to \$1,500. The building is 36x60 with three truck stalls and a 21x35 meeting room, complete with toilet, sink, lunch counter and chairs.

There are still two major jobs to be done as well as numerous small things. The major jobs being: insulating the roof over trucks with a great saving of heat and tarring, loaming and grassing the yard. We hope and feel that the taxpayers will furnish the money for the comparatively small cost of these jobs (the Dept. to give the free labor) so they may be done this spring. As Chief of the Department, I want to sincerely thank all the donors, citizens of the town, and members of the Department for their wonderful cooperation in this project.

There has also been added to the Fire Department a communication system at a cost of \$700 (plus donations) consisting of two mobile unit radios and a base station. These have already been used to a great advantage several times. With radio, red network phones, and the siren set up, we feel that the Department's communication system is as good as any of its size in the state.

REPORT OF THE FOREST FIRE WARDEN

---

*Forest Fire Prevention is Everybody's Business*

Carelessness is responsible for 97 percent of all our forest fires. This is a serious indictment of our interest in our own welfare and that of our neighbors. In too many instances this carelessness results in the destruction, not of the careless one's own property, but of someone not even known to him.

Thoughtlessly thrown lighted cigars, cigarettes and matches from moving vehicles by hikers, hunters and fishermen; the careless burning of debris during hazardous periods, high winds or in dangerous locations; improperly extinguished camp or cook fires — all add up to the CARELESSNESS that means serious loss of property, disruption of industry and farm work and unnecessary expenditure of town and state funds.

It points to the need of eliminating CARELESSNESS so far as it concerns fire from our daily life. The rules are simple — your cooperation is earnestly solicited.

1. Be careful with fire in or near woodlands.
2. Be sure that all lighted material — cigars, cigarettes and matches — is completely out before discarding it. Use ash trays in autos.
3. Secure the required written permission to burn from your local forest fire warden when the ground is not completely covered with snow.
4. Insist that others be careful and comply with burning requirements.
5. Call the warden promptly when fire is detected and aid him to extinguish it.

Let's remember that FOREST FIRE PREVENTION  
is EVERYBODY'S BUSINESS and our MOST IM-  
PORTANT undertaking!

Each blow or number of blows is repeated to be sure of count. The code is:

- 1 long blow — Fire Station
- 2 repeated — all east of Firehouse
- 3 repeated — Gossville and Goborough Road
- 4 repeated — Traffic Circle — all west of river
- 5 repeated — Short Falls — East of River
- 6 repeated — New Rye
- 7 repeated — Civil Defense
- 1 short blow "all out"

For members going by Fire Station there is a blackboard at the front with the location of the fire written on it.

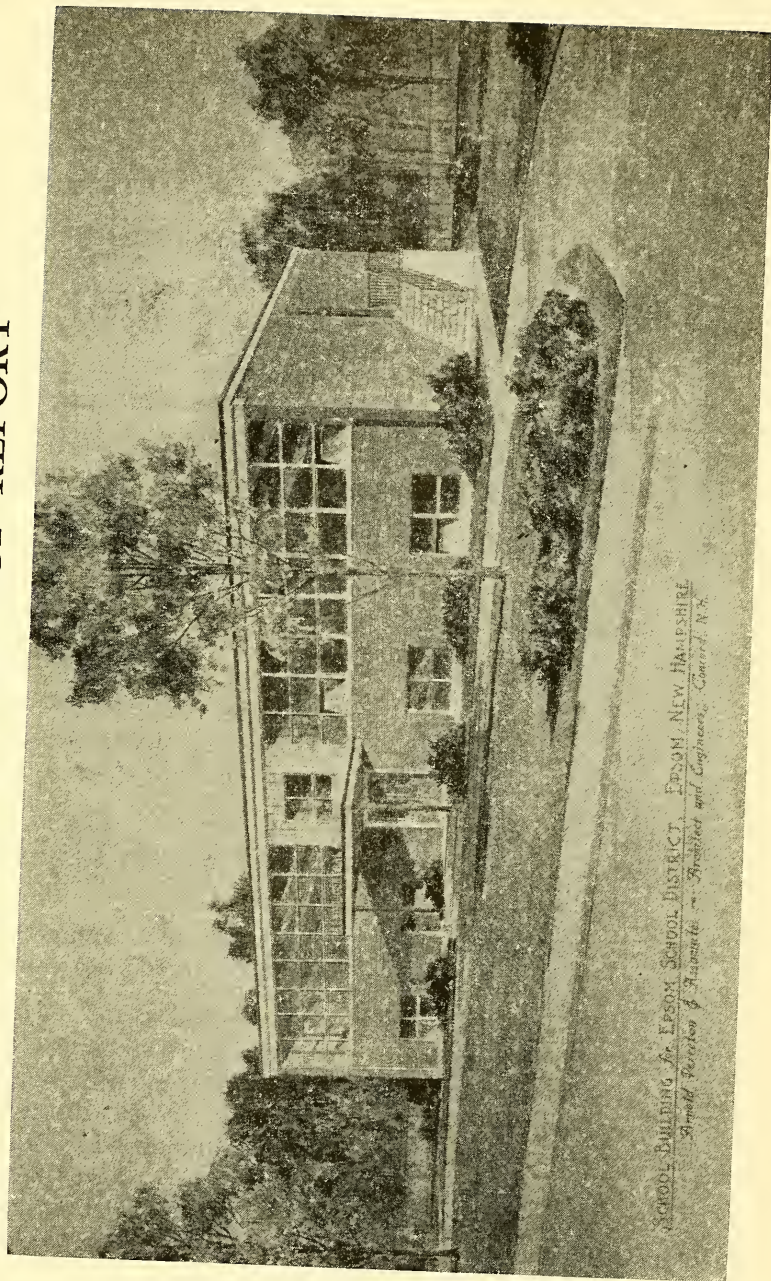

You are hereby notified to meet at the Town Hall in said district on the 5th day of March 1955, at 2 o'clock in the afternoon, to act upon the following subjects:

11. To see if the District will authorize the School Board to dispose of unused school buildings.

12. To transact any other business that may legally come before the meeting.

Miss Myrtle Fletcher, R.N. succeeded Miss Douillette, who left as Epsom School Nurse on account of

duties elsewhere. Mrs. Georgette C. Roy took the place of Miss Coll as first grade teacher in November.

The numbers expected to enroll in the first grade each September are 18 in 1955, 15 in 1956, 23 in 1957, 18 in 1958, and 16 in 1959.

At the annual meeting held March 6, 1954, the School District of Epsom voted to construct and equip a new Central School, and to raise and appropriate the sum of \$67,500.00 for this purpose, \$7,500 from the capital reserve and \$60,000 from bonds or serial notes. The school board engaged Mr. Arnold Perreton of Concord as architect and accepted his plans and specifications for a four-classroom building with a general-purpose room the size of two classrooms, together with supplementary rooms. The general contract was awarded to the successful bidder, Hillsboro Construction Co., Inc. This building is now under construction, on the northwest side of Black Hall Road, on a six-acre lot given by Mr. Robert E. Cutter who also did the preliminary grading (*gratis*). As in any project of this kind, the committee has been constrained to forego some desirable features. However, the essentials of health, comfort, and educational convenience have been maintained. A few more weeks will see the building occupied and classroom activities under way. Mr. Andrews, now teaching upper grades at Short Falls School, has been designated by the school board as principal of the new school.
