THE STATE OF NEW HAMPSHIRE

To the inhabitants of the town of Campton in the county of Grafton in said state, qualified to vote in town affairs:

You are hereby notified to meet at Campton Town House in said Campton on Tuesday, the ninth day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation for same.
3. To see if the town will vote to qualify for state aid for highways under the law passed at the January session 1905 with amendments.
4. To see if the town will vote to raise \$1,890.00 for the permanent improvement of highways for the ensuing year.
5. To see how much money the town will vote to raise and appropriate for trunk line maintenance.
6. To see how much money the town will vote to raise and appropriate for state aid maintenance.
7. To see how much money the town will vote to raise and appropriate for the support of its highways and bridges.
8. To see if the town will vote to authorize the selectmen to hire money to defray town charges.
9. To see how much money the town will vote to raise and appropriate for Campton cemetery, also to clean up and fence other cemeteries in town.
10. To see how much money the town will vote to raise and appropriate for Memorial Day.

11. To see how much money the town will vote to raise and appropriate for the support of the Emily Balch and Soldiers and Sailors Memorial Hospital.

12. To see if the town will vote to discontinue the road in the South East part of Campton, commonly called "The New Discovery Road" from the Evans road, so called, thence in a Southerly direction to the Holderness town line.

13. To see if the town will vote to discontinue the road leading from main highway from Campton Hollow to Campton Village to the George Keniston buildings, so called.

14. To see how much money the town will vote to raise and appropriate for the suppression of the Pine Blister Rust.

15. To see what action the town will take regarding the footbridge at Campton Village: whether they will raise money enough to build, or transfer the \$1,000.00 raised last year to some other account, and pass any vote relating thereto.

16. To see if the town will vote to accept reports of Agents and Officers heretofore chosen.

17. To transact any other business that may legally come before said meeting.

SUPERINTENDENT'S REPORT

Mrs. Chairman and Members of the School Board:

I hereby submit for your consideration my seventh annual report of the Campton schools.

At the opening of the schools in September, all but one teacher were new to Campton. The present teaching force is as follows: Campton Village—Jessie K. Thompson, a graduate of Truro Normal College and has done some summer work at Boston University of Education. (This school was opened in the fall by Edith M. White who resigned on account of ill health;) Lower Village—Charlotte E. Porter, graduate of Plymouth Normal School; Beebe River—primary room, Mildred E. Simpson, and grammar room, Betha E. McAllister, both Plymouth Normal graduates; Livermore Falls—Alice M. Allard, also a Plymouth Normal graduate; Blair—Rose Dearborn, a normal graduate and a teacher of long, successful experience; and the Center School has been supplied by cadet teachers from the normal school.

During the fall term the children from the Branch were transported to the village schools and those of the Bog to Blair. After the Thanksgiving recess, the Branch and Bog Schools were opened with cadet teachers from the Plymouth Normal School. The work of the cadet teachers has been satisfactory. It seems a worth while method of securing efficient service at a comparatively small expense. The cadet teachers are visited frequently by a critic teacher from the Normal school who offers help and gives suggestions so that the work is kept up to a high standard.

Something warm is being served with the school lunches each day during the cold weather. There is no expense to the district for the materials served are contributed by those who participate.

Tests and drills are still continued in the schools as a check on progress and efficiency.

The school census taken in September, reported 100 boys and 84 girls or a total of 184 children in town between the ages of 5 and 16. Of those reported, 146 were registered as members of our local schools, 26 attending high school and 5 elementary schools outside the district, or a total of 168 were reported in school and 16 were reported not in school; viz., 13 between 5—8 years; 1 between 8—14 and 2 between 14—16, in other words, all the children are accounted for and comply with the attendance law.

The medical examination was made by Katherine Ferguson, R. N., of Lincoln. Many defects were reported to the parents which we trust will be considered seriously and corrected if possible for the benefit of the child.

Dr. Cheney has vaccinated the greater part of the unvaccinated children who must, by law, be vaccinated before they may attend school.

The school registers showed the following nine pupils with a perfect record for the year: Martha Adams, Clifton Moulton, Fred Moulton, George Estabrook, Edward Pettingill, Raymond Elliott, Arthur Noseworthy, Fred Willoughby and Frances J. Washburn.

The per cent of attendance was 94.08 with 294 tardy marks—far too many. There were 7 non-resident pupils in the elementary schools and 33 resident pupils attending high school.

The school board members made 13 visits to the schools, the citizens 285 and the superintendent 235.

The major repairs were made at Beebe River by installing chemical toilets. They are proving satisfactory. The school building on Pulsifer Hill was shingled. Much glass had to be set at Beebe River, owing to the maliciousness of boys during the summer.

Three full time transportation routes are maintained; viz., east part of town to Center School, Hildreth Hill to Branch and Beech Hill to Plymouth.

It would seem from what I am able to gather that greater school room facilities will be needed at Beebe River by another fall. If this is true, the preparation for the same should be made during the summer vacation so that the school work may not be hampered in the fall.

I wish to thank all those who have aided in any way to make our schools as efficient as they are and hope that closer co-operation may be effected in the future so that our schools may constantly grow in efficiency.
