

Commissioners' Report

To the Citizens of Grafton County:

Your Commissioners herewith present their report, together with the report of the Sheriff, Solicitor, Clerk of the Court, Jailer, and Auditors and the Superintendent, Physician and Chaplain of the County Farm for the year ending December 31, 1931, and a statement of the financial standing of the County at the close of the year.

During the 1931 session of the General Court of New Hampshire the following act was passed:

An act providing for assistance to aged and dependent persons as follows:

For the more humane care and relief of aged and dependent persons, a system of assistance is hereby established. Such assistance shall be administered in each county by the county commissioners and the cost of such assistance, together with the expense occasioned thereby, shall in the first instance be paid by the county; but the county shall be reimbursed by each city or town legally chargeable for such assistance rendered, together with the expense occasioned thereby.

This act became effective September 1, 1931 and has been granted to nine persons up to December 31, 1931.

Due to the depression, aid required during the present year has exceeded all records. The number taken care of at the Farm has been the heaviest in history and had it not been for the new building it would have been necessary to have taken care of many more outside which would have increased the expense materially. The number assisted off the Farm has been very expensive and after practicing economy to the limit, taking into consideration that we are dealing with human beings, it has been necessary to exceed the appropriation by approximately \$25,000.00.

The Commissioners wish to extend their thanks to Mr. and Mrs. J. Earl Andrews for the faithful and efficient manner in which they performed their duties as Superintendent and Matron of the County Farm.

The Commissioners further wish to extend their thanks to the various county and town officers and all others for their assistance in carrying on the work of the County.

The Commissioners extend to the people of Grafton County and the public in general a hearty and sincere invitation to visit and inspect the Grafton County Farm. The former are especially urged to do so, as it is their farm and an institution in which they alone should be interested.

Selectmen of Town and Overseers of the Poor

Your attention is called to the following extracts from the laws of 1903:

CHAPTER 42, SECTION 1

SECTION 1. Any town or county furnishing any assistance to any person within six years preceding his death shall be entitled to recover from the estate of such persons the sum or sums paid out for such assistance, the said claim to be a preferred claim against his said estate after payment of funeral charges, expense of last sickness and expenses of administration, provided he leaves no widow or minor children living at his decease.

CHAPTER 106, SECTION 1, as amended

"SECTION 1. No town shall be liable for the support of any person unless he, or the person under whom he derives his settlement, shall have wholly gained a settlement therein during the ten years preceding the last date of application for support provided that no person having a settlement in any town in this state upon arriving at the age of seventy years shall lose that settlement on account of being exempt by law from paying a poll tax, if he resides in said town."

ASSISTANCE TO PERSONS IN QUARANTINE: PUBLIC STATUTES, CHAPTER 110, Following

SECTION 6

SECTION 1. Whenever any person or family is placed in quarantine by a board of health, to protect the public against small pox, scarlet fever, diphtheria or any other dangerous, infectious or contagious disease, it shall be the duty of said board to assist such person or family while in quarantine in such manner as in the judgment of the board may be deemed wise and necessary.

SECTION 2. All expenses thus incurred, or such part thereof as the board may determine, shall be

deemed a legitimate expenditure for the protection of the public health and shall be charged to the account of incidental expenses, but not to any indigent pauper account, nor shall such expenditure be construed to mean a public aid to the person or persons so quarantined and assisted unless such person or persons are already paupers as defined by the Public Statutes.

FRED PARKER, Lisbon, N. H.—Bethlehem, Bath Easton, Franconia, Haverhill, Landaff, Littleton, Lisbon, Lyman, Livermore, Monroe, Warren, and present their bills to the commissioners at Woodsville in March and September.

JOHN GADD—Plymouth, N. H.—Ashland, Alexandria, Bristol, Bridgewater, Campton, Ellsworth, Hebron, Holderness, Lincoln, Groton, Plymouth, Rumney, Thornton, Wentworth, Waterville, Woodstock, and present their bills to the commissioners at Plymouth in May and November. If considered advisable, different dates for settlement with towns may be arranged.

All applications for aid should be immediately reported to the commissioners, as under the laws of 1903 no bill will be paid more than 10 days' support previous to the proper affidavit being received. Affidavit blanks will be supplied by the commissioners upon request.

Haverhill, N. H. February 20, 1931.

A meeting of the Grafton County Delegation was held at the County Farm at two o'clock in the afternoon February 20, 1931. The meeting was opened by the Chairman, E. H. Hunter. Upon motion made by Mr. Thayer which was duly seconded it was voted that this meeting be for the purpose of an informal discussion; that no definite action be taken at this time on any important matters. Mr. Pushee made a few remarks on behalf of the Commissioners. Mr. Gadd went over the 1930 report of the Commissioners and outlined the program for the coming two years. Discussion followed.

At this time the Roll Call was taken by the Clerk and the following members were present: Huckins of Ashland, Webster of Canaan, Sanborn of Enfield, Gage of Grafton, Guyer and Hunter of Hanover, Brunelle, Thayer and Wells of Haverhill, Briggs, Eaton and Stearns of Lebanon, Merrill of Lisbon, Harris, Lyster, Lytle and Simpson of Littleton, Burgault of Lyman, Perkins of Lyme, Frazer of Monroe, Eastman of Orange, Renfrew of Orford, Metcalf of Piermont, Bell and Wakefield of Plymouth, Stewart of Rumney, Merrill of Thornton, Little of Warren, Colby of Wentworth and Keniston of Woodstock.

Remarks were made by Mr. Sanborn, Mr. Ross, Mr. Thayer and Mr. Brunelle.

Upon motion made by Mr. Sanborn, which was duly seconded, it was voted that the proposed expenditures for the next two years and the added expenditures of the past two years be placed in the form of a budget to be printed before action at the next meeting. There was a general discussion.

Interesting remarks were made by Mr. Webster and Dr. Miller with reference to an X-Ray machine for the County Farm.

Commissioner Gadd brought up the question of the Town of Plymouth securing a rest room in the Plymouth Court House. On motion made by Mr. Renfrew, which was duly seconded, it was voted that the entire matter be left to the discretion of the County Commissioners with regard to permitting the Town of Plymouth to have a rest room in the Plymouth Court House.

Mr. White, President of the Farm Bureau made a few remarks.

On motion made by Mr. Merrill, which was duly seconded, it was voted that the Chair appoint a Committee on Resolutions consisting of three and the Chair appointed Mr. Ross of Lebanon, Mr. Bell of Plymouth and Mr. Merrill of Lisbon. The Committee brought in the following resolution which was unanimously adopted.

BE IT RESOLVED, That we, the Grafton County Delegation, wish to voice our appreciation for the excellent entertainment and the bounteous dinner served us. We wish also to compliment the Commissioners, also Mr. and Mrs. Andrews, the Superintendent and wife for the thorough manner in which they have conducted the affairs of this institution and the apparent comfort in which we find the inmates, which to us seems to be of paramount importance.

The Minutes of the meeting of March 4th were read.

On Roll Call, the following members were present. Commissioners Gadd, Pushee and Parker were present. Mr. Gadd on behalf of the Commissioners discussed the proposed budget for 1931 and 1932. A discussion followed.

On motion made by Mr. Guyer which was seconded it was voted:

That the County Commissioners be authorized to construct a manure pit and to purchase a milk cooler and an X-Ray Machine in the year 1931 at a total cost not to exceed \$3700.00 and that they be further authorized to purchase in the year 1932 a silo and a truck at a total cost not to exceed \$2500.

The following motion was made by Mr. Ross and duly seconded:

That the sum of \$148,700.00 be and hereby is appropriated for County purposes for the year 1931. This sum to include payment on Building Bonds, Water notes, one serial note of \$4500.00, all interest charges

and the miscellaneous equipment authorized by previous vote.

The following amendment to the motion of Mr. Ross was made by Mr. Thayer and duly seconded:

That \$7000.00 be added to this appropriation for the Farm Bureau and the words added that this shall be the total amount of tax to be raised for the County for the year 1931 in accordance with Chapter 35, Section 5 of the Public Laws of New Hampshire.

The vote on the amendment was in the negative. The original motion offered by Mr. Ross was called for and the vote on this motion was in the affirmative.

On motion of Mr. Ross which was duly seconded it was voted:

That the sum of \$140,700.00 be and hereby is appropriated for County purposes for the year 1932. This sum to include payment on Building Bonds, Water Notes, one serial note of \$4500.00, all interest charges and the miscellaneous equipment authorized by previous vote.

Mr. Lytle offered the following motion which was duly seconded:

That the sum of \$7000.00 be and hereby is appropriated for the Farm Bureau for the year 1931 and that a like sum be appropriated for the year 1932.

There was a discussion on this motion. Amendment to the motion was made by Mr. Ross which was seconded, the amendment being that the amount to be expended be \$5000.00 instead of \$7000. A discussion followed on this amendment. On vote on the amendment the vote was in the negative. Question on original motion of Mr. Lytle. Vote on this motion was in the affirmative.

The following resolution was offered by Mr. Blandin and duly seconded:

Resolved—That it is the desire of the Delegation that their Executive Committee co-operate with the County Commissioners in 1931 and 1932 that every thing possible may be done to make the appropriations cover expenditures.

The vote on this resolution was in the affirmative. On Motion of Mr. Blandin duly seconded it was voted:

That the Executive Committee be empowered to add to their numbers any citizen of Grafton County to aid them in any study of the County Farm they may deem it desirable to undertake.

Concord N. H. March 25, 1931.

The meeting of the Grafton County Delegation was held in Room 157 at one thirty P. M.

Meeting called to order by Chairman Hunter.

The Chairman explained that this meeting was called for the purpose of considering what action the Delegation should take with regard to raising the Commissioners salaries and explained the Commissioners views, and then opened the meeting to an informal discussion of this subject.

On Roll Call, the following members were present: Huckins of Ashland, Plummer of Bristol, Smith of Campton, Webster of Canaan, Sanborn of Enfield, Gage of Grafton, Guyer and Hunter of Hanover, Brunelle, Thayer and Wells of Haverhill, Marden of Holderness, Chandler of Landaff, Stearns of Lebanon, Price of Lisbon, Burgault of Lyman, Perkins of Lyme, Frazer of Monroe, Eastman of Orange, Renfrew of Orford, Metcalf of Piermont, Wakefield of Plymouth, Stewart of Rumney, Merrill of Thornton, Little of Warren, Colby of Wentworth.

The Chairman explained that there was some question about the legality of the assessments against

the towns for the years 1929 and 1930. On Motion of Mr. Price of Lisbon it was unanimously voted that the assessments against the towns for the years 1929 and 1930 for interest on current notes by the County Treasurer and County Commissioners be hereby legalized. A further discussion followed on the matter of Commissioners salaries.

Mr. Price of Lisbon offered the following motion; which was duly seconded: That it is the sense of this meeting that we prepare a bill to be drafted and presented to the Legislature to increase the Commissioners salaries to seven hundred and fifty (\$750.00) dollars per year. The vote on this motion was by ballot.

The result was as follows: Total votes cast 26. Votes in the affirmative 16. Votes in the negative 10.

The following resolution was offered by Mr. Price which was duly seconded and was unanimously adopted: Resolved that it is the sense of the Delegation that the personal expenses of the Commissioners be interpreted strictly as expenses according to law and an itemized statement of the personal expenses should accompany the statement of each Commissioner.

On motion of Mr. Thayer it was voted that the Chairman be authorized to prepare a bill to be introduced in the Legislature providing for the increase in the Commissioners salaries to seven hundred and fifty (\$750.00) dollars per year.



In accordance with Chapter 30, Section 1, Public Statutes, the Superintendent of County Farm shall make up his report to January 1, annually, and also Section 2 of said Chapter requires that the Superintendent's reports shall contain, in addition, a list of paupers actually supported at the Farm and the number of weeks each was supported, also a statement of the average cost per week for each pauper with an explanation of the basis upon which such calculations were made.

The whole number of persons supported and partially supported for the year ending Dec. 31, 1931, was 207. The number of weeks board is ascertained by taking the number of days between the day of admittance and the day of departure of each individual and dividing that number by seven which gives the

number of weeks each was supported.

The whole cost of supporting paupers at the Farm for the year ending December 31, 1931 was \$38,797.42. This sum divided by the whole number of weeks furnished—4696 weeks gives \$8.26 plus, as price per week.

The past year has brought about several changes in our working force, and an increase in number in the Almshouse, especially in the Hospital department. Many contributions, as usual, have been received from our outside friends and were greatly appreciated.

I wish to thank the Commissioners, Chaplain, Physician and Employees for their help and co-operation in

our work for the year.

I submit herewith my report of the clinical affairs of the Hospital for the year ending December 31, 1931.

The hospital has run pretty nearly to full capacity throughout the year. The wise and economical policy of the commissioners in sending to the County's own hospital such cases as would surely become County charges, has resulted in a considerably increased number of major operations and also of obstetrical cases.

Superintendent and Mrs. Andrews have been personally interested in every individual and have kept the hospital on a very high plane for service.

The installation of a modern X-ray outfit has been timely and has demonstrated the wisdom of the County Delegation. In the few months of its use, it has already saved the County about one-sixth of its entire cost.

The hospital is always ready to receive emergency cases, but before they are sent in, one of the commissioners should be consulted whenever possible.

I would gratefully acknowledge the valuable council of the Commissioners, the cooperation of the management, and the assistance of all those connected with the institution.
