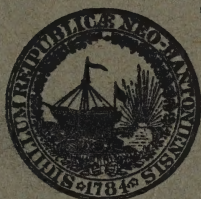

## THE STATE OF NEW HAMPSHIRE

---

To the inhabitants of the Town of Piermont, in the County of Grafton, in said State, qualified to vote in Town affairs:

You are hereby notified to meet at the Town Hall in said Piermont on Tuesday, the 9th day of March, next, at nine o'clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriations of the same.
3. To raise and appropriate money to maintain Highways and Bridges.
4. To raise and appropriate money for the general expense of the Highway Department.
5. To raise and appropriate money to maintain street lights.
6. To raise and appropriate money for the support of Library.
7. To raise and appropriate money for the support of the Fire Department.
8. To raise and appropriate money for the relief of poor and old age assistance.
9. To raise and appropriate money for Memorial Day and choose committees for same.
10. To raise and appropriate money for Town Maintenance of Highways, with State Aid.
11. To raise and appropriate money for Pine Blister Rust Control, with State Aid; the State asks for \$400.00.
12. To see if the Town will authorize the Selectmen to distribute the inventory blanks at the time they examine the taxable property.

13. To see if the Town will authorize the Selectmen to administer or dispose of any real estate acquired by Town through Tax Collector's deeds or otherwise.

14. To see if the Town will authorize the Selectmen to borrow money in anticipation of taxes.

15. To transact any other business that may legally come before said meeting.

It was impossible for us to continue the hot lunch program as in previous years, because no eligible person could be found to do the work on the Federal Aid Plan. Some surplus commodities have been distributed during the fall and winter. These included such things as grapefruit, apples, etc., which did not require cooking.

The percentage of attendance for 1941-1942 was 96.05. This was above the State average.

New reading materials have been added in the primary room. The use of these new books and work-books has added to the breadth of the reading program.

The fact that the town has twenty-three of its students going on to high school is an indication of the continued interest of the pupils in taking advantage of every possible educational opportunity.
