TOWN WARRANT
TOWN OF CARROLL

March 5, 1974

To the Inhabitants of the Town of Carroll in the County of Coos and State of New Hampshire, qualified to vote in the Town Affairs:

You are hereby notified to meet at the Town Hall, Twin Mountain in said Town of Carroll, on Tuesday, the Fifth Day of March next at 7:30 o'clock P.M. to act on the following subjects. The Polls will be open for voting at 10 o'clock in the forenoon and shall not close before six o'clock in the afternoon.

1. Elect the necessary Town Officers.
2. To raise and appropriate such sums as may be necessary for:

3. To see if the Town will vote to authorize the Selectmen and Treasurer to borrow money in anticipation of the collection of taxes, and to issue in the name and on the behalf of the Town negotiable notes therefor.

4. To see if the Town will vote to authorize the Selectmen to administer or dispose of any real estate acquired by Tax Collector's Deeds or otherwise.

5. To see if the Town will vote to except from taxation for the year 1974 the air navigation facility known as Twin Mountain Airport, provided such facility is available for public use without charge and the owner holds a certificate from the N.H. Aeronautics Commission that is necessary for an effective airways system. The property to be exempt from taxation shall include the surfaces maintained and available for take-off, landing, taxiing, open air parking of any aircraft and any navigation or communications facility and any passenger terminal building available for public use without charge pursuant to RSA 72:38 as inserted by 1963 79:2.

6. To see if the Town will vote to raise and appropriate the sum of \$448.74 to be paid over to the White Mountain Community Services.

7. To see if the Town will vote to raise and appropriate the sum of \$431.00 to be paid over to North Country Home Health Agency.

8. To see if the Town will vote to raise and appropriate the sum of \$102.56 on Class IV and Class V Town Road Aid. (The State will contribute \$683.74)

9. To see if the Town will vote to raise and appropriate the sum of \$2,500.00 to be paid over to the Twin Mountain Chamber of Commerce for use in advertising the resources and natural advantages of the Town.

10. To see if the Town will vote to raise and appropriate the sum of \$563.10 and authorize the Selectmen to pay said sum to the White Mountain Region Association for its program of advertising, etc. as part of the cooperative investment by regional towns.

11. To see if the Town will vote to raise and appropriate the sum of \$100.00 to be paid to Ski 93 Associates for advertising the Town of Carroll.

12. To see if the Town will vote to authorize the Selectmen to receive and expend grants or loans which may be available from the State or Federal Government, or both, for any proper municipal purpose and to further authorize the Selectmen to continue their efforts to make and process all appropriate requests for such funds and assistance with proper administrative agencies of the State and Federal Government.

13. To see if the Town will vote to authorize the Selectmen to withdraw the sum of \$7,500.00 from the Revenue Sharing Fund established under the provisions of the State and Local Assistance Act of 1972 for use in expanding and improving the municipal water system and to raise and appropriate as matching funds the sum of \$7,500.00 to be used with such withdrawal from the Revenue Sharing Fund for such use in expanding and improving the municipal water system.

14. To see if the Town will vote to raise and appropriate the sum of \$14,000.00 for the purpose of a backhoe with frontend loader and for this purpose to authorize the Selectmen to borrow upon the note of the Town a sum not in excess of \$14,000.00 at such rate of interest and payable at such time and place in accordance with Chapter 33 of New Hampshire Revised Statutes Annotated and any amendments thereto, "Municipal Finance Act", as the Selectmen shall deem appropriate.

(If the vote on the foregoing Article 14 passes, the following Article 15 shall be passed over. If the vote for the aforesaid Article 14 does not pass, Article 15 is the next order of business.)

15. To see if the Town will vote to raise and appropriate the sum of \$2,500.00 for repairs to and improvements of the Town Recreation area septic system.

16. To see if the Town will vote to raise and appropriate the sum of \$6,300.00 for repairs and improvements to the Town Hall, such repairs and improvements to consist of installation of combination windows, paving the driveway and parking areas and repairs and improvements to the plumbing and heating systems.

17. To see if the Town will vote to affirm the authority of the Selectmen to adopt an ordinance regulating the keeping and control of dogs in the Town of Carroll.

18. To see if the Town will vote to raise and appropriate the sum of \$200.00 as a donation to the support of Alpha House, a group home for boys in Lancaster, serving the needs of boys with family and social problems in Coos and Grafton Counties.

19. To see if the Town will vote to appropriate the sum of \$396.00 as the Town's share for operation of the North Country Council for one year beginning July 1, 1974. These funds will be used for financing staff, office and general operating expenses; regional planning studies; technical assistance to member communities; coordination with local, State and Federal agencies; and other programs of the Council. These funds may be used in conjunction with State and Federal funds available for planning purposes.

20. To see if the Town will vote on restricting any one person from holding more than one elected or appointed Town Office at any given time.

21. To see if the Town will vote to establish a Capital Reserve Fund for the Twin Mountain Snowmobile Club, Inc.

22. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 to be placed in a Town Snowmobile Recreation Fund, said sum to be used for the construction of recreation facilities within the Town of Carroll, New Hampshire, including Snowmobile Trails, barbeque facilities, trail signing, etc., provided that matching funds are obtained from the State of New Hampshire. The above items are to be constructed to the specifications of the Twin Mt. Snowmobile Club, Inc.

23. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 for the improvement of the Town Police Department, such appropriation to be made only if matching funds are obtained from the Crime Commission.

24. To see if the Town will vote to authorize the Selectmen to implement absentee balloting for Town Meeting in compliance with State Law. (These absentee ballots are for Town Officers election only.)

The following is a statement of services from January 1, 1973 to December 31, 1973 rendered to the people of Twin Mt. by our Agency.

The nursing staff made 36 visits to residents of Twin Mountain along with 2 Physical Therapy and 1 Social Service visit. This is a total of 39 visits made to the residents of your town. Coupled with the Child Health Programs and the Expectant Parent Classes this represents approximately \$630.00 in total services to your residents in 1973. Of this amount \$610.00 was charged to town funds. Last year's appropriation was \$309.00 so the remaining \$301.00 was charged to other funds or paid for from donations.

In mid-year we terminated the Social Service component as Federal funds expired for this program. We were able to refer a great number of cases with social problems to other social agencies in the area and utilize other staff members for these services.

This fall we initiated a series of Well Child clinics for this area. They will be held every other month with either Dr. Bishop or Dr. Lewis as the attending physician. Physicals are given by appointment. These are geared to low income families especially those children not under regular medical attention. The age group is primarily birth to 5 years although exceptions will be made in special circumstances. Immunizations and TB tests are available for any child needing them. We plan in the future to include vision and hearing testing and dental screening.

We also held a series of Expectant Parent Classes in November. The people attending received instruction in Child Birth, Diet and Nutrition, Baby Care, Exercises and many basic facts about prenatal care. This series of 5 classes will be run in Woodsville in the Spring and in Littleton in July or August. They will be held approximately three times a year. There was an average attendance of 12 persons at each of the 5 classes with many fathers in attendance. The results were very gratifying. People from Littleton, Lisbon, Bath, Haverhill and Bethlehem attended the classes which were held in Lisbon.

The Nursing and Physical Therapy components of our service are very important to the patients we serve. These services help reduce hospital stays, assist people to return to as high a degree of independent functioning as is possible. They also allow people to recuperate at home in more familiar surroundings and with family

members present. The service also saves money as it is less costly than extended hospital stays.

An example of this would be a 35 year old male patient with Transverse Myelitis, Sacral Decubitus and Neurogenic Bladder. This patient also has Laennec's Cirrhosis. This patient is being seen 5 days a week to treat the decubitus, irrigate the catheter, monitor general condition and supervise diet, medication and cirrhosis. This patient has been on our caseload since May 25, 1973. The total cost of our service for this patient has been \$2,160.00 for that period. Adding \$180.00 a month for housekeeping and food service brings the total cost of maintaining this individual at home to \$3,240.00 Had he been cared for in a hospital it would have cost \$18,000.00 for a comparable period and \$7,200.00 for an extended care facility. As you can see, this represents a substantial savings to whoever is paying the bill. The cost of all these services eventually comes from the tax or public dollar at some level. As you can see, this service is worth at least each dollar asked for from all services.

We are now planning a Homemaker Home Health Aide Program for the area we serve. This program will provide a much needed service for area residents and reduce the cost of providing nursing service to patients.

White Mountain Community Services wishes to request \$448.75 be appropriated at the 1974 Town Meeting. This represents \$1.25 per capita of population, the same amount requested last year.

Demands for our services in your schools, hospitals, and for psychiatric emergencies have increased markedly in the area we serve. Hopefully we will be able to continue to provide these vital, and at times, lifesaving services.

White Mountain Community Services increased its services to your area this year by increasing personnel (additional psychiatrist and psychiatric nurse) to serve at the Weeks Memorial Hospital. Reports to us from the medical and hospital staff of the area acknowledge the help this effort on our part has been to them. We are continuing to consult with school personnel and provide follow-up counselling care. We have been able to help to drastically reduce admissions to the New Hampshire Hospital from your area.

In conclusion, we are grateful to you and your townspeople for their support in the past. We realize no single town among the towns we serve can financially bear the quality and level of mental health services needed and available to all of our citizens through White Mountain Community Services. However, if each town is willing to vote its full share to help defray these costs, then all of our citizens benefit. We need your help and hope you will speak and act in favor of our request.

The past year has seen an upsurge in crime in rural areas, based on figures compiled by the FBI. In our own location I have noted an increase in serious crimes such as burglary, larceny and various violations of the controlled drug law. The surrounding towns also reflect this increase as does Northern New Hampshire. The number of assaults and crimes against the persons has likewise shown marked increase in rural areas.

During the past year numerous situations have arisen in which another full time officer has been needed both to augment myself in serious situations and to provide in depth police coverage. I believe that the addition of another full time officer is of the utmost importance in order to combat the rise of serious incidents within our town. By the addition of this officer the number of hours "On Patrol" could be greatly increased leading to greater visibility of our town's police, in an effort to provide faster, more effective response. The problem of response is also of growing concern to me as the Bretton Woods Complex continues to grow. When the town's cruiser is out of service on a call in the Bretton Woods area it takes some 10

to 15 minutes to get back in the Twin Mt. area should the officer be even the shortest distance from the car. Because of this the town should consider in the near future the purchase of a second car (cruiser) to be used during peak periods. (Research indicates state and federal funding would be available to aid in the purchase of this.) I also believe that extra funds should be available for the expanded use of Special Officers during high traffic periods and to implement a greater security patrol for our town's businesses during high crime hours (Ex. Foot patrol in Twin Mtn., area during evening hours in the summer). The greater use of Special Officers and the addition of a full time officer would further add a measure of safety on the various Emergency First Aid and Transport calls to which the department responds as in such situations one officer is needed to drive while the other administers first aid.

The town's highway safety report showed a slight increase in accidents. However, most of this I attribute to longer and more detailed reporting system used this year. The number of motor vehicle violations was increased considerably and I am currently working on a highway safety project to make our area motorists more aware of the dangers on the highway.

In closing I wish to thank the members of the Board of Selectmen for the assistance extended to me. I would further add the constant upgrading of our Police Dept. is a helpful step in bringing new residents and business to the area as it shows interest in the welfare of our townspeople.

CARROLL PLANNING BOARD

The Carroll Planning Board continued to grow in 1973 becoming involved with many new sub-divisions and especially with the Mount Washington Development Company project at Bretton Woods.

The Planning Board members are as follows: William J. Wright, Chairman; Lee M. Sanborn, Secretary; Dorothy O'Brien, Asst. Secretary, Selectman; Lillian Edelmann, John Asker, Marcel Paquette, Robert Thompson, Herb McGee, Alternate.

The Planning Board has its regular meeting on the first Thursday of each month in the Town Hall at 7:30 p.m. The public is cordially invited to attend these open meetings. The Board is also involved in other meetings on sub-division hearings and with prospective sub-dividers.

In 1973 the Planning Board completed the zoning regulations for District Two which is defined as The Village at Bretton Woods. In late September the Town voted 120 to 69 to approve this new ordinance. We are currently at work on District One, the Village at Twin Mountain, zoning ordinance and expect it to be completed within the next year. We are working with the New Hampshire Department of Comprehensive Planning, Soil Conservation Service, and the Selectmen to cover all aspects of what is needed for our community. A questionnaire is to be published in time for discussion at this year's Town Meeting.

The Mount Washington Development Company took up the majority of our time this year. We approved a 28 townhouse sub-division and a land sales area for 152 lots which are both currently under construction. We have given contingent approval to approximately 200 more lots, 40 forest condominiums, 70 village condominiums, and 33 new townhouses. Approvals are tentative upon New Hampshire Water Supply and Pollution Control Commission's concurrence with water and sewer plans.

The Town of Carroll will continue to grow next year. We of the Planning Board look forward to guiding this growth in a planned and controlled manner to ensure the quality of life for its residents.

WATER COMMISSIONER'S REPORT

TOWN OF CARROLL, N. H.

By-Laws for Carroll Water Department

1. All new water taps must have approval of the Water Dept. as to size of tap, and location of tap. One week prior notice must be given to the water dept. before installation of line, so that one member of the Water Board can be present during installation.

2. Any person turning water on or off without approval of water dept. is responsible for all damages and repair.

3. Any person or contractor breaking the town water main is responsible for cost of repair.

4. One week's notice must be given when asking for water to be turned on or off. This will be done only during regular working hours.

5. All water lines from Stop and Waste Valve to house are responsibility of the property owner—they will be responsible for all maintenance and repair.

6. Any damage to town property (roads, shoulders, etc.) caused by installation of private lines shall be the responsibility of the individual.

7. Approval for use of hydrant must be given by Fire Dept. and Water Dept.

8. All family residences (house or trailer) shall be charged a \$15 fee for the first faucet.

8. During periods of low water the water dept. can control the use of water for outside use. (watering lawns, washing cars, etc.)

Report of White Mountains Region Association for 1973 (36th Year)

Your Region Association, through its promotional and financial responsibilities, was one of the principal organizers of the White Mountains Art and Music Festival. This Festival has been acclaimed as a truly significant contribution to northern New Hampshire and in 1974, with a much larger budget, the program is expected to expand markedly.

Your Region Association also helped to set up the Hotel-Motel training program at the Waumbek, Jefferson, N.H. Because your Association has for many years promoted the region's hotel-motel industry, the directors felt this training program would effectively complement these on-going promotional activities. The responsibilities incurred by your Association were: a questionnaire designed to answer "Is there a need for the program?" and assistance in employing graduates of the program in the region's hotel-motel industry. Additionally, your Association set up meetings with hotel-motel owners and managers to work out any problems and to exchange ideas.

Other activities for 1973 included: completion of a canoe and kayak folder (designed for promotional purposes), a State requested survey of flood damage to the private sector of northern New Hampshire's economy, representation at the Eastern States Exposition in Springfield, Mass., presentation of 4-H awards in Grafton and Coos Counties and annual subscriptions of the 4-H National News Magazine to club leaders, and the annual solicitations of listings for the New Hampshire Accommodations and Dining Directory and the Where to Stay folder. Additionally, your Association's executive director acted as secretary of the N.H. Council of Region Associations, an organization which works closely with the State's Office of Vacation Travel.

Your Association for its 1973 annual meeting set up a panel discussion on the subject of "Wilderness in the White Mountain National Forest." Panelists included representatives of the N.H. Snowmobile Association, the Appalachian Mountain Club, the Society for the Protection of N.H. Forests, Sno-Engineering, the wood products industry in northern New Hampshire, the Sierra Club, the State's Bureau of Off-Highway Recreation Vehicles, the U.S. Forest Service and the North Country RC&D Project, Inc.

With regard to legislated matters your Association supported House Bill relative to Open Space. In large part the directors saw this bill as an attempt to help preserve our farmlands here in the region. Furthermore, your Association supported House Bill #10 relative to Off-Highway-Vehicles with the exception that the majority of directors felt snowmobilers should ask the permission of the land-owners during periods when there is adequate snow cover.

Finally, the executive director spoke on Association activities both on radio and before several chambers of commerce and Rotary clubs in the region.

Inquiries for the year totaled 5,000.

Wrote 27 news releases, 2 newsletters and 140 personal letters.
