

Town Warrant for 1966

THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Kensington in the County of Rockingham in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Kensington Town Hall in said Kensington on Tuesday, the eighth day of upon the following subjects:

March, next at ten of the clock in the forenoon, to act

1. To choose all necessary Town Officers for the year ensuing.

2, To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriation of the same. The Selectmen's estimate of expenditures for the ensuing year is \$35,677.55.

3. To see if the Town wishes to allow a discount on taxes paid within 30 days or 60 days after presentation of tax bills.

4. To vote on the basis of payment and the amount thereof to be paid the Tax Collector for the collection of taxes.

5. To see if the Town will grant the Selectmen authority to borrow money in anticipation of taxes.

6. To see if the Town will vote to authorize the purchase of a new tanker and pumper fire engine and necessary equipment, said engine to meet specification as drawn by the Board of Fire Engineers; and for this purpose, to raise a sum not exceeding Fifteen Thousand Dollars (\$15,000.00) by issue of serial notes of the Town, under and in accordance with, the provisions of Chapter 33 (Municipal Finance Act) of New Hampshire Revised Statutes Annotated as amended, the discretion of fixing the date, maturities, interest rate or discount rate, the place of payment, the form and other

details of said notes to be delegated to the Selectmen.

7. To see if the Town will authorize the Selectmen to sell at Public Auction property obtained by tax deed.

8. To see if the Town will give permission to Richard E. Welsh to re-locate that portion of Round Hill Road now open to the public, at no expense to the Town, all work to be done under the supervision of the Selectmen.

9. By petition of Doris P. Swift and eleven others, to see if the Town will raise and appropriate the sum of Five Hundred (\$500.00) for the improvement of the recreation area.

10. To see if the Town will vote to raise and appropriate the sum of Two Thousand Dollars (\$2,000.00) to remove the existing partition between the large room and Selectmen's room in the Town Hall, remove the front chimney and stoves and install four suspended gas heaters to replace the stoves.

11. To see if the Town will vote to adjourn this meeting to act upon re-recommendations of its Planning Board in regard to subdivision control regulations, to the second Tuesday in May - May 10, 1966.

12. To transact any other business that may legally come before the meeting. Business meeting starts at 7:00 p.m. Polls will close at end of business meeting.

A substantial increase in circulation this year is due in part to the increase in the number of school children in town but there is an ever increasing interest in reading on the part of our adult population. It is particularly gratifying to have so many adult readers ask for books and information on special subjects.

129 books were added to the library during 1965. Of these 60 were gifts and 69 were purchased from town funds. Despite a greater discount under the Co-operative Book Purchasing of the State Library, the increase in the average cost per book has been reflected in the fewer number of books purchased this year.

Early in 1965, the Public Library Trustees voted to have the library join the State-wide Library Development Plan. This has brought many advantages to the small library. Books purchased through the State Book Purchasing Cooperative come with catalog cards — this cuts down on the time taken to process and enter books for circulation. \$125 was made available to the library for the purchase of some much needed reference books. We continue to get fine Bookmobile service and consultant service is available to us. Mrs. Charles

Bickford as chairman of the Public Library Trustees represented us on the District Advisory Council of the State-wide Library Program.

The Friends of the Library, under the chairmanship of Mrs. Andrew Mertinooke, continue to do much for the library. A group of volunteers meets with the librarian on Thursday mornings to help with book processing, cataloging, weeding and other necessary library work. The Friends sponsored the National Library Week activities in April. An open house, special exhibit and film program for the children was held. They have continued the service to shut-ins with Mrs. Harold Smith and Mrs. J. Clark Jacobs making the calls. Anyone wishing to have this service should contact a member of the committee or the librarian.

The library was closed for one week during August for a thorough cleaning and rearrangement of the books on the main stacks. A vacuum cleaner has been purchased for use in the library from the Esther Warner Fund.

The librarian completed her course in Public Library Techniques at the University of New Hampshire this summer and received her certificate at the graduation exercises.

The librarian wishes to thank the Public and Social Library Trustees, the volunteers of the Friends of the Library and the teachers at the elementary school for their cooperation during the past year.

*REPORT OF THE FOREST FIRE WARDEN
AND DISTRICT CHIEF*

Most of us who live in New Hampshire and the thousands of vacationists that visit us every year love the State for the variegated woodlands that encircle our clean lakes and clothe the hills and mountains. Most of us appreciate these values, but still there were enough careless people among us to cause over 880 grass and woodland fires to start in 1965. True this was a much dryer than normal year but this should have meant the use of extra care. Fortunately the fire fighting forces have held the line against such careless acts. It is up to each one of us to be ever mindful that a spark or flame is a potential fire.

WE MUST ALL BE CAREFUL:

1. To teach our children the danger in lighting matches.
2. To never discard lighted smoking material from a car or while walking through fields or woods.
3. To safely dispose of rubbish preferably at the town dump. If you must burn rubbish or brush;
 - a. Always get a permit to burn from the warden.
 - b. Start your fire late in the day after 5:00 p.m.
 - c. If burning a field or brush have equipment and adequate help on hand. The heat from your fire creates its own draft to spread fire.

Our carelessness with fire is costing our State and Towns thousands of wasted dollars in suppression and hundreds of acres of destroyed woodlands. Yours never to enjoy.

The school year 1965 - 1966 opened with the following teaching staff:

Mrs. Evelyn Turner, a graduate of Bates College, replaced Mrs. Helen Pierce as teacher of grade 3; and Mrs. Virginia Holder was employed as the school nurse for the school districts of Kensington, Newfields, Stratham, East Kingston and Greenland. Exeter now employs Miss Shea and Miss Jean as school nurses.

The enrollment as of December 23 was as follows:

It is gratifying to have the State Board of Education and the school districts of Brentwood, East Kingston, Exeter, Kensington, Newfields and Stratham accept the AREA School Plan after several months of study by the AREA Committee. This would appear to be a step forward in the direction of guaranteeing good education for the pupils in grade 7 - 12 in these school districts.

The Elementary and Secondary Education Act of 1965 provides funds for most school districts. Title 2 of the Act provides \$8,000.00 for Supervisory Union 16 to purchase library books and materials and audio-visual materials. These must be shared by all of the schools, both public and private, in the Union. An application listing the materials desired was submitted early in December.

Title 1 of the Act provides funds for approved programs for educationally deprived children for those districts which are eligible. Eligibility is based upon the number of families in a school district whose income was less than \$2,000.00 a year according to the 1960 Census and upon the number of welfare cases for dependent children in 1962.

The school districts of Exeter, Greenland, Newfields and Stratham have had funds made available to them pending the approval of projects. East Kingston and Kensington are not on the eligible list as submitted by the State Department.

A statement by Mr. Frederick King, Teacher Consultant for Supervisory Union 16, on some of the work which he is doing in the area of curriculum follows :

“The function of the teacher consultant is to help schools do their work better. The specific ways in which this service is provided vary widely. Among the activities are included observing and participating in classroom work; helping teachers understand children; interpreting and using the findings of research; helping to prepare curriculum guides; locating and procuring materials for teachers; planning meetings and workshops for in-service education; helping schools ‘pioneer’ in the use of new materials and methods; helping to interpret curriculum change to the staff and the public; and helping to appraise educational programs.

The development of curriculum in many fields of study at the public school level has been dynamic and explosive during the past decade. Science and mathematics are the two most obvious areas of curriculum change. Both have received a great deal of attention in this school system. Educators are now taking a look at the

social studies. It is ironic that the social studies, the area most vitally and directly concerned with social forces and trends, should be one of the last segments of the curriculum to come under careful study throughout school systems.

This fall our teachers spent an afternoon and evening in a workshop designed to acquaint them with some recent developments in the social sciences. A course has been conducted by the University of New Hampshire, another step in the 're-education' of our staff in social studies teaching. A display of books was arranged which included many new reference books in the social studies field.

New ideas and new approaches are plentiful; new instructional materials, including textbooks, are found in quantity and variety. The New Hampshire State Department of Education will soon issue a new guide in social studies. It is my job now to organize the staff in a complete study of the present social studies curriculum; to examine curriculum projects underway in New Hampshire and the country as a whole; and to set up a revised course of study for our pupils based upon the best of the present projects and latest research in this field.

This is not an easy task, and will not be done 'overnight'. Time is an important factor, and this, teachers have in limited quantities after all the rest of their educational activities receive a share. Many discussions, hours of meetings, abundance of ideas on reams of paper, and the slow democratic process of curriculum study will take place before this school district will have a new social study curriculum guide.

This report reflects only one of the areas of work of the teacher consultant - that of curriculum change. This is an important one as it reflects not only what will be taught in our classrooms, but, in many cases, how it will be taught. Certainly this is a responsibility not to be taken lightly."

SUPERVISORY UNION NO. 16 CLASS

To the Superintendent of Schools:

The Union No. 16 class has fourteen members this year, 10 boys and 4 girls. The academic needs of these children are from kindergarten into the sixth grade levels. This is a wide range to be met and taught by one teacher.

Intergration with regular classes of the school in science, physical education, music, art and extra curricula activities is again the policy. Field trips for the younger groups are being used to enrich and to teach community services. The Boy Scout Troop meets regularly each Thursday at the Community Center. Phillips Exeter students are most faithful in handling the boys.

Each year the need for Special Classes is growing. Our children with educational problems should have the opportunity to work out these problems with a degree of success. Unfortunately, these children must meet failure early in school life before help is offered them. Thus, many enter the Union Class emotionally troubled.

The dissimilitude in ages, aptitude and achievement make high standards arduous to maintain. The necessity of much individual support, tutoring, and guidance causes inadequacies and gaps in the educational program. As mentioned in my report of 1965, a part-time assistant, who could work under me, would improve greatly the learning situation.

SCHOOL HEALTH REPORT

To the Superintendent of Schools:

The School Health Service is designed to serve the physical and emotional health needs of all children in the school system - collectively and individually; and to promote an awareness among parents of these needs and of available help through this department.

The School Nurse offers leadership and guidance to the development and maintenance of the health program.

Following are some of the health services included in the Kensington Elementary School Health plan this year: Maintaining individual records of heights, weights, vision and hearing, physical examinations, histories of immunizations and diseases, and any special notes. Vision and hearing testing.

Physical examinations and urinalyses - grade 1, 3, and 5, and all referred. Follow-up of physical examination findings. If parents are not present communications (personal or by letter) must be made. Also, conferences with the Principal and Teachers in relation to physical examinations, visual or hearing losses or other apparent problems.

Referrals for special services - crippled children; sight conservation; hearing; mental health, speech, dental, etc.

In general, Dental Health has been highlighted in the schools through demonstrations, clinics and education. The importance of dietary fluorides for all children up to age 9, has been emphasized. Available if accepted by

a sponsoring organization is a dental hygiene clinic in cooperation with the State Department of Health.

Pre-school clinics.

Speech clinics.

Health Education: through education only, can we expect most favorable returns from our efforts to establish good understanding and practices of health, hygiene, and safety. Available through the State Dept. of Health. The University of N. H., and other sources, are films, filmstrips and various helpful aids to enrich the health education curriculum. We endeavor to present these in conjunction with special class units at a time when our material will be most meaningful to the students.

Our needs are simple but real. The importance of a pre-school clinic for vision screening of children aged 3 to 6 years cannot be overemphasized. An all out effort will be made this spring to promote active community participation in a program for testing vision of very young children. Success here, will depend largely upon the time contributions of 5 or 6 helpers in each community.

May I express my sincere appreciation to the individuals and the organizations who have helped in so many ways to make this a successful and productive year.
