STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Columbia, in the County of Coos, in the State of New Hampshire, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall, on Tuesday, the 12th day of March, next, at ten o'clock in the Forenoon to act upon the following subjects:

1. To vote and bring in ballots for election of Town Officers to be elected by ballot for the Town of Columbia for the ensuing year.
2. To see if the Town will instruct its Selectmen to appoint all other Town Officers as required.
3. To raise such sums of money as may be necessary for the support of the poor for the year ensuing.
4. To raise such sums of money as may be necessary for the Old Age, Blind and Disability Assistance for the year ensuing.
5. To raise such sums of money as may be necessary for the repairs of highways and bridges.
6. To see if the Town will vote to authorize its Selectmen to take such action regarding plowing or otherwise keeping winter roads open in said Town for the year ensuing, as in their judgment seems conducive to the best interest of the Town, and appropriate money for the same.
7. To see if the Town will vote to accept State Aid for Construction of Class V roads and raise and appropriate or set aside for said purpose the sum of \$563.-14, the State to contribute the sum of \$3,754.27.

8. To see if the Town will vote to authorize the Selectmen to apply any surplus remaining in their hands at the end of the fiscal year 1967 to the defraying of Town Charges for the fiscal year 1968 in order to effect a proportionate reduction of the amount to be raised by taxes.
9. To raise such sums of money as may be necessary for the upkeep of cemeteries.
10. To see what action the Town will take with reference to hiring the Colebrook Fire Precinct and the Stratford Fire Department for the purpose of extinguishing fires in said Town, and in the event of favorable action to make necessary appropriation for the same.
11. To see if the Town will vote to authorize the Selectmen to incur debts for temporary loans in anticipation of the Taxes for the ensuing year, and to pay such debts out of tax money when the same is received.
12. To see if the Town will vote to authorize the Selectmen to administer or dispose of any real estate acquired by the Town through Tax Collector's Deeds.
13. To see what sum of money the Town will raise for the support of Town charges for the ensuing year.
14. To see if the Town will vote to raise money for the purpose of uniting with the 45 other Towns in the White Mountains Region Association in publicizing and otherwise promoting the natural and commercial factors upon which the economy of the North Country is based.
15. To see if the Town will vote to authorize the Selectmen to sell the old town truck.
16. To see if the Town will vote to have the Town Hall painted, and in the event of favorable action, to raise money for the same.
17. To see if the Town will vote to contribute to the North Country Community Services, Inc., and appropriate for said purpose the sum of \$441.00.
18. To see if the Town will vote to determine if it is in favor of having a three year term for the Town Clerk,

Town Treasurer and Tax Collector. In the event of a favorable vote, at the next annual meeting, the Town shall choose, by ballot, the mentioned Town Officers for the three year terms.

19. To see if the Town will vote to raise money to join with surrounding Towns for contribution to the Upper Connecticut Valley Hospital Association.
20. To see if the Town will vote to accept the reports of agents, auditors, Selectmen and all other officers, and ratify and confirm the same.
21. To transact any other business which may legally come before the meeting.

You are hereby notified to meet at the Town Hall in said district on Monday, the 12th day of March, 1968, immediately following the Town District meeting, to act upon the following subjects:

1. To choose a Moderator for the ensuing year.
2. To choose a Clerk for the ensuing year.
3. To choose a Member of the School Board for the ensuing three years.
4. To choose a Treasurer for the ensuing year.
5. To determine and appoint the salaries of the School Board and Truant Officer, and fix the compensation of any other officers or agents of the district.

9. To see if the district will vote to authorize the School Board to make application for and to accept, on behalf of the district, any or all grants or offers for educational purposes which may now or hereafter be forthcoming from the State of New Hampshire and/or United States.

10. To see if the district will vote to implement the ballot system for the election of School District Officials beginning with the year 1969-1970 and all ensuing years.
11. To see if the district will vote to authorize the School Board to request, and to accept or reject, any bids on the Church and Cone Schools.

Report of the Superintendent

To the School Board and the Citizens of the School District
of Columbia

FOREWORD

The large school building of the modern city and the little red schoolhouse of the pioneer hamlet are part of our picture of life in the United States. As American as apple pie, the schoolhouse is a symbol of community cooperation for the welfare of children and youth.

What every community needs in its schoolhouse is a structure, and a setting for it, that will make it possible for the community to have the best educational program that today's wisdom can devise, and at the same time to keep the way open for the improved program that the future will develop. Today the immediate need for additional school building in Supervisory Union No. 7 cannot be overlooked. The problem is not so simple, however, as that of merely replacing or extending the school facilities now in use. The more that today's citizens reflect on the demands to be met by the school plant, the more they realize that new schools must be more spacious and must be provided with many more mechanical features than the typical building in use today. This added space and serviceability means added costs. Even without these improvements, costs of construction have risen to such levels that new buildings of the most conservative type are far more costly than any previous schoolhouse construction. And, although added costs must be met, school money remains as difficult as ever to secure.

In this series of dilemmas the school administrator and school boards must exercise their soundest judgement. New buildings must be built; some old buildings must be rehabilitated. The building policies with the help of the school staff, other citizens of the community, and such expert consultative services as are available. They will want to inform themselves on accepted principles

and desirable practices in providing a total school plant that will meet present and future community needs.

Every citizen should see that the school building in his community meet the following criteria:

Curriculum adequacy—do they provide the space and facilities for the educational program that your community needs for its children, youth, and adults?

Safety and well-being—do they not only protect against danger but also provide a positive influence for improving the health and physical welfare of the pupils?

Interfunctional coordination—are they so planned that the activity in each part of a building may be coordinated harmoniously with related activities and may be carried on effectively without disturbing other activities?

Efficiency and ability—are they so planned that the handling of materials and the comings and goings of pupils, school staff, and the public are accomplished with a minimum of interference and a maximum of ease and satisfaction to all concerned?

Beauty—are they pleasing in appearance, with simplicity, usefulness, and balance as ideals, rather than ornamentation or symmetry?

Adaptability—are they so planned that they can be enlarged or rearranged internally to meet new educational demands with a minimum of additional cost?

Economy—are they so planned that in original outlay and in future operation the utmost in educational utility can be secured for every dollar spent?

Each schoolhouse in the nation reflects the degree of concern of each citizen for the welfare of the children in his community.

General

BUDGET :

The School Board's budget for 1968-1969 is \$53,561.00 in comparison to \$52,588.00 for the current year. This amount is decreased by an estimated income of \$27,500.00 which leaves a balance of \$26,061.00, an approximate decrease of 15% in the amount of taxes to be raised by the town.

For the most part, the decrease in the town's appropriation, as will be noted in the budget breakdown, is due to higher estimated revenue in Foundation Aid, and a decrease in Supervisory Union costs.

School Health

The objectives of a school health program are to perform the necessary functions to maintain and promote good health of the pupils in our schools. This contributes to the overall success and happiness of the students and enables them to perform better academically.

Services performed include: pre-school clinics every spring for in-coming first graders; checking height and weight of each student at the beginning of each year; testing vision and hearing of all pupils yearly; physical examinations for all students in grades 4, 8, 11, and athletics; immunizations as necessary; annual skin tests for T. B. in grades 1, 4, 8, 12, and personnel; and continuous supervision of general health.

As in the past two years, a dental health clinic was available to children in the elementary grades. A total of 45 youngsters from the whole union were treated at this clinic.

Generally speaking, the overall program of school health in this area is adequate, but as in all things, there are areas for improvement. It is hoped that by everyone working together these can be realized to the mutual benefit of our students and community as a whole.
