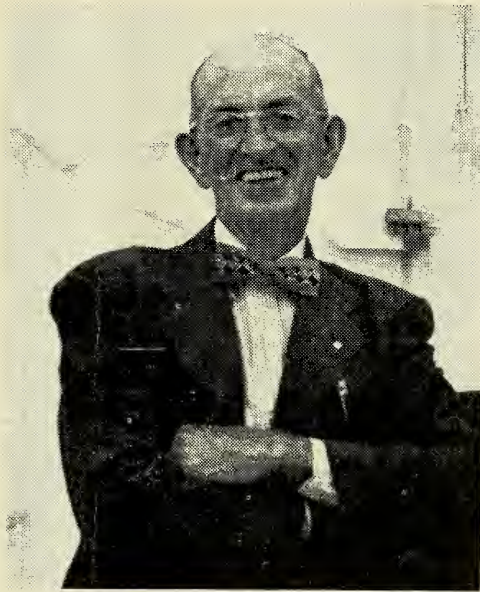



TOWN WARRANT

State of New Hampshire

To the Inhabitants of the Town of Deering, in the County of Hillsborough, in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Deering on Tuesday, the twelfth day of March, next at ten of the clock in the forenoon, to act upon the following subjects:

Article 1. To choose all necessary Town Officers for the ensuing year. —Submitted by Selectmen

Article 2. To see if the Town will vote to raise and appropriate the sum of \$2,500.00 for the Town Officers' salaries and expenses. —Submitted by Selectmen

Article 3. To see if the Town will vote to raise and appropriate the sum of \$150.00 for the elections and registrations. —Submitted by Selectmen

Article 4. To see if the Town will vote to raise and appropriate the sum of \$500.00 for the upkeep of the Town Hall and other buildings. —Submitted by Selectmen

Article 5. To see if the Town will vote to raise and appropriate the sum of \$600.00 for the Police and Fire Departments. —Submitted by Selectmen

Article 6. To see if the Town will vote to raise and appropriate the sum of \$750.00 for insurance. —Submitted by Selectmen

Article 7. To see if the Town will vote to raise and appropriate the sum of \$8,000.00 for summer and winter roads. —Submitted by Selectmen

Article 8. To see if the Town will vote to raise and appropriate the sum of \$851.10 to secure Town Road Aid. —Submitted by Selectmen

Article 9. To see if the Town will vote to raise and appropriate the sum of \$310.00 for street lights. —Submitted by Selectmen

Article 10. To see if the Town will vote to raise and appropriate the sum of \$1,900.00 for Old Age Assistance and Town Poor. —Submitted by Selectmen

Article 11. To see if the Town will vote to raise and appropriate the sum of \$500.00 for interest. —Submitted by Selectmen

Article 12. To see if the Town will vote to raise and appropriate the sum of \$10.00 for Flags for Soldiers' Graves on Memorial Day.
—Submitted by Selectmen

Article 13. To see if the Town will vote to raise and appropriate the sum of \$4,000.00 to complete blacktopping of that portion of the second New Hampshire Turnpike, from near the old School House to Junction of Bennington Road, and that portion of the road leading from Second New Hampshire Turnpike, near River Bridge to Holton's Crossing, all in West Deering. This money is to be raised under Town Road Aid, of which the State of New Hampshire will contribute approximately eighty-five percent, and the Town of Deering approximately fifteen percent, plus interest, such sum to be raised through the issuance of bonds or notes, under and in accordance with the provision of Statutes, and to authorize the Selectmen to issue and negotiate such bonds or notes, and to determine the time and place of payment thereof, under such terms and conditions as they may deem to be the best interest of the Town.

The moneys to complete these roads was appropriated under Article 16, March 1955, but such moneys were used elsewhere in the Town of Deering. These portions of the roads named above have already been prepared for blacktopping, this work having been done in 1954, and the saving to the Town in grading and filling in each year will more than offset the cost to the Town to complete the blacktopping. The Town's Share would approximate to \$600.00, while the State's share would approximate \$3,400.00, and the Town would pay the interest for two years of approximately \$80.00 per year. The completion of this work would serve about twenty families, equally divided with the Road to Holton's Crossing and at the end of Second N.H. Turnpike and Bennington Road.

Article 14. To see if the Town will vote to raise and appropriate the sum of \$25.00 for damages and legal expenses.
—Submitted by Selectmen

Article 15. To see if the Town will vote to raise and appropriate the sum of \$70.00 for the purpose of improving the area around the Deering Reservoir Dam.

—Submitted by Selectmen

Article 16. To see if the Town will vote to authorize the Highway Agent to use a wage scale from minimum, to one dollar and a quarter per hour in hiring labor.

—Submitted by Carroll Greene

Article 17. To see if the Town will vote to adopt a plan for extending to employees of the Town the benefits of title II of the Federal Social Security Act (Old Age and Survivor's Insurance), as authorized by Chapter 101 of the Revised Statutes Annotated Amended by Chapters 301 and 332 of the Laws of 1955 and to raise and appropriate the sum of \$100.00 to defray the town's share of the cost thereof.

A. To see if the Town wishes to exclude from the plan services in any class or classes of positions filled by popular election.

B. To see if the Town wishes to exclude from the plan services in any class or classes or positions the compensation for which is on a fee basis.

C. If a plan for Social Security coverage is adopted, to see if the Town will authorize the Selectmen to execute on behalf of the Town necessary agreement with the State of N.H., to carry into effect the plan and to see if the Town will designate the Board of Selectmen as the officers to be responsible for the administration of the plan.

Article 18. To see if the Town will vote to raise and appropriate the sum of \$3,500.00 for the purpose of purchasing a new truck, (cab and chassis). —Submitted by Selectmen

Article 19. To see if the Town will vote to raise and appropriate the sum of \$1,200.00 for purchasing a wing for the Grader. —Submitted by Selectmen

Article 20. To see if the Town will vote to raise and appropriate the sum of \$150.00 for the purchasing of a new adding machine. —Submitted by Selectmen

Article 21. To see if the Town will vote to authorize the Selectmen to borrow money in anticipation of taxes.

—Submitted by Selectmen

Article 22. To see if the Town will vote to authorize the Selectmen to auction property taken by Tax Collector's Deed.

—Submitted by Selectmen

Article 23. To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations of the same. —Submitted by Selectmen

Article 24. To transact any other business that may legally come before the meeting. —Submitted by Selectmen

REPORT OF THE ANNUAL TOWN MEETING

DEERING, N. H., MARCH 13, 1956

A legal meeting of the inhabitants of the Town of Deering, N.H., qualified to vote in Town affairs was called to order at 10:40 o'clock in the forenoon of March 13, 1956, by the Moderator, Howard Whitney. The warrant was read by the Moderator.

: Upon a motion made by Robert Putnam, it was voted to keep the polls open until 6 p.m., o'clock.

Article 1. Ballots were cast for the officers on the Australian Ballot as follows:

Selectman for 3 years: Stuart Michie had 35 votes; John Griffiths had 76 votes and took the oath of office.

Selectman for 1 year: Harvey Stimpert had 38 votes; Robert Putnam had 75 votes and took the oath of office.

Town Clerk: Irene McAlister had 70 votes and took the oath of office.

Town Treasurer: Irene McAlister had 65 votes and took the oath of office.

Tax Collector: Lillian Murdough had 19 votes; Howard Whitney had 92 votes and took the oath of office.

Highway Agent: Carroll Greene had 103 votes and took the oath of office.

Overseer of Poor: George Wolf had 34 votes; Board of Selectmen had 63 votes and took the oath of office.

Auditors: Marjorie Heath had 84 votes; Eunice Willgeroth had 87 and they each took the oath of office.

Library Trustee: Rosamond Herrick had 66 votes and took the oath of office.

Trustee of Trust Funds: Perley Adams had 1 vote; Edna Yeaple had 88 votes and took the oath of office.

Chief of Police: Charles Williams had 99 votes and took the oath of office.

Police Officer: Harold Wells had 95 votes and took the oath of office.

Surveyor of Wood and Lumber: Everett Abbott had 2 votes; Board of Selectmen had 73 votes and took the oath of office.

Upon a motion made by Robert Putnam it was voted to take up Article 2 at 11 o'clock.

Article 2. Upon a motion made by Robert Putnam it was voted to raise and appropriate the sum of \$3,000.00 for the Town Officers' salaries and expenses.

Article 3. Upon a motion made by Robert Putnam it was voted to raise and appropriate the sum of \$400.00 for the elections and registrations.

Article 4. Upon a motion made by George Wolf it was voted to raise and appropriate the sum of \$400.00 for the upkeep of the Town Hall and other buildings.

Article 5. Upon a motion made by Robert Putnam it was voted to raise and appropriate the sum of \$500.00 for the Police and Fire Departments.

Article 6. Upon a motion made by George Wolf it was voted to raise and appropriate the sum of \$750.00 for insurance.

Article 7. Upon a motion made by George Wolf it was voted to raise and appropriate the sum of \$1,500.00 for winter and \$5,000.00 for summer roads.

Article 8. Upon a motion made by Robert Putnam it was voted to raise and appropriate the sum of \$851.10 to secure Town Road Aid.

Article 9. Upon a motion made by George Wolf it was voted to raise and appropriate the sum of \$310.00 for street lights.

Article 10. Upon a motion made by Robert Putnam it was voted to raise and appropriate the sum of \$1,750.00 for Old Age Assistance and Town Poor.

Article 11. Upon a motion made by George Wolf it was voted to raise and appropriate the sum of \$400.00 for interest.

Article 12. Upon a motion made by Edna Yeaple it was voted to raise and appropriate the sum of \$10.00 for Flags for Soldiers' Graves on Memorial Day.

Upon a motion made by Robert Putnam it was voted to take up Article 13 immediately after lunch.

Article 14. After a discussion of the article, upon a motion made by Irene McAlister it was voted to dismiss the article to raise and appropriate the sum of \$70.00 to the Monadnock Region Association.

Article 15. After a discussion of the article, upon a motion made by Irene McAlister it was voted not to raise and appropriate the sum of \$300.00 for the purpose of finishing the

dining room in the upstairs of the Town Hall. Upon a motion made by Marie Wells it was voted to have the moderator appoint committees made up of two members from each organization to consider the finishing of the dining room.

Upon a motion made by Robert Putnam it was voted to recess for lunch until 1:30 p.m.

Article 13. Upon a motion made by Chester Durell it was voted not to raise and appropriate the sum of \$4,000.00 for completing the black topping of a portion of the town road. A standing vote was asked for. 45 yes. 15 no.

Article 16. Upon a motion made by Robert Putnam it was voted to buy a sand-spreader.

Article 17. Upon a motion made by Marie Wells it was voted to raise a sum not to exceed \$300.00 to pay for the sand-spreader.

Article 18. Upon a motion made by Rosamond Herrick it was not voted to increase the salary of Clerk and Treasurer. Upon a motion made by Robert Putnam it was voted that salaries of Town Officers remain the same.

Article 19. Upon a motion made by George Wolf it was voted to authorize the Selectmen to borrow money in anticipation of taxes.

Article 20. Upon a motion made by Robert Putnam it was voted to authorize the Selectmen to auction property taken by Tax Collectors Deed.

Article 21. Upon a motion made by Marie Wells it was not voted to raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.

Resignation of Richard Savage as Civil Defense Director was read by Robert Putnam.

It was voted to adjourn without date.

SUPERINTENDENT'S REPORT

HILLSBORO-DEERING COOPERATIVE

To the School Board and Citizens of Hillsboro and Deering:

Again, I am happy to have the opportunity to present, for your consideration, my third annual report.

As you know, since last May our school has been operating under very difficult conditions due to the construction program. It has not been easy for the teachers, the administration, the custodians or the pupils. However, it is our hope that by the middle of April this will all be behind us and the remainder of the school year will be spent utilizing our new facilities to the best advantage.

Due to the construction program it was necessary to obtain quarters for three elementary classes outside of the school and the new armory was made available to us by the Governor and Council. Former General John Jacobson, Mr. Elwin Phelps and Mr. Ralph K. LaRose have been extremely cooperative in helping us obtain these very adequate facilities.

The new building program has not progressed as fast as we would like to have seen it, but in many instances it was not the fault of the contractor. Mid-summer strikes in several areas delayed delivery of key items and the local labor market at times presented problems. Our Architect, Mr. Irving Hersey, was extremely helpful in expediting materials and has supervised the job at regular intervals. We have received many fine compliments on the building and feel that you will be pleased with the finished product. A financial accounting to date will be found elsewhere in the school report.

As was anticipated, the income of the state was sufficient to provide the School Building Aid program and being a Cooperative School District we received 40% of our bond payments for 1956 which amounted to \$8,000.00. Much to our surprise we were advised in September that we would receive \$1,364.04 in state aid this year. Therefore our amount to be raised by taxation was reduced that much. However, due to the increase in taxable property in Hillsboro during this past year we do not anticipate that we will be eligible for any state aid for the year 1957-58.

Each year, I am forced to advise you that cost of school operation is increasing. However, I assume that you find the same thing be true of your personal expenses. You may be interested to know that a report of high school costs from the State Department of Education shows Hillsboro-Deering's cost per pupil to be \$319.27. We were 51st from the top out of 79 schools. The high was \$1,217.94, the low \$184.06, the median \$341.46, and the average \$376.54. However, another report showing teacher's salaries indicated that we compared favorably with schools of our size but that our maximum salary for teachers is low.

Again this year, our budget will call for an increased appropriation. More than 50% of this increase is due to additional teachers which you were advised four years ago would have to be hired this year. As we look to the future it appears that our budgets will continue to increase and the only possible relief from direct taxation to finance the schools is a state aid program which would make a sizable contribution. This cannot be done under the present tax structure.

As you know, plans for the new construction were drawn and contracts let prior to the announcement of the coming of Sylvania and the reopening of the Woods' Mill. There has been some question in our minds as to the adequacy of our planning because of this new industry and we have wondered what the impact would be upon the schools. At this writing it appears that most of our growth has taken place in the elementary school and with the exception of the fourth grade there has been no problem. Both sections have thirty-one pupils registered, which is a little higher than we like to see it. However, it seems that any new need for school house construction will be in direct proportion to future home construction in the community.

There are four active cooperative school districts in the state all comprised of two towns with the exception of one which has three towns. In all probability there will be legislation adopted at this session of the General Court which will make it necessary for not less than three towns to cooperate in the future. The underlying reason for this is that it is difficult to obtain enough pupils from two small schools to provide the type of a program that the cooperative was intended to provide.

Cooperatives are going to get a "shot in the arm" when the State Department of Education adopts what is called, "A Framework for Secondary Education in New Hampshire." This program is an effort on the part of the State Board to raise the standards of education in New Hampshire. It will make it very difficult for the small high school to continue in operation, thus the reason so many small communities are studying the possibility of cooperating.

Although much of the work in Hillsboro has been tied to the building program during the past year, it has been an interesting year and much has been accomplished. The Citizens of Hillsboro have been wonderful in adjusting to the many problems with which they have been presented and my many thanks for their patience.

May I also express my appreciation to the School Board members from both Hillsboro and Deering. Your cooperation with each other and with me has been exemplary of what a group can do when working for a common purpose.

SCHOOL NURSE'S REPORT

To the Board of Education:

I am submitting an account of the school nursing work for the year 1955-56.

The Pre-School Registration for next September took place in school as in previous years, with both teachers of first grade present, 42 registered.

Late September we had a very mild case of Polio, a boy in the third grade. This boy was not vaccinated against the disease in the spring at our clinic in school. It proved to be a mild case, and non-paralytic. Nevertheless, it was a positive case, and our Board of Health Officer here in town was provided with Gamma Globulin from the State Board of Health Department in Concord. This was given to 28 pupils, all those who came in contact with the boy, either in the classroom, including his teacher, or on the bus. This took place October 5. On October 11 all the children who had their first shot of the Salk Anti Polio Vaccine in the spring, received their second shot. The Gamma Globulin is not a vaccine, it is given only to those in contact, and the protection lasts only four to six weeks. Fifty-nine from Hillsboro-Deering and four from Stoddard received their second shot of Salk vaccine. On February 9, 1956, we had a very large Anti Polio Clinic in school, for everyone from one year through fourteen and pregnant mothers. We had two local doctors in attendance, four registered nurses besides the State Nurse and myself, six ladies as assistants. 262 from our school were vaccinated, this took practically all of the nine grades, 106 pre-school and 6 adults. No reaction recorded.

We have the T.B. Patch Test Clinic in our school every two years and were due for the clinic in the spring of 1956. This includes pupils from the 7th grade through the 12th grade but this year, for a special reason, I felt that a general survey throughout the school was in order. On March 17 we held a T.B. Patch Clinic in school for everyone from the first through the twelfth grades. They were patched on Monday, de-patched on Wednesday, and read again on Friday for possible reactors. Those reactors as all the Seniors, regardless, plus fourteen teachers, the secretary, the ladies in the cafeteria (3 of them), thirty-one out patients referred to me by their physicians were chest X-rayed on April 27. All

reports were forwarded to me, and not one positive T.B. found.

A large number of pupils were taken by me to the Ophthalmologist for eye refraction in Concord and Manchester. The Lions Club paid for at least four pairs of eye glasses for needy ones.

The hearing test was given to a limited number of pupils, 173. No new cases of defective hearing were found. The same four with loss of hearing from one ear have had all that can be done, they have repeatedly been taken to Otologists and nothing more can be done.

We had some impetigo, not too many cases, and very few cases of pediculosis, all of them were taken care of very promptly. We also had a large amount of German Measles, especially in the lower grades.

Forty-six pupils in Grammar School and thirty-seven in Junior High and High School received nursing care in one form or another. Several were taken to the Doctor's office for X-ray and for minor injuries.

Free lunches were provided by the school to seventeen pupils also half-price to nine others. Thanksgiving dinners were paid for by me for eleven pupils with Salvation Army Fund. Christmas dinners to seventeen pupils paid with left over money from the Lions Club Christmas check to me for Christmas dinners for needy ones. I also paid half-price lunches for two boys after they lost their home by fire for the remainder of the school year with money from a special fund.

I have reported to school daily after lunch, and in the forenoon when called for emergency.
