You are hereby notified to meet at the Town House in said Ellsworth on Tuesday, the 8th day of March, next at 10 of the clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary Town Officers for the year ensuing.
- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
- 3. To see how much money the town will vote to raise and appropriate for the support of Highways and Bridges.
- 4. To see if the town will vote to qualify for T. R. A. and raise and appropriate \$72.90 for same.
- 5. To determine and appoint the salaries of the town officers and make appropriations of the same.
- 6. To see if the town will vote to support the White Mt. Regions Association and raise and appropriate \$8.90 for same.
- 7. To see how much money the town will vote to raise and appropriate for employees' Social Security.
- 8. To see how much money the Town will vote to raise and appropriate for support of the Town House.

- 9. To see if the town will vote to install a telephone at the Town Clerk's residence and raise and appropriate the necessary amount for same.
- 10. To see if the town will vote to authorize the Selectmen to borrow money in anticipation of taxes.
- 11. To see what wages the town will vote to pay for Highway labor.
- 12. To transact any other business that may legally come before said meeting.
