State of New Hampshire

To the Inhabitants of the Town of Brookfield in the County of Carroll in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Town Hall in said Brookfield on Tuesday, the ninth day of March, next, at one of the clock in the afternoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the ensuing year.

2. To see if the Town will authorize the Selectmen to hire a sum of money to pay Town charges in anticipation of taxes.

3. To see if the Town will vote to accept Town Road Aid on Class V Highways and appropriate the sum of \$372.89 as the Town's share.

4. To see if the Town will vote to raise and appropriate the sum of \$1,250.00; \$750.00 for Sanbornville Fire Precinct and \$500.00 for forest fires.

5. To see if the Town will vote to raise and appropriate the sum of \$1,040.00 for use of Sanbornville Dump.

6. To see if the Town will vote to raise and appropriate the sum of \$200.00 for the Gafney Library.

7. To see if the Town will vote to raise and appropriate the sum of \$180.00 for Huggins Hospital.

8. To see if the Town will vote to raise and appropriate the sum of \$395.00 for the Public Health Visiting Nurse Service.

9. To see if the Town will vote to raise and appropriate the sum of \$100.00 for the Carroll County Mental Health Service, Inc.

10. To see if the Town will vote to raise and appropriate the sum of \$200.00 for the Lakes Region Association.

11. To see if the Town will vote to raise and appropriate the sum of \$3,000.00 for oiling roads.

12. To see if the Town will vote to transfer the sum of \$2,000.00 to the Capital Reserve Fund.

13. To see if the Town will vote to withdraw \$1,805.00 from the Capital Reserve Fund for the purchase of a new snow plow and wing.

14. To see if the Town will vote to allow the Selectmen to appoint a committee to supervise renovation of the School House.

15. To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriations for same.
