- 7. To see how much money the town will vote to raise and appropriate for the support and repair of

- 9. To see if the town will vote to authorize the Selectmen to borrow money in anticipation of taxes.
- 10. To see what wages the town will vote to pay for Highway labor.
- 11. To see if the town will vote to accept the report of Agents and Officers.
- 12. To see if the town will vote to establish a bicentennial committee, to be appointed by the Moderator, and further, that the committee be authorzied to prepare for the 200th anniversary celebration of the town in 1969 (by request.)
- 13. To transact any other business that may legally come before said meeting.
