#### SELECTMAN'S REPORT FOR 1978

Harts Location is one of 26 "<u>unincorporated places and unorganized towns</u>" in the State of New Hampshire. Only two of these twenty-six are towns. Towns have charters. The two towns are Harts Location, Carroll County and Ellsworth in Grafton County. Each of the two towns has selectmen; the 24 unincorporated places do not. In fact, five of these twenty-four, all of them in Coos County, have no inhabitants at all.

The state's Deptartment of Revenue Administration is responsible for property evaluation in each of these 26 places and towns. Our evaluations were updated by the Department during 1976 and 1977 and are currently on the basis of 100% evaluation. Evaluations prior to the current one did not have the advantage of being based on a state-made map of the complete and accurate land holdings of each of the property owners in Harts Location.

The State Tax on unincorporated places and unorganized towns is for schooling the children who live in these towns. There were thirty-two students from five of these places and towns during the 1977-1978 school year. Six of these thirty-two students live in Harts Location. The tax rate is arrived at by the State's consolidating the total number of children in the twenty-one places and towns. Then, the Department arrives - composite cost per \$1000 evaluation, which was \$3.79/\$1000 this year and wn. pplies to each of these towns. The tax rate and your own updated property valuation are the two figures used to calculate your tax to the State.

The County used this Town's State-updated property valuation figure to decide that Harts Location owed Carroll County \$1787 for 1978. Harts Location is in the somewhat unusual and certainly enviable situation of having a modest amount in the Town's bank account. The Selectmen agree that the only way to keep the Town solvent is to calculate each property owner's share, using the County's \$1.40/\$1000 tax rate and each owner's updated property valuation. This is the tax you paid to the Town's Tax Collector. Except for the Town's delinquent payers of their County Tax, the Town has been paid back for the tax money it has already had to pay the County last December for 1978. During the highway construction season in 1978, 1.2 miles of curvey road centered around Nancy Brook were straightened at a total cost to the State of 1.4 million dollars. The \$300,000 contract for the bridge over Nancy Brook and continuing over the railroad just north of the brook crossing have already been let. Remainder of the Rte. 302 straightening north of the Nancy Brook bridge to the corner just south of the Fish residence will be completed in the 1979 construction season.

A trailhead parking space for Davis Path climbers will be constructed on the east side of the new Rte. 302 and just south of the suspension foot bridge over the Saco.

#### SCHOOL REPORT

Harts Location is an unorganized town, which means that it has no school district. Children of school age in unorganized towns go to school in towns which do have school districts. The State's Department of Revenue Administration is responsible for setting the school tax rate for unorganized towns (\$3.79/\$1000 evaluation in 1978), and for collecting the tax.

This year there are six students attending school from Harts Location. Four go to Kennett High in Conway and two go to the Bartlett Elementary School.

#### FIRE WARDEN'S REPORT

There were two fires in Harts Location during 1978. One was a fire in the Varney house on Rte 302. The other was from a campfire that was not completely put out. The Town received help from the Bartlett Fire Department on both of these fires.

The town of Bartlett provides fire protection for Harts Location if a situation arises which we can't handle ourselves. Both the Fire Warden and the Deputy Fire Warden for Harts Location know who to contact if help is needed. Contact either of them, giving type and location of fire if in your opinion they should send for help.

#### MINUTES OF TOWN MEETING

MARCH 14, 1978

The meeting opened at 9:00 a.m. with all eighteen voters present. Moderator pro-tem Robert H. Miller presided until after the election of the new moderator. The warrant was read. It was agreeable to the voters not to read the minutes of the last meeting, since they were in the Town Report. Supervisors of the checklist, Nancy Severino and Linda Richardson counted the election ballots and reported as follows:

- Art. 1 Selectman Robt. Miller 12 G. Ameden 4 G. Morey 1 Moderator - Geo. Holmes 16 Road Agent - Bonnie Cross 15 G. Morey 2 Auditor - Doris Clemons 16 Supervisor of Checklist - B. Cross 14 A. Gendron 1
- <u>Art. 2</u> Motion to accept by Geo. Holmes and seconded by Linda Richardson. Unanimous vote.
- <u>Art. 3</u> Motion to accept by G. Holmes and seconded by Nancy Severino. Unanimous vote.
- <u>Art. 4</u>(a) G. Morey made a motion that we go back to the original system of itemizing the salaries of the town officials. This was so voted.
  - (b) Motion was made by G. Morey and seconded by Lyle Richardson to accept. Unanimously voted.
  - (c) E. Marsters pointed out that the figures in the Treasurer's report of Town expenses did not appear to add up correctly. Lyle Richardson acknowledged that this was correct as he had inadvertantly omitted one item of expenses in typing the report. He went on to say that the total figure was not only correct but had been audited.

D. Clemons made a motion to raise the election expense figure to \$100 this year, since 1978 is a Biennial Election year. The motion was seconded by N. Severino and so voted.

- (d) Motion to accept made by G. Holmes and seconded by L. Richardson. So voted.
- (e) Motion to accept made by L. Richardson and seconded by R. Miller. So voted.
- (f) With regard to the figure of \$1100 for damages and legal expenses, Lyle Richardson pointed out that the Town still owes Lawyer Middleton \$905.55 for legal expenses when Town officials were taken to court. The motion was made by N. Severino to accept this figure and seconded by L. Richardson. So voted.

- (g) Motion made by G. Morey and seconded by R. Miller to accept. So voted.
- (h) Motion made by N. Severino and seconded by L. Richardson to accept the figure of \$50 to cover the first trip of an ambulance when needed in the Town. So voted.
- (j) Motion made by G. Morey and seconded by R. Miller to accept the figure of \$200 for use of the Bartlett dump. So voted.
- Motion made by G. Morey and seconded by N. Severino to accept the figure of \$100 for Town highway maintenance. So voted.
- (m) Motion made by N. Severino and seconded by R. Miller to accept the County Tax figure. So voted.
- (n) It was approved by all the voters that the Town make the appropriation of \$19.78 in 1978 for TRA in order to obtain the amount of \$131.90 from the state for this purpose.

The meeting was adjourned at 11:05 a.m.
