## TOWN WARRANT

---

### The State of New Hampshire

To the Inhabitants of the Town of Warren in the County of Grafton in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the town hall in said Warren on Tuesday, the eighth day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

1 To choose all necessary Town Officers for the year ensuing.

2 To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.

3 To choose Delegate to the Constitutional Convention.

4 To raise and appropriate money to maintain highways and bridges.

5 To raise and appropriate money for snow removal and sanding roads.

6 To see if the town will accept State-Aid for construction on the Class 2 A road, known as the Lake Tarleton road, and raise and appropriate for said purpose the sum of \$1500.00; or will accept State Aid for the construction of Class V roads and raise and appropriate for said purpose the sum of \$237.43.

7 To see if the town will vote to raise and appropriate the sum of \$400.00 for White Pine Blister Rust Control in cooperation with the State Forestry and Recreation Department.

8 To raise and appropriate money for the support of town poor.

9 To raise and appropriate money for town library.

10 To raise and appropriate money to maintain street lights.

11 To raise and appropriate money for Memorial Day.

12 To raise and appropriate money for cemeteries and to pass any vote relating thereto.

13 To raise and appropriate money for support of fire department.

14 To see if the town will vote to raise and appropriate the sum of \$50.00 to repair the water hole at Glenclyff.

15 To see if the town will authorize the Selectmen to sign a contract for a term of ten years with the Public Service of Vermont for ten street lights in Glenclyff, at \$15.00 per light, and to raise and appropriate money for same for the ensuing year.

16 To see what action the town will take in regard to a bonus for Dr. F. J. Kasheta and to pass any vote relating thereto.

17 To see if the town will vote to raise and appropriate money for the celebration of the anniversary of the ratification of the federal constitution by the State, June 21, 1938, and to pass any vote relating thereto.

18 To see if the town will vote to raise and appropriate a sum sufficient to clear up the 1937 deficit, and all or part of the notes held by Frank B. Little.

19 To see if the town will vote to accept Govern-

ment aid for a W. P. A. recreation project and to raise and appropriate money for same.

20 To see if the town will vote to adopt the provisions of the Municipal Budget Act.

21 To see if the town will vote to grant a discount on taxes on real estate and personal property if paid in full, and determine date and percentage for same.

22 To authorize the selectmen to distribute inventory blanks at the time they examine and appraise taxable property.

23 To authorize the selectmen to hire money in anticipation of taxes.

24 To raise and appropriate money for other town charges.

25 To raise the sum of \$56 for Town share of cooperative advertising in the White Mountains Region Association.

26 To transact any other business that may legally come before said meeting.
