## *STATE OF NEW HAMPSHIRE*

To the inhabitants of the Town of Columbia, in the County of Coos, in the State of New Hampshire, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall on Tuesday the 10th day of March, next at ten o'clock in the forenoon to act upon the following subjects:

1. To vote and bring in ballots for election of Town Officers to be elected by ballot for the Town of Columbia for the ensuing year.
2. To see if the Town will instruct its Selectmen to appoint all other Town Officers as required.
3. To raise such sums of money as may be necessary for the Old Age, Blind and Disability Assistance for the year ensuing.
4. To raise such sums of money as may be necessary for the support of the poor for the year ensuing.
5. To raise such sums of money as may be necessary for the repairs of highways and bridges.
6. To see if the Town will vote to authorize its Selectmen to take such action regarding plowing or otherwise keeping winter roads open in said Town for the year ensuing, as in their judgment seems conducive to the best interest of the Town, and appropriate money for the same.
7. To raise such sums of money as may be necessary for the upkeep of cemeteries.
8. To see what action the Town will take with reference to hiring the Colebrook Fire Precinct and the Stratford Fire Department for the purpose of extinguishing fires in said Town, and in the event of favorable action to make necessary appropriation for the same.

9. To see if the Town will vote to authorize the Selectmen to incur debts for temporary loans in anticipation of the taxes for the ensuing year, and to pay such debts out of tax money when the same is received.
10. To see if the Town will vote to authorize the Selectmen to administer or dispose of any real estate acquired by the Town through Tax Collector's Deeds.
11. To see if the Town will vote to authorize the Selectmen to apply any surplus remaining in their hands at the end of the fiscal year 1969 to the defraying of Town Charges for the fiscal year 1970 in order to effect a proportionate reduction of the amount to be raised by taxes.
12. To see if the Town will vote to raise the salary of Town Officers.
13. To see if the Town will vote to repair the Town Hall, and in the event of favorable action, to raise money for the same.
14. To see if the Town will vote to repair the Columbia Bridge, and in the event of favorable action, to raise money for the same.
15. To see if the Town will vote to contribute to the North Country Community Services, Inc., and appropriate for said purpose the sum of \$441.00.
16. To see if the Town will vote to raise money for the purpose of uniting with the 45 other Towns in the White Mountains Region Association in publicizing and otherwise promoting the natural and commercial factors upon which the economy of the North Country is based.
17. To see what sum of money the Town will raise for the support of Town charges for the ensuing year.
18. To see if the Town will vote to accept State Aid for Construction of Class V Roads and raise and appropriate or set aside for said purpose the sum of \$636.81, the State to contribute the sum of \$4,245.43.
19. To see whether the voters will authorize the selectmen to act as a Zoning Commission, or appoint such a Zoning Commission and/or a Board of Adjustment, pursuant to Revised Statutes Annotated, Chapter 31, Sections 63-a, 65 and 66, for the purpose of taking such steps as may be necessary to prepare and present a proposed zoning ordinance in such manner as to permit final action thereon at the 1971 annual meeting of the Town of Columbia.



20. To see if the Town will vote to accept the reports of agents, auditors, Selectmen and all other officers, and ratify and confirm the same.
21. To transact any other business which may legally come before the meeting.

# Report of the Superintendent

---

To the School Board and the Citizens of the School District of  
Columbia

## FOREWORD

The concept of shared services and facilities is increasingly becoming the most practical method by which individual school districts can meet the current demand and challenges of education. The recent ruling by the State Department of Education allowing dual enrollment, a method by which a student in one school district may attend school in another district for the purpose of taking a course or courses not offered in his own school, certainly is a logical step in reducing the demanding cost of education and in the duplication of services and facilities within immediate school districts.

This past year the five school districts comprising Supervisory Union No. 7 agreed to share the costs of a junior and senior high guidance counselor. Students attending school in Colebrook, Pittsburg, and Stewartstown now have available to them the services of a counselor for vocational and college plans, as well as obtaining assistance in securing part-time or summer employment. This position is now capably filled by Mr. Jason Sibulkin, who has had a number of years experience working with young people in a social worker capacity and as an educator in the Colebrook School District.

This year, voters in the towns of Supervisory Union No. 7 will be asked to support the guidance counselor service on a Supervisory Union level. Since no new service may be added to the Supervisory Union budget without consent of the majority of the school districts, as specified in RSA 189:47, voters will be asked to support this service beginning with the 71-72 school year by means of a special article in the current school warrant. It should be noted that the "grace" period allocated to Supervisory Union No. 7 was given with the stipulation that the State Board of Education would re-examine in June of 1970 the services originating from the Supervisory Union office. Realizing that each district is

financially incapable of supporting this service alone, the decision by local school board members to initiate and maintain this needed and worthwhile service until it could be placed on a Supervisory Union level through voter action is to be commended.

The possibility of sharing specialists and creating a quality multi-media center is now being investigated by seven Supervisory Unions in the north country. Designated the North Country Shared Services Project, school districts from North Conway to Pittsburg will be investigating what services, materials and equipment can be feasibly shared at a reasonable cost. These districts now have available to them a shared Central Arts Library which developed out of Project Arise. Each school may now count the books, records, filmstrips, etc. in this library as part of its own library in meeting library standards.

With the ever increasing cost and demand for quality education and services, the concept of sharing, either by local districts or at a Supervisory Union or Inter-Supervisory Union level, certainly appears to present the most practical solution and one that should be earnestly considered and investigated for the improving and expanding of the educational process.

## School Health

---

The purpose of a school health program is to perform the necessary duties to maintain and promote good health of the pupils in our schools.

The following services are performed each year: checking heights and weights, vision and hearing; physical examinations for all students in grades 4, 8, 11, and athletics; T. B. skin tests as recommended by the state T. B. Association; necessary immunizations; pre-school clinics every spring for in-coming first graders; and continuous supervision of general health.

In May, a Lazy-Eye Clinic was held for pre-school youngsters under the sponsorship of the PTA. The response to this clinic was very gratifying and very few youngsters were found to have vision defects.

The overall program of school health in this area is adequate, but there is always chance for improvement. By everyone working together, it is hoped that these improvements can be realized to the mutual benefit of our students and community as a whole.

## School Counselor

---

Guidance is that part of the total educational program which assists the individual student in developing a realistic concept of himself and society and in setting and achieving goals consistent with his potential. The guidance process helps the student to understand his abilities, interests, and special aptitudes; to acquire information about educational and vocational opportunities within a changing society; and to make appropriate adjustments and wise choices.

Guidance is based on the philosophy that no two students are alike. Each has his own pattern of growth. This pattern governs to a large extent the direction and rate of growth for each. The good teacher and counselor will provide the appropriate environment for the unfolding of this pattern.

Guidance is a continuous process which, from the school's standpoint, begins with the child's first contact with the school and continues as long as the school can be of service. This concept indicates that guidance is developmental in nature rather than merely remedial or preventive. Each student needs continuing assistance in assessing previous and present situations and in planning for the future.

Guidance emphasizes assisting students in making their own choices rather than having decisions dictated to them. Guidance is a school-wise responsibility requiring close working-together of teachers, administrators, counselors, and other school personnel. All of this is used upon the cooperative efforts of the school, the home, and the community.

### BUDGET

The School Board has requested for its budget an appropriation of \$67,282.00 for the fiscal year 1970-71. A sum of \$22,625.45 has been determined as estimated receipts, leaving a balance of \$44,656.55 to be appropriated through taxes. This

represents an increase of 7.3%, in comparison to the previous year, 7.90%.

The principal increase is due to the increase in tuition rates. Of the total increase in the budget of \$5,396.00, an increase of \$4,282.00 can be contributed to the increase in tuition. The increase in requested appropriations is also due to the decrease in Foundation Aid received from the State. Additional increases are due to the contribution to the new Central Arts Library, Guidance Service and Supervisory Union apportionment.
