TOWN MEETING - MARCH 10, 1964

The Meeting was called to order at 7:48 P.M.

Article 7. Voted to pass over Article 7 because Town had already voted on Delegate to Constitutional Convention.

Article 8. Voted to pass over as Sweepstakes was on State Ballot.

Article 9. Voted to spend Three Thousand Dollars (\$3,000.00) on Old Meeting House.

Article 10. Voted to close meeting at 8:17 P.M.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

It is with mixed emotions that I submit this, my annual report and as such, the last one ever to be submitted by a Union #14 superintendent. This ends a series of reports which date back to more than forty years, back to the time when Danville first became organized under the supervisory union plan. Serving on your school board at tha' une were Louis M. Griffin, Gertrude T. Kimball, and Ada L. Huntington while Mr. Frederick E. Pitkin was serving as Superintendent of Schools.

Throughout these many years, numerous local educational changes have taken place. One of the greatest occurred in April 1960 when, at a special school district meeting, you voted to build a new elementary school at a cost of approximately \$94,000.00. This was also the year Mr. Robert MacPherson joined Mrs. Beryle Eppich and Mr. Everard Goldthwaite by replacing Mr. Joseph Fowler on the school board. Mr. Thayer D. Wade, who is now Dr. Thayer D. Wade, Superintendent of Schools in Ridgefield, Connecticut, was your superintendent at this important time.

The next major change and probably the greatest to date occurred on June 11, 1964 when you voted to become part of the Timberlane Co-Operative School District. For the first time ever, you now have a voice in choosing the type of secondary education you want for your children. Since, in my report to you last year I strongly encouraged you to take advantage of such an opportunity, I now rejoice with you. In our rejoicing, however, let us not become complacent. We must realize that to create and then to operate an altogether new educational system is a tremendous task, one which will undoubtedly continue to require the total co-operative efforts of everyone concerned. Thus, my final recommendation to you is simply this -- please continue to take an active part in your schools, especially as it pertains to your representation on the co-op school board. It is through the representatives, and through them only that your small voice will be heard -- a voice so vital in determining the kind of education your children will receive.

In closing I want to express my thanks to all the people in Danville who have helped to make my work so enjoyable during the past three years. I wish especially to thank your dedicated school board members and your fine staff. You are indeed fortunate to have such capable people associated with your children's education -- see to it that this good fortune continues!

It is with a degree of sadness that I write this, my last annual report for your town. My association over the past twelve years with Danville has been most pleasant. The co-operation of all with whom I have come in contact, and the interest of all in their junior citizens, have been a source of encouragement and inspiration throughout these years. Please accept my heartfelt thanks for the pleasant memories which I shall carry away with me.

Two more health programs have been instituted during this past year which will undoubtedly bear lasting benefits to the children involved.

First, with the backing and help of Minerva Rivers, R. N., annual physical examinations are being done by Dr. Moore in the first, third, fifth, and seventh grades. This program is sponsored by your P. T. A. at a cost of \$1.00 per child.

Secondly, a federal matching fund dental program has gotten under way, also under the auspices of your P. T. A. We feel that our first clinic has been very successful with 16 children attending. All necessary work was completed on all but one of these.

In the four months since the organization of the District on September 19, 1964, more board business has transpired than Board Members normally experience in a full three-year term. This activity is summarized here. The details of school and budget planning will be discussed at hearings and compiled in a special report prior to the first annual Regional School District meeting. The date of this meeting is still to be established. At this time, it appears that it will be held in late March, or early April.

As of February 3rd, nineteen regular weeklyBoard meetings, countless committee meetings, and five special Board meetings have been held. The heaviest work load has been on the Curriculum, and the Building and Site Committees with their associated staff members. 4. The Building and Site Committee reported:

a. that all signatures on the option-to-purchase agreement for the Little land on the Greenough Road, have been secured.

5. The Board was presented by the Building and Site Committee with the provisional requirements for elementary housing for the 1965-66 and 1966-67 years. These requirements are for a four-room addition to the Academy School, a two-room addition to the Danville School, a general activity room addition to the Pollard School, and a one-room addition to the Sandown Central School, with a recommendation that the Rockwell School be used as a permanent home for the Special Education Program, starting in 1966.

Dec. 17, 1964 Regular Meeting cate a bond issue. The question of the non-contiguity of the Timberlane District was raised in this discussion.

2. The Building and Site Committee reported on the adequacy of all of the present elementary school sites within the District.

3. The Board discussed the provisional space requirements of 134,000 square feet for a 1000 pupil building. Based on current enrollment projections, this would be adequate through the 1970-71 year, on an optimum capacity basis, and probably a year longer on a maximum capacity basis.

4. The Board discussed the adequacy of the statutory debt limit. It was conceded that this limit would not be adequate to cover the provisional space requirements of the proposed 1000 pupil school. In addition the Board conceded it still was faced with another immediate problem of elementary facilities. Various alternative short-range and long-range solutions were discussed.

5. The problem of space requirements vs financial limitations was referred back to the educational consultant.

6. The Board was informed that the Newton School District had voted against having the Newton School Board petition the Timberlane School Board for annexation.

Dec. 30, 1964 1. The Board Discussed estimated space requirements of 115,000 square feet for an 800-pupil building. Based on current enrollment projections this would be adequate through the 1968-69 year on an optimum capacity basis and through the 1969-70 year on a maximum capacity basis. The educational consultant was directed to provide provisional space requirements for an 800-pupil building.

2. Upton, Sanders and Upton of Concord was appointed the Board Counsel on all matters pertaining to the formation of the District.

Jan. 4, 1965 Special Meeting with Spaulding-Potter Fund financed pupil-profile studies. 2. The Board discussed the provisional space requirements of 111,045 square feet for an 800-pupil building. These were approved by the Board after an amendment to 115,800 square feet. The amendment provided additional space in three areas where the building would become crowded first.

Jan. 7, 1965 1. Assistant Superintendent O'Shea reported that Regular Meeting Fund Projecthad been compiled and was being forwarded to the educational consultant's office. School administrative and clerical staff worked on this also.

> 2. A Finance Committee Report of a preliminary estimate of the amount of bond issue, was accepted by the Board. This estimate includes the provisional elementary housing needs program, as well as the High School needs, and is for \$2,300,000.

> 3. The Board approved a policy on entrance age for the Special Education Class.

4. The Board approved a policy on school accidentsand accident reports.

5. The Board worked on the 1965-66 Budget.

1. The Board voted to authorize its legal counsel, Richard Upton to take the necessary steps to petition the N. H. General Court to validate the organization of the Timberlane Regional School District. (This is a precautionary action, recommended by the bonding authorities.)

2. The Board voted to authorize Mr. Upton to petition the New Hampshire General Court to permit the School District to exceed the statutory debt limit by 2%. (This is also a precautionary action, deemed necessary by the Board, in the event that the 1964 Assessed Valuations as equalized figures for the state are not validated by the legislature prior to District approval of a bond issue.)

3. The Board voted to request former members of the Timberlane Planning Board Publicity Committee to assist the School Board in a similar manner. These members are Elmer G. Kutzelman, Atkinson, Aram Melkonian, Danville and M. A. Plant, Plaistow.

Jan. 14, 1965 Regular Meeting 4. The Board appointed an advisory committee for the Spaulding-Potter Fund financed planning project for the high school. These members are Mrs. Jane Ingalls, Timberlane School Board Curriculum Committee Chairman, Dr. Nicholas Engelhardt, Educational Consultant, New York, Dr. Roland Kimball, University of New Hampshire, Mr. Jack Adkins, Phillips Exeter Academy, Exeter, Mr. Damon Russell, State Department of Education and Seth O'Shea, Assistant Superintendent of Schools in Union #55 and Howard Kimball of the State Department of Education.

Jan. 20, 1965 1. The Board worked on the 1965-66 Budget.

Special Meeting 2. The Board reviewed preliminary sketches of the proposed High School, with the architect and the consultant. A second draft will be presented to the Board at the February 4th meeting, following planning sessions between the architect and the consultant. A developed plot plan was requested for the same meeting.

Jan. 21, 1965 Regular Meeting and Site, Publicity, Curriculum and Finance Committees.

2. The Board worked on the 1965-66 Timberlane Budget.

3. The proposed 1965-66 School Calendar was approved.

4. The Board voted to set the time for 1965-66 Teachers' Contracts at 185 days.

Jan. 28, 1965 Regular Meeting 1. The Board was informed of a new policy adopted by the State Board of Education on December 30, 1964, having to do with special approval of building plans before State Building Aid is granted on proposed buildings which fail to meet certain minimum housing needs.

4. The Board discussed a preliminary Curriculum Committee report of Pennsylvania and Florida high school visits. These visits are part of the Spaulding-Potter project.

5. The Board discussed a rough draft of this report.

6. The Board adopted a policy on the retention of non-tenure teachers.
