TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Wakefield in the County of Carroll in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town Hall in said Wakefield on Tuesday, the twelfth day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
3. To see what sum of money the Town will vote to raise and appropriate for the repairs of highways.
4. To see what sum of money the Town will vote to raise and appropriate for culverts, bridges, and general expenses.
5. To see what sum of money the Town will vote to raise and appropriate for oiling roads.
6. To see what sum of money the Town will vote to raise and appropriate for maintaining camp roads.
7. To see what sum of money the Town will vote to raise and appropriate for winter highways.
8. To see what sum of money the Town will vote to raise and appropriate for Town Poor.
9. To see what sum of money the Town will vote to raise and appropriate for Public Nurse and to be employed by Red Cross Organization.
10. To see what sum of money the Town will vote to raise and appropriate for Public Libraries and where it shall be expended.
11. To see what sum of money the Town will vote to raise and appropriate for street lighting in the

villages, Sanbornville, East Wakefield, Wakefield, Union and Woodman.

12. To see what sum of money the Town will vote to raise and appropriate for proper observance of Memorial Day.

13. To see if the Town will vote to authorize the Selectmen to hire such sums of money as may be necessary to pay Town Bills in anticipation of taxes.

14. To see what sum of money the Town will vote to raise and appropriate for State Aid Roads on a Joint account with the State.

15. To see if the Town will vote to raise and appropriate the sum of \$532.81, the State to contribute their share, \$2131.26, for Town maintenance on Class 5 roads.

16. To see if the Town will vote to raise and appropriate money for the issuance of printed matter calling attention to the resources and natural advantages of the Town in cooperation with other Towns in the Lakes Region.

17. To see if the Town will vote to raise and appropriate the sum of \$100.00 to be paid to Sanbornville Fire Department, also a like sum to be paid to Union Fire Department.

18. To see if the Town will vote to raise and appropriate the sum of \$150.00 to be expended on land owned by the Town adjoining Sarah's Spa, for the extension of a hockey and skating rink.

19. To see what sum of money the Town will vote to raise and appropriate for the repair and construction of Summer Street leading from State Highway to Church Street.

20. To see what sum of money the Town will vote to raise and appropriate for the installation of a drinking fountain, to be erected adjoining Town Hall.

21. To see what action the Town will take rela-

tive to accepting land and a sum of money for the completion of a part or parts of certain roads at Province Lake.

22. To transact any business that may legally come before said meeting.

Dr. Kerr's annual Clinic was held in July and 18 received chest examinations. Two patients were transported to Dr. Kerr's Clinic in Rochester in December.

A pre-school and infant clinic was held in July in Sanbornville and Union. A total of 22 children were examined and 6 immunized.

Tag day was held in which the local children participated, proceeds helped toward our dental clinic.

Attended Dr. Jones Orthopedic Clinic in Manchester taking 2 children.

Through the cooperation of the parents, mumps and whooping cough did not spread, avoiding another epidemic.

The Red Cross very generously donated a new nurses visiting bag, also stationery.

Three tonsils and adenoids Clinics were held in Wolfeboro. A total of 9 children corrected.

Three baskets were given out at Thanksgiving to the needy.

Through the State Dept. of Public Welfare, 9 children were corrected to glasses. The Red Cross furnished 3, eleven parents paid for their children. A total of 23 children with eyes corrected.

Clothing, overshoes, C. L. Oil etc., were given out where most needed.

Two rummage sales were held and both proved to be a big success. Thanks to members of our committee and all those who helped in any way.

I wish to thank you one and all for your cooperation.

SUPERINTENDENT'S REPORT

To the School Board of Wakefield:

I herewith submit my third annual report as superintendent of schools.

The unemployment situation in the country is tragic. Allegedly there are 10,000,000 unemployed, 4,000,000 being young persons between sixteen and twenty-four years of age. Disappointed youth has the greatest right to complain. Free government is on trial today in the opportunity and faith in the future that it offers to youth. Unemployed youth is the soil on which dictatorships grow to power.

It would be much to the point to introduce something of Manual and Domestic Arts in our grammar schools, seeking to train the hand as well as the mind.

An excellent corps of teachers is doing good work. On account of the smaller number of children in Sanbornville, the number of teachers has been reduced by

one. Only grades VI to VIII are now taught in the Grammar School building, the fifth grade remaining in the Primary building.

A large number of pupils go from the grammar school to surrounding high schools where they are doing good work. The number in the fall was as follows:

Rochester High School	47
Nute High School	9
Farmington High School	1

The health work is in care of Mrs. Irene Jones, the Red Cross nurse. Her school report is included in the Red Cross report.

School property is still kept in good condition by the wise expenditures of the school board. A new boiler has been installed at Sanbornville Primary School. Now that the public water system has become established, provision should be made to install running water and flush toilets in the Grammar School building. It would add much to the attractiveness of the town if the school yards could all be beautified with shrubbery. Many summer visitors would appreciate this, and children would profit by the artistic beauty. Work of this kind is progressing at the Union School.

Visual education has become an established part of the school program. "Daniel Boone", "The Frontier Woman", "The Covered Wagon", "Gateway to the West", "Old Scrooge", "Posture" and a safety reel have been used.

For the year ending June 30, 1939, we had an average attendance of 145, and average membership of 151 and a percent of 96.
