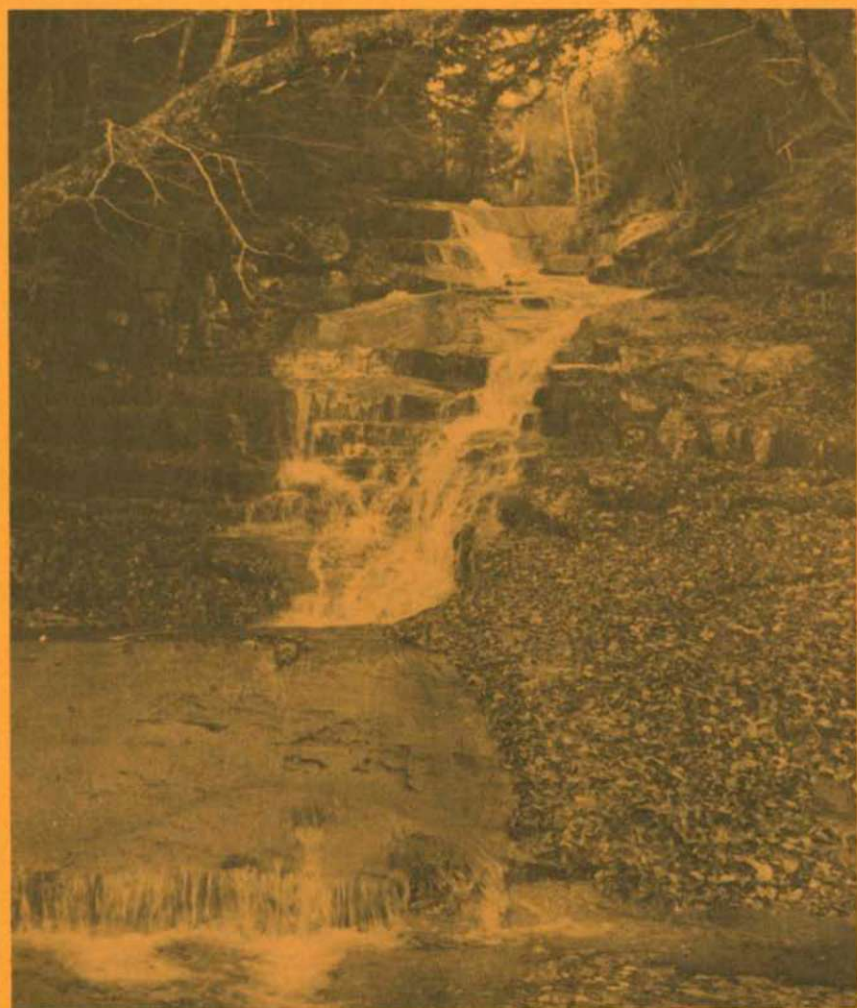

The Polls will be open from 9:00 A.M. to 2:00 P.M.

To the inhabitants of the Town of Hart's Location, New Hampshire in the County of Carroll in said State, qualified to vote in Town affairs:

You are hereby notified to meet at the Varney residence in said Hart's Location on Tuesday, the tenth day of March, next at nine o'clock in the forenoon, to act upon the following subjects:

Article 1. To choose all necessary Town Officers for the ensuing year.

Article 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.

Article 3. To authorize the Selectmen to borrow sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.

Article 4. To see if the Town will vote to petition the Representatives and Senators who represent the Town in the General Court to support in the current session of the General Court, the concurrent resolution to amend the State Constitution to limit the annual increase in property taxes to five percent and to limit the annual increase in spending by the state or any city, town or other governmental unit of the state to five percent.

Article 5. Shall the Offices of Town Clerk and Tax Collector be combined as one office.

Article 6. To approve the Town Budget for the ensuing year and make appropriations of the same:

a. Town Officers' Salaries (Selectmen, Tax Collector, Treasurer & Town Clerk @ \$100. each) plus Moderator @ \$5. per meeting, not to exceed.....	\$ 700.00
b. Town Officers' Expenses Including Auditor @ \$25....	600.00

e. Planning Board Expenses.....	50.00

DOG LEASH LAW

At the State Election Meeting on November 4, 1980, the town of Hart's Location voted to adopt the provisions of RSA 466:30a which makes it unlawful for an owner of any dog licensed or unlicensed to allow said dog to run at large, except when accompanied by the owner or custodian and when used for hunting, herding, supervised by competition and exhibition or training for such. This law to take effect January 3, 1981.

MINUTES OF TOWN MEETING MARCH 11, 1980

The meeting opened at 10:20 A.M. due to 12" snowstorm.
Fifteen voters were present. The Warrant was read by Moderator George L. Holmes.

Art. 1. Voted for Town Officers.

Art. 2. Motion by Glenn Amsden, seconded by N. Linda Richardson that we accept Art. 2. So voted.

Art. 3. Motion by Victor Blais, seconded by F. Maurice Varney, that we accept Art. 3. So voted.

Art. 4. Moderator Holmes suggested he read each item of the budget, have a discussion on it and then have one motion to accept the entire Article.

It was noted here that the bill for this item was received after the town reports had been printed and the rate had been increased to \$65.00. The town report shows this item to be \$50.00.
