Claremont, N. H., March 2nd, 1936

The Sullivan County Delegation, of the 1935 Legislature met at the Court House, Claremont, N. H., March 2nd, 1936 for the purpose of considering a change in the budget for 1936. The Commissioners asked

that the amount voted by the delegation,(\$144,100.00) be increased to \$172,450.00.

After some discussion it was voted to amend the amount recommended in the budget for 1936, (\$144,100.00) so as to read, \$159,100.00, an increase of \$15,000.00.

The following resolution was presented and adopted: "

Resolved: That the County Agent of the Sullivan County Farm Bureau Extension Service furnish the Sullivan County Commissioners with a financial report covering receipts, expenditures, present salary payroll, budget, estimated expenses and remarks. This report to be printed in the County report. The financial report to be made out like the form dated Feb. 26, 1936, attached to this resolution. The County commissioners may make changes in the form from time to time as they deem it necessary. The report to be in the hands of the County Commissioners on, or before, the first of each February.

Commissioners' Report

In accordance with the Public Laws of the State of New Hampshire, the Commissioners of Sullivan County, herewith present the annual report of the County Commissioners, the County Home and House of Correction, Treasurer, Auditors, Solicitor, Clerk of Court, Sheriff, Chaplain, and the Physician of the County Home for the year ending December 31, 1936.

The County Home continues under the management of Mr. and Mrs. L. M. Grout, Superintendent and Matron. Nothing but praise is in order for their efforts and the Commissioners desire to express their thanks and appreciation for their splendid work at the Home. We also desire to express our appreciation for the excellent service of the Chaplain, Physician, and all connected with the Home.

No major improvements were made at the Home during the year. Only general upkeep and repairs were made. The buildings are all in very fair condition and are a credit to the County.

Financial Condition of the County:

We closed the year with all bills paid that have been presented and \$30,330.20 cash in the Treasury. For the third consecutive year the County Debt has been reduced, the reduction for 1936 being \$24,356 14, and we desire to express our appreciation to the County Delegation for their cooperation in adopting, as near as possible, a balanced budget for 1936. It is the one item (a balanced budget) that establishes the credit of the County.

In closing, we wish to express our appreciation to the Overseers of the Poor and Selectmen in the several towns for their splendid cooperation in assisting us in County affairs, and to all the people and organizations that have interested themselves in the welfare of our county dependents, we desire to express our appreciation.

Report of Superintendent and Matron

1936

To the Honorable Board of Commissioners of Sullivan County:

We again submit our annual report of Sullivan County Home and House of Correction.

As usual, during the past year we have done considerable building, as well as making necessary repairs. Each year we try to add some needed buildings, in addition to making repairs.

We have just completed a two-story hen-house, seventy-five by twenty feet, with running water and large enough to accommodate about seven hundred hens. This was done because one of the hen-houses was old and much in need of repair and was located too near the Annex, a building housing some of the Charges. The tool and wagon shed has been enlarged by about fifty feet. An extension about fifty by thirty feet has been added to the piggery.

Taking advantage of the help of two or three painters who have been here this Winter, considerable renovating has been done to the inside of the buildings.

Mr. Osborne will be greatly missed as a member of the Board of Commissioners. We have always worked harmoniously and the counsel and advice given by him, as well as by the other members of the Board, have helped us very much. We appreciate the fact that there has never been any friction between the Board and us and we trust this will continue.

We wish to express our thanks to the various organizations in Claremont and Newport for the entertainment given our people. We appreciate the efficient service rendered by Dr. Sanders and by our Chaplain. To our co-workers we extend our thanks for their efficient work and loyal support.

Gentlemen:

I submit herewith my report as Solicitor for the period beginning January 1, 1936 to January 1, 1937.

The Solicitor finds that more and more complaints are being made to him on minor matters. Hardly a day passes but someone is in with some trivial matter. During the past year two respondents were tried and convicted of a charge of Arson. One was sent to States Prison for ten to fifteen years on a rape charge. There were a large number of criminals at the September Term of court covering crimes of Larceny, rape, arson, death from reckless driving, obtaining under false pretences and forgery. The coming term looks very favorable as there is no serious matter to come before the Grand Jury at this time.

It is difficult to keep accurate records of all matters handled by the Solicitor because no provision is made for the employment of office help by the Solicitor.
