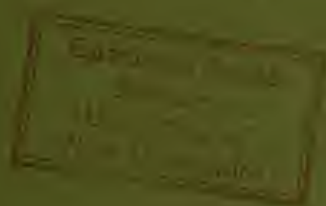

## TOWN WARRANT

### STATE OF NEW HAMPSHIRE

*To the inhabitants of Bedford, in the County of Hillsborough,  
in said State, qualified to vote in Town Affairs :*

Your are hereby notified to meet at the Town Hall in said Town on Tuesday, the thirteenth day of March next, at ten of the clock in the forenoon, to act upon the following subjects :

Article I. To see whether beer or other lawful alcoholic beverages shall be manufactured or sold locally as permitted under Chapter 99, Section 22 of the laws of 1933.

Art. II. To choose all necessary Town Officers for the ensuing year.

Art. III. To raise such sums of money as may be necessary to defray Town charges for the ensuing year and make appropriation for the same.

Art. IV. To raise and appropriate such sums of money as may be necessary for the support of the poor, for Memorial day, Highways, and Bridges, and for any other necessary expenses to the Town.

Art. V. To see if the Town will vote to authorize the Selectmen to hire money, up to the sum of \$10,000, if needed.

Art. VI. To see if the Town will vote to allow a discount on early payment of taxes, and if so, to fix the time and rate.

Art. VII. To see if the Town will vote to raise and appropriate the sum of money necessary to maintain street lights for the ensuing year.

Art. VIII. To see if the Town will vote to raise and appropriate the sum of \$3000 to pay up on notes.

Art. IX. To see if the Town will authorize the Selectmen to administer or dispose of any real estate acquired by the Town through Tax Collector's Deeds.

Art. X. To see if the Town will vote to raise and appropriate the sum of \$125 for the Town Library.

Art. XI. To see if the Town will vote to raise and appropriate the sum of \$15 for the care of the clock on the Church.

Art. XII. To see if the Town will vote to raise and appropriate the sum of \$100 for the care of the New Cemetery.

Art. XIII. To see if the Town will vote to raise and appropriate the sum of \$10 for the care of the Old Cemetery on the Back River Road.

Art. XIV. To see if the Town will vote to raise and appropriate the sum of \$7 for the care of the Old Cemetery on the Beals Road.

Art. XV. To see if the town will vote to raise and appropriate the sum of \$15 for the care of Joppa Cemetery.

Art. XVI. To see if the Town will vote to raise and appropriate the sum \$2349.00 for State Aid Construction the State to furnish \$2349.00.

Art. XVII. To see if the Town will vote to buy a tractor and snow plow, and raise and appropriate money for the same.

Art. XVIII. To see if the Town will vote to buy snow fence and raise and appropriate money for the same.

Art. XIX. To see if the Town vote to use the Australian Ballot system hereafter for the election of Town Officers.

Art. XX. To see if the Town will vote to raise and appropriate the sum of \$1500 to build a cement culvert over the brook near the Perham Parker Homestead.

Art. XXI. To see if the Town will vote to raise and appropriate the sum of money necessary to buy a truck chassis to replace the chemical truck.

Art. XXII. To see if the Town will vote to accept \$150 in trust from Katherine E. Moore, the interest to be expended for the care of her lot in the Old Cemetery.

Art. XXIII. To see what action the Town will take regarding the licensing of retail milk dealers who sell milk in the Town of Bedford.

Art. XXIV. To see if the Town will vote to raise and appropriate the sum of money necessary to purchase land for a recreation field.

Art. XXV. To hear the reports of Agents, Auditors, and Committees, and of all other officers heretofore chosen, and to transact any other business that may legally come before said meeting.

## ANNUAL REPORT OF SCHOOL BOARD

---

The annual meeting of the Bedford School District was held at the Town hall on Thursday, March 9, 1933, at 2 P. M. The following officers were elected for the ensuing year:

Moderator—William Melendy.

Clerk of School District—Frank Manning.

Treasurer—Henry Blood.

Mr. Geo. H. Robertson was elected a member of the school board for three years.

The town auditors were elected school auditors for the ensuing year.

The district voted to reduce the School Board's budget by five hundred dollars (\$500.00).

The Medical Inspection Action was dismissed.

Bedford is now united with Hudson, Pelham, Litchfield and Merrimack in a Supervisory Union, No. 27, with Mr. Fred Hall as superintendent of schools.

Miss Edith Walker was again re-elected as school nurse and Dr. Manning as school doctor.

The Board organized for the year 1933-1934 with Mr. Geo. Warren as chairman and Mrs. Nettie B. Tarr as clerk.

## REPORT OF THE SUPERINTENDENT OF SCHOOLS

Hudson, N. H., Feb. 1, 1934.

*To the School Board and Citizens of the Town of Bedford:*

Following is my first annual report as Superintendent of your schools.

Upon coming to Bedford as Superintendent of your schools, I found two vacancies in your teaching staff. Miss Gretchen Smith, a graduate of Plymouth Normal School, with four years' experience, was secured as teacher for the upper grades at the Donald Street School, and Miss Beulah Perkins, a graduate of Keene Normal School, 1933, was secured for the primary grades at the Stephen Buswell School.

I was very much pleased to discover that the schools of Bedford had been consolidated into three two-room buildings. These school buildings were of modern construction and in very good condition. The Donald Street schoolhouse was repaired inside and outside during the summer of 1933. The other two schoolhouses are in fair condition, but will need repainting within the next few years.

During the last year, the school book companies offered a special discount of fifteen to twenty per cent on the return of an equal number of old books of the same kind and grade.

Upon investigation, I found a large number of badly worn books in the Donald Street and Stephen Buswell Schools. When I talked with the school board, they informed me that there had been a complaint in regard to the condition of the books during the last year. The board authorized me to return the old books for credit, and to expend two hundred dollars more than the regular appropriation order that there might be an adequate supply of good text books. These text books have been purchased, and unless there is a marked increase in enrollment, the normal expenditure each year should provide adequate text books for some years.

It seems to me that music is one of the things which should receive special emphasis in the Bedford schools. Adequate supervised music instruction would prove a benefit as well as a pleasure in the lives of your boys and girls. Your school board is very much interested in adequate music instruction for the children of Bedford, and specified in the selection of new teachers for this year that they must be qualified to teach music. I would like to see a music supervisor employed to spend one day each week in the schools of Bedford for the next year to organize a uniform music program for all the schools to provide initial instruction for new assignments and to see that there is a steady advance in the mastery of music.

The high school attendance from Bedford for the last ten years has been rather irregular, but during the present year there are thirty-five pupils enrolled in Manchester West, Manchester Central, and Milford High Schools.

The appropriation for high school tuition for this year was twenty-five hundred dollars; the amount necessary to pay the high school's tuition will be thirty-five hundred dollars. In order that the school board may be able to meet this extra thousand dollars in high school tuition, it seems necessary that the school meeting should vote to raise and appropriate



one thousand dollars as a deficiency appropriation to meet the increase in high school tuition.

The people of Bedford are to be complimented on the three active Parent-Teacher Associations. Such associations are a great asset in developing and maintaining parent-teacher cooperation, and parent interest in the school activities.

It is hoped that more parents will visit the schools and observe the work which is being accomplished.
