TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

*To the Inhabitants of the Town of Chatham in the County
Carroll in said State, qualified to vote in Town Affairs:*

You are hereby notified to meet at the Town House in said Chatham on Tuesday, the 4th day of March, next at 6:30 of the clock in the afternoon to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To see if the Town will vote to appropriate the sum of \$43.00 asked for by the State of N.H. Department of Resources and Economic Development for the control of White Pine Blister Rust.

3. To see if the Town will vote to allow a 2% discount on all property taxes paid within 30 days of receipt of tax bill.

4. To see if the Town will vote to appropriate \$100.00 for the support of the Eastern Slope Regional Airport for the current year.

5. To see if the Town will raise \$100.00 for Civil Defense.

6. To see if the Town will raise and appropriate \$134.80 asked for by the White Mountain Regional Association.

7. To see if the Town will vote the sum of \$300.00 to the Saco Valley Fire Department as our share of expenses.

8. To see if the Town will raise and appropriate the sum of \$134.00 for the Home Health Agency, the said sum being equal to \$1.00 per person.

9. To see if the Town will raise and appropriate the sum of \$46.59 to assist the Carroll County Mental Health Service, Inc. 1975.

10. To see if the Town of Chatham will vote to become a member of the North Country Council, organized in July, 1973, under RSA 36:45-53. The Council has been designated by the State Office of Comprehensive Planning

to be the official planning commission for New Hampshire Planning Region One. The objectives of the Council are to provide local planning assistance to member Towns, to work on problems of area-wide concern. The Selectmen appoint two representatives to the Council.

11. To see if the Town will vote to appropriate the sum of \$145.00 as the Town's share for operation of the North Country Council for one year, beginning July 1, 1975. These funds will be used for financing staff, office and general operating expenses; regional planning studies; technical assistance to member communities; coordination with local, State and Federal agencies; and other programs of the Council. These are used in conjunction with State and Federal Funds.

12. To see if the Town will raise and appropriate the sum of \$125.00 for our share of the Fryeburg Rescue Unit.

13. To see if the Town will vote to set aside \$2,500.00 from Revenue Sharing Funds to be used for the purpose of preparing tax maps for the Town.

14. To see if the Town will vote to adjust the salaries of the Selectmen - Chairman to \$400.00, second and third members to \$250.00

15. To see what action the Town will take on the Budget Submittal by the Budget Committee.

16. To transact any other business that may legally come before this meeting.

During the past year the Rescue Unit has had 134 calls broken down as follows: Stow 6, Chatham 6, Lovell 16, Brownfield, 24, and Fryeburg 82. This is an increase of 9 over last year.

During the year we have had six members take the 81 hour Emergency Medical Technician course put on by the Southern Maine Vocational Technical Institute. This course involved driving to Portland or Biddeford two nights a week and spending three hours each night in class.

Through a lot of work by the Captain of the Unit an EMT course has been set up to be held at the Bridgton Hospital early in 1975. This will allow more members to take the course.

We would like to thank everyone who has sent donations to the Unit. The donations are used to buy equipment and supplies and to pay the tuition for members taking the EMT course.

FOREST FIRE WARDEN

Chatham

All open burning when the ground is not covered with snow is controlled by the Town Forest Fire Warden in cooperation with the New Hampshire Forest Service. Anyone wishing to kindle a fire out-of doors when the ground is not covered with snow must have a written permit signed by the Town Forest Fire Warden. If the fire is to be kindled on land not owned by the person kindling the fire then he must have the permission of the landowner. No outdoor fires can be kindled between 9 A.M. and 5 P.M. unless it is raining, without the additional approval of the District Forest Fire Chief.

The 1974 forest fire season was one of the worst in the past two decades. Woodlands in central and southern New Hampshire became so dry in mid August that the Governor and Council, upon the recommendation of the State Forester, enacted a partial woodlands closure in Sullivan, Cheshire, Hillsborough, Merrimack and Belknap Counties and a complete woodlands closure in Strafford and Rockingham Counties plus the towns of Barnstead, Gilmanton and Alton in Belknap County. Through the excellent cooperation of the citizens of our State no major forest fire occurred at any time during the year.
