THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Ellsworth in the County of Grafton in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at The Town House in said Ellsworth on Tuesday, the 9th day of March next at six of the clock in the afternoon, to act upon the following subjects:

- 1. To choose all necessary Town Officers for the year ensuing.
- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
- 3. To see how much money the town will vote to raise and appropriate for the support of highways and bridges and set hourly wage for labor.
- 4. To see if the town will vote to qualify for T. R. A. and raise and appropriate \$90.50 for same.
- 5. To determine and appoint the salaries of town officers and make appropriations of the same.
- 6. To see how much money the town will vote to raise and appropriate for Employees' Social Security.
- 7. To see how much money the town will vote to raise and appropriate for the support of the town house.
- 8. To see if the town will vote to authorize the Selectmen to borrow money in anticipation of taxes.
- 9. To see if the town will vote to accept the reports of agents and officers.
- 10. To see how much the town will vote to raise and appropriate for the use of the Campton-Thornton Town Dump.
- 11. To see how the town wishes to pay off the \$6,000.00 loan borrowed from the Pemigewasset National Bank to improve the pond road. And vote to raise and appropriate the same.

- 12. To see if the town is in favor of having the office of the town clerk combined with office of the tax collector, thereby creating a new office of town clerk-tax collector to be held by one individual.
- 13. To see if the town will establish a planning board consisting of five members.
- 14. To see if the town will establish a town conservation commissioner.
- 15. To see if the town will establish the office trustee of trust funds. For the purpose of accepting gifts, legacies and devices and elect by ballot a board of three trustees.
- 16. To transact any other business that may legally come before said meeting.
