TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

(L.S.)

*To the inhabitants of the Town of Rye in the
County of Rockingham in said State, qualified
to vote in Town Affairs:*

You are hereby notified to meet at the Town Hall in said Rye on Tuesday the sixth day of March, next, at ten o'clock in the forenoon, to vote upon the following subjects:

ARTICLE 1. To choose a Town Clerk, a Treasurer and a Highway Agent for the ensuing year and a Selectman, a Cemetery Trustee, a Library Trustee, a Trustee of Trust Funds and to elect two members of the Budget Committee for the ensuing three years.

ARTICLE 2. To choose all necessary officers for the Rye School District in accordance with the statutory procedure adopted by said District at its March 1962 annual meeting.

ARTICLE 3. To see if the Town will vote to amend the zoning Laws, Chapter 4-A, as follows:

4-A CONDOMINIUMS

(1) *Definition:* The term "condominium development" shall mean a specific subdivision development in which there is to be constructed either single-unit or multi-unit dwellings or a combination of each type, each of whose resident enjoys exclusive ownership of his individual unit, holding a fee simple title thereto and owning an undivided interest as a tenant-in-common in the common facilities and areas of the building or buildings and grounds which are used by all residents of the condominium development.

(2) *Condominium District Location:* The condominium district shall be that portion of the Town of Rye which is bounded on the northerly side of Pioneer Road from Seavey's Creek to Sagamore Road thence continuing on the easterly side of Sagamore Road to the Rye/Portsmouth Town Line; thence following the Rye/Portsmouth Town Line in a northeasterly direction to the southeasterly side of Wentworth Road; thence continuing along the southeasterly side of Wentworth Road to the Little Harbor Bridge. Any districts within said condominium district which are presently zoned business or

commercial shall, in addition to the provisions of this section, retain their current zoning status.

(3) *Eligibility:* Any tract or contiguous tracts of land to be developed as a single entity for condominium construction, as hereinbefore defined, shall contain a minimum of 75 acres, excluding water bodies, wetlands and exposed ledge areas. In addition, the Board may approve tracts that are divided by wetlands, exposed ledges and bodies of water but which said tracts are connected by approved roadways within a distance of 1,000 feet.

(4) *Permitted Uses:* Family dwelling units in single family detached homes, or other configuration of family dwelling units of the condominium type subject to the other requirements of this section. Residential and accessory buildings may contain non-residential uses provided such non-residential uses are incidental to the residential use and serve the residents of the development and their guests only, and not the community at large.

(5) *Density Requirements:* The maximum residential density of construction on any development under this provision shall not exceed one dwelling unit per 20,000 square feet of land in the entire tract.

(6) *Setback Requirements:* No building or structure constructed in any such development shall be constructed nearer than 100 feet from any property line of an abutting property owner unless such abutting owner shall consent in writing, and such construction is approved as well by the Planning Board. Front yard, side yard and rear yard requirements for buildings located on internal streets within such development shall be in accordance with setback requirements for single residence districts.

(7) *Common Areas:* In any condominium development the common areas shall be governed in accordance with the requirements of New Hampshire Revised Statutes Annotated Chapter 479-a, paragraphs 1-28 as amended. With regard to common open space area, regardless of the form of ownership of the dwelling units, the following provisions shall apply:

A. In addition to any applicable provision of New Hampshire Revised Statutes Annotated Chapter 479-a, paragraphs 1-28, common open space areas shall mean a parcel of land or area of water or combination thereof designed and

intended for the benefit and enjoyment of the residents of the condominium development.

B. Areas devoted to street, rights of way, vehicular parking or utility services shall not be considered as a common open space.

C. Common open space areas may contain accessory structures and improvements necessary and appropriate for educational, recreational, cultural or social uses. Structures within designated open space areas devoted to such uses will not occupy in excess of 10% of open space area and may be operated on a membership basis whereby membership is restricted to all residents of the condominium development and their guests only.

(8) *Height Requirements:* No building constructed in any such development shall exceed 35 feet in height.

(9) *Other Requirements:* A. Whether or not actual subdivision of the tract is contemplated, all pertinent provisions of the subdivision regulations and Section 4 of the Zoning Ordinance of the Town of Rye and Building Regulations of the Town of Rye shall be complied with, including but not limited to, street design and construction standards, the filing of a bond for improvements, and the filing of preliminary and final plats. In the event that the development is designed in such a fashion that individual structures and the land upon which they are sited are to be sold separately, the provisions of Section 4 of this ordinance shall apply to each such lot separately and in addition to the provisions for the development as a whole, which are contained herein.

B. In addition to any provisions controlling the subdivision of land the Planning Board shall consider and approve the following:

- (i) Height, bulk and area of buildings.
- (ii) Size, type and location of signs.
- (iii) Landscaping and screen planting, parking and loading areas.
- (iv) Access to site.
- (v) Relation to the existing structures in the vicinity.
- (vi) Location, size, elevation of buildings.
- (vii) Number and type of dwelling units.
- (viii) Number and type of structures designed for

other permitted uses.

- (ix) Location of parking spaces.
- (x) Location of common open spaces.
- (xi) Sewerage treatment plant, design and location.
- (xii) Water supply and fire protection plan.
- (xiii) Power and utilities plan.

C. In the event it is determined that the proposed improvements are not in harmony with the surroundings, the Planning Board shall confer with the applicant in an endeavor to have plans changed or modified. Applications for the construction of any condominium development as herein set forth shall be submitted to the Planning Board for the Town of Rye and shall be subject to the approval of the Planning Board, as in the case of a subdivision, provided, however, the Planning Board shall have the right to refuse the approval of any condominium development.

(10) *Modification — Abandonment:* Plans for a condominium development may be modified in accordance with the requirements for initial approval. Failure to diligently pursue construction of such development or a portion thereof for a period exceeding two years shall constitute abandonment of the plan or pertinent portion thereof and shall render all permits issued for that portion null and void. Where appearance or habitability of any such development or any portion thereof has been destroyed or interfered with by fire, flood, wind or other means, the buildings or areas shall be restored or removed as directed by the Planning Board.

ARTICLE 4. To see if the Town will vote to rezone the following described property from "single residence" to "commercial":

"A certain tract or parcel of land on the easterly side of U.S. Route #1 bounded and described as follows:

Beginning at an iron pin on the easterly side of U.S. Route #1 at the northwesterly corner of land now or formerly of Beres; thence turning and running south 25° 30' West a distance of 162 feet more or less to a point at land now or formerly of Ham; thence turning and running north 41° 44' east a distance of 303.31 feet more or less along said land now or formerly of said Ham to a point at land now or formerly of Corbett and Brennan; thence turning and running westerly along said land of Corbett and Brennan a distance of 170.17

feet more or less to an iron pin on the easterly sideline of said Lafayette Road; then turning and running southwesterly along the easterly sideline of said Lafayette Road a distance of 160.76 feet more or less to the point of beginning; said lot containing 35,291 square feet more or less and lying between aforesaid land of Beres presently zoned as 'business A' and aforesaid land of Corbett and Brennan presently zoned 'commercial'."

ARTICLE 5. On petition of Ralph Hammond and 32 others to see if the Town will vote to amend the Zoning Ordinance of the Town of Rye as follows:

Section 4 — Single Residence Districts, Paragraph F Area of Lot per Family: No building shall be erected on a lot containing less than sixty thousand (60,000) square feet. The frontage of any lot shall be at least 200 feet and depth of any lot shall be at least 150 feet, but in combination shall constitute the required area of 60,000 square feet.

This Article not recommended by the Planning Board.

You are hereby further notified to adjourn to meet at the Rye Junior High School on the seventeenth day of March, next, at seven o'clock in the evening, to vote upon the following subjects:

ARTICLE 6. To see if the Town will authorize the Selectment to hire money from the Trustees of Trust Funds.

ARTICLE 7. To see if the Town will authorize the Selectment to hire money in anticipation of taxes.

ARTICLE 8. To see if the Town will vote to allow five percent discount on all property taxes paid within thirty days from the mailing of the tax bills.

ARTICLE 9. To see if the Town will vote to authorize the Supervisors of the checklist to hold the final hearing for the correction of the checklist eight days prior to any election as provided in RSA 55:6.

ARTICLE 10a. On petition of Maynard L. Young and 18 others: to see if the Town will vote to acquire A Street as identified on the Town of Rye assessors' map, dated 1964, and other plans filed in Rockingham County Registry of Deeds, said street to be used for the purpose of providing access to the beaches along said street. This street to become right of way only under class 6 (Recreational Usage) that require no maintenance and to raise and appropriate the sum of \$200.00 (two

hundred dollars) to cover necessary costs to enable the Selectmen to begin acquisition procedures upon passage of this article.

ARTICLE 10b. On petition of Maynard L. Young and 19 others: to see if the Town will vote to acquire B Street as identified on the Town of Rye assessors' map, dated 1964, and other plans filed in Rockingham County Registry of Deeds, said street to be used for the purpose of providing access to the beaches along said street. This street to become right of way only under class 6 (Recreational Usage) that require no maintenance and to raise and appropriate the sum of \$200.00 (two hundred dollars) to cover necessary costs to enable the Selectmen to begin acquisition procedures upon passage of this article.

ARTICLE 10c. On petition of Maynard L. Young and 18 others to see if the Town will vote to acquire C Street as identified on the Town of Rye assessors' map, dated 1964, and other plans filed in Rockingham County Registry of Deeds, said street to be used for the purpose of providing access to the beaches along said street. This street to become right of way only under class 6 (Recreational Usage) that require no maintenance and to raise and appropriate the sum of \$200.00 (two hundred dollars) to cover necessary costs to enable the Selectmen to begin acquisition procedures upon passage of this article.

ARTICLE 10d. On petition of Maynard L. Young and 18 others: to see if the Town will vote to acquire D Street as identified on the Town of Rye assessors' map, dated 1964, and other plans filed in Rockingham County Registry of Deeds, said street to be used for the purpose of providing access to the beaches along said street. This street to become right of way only under class 6 (Recreational Usage) that require no maintenance and to raise and appropriate the sum of \$200.00 (two hundred dollars) to cover necessary costs to enable the Selectmen to begin acquisition procedures upon passage of this article.

ARTICLE 10e. On petition of Maynard L. Young and 18 others: To see if the Town will vote to acquire E Street as identified on the Town of Rye assessors' map, dated 1964, and other plans filed in Rockingham County Registry of Deeds, said street to be used for the purpose of providing access to the beaches along said street. This street to become right of way only under class 6 (Recreational Usage) that require no main-

tenance and to raise and appropriate the sum of \$200.00 (two hundred dollars) to cover necessary costs to enable the Selectmen to begin acquisition procedures upon passage of this article.

ARTICLE 10f. On petition of Maynard L. Young and 18 others: To see if the Town will vote to acquire F Street as identified on the Town of Rye Assessors' map, dated 1964, and other plans filed in Rockingham County Registry of Deeds, said street to be used for the purpose of providing access to the beaches along said street. This street to become right of way only under class 6 (Recreational Usage) that require no maintenance and to raise and appropriate the sum of \$200.00 (two hundred dollars) to cover necessary costs to enable the Selectmen to begin acquisition procedures upon passage of this article.

ARTICLE 11. On petition of Joan A. LaFrance and 20 others: To see if the Town will vote to designate all roads and highways in the Town of Rye, except Class I and Class II highways, as scenic roads, thereby putting them under the protection of the Revised Statutes Annotated 253:18 which says that "any repair, maintenance, reconstruction or paving work done with respect thereto shall not involve or include the cutting or removal of trees, or the tearing down or destruction of stone walls, or portions thereof, except with the written consent of the Planning Board . . . after a Public Hearing.

ARTICLE 12. To see if the Town will vote to purchase Sawyer's Beach, so called, from the present owners for the sum of \$30,000.00 (thirty thousand dollars) and for that purpose to raise and appropriate the sum of \$6,000.00 (six thousand dollars) annually beginning this year and for each of the ensuing four years, these funds to be taken from the special fund created under the State and Local Fiscal Assistance Act of 1972 (Title I, Public Law 92-512) Approved October 20, 1972. .

ARTICLE 13. To see if the Town will vote to create a Capital Reserve Fund for the purpose of acquiring a suitable site and erecting a town office building and for that purpose to raise and appropriate the sum of \$10,000 (ten thousand dollars) from the special fund created under the State and Local Fiscal Assistance Act of 1972 (Title I, Public Law 92-512) Approved October 20, 1972.

ARTICLE 14. To see if the Town will vote to raise

and appropriate the sum of \$500.00 (five hundred dollars) and to authorize the Selectmen to expand said sum for the purpose of acquiring additional land for refuse disposal.

ARTICLE 15. To see if the Town will vote to raise the maximum fine imposed by the dog ordinance from \$10.00 to \$50.00.

ARTICLE 16. To see if the Town will vote to raise the authorized paid sick leave for the Town employees to a maximum accumulation of sick leave to 90 days. The present limits being 5 days per year and 30 days accumulation.

ARTICLE 17. To see if the Town will vote to enact the following ordinance: Be it ordained

1. That the Highway Agent, with the approval of the Selectmen, may from time to time set and post load limits for the Town roads by posting in conspicuous places notices of said load limits in such a manner that the same are clearly legible and weatherproof.

2. Any person, firm, corporation found to be exceeding said limits during the period shall be fined not more than \$50.00 for each such violation.

ARTICLE 18. To see if the Town will vote to amend the existing town ordinances relating to the use or presence of motor vehicles, bicycles and animals on the beaches and the surfing ordinance by changing the effective dates thereof from the present June 15 to September 15 to from June to October 1.

ARTICLE 19. To see if the Town will vote to authorize the Fire Wards to order a new fire truck for delivery in April of 1974 to be paid by appropriation from the Capital Reserve Fund established for such purpose, said appropriation to be made in 1974.

ARTICLE 20. (a) To see if the Town will vote to accept the budget submitted by the Budget Committee and pass any vote in relation thereto, and

(b) To raise and appropriate such sums of money as may be necessary to defray Town charges for the ensuing year.

ARTICLE 21. To transact any other business that may legally come before this meeting.

Polls will not close before Eight O'Clock P.M., March 6, 1973.

Selectmen's Report

To the Inhabitants of Rye:

This past year has been a very busy year for the Board of Selectmen.

Due to the closing of the Portsmouth dump Rye was confronted with a very serious problem. Our dump was being used by residents of surrounding Towns, this necessitated the Selectmen to take steps to prevent our dump being used by other than the property owners of Rye. The letter R was issued to all property owners of the Town. For the most part this has worked very well. We would like to once again bring to the attention of the residents that the Town is fast running out of dump space.

Many violations of the Zoning Ordinance have been reported to the Board. As long as a Zoning Ordinance exists there will always be violations: some small — some large. Many violations are corrected by merely contacting the violator once, in other cases action has to be taken by the Town Attorney. To some people it might seem that the violations are not taken care of by the Board of Selectmen or/and the Building Inspector but we can assure the residents a great deal of time and effort is spent on this problem.

The Town of Rye is very fortunate to have a man like Mr. Hammond as building inspector. His helpfulness and conscientiousness in carrying out his work is certainly deserving of any gratitude that could be paid to him.

The Memorial Day observance certainly showed that a great deal of time was spent in getting this program together. Our thanks to the committee that was in charge.

The yearly work done by our Ambulance Corps is certainly deserving of all our thanks and our support.

Again we would like to say that we feel that both the Police and Fire Departments are doing an excellent job in protecting the Town and its residents, each in their own line of duty.

Fire Chief's Report

The year of 1972 has been a busy and rewarding year for the Fire Department.

The members and myself would like to sincerely thank the Selectmen's Secretary, Tax Collector as well as the many, many people that have assisted this department in any way this past year.

It was very gratifying to me when I learned that the Town of Rye was reclassified from a "D" Town to a

"C" Town on their fire insurance premiums. This amounts to a saving to the people of Rye about \$16,800.00 per year. This was effective as of April 1, 1972. The people that live within 600 feet of a hydrant in any section of Rye are eligible for the rate reduction. If you have not had a reduction or been notified of such contact your insurance company and ask about it. This 16,800.00 saving represents about 1/3 of our 1972 Fire Department budget. No other department receives a saving for the taxpayers by up-grading their department.

The recommendations that were made in the survey have been put on a list of priorities. A drillmaster be appointed (Done) 1971. Revising the Town ordinance governing the fire department (Done) voted 1972 Town meeting. Installing a phone for incoming alarms of fire (Done) 1972. Tel. No. 964-8683. Replacement of the Tank on the tank truck in accordance with pamphlet #19 of N.F.P.A. (Done) 1972. Up-grading our training schedule being done each year. Some of the things take little or no funds and some of the recommendations take time because they need funds. Some of the things we are going to try and accomplish in the next two to three years. Replacement of Eng. #2 due to age hopefully in 1974. More man power. A Fire Prevention Code be adopted.. An Inspection program of buildings by both permanent and callmen to familiarize themselves with the fire hazards.

The Fire Department hopes you will favor the article that will be in the Town Warrant for authorization to order a new pumper to replace Engine #2 to be delivered in April of 1974.

I would like to thank both permanent and callmen for the many hours they have given to help in the up-grading of the fire department and also the Taxpayers that have appropriated the necessary funds to make this reduction possible.

Bruce Walker was appointed in May of 1972 as a permanent firefighter.

The bad storm of February 19, 1972 will be long remembered by some of us and it was a costly one for the Fire Department. We had 12 men on duty until 3:00 A.M. of the 20th. We had teams of 4 men working together and we went from one call to another without coming back to the station. It was a long day. A job well done.

I would like to remind the Taxpayers that the monies that was appropriated for the replacement of the tank on the tank truck covered the cost of the construction of the tank only. There was about 51 days of labor spent by the firefighters in our station building compartments, hose body dividers, hose body covers, installing necessary piping from the tank to the pump and a preconnect line to the rear of the truck. A donation of money was given to purchase some metal to construct a rear step for the tank truck from funds received from the card parties that are held once a week. The men have enjoyed themselves making a piece of equipment that will be of great use not only to structural but grass fires as well.

Eleven men attended the Lilly Pond Fire School June 3rd and 4th, 1972 in Laconia and also we have three men attending the Vocational College in Portsmouth, N. H. taking the Fire courses that are being offered.

Your Fire Department responded to 100 calls this past year compared to 95 calls the previous year. Here is a list of calls for 1972 as follows: sixteen brush grass and woods, seven buildings, four smoke calls, six oil burner, five auto fires, nine auto accidents, twenty-two public assist, nine electrical, ten assisted ambulance calls, nine unattended fires, two false alarms and responded to North Hampton for mutual aid once.

There were 267 Beach Fire Permits issued, 262

Burning Permits issued and 81 Cooking Fire Permits for back yard issued.

The members and myself would like to thank the Ladies Auxiliary for all they have done for us in various ways.

The Christmas Parade was held on December 17, 1972 and I think the people that participated in the parade deserved a lot of credit to brave the cold and the wind. There were four prizes given. 1st. prize was won by the Cub Scouts pack 183; 2nd. prize, Rye Youth Club; 3rd. prize to Brownie Troop 146. Best out of town float was the Portsmouth Fire Department; two Honorable Mention went to the Driftwood 4-H and Brownie Troop 422.

Forest Fire Warden's Report

In New Hampshire, forest fire control is a cooperative State-Town program. The Town Forest Fire Warden, appointed by the Director, Division of Resources Development upon recommendation of the Selectmen and the State's District Forest Fire Chief is responsible for fire suppression and other related duties. The State shares equally with the town in the cost most forest fires, except illegal and careless fires, which are charged to the responsible party. The State further provides fire detection services, prevention programs, fire training for town wardens and crews, and back up equipment for fire suppression.

By authority of the State, the Town Forest Fire Warden controls all outside burning in this town except

backyard cooking fires. Any person wishing to kindle a fire when the ground is not covered with snow must obtain a fire permit, free of cost, from the Town Forest Fire Warden. No permits will be issued for fires between 9:00 A.M. and 5:00 P.M. unless it is raining, except for commercial purposes.

Please be careful when using fire, remember it can be an extremely useful tool when under control but once allowed to run wild it can become a disastrous and devastating force. Only you can prevent a forest fire.

I would like to thank everyone who helped the Rye Police Department this past year.

The Department had a busy year and the work is still increasing. The alcohol blood count has been lowered from 0.15% to 0.10%. This has increased the driving while under the influence cases in the Rye Court. Most cases are appealed to Superior Court, which means a case report and the Officers may be tied up in Superior Court from one to three days.

The blood bank is in dire need of donors so please don't waste your blood or anyone else's by spilling it on the highways. Slow down and let's live on. Now the County Attorney wants two officers on all D.W.I.

cases. One to do the arresting and the other to observe and write up the report on what he observed, so he can start trying some of these and have good cases.

For those who do not know the speed limit is 20 M.P.H. when passing a school during recess or while children are going to or leaving school during opening or closing hours.

The following is a list of some of the work load and items that were handled by this Department during the past year. The Department talked to 78 juveniles for different matters of which 4 were brought before Juvenile Court and 3 were sent to the State Industrial School for evaluation, testing and schooling.

Rye Municipal Court

The Rye Municipal Court continues to hold its regular sessions each Wednesday morning at the Court Room in the Town Hall. We also have continued the policy of hearing contested cases on Thursday mornings throughout the summer months.

Three hundred and six cases were entered during the calendar year 1972. Of this total, one hundred and seventy-eight were violations of the State Motor Vehicle Laws, forty-eight were violations of Town Ordinances and the remainder were Fish and Game Violations or other misdemeanors. The greater number of complaints were entered by the Rye Police Department with the other State Law Enforcement Agencies bringing in other violations which occurred within the jurisdiction of the Court.

This past year has seen the innovation of the A.S.A.P. Program into the Court Systems. This program gives the Court an additional alternative in the sentencing of persons found to be intoxicated while operating a motor vehicle. The Court may now order a person who is found guilty of this charge to participate in the program. In addition to a fine, possible commitment and suspension of license, the person may be ordered to attend regular sessions of an alcohol Medical Review Board for diagnosis

and education prior to the restoration of his rights to operate.

The Court is also initiating a new system of record keeping in accordance with the procedures ordered by the Administrative Committee of District and Municipal Court. These procedures will update and increase the efficiency of recording statistics.

We would like to take this opportunity to thank the Selectmen, Rye Police Department and all others who have cooperated and aided the Court in the discharging of its responsibilities throughout this past year.

One of the functions of the Board is to act upon applications for approval of subdivisions. Public hearings are held by the Board for those applications. In this connection, the Board recommends that a preliminary layout of proposed subdivisions be presented to the Board for their review. In this manner, the Board may have its recommendations incorporated in the proposed subdivisions prior to the public hearings.

The Planning Board has prepared an amendment to the Rye Zoning Ordinance which would permit the construction of condominium dwellings in a specified area of the Town. That amendment is presented to the voters of the Town for their consideration.

" **Report of the Board of Adjustment**

The Board of Adjustment consists of five members appointed by the Selectmen for a five year term each. This Board is established to act on certain requests officially submitted and referred to them. The major duties of the Board of Adjustment are to take action upon appeal from the terms of the zoning ordinance when persons submit a request for a variance.

The Board is not a police or control agency and has no power or authority to enforce the terms of the zoning ordinance, this is the responsibility of the Building Inspector and the Selectmen. However, in the interest of uniform administration of the zoning ordinance, representatives of the Planning Board and the Board of Adjustment have met with the enforcing officials, reported violations that have been brought to their attention during public hearing and in private discussions and discussed ways and means of uniform enforcement of the zoning ordinance.

During 1972 the Board processed 26 applications, approving 11 and disapproving 15. The interest shown by the Selectmen, members of other Boards and groups and the residents of Rye in the activities of the Board were very much appreciated.

Report of the Building Inspector

As I submit my fourth annual report as Building Inspector for the Town of Rye, I look with some alarm at the results of the population increase in our Town. Desirable house lots of suitable size, located on high ground, are very scarce, with the result that many people are trying to build on low ground and on small lots that are not large enough to contain their own sewage on their own land. Although they have to comply with the Town and State regulations as to obtaining permits and approvals, the sewage systems on low ground in a few short years begin to fail with the result that the contamination runs off onto other peoples' property, also creating a serious health problem. I believe that larger sized house lots could solves part of the problem.

There were 47 building permits issued for new construction, 81 for repairs, remodeling and additions, 4 for swimming pools, 2 for operating gravel pits, 2 to demolish old buildings and 11 to erect new fences. Total value of receipts to the Town of Rye for permits was \$2,334.00.

There were 85 inspections made of sewage system installations as well as investigation of 22 violation complaints of our Zoning Ordinance and Building Code.

Office hours for the Building Inspector continue to be from 7:30 P.M. to 9:30 P.M. on Thursday evenings and at other times by appointment and are held in the Selectman's Office at the Rye Fire Station.

Librarian's Report

The library closed the year with an increase in circulation — 31,376. Included in this total were 15,150 fiction — 7878 non-fiction — 7633 juvenile — 715 records. 784 books were borrowed from the bookmobile and 134 from the state library and Portsmouth. 629 new books were purchased, several records and one film. This film is to circulate the same as books and records. We are in hopes of having several more film.

With school libraries having a duplication of our books this circulation has dropped off. We miss the children and feel that it is too bad to have this situation.

The library is now open 40 hours a week to comply with State requirements. This will be the last increase in hours until the population is greatly increased.

The Helen Trefethen room is being used extensively. Anyone wishing to use the room please contact the librarians.

A story hour for pre-school children is being conducted once a week by Mrs. Philbrick. Any child between the ages of 3 and 5 is welcome to hear the stories, see the film and play the games. Programs for children this year included the 'Little Red Wagon' with the theater group from UNH and a summer reading program closing with a party. The 4 H exhibit was excellent and included the Ocean Waves and the Driftwoods. The Cub Scouts made decorations for a X'mas tree and presented tree and decorations to the library.

Drapes were added to the reference room and children's room, also, a paved driveway was laid to the conference room door.

Hobbies were on exhibit all year and created much interest. If you have a hobby you would like to share just call the library.

Mrs. Cameron, assistant librarian, attended 2 courses at UNH in the spring and summer.

The librarians attended many meetings this year throughout the southeast district. Included were book meetings, DAC meetings, NHLA at Eastern Slopes Inn and NELA at the Wentworth and the dedication of the refurbishing of the State Library. With the Librarian being chairman of the planning board for the District Advisory Council wider areas are being incorporated in the local library. These we hope will be beneficial.

Part of the reference room has been turned into a New Hampshire corner. All New Hampshire material and an easy chair (given by the Friends) are well used.

The Friends of the Library have been very active with programs and furnishing refreshments and having several workshops. Also, book mending, food and book sales. A hobby show was held in April and it is hoped to make this an annual affair. Telephone books were transported to Exeter by Mrs. Tallman of the Friends to be reprocessed. All of this is greatly appreciated.

Mrs. Tallman has presented the library with several books on wildflowers and trees to be found in Rye.

Again our sincere thanks to the many individuals and organizations who have given money, books, magazines and their time to the library. We are very fortunate to have so many interested people.

The librarian would like to express her gratitude for the cooperation of Mrs. Cameron, assistant librarian, and Mrs. Philbrick. Also, a wonderful board of trustees.

Rye Recreation Commission

Another very successful year was enjoyed at the Recreation Area under the able leadership of Mr. Paul Cuetara, Director. There were 199 children that registered for the program this year with a total attendance of 1,598. This brings the six year attendance total from 1967 through 1972 to 8,942.

Assisting Mr. Cuetara as Field Director for the second year was Miss Kathaleen Phillips. Miss Patricia Christo was the Director of Arts and Crafts and William Carter worked part time as an assistant.

Besides the regular summer programs including horse-shoes, ping pong, basketball, badminton, relay races, other competitive sports, and arts and crafts, this year a soft ball team was organized and games were played against the neighboring towns of Hampton, North Hampton and New Castle. This program was most popular and successful. Each Friday a special event was held such as "Gold Rush Days", "Costume Carnival", "Capture the Flag", etc. These proved very successful. A point system was maintained on the honor system and at the end of the program trophies were awarded to those who won tournaments (checkers, chess, ping pong, horeshoes), those who scored the most points, and also other areas. Each child who took part in the program was presented a Certificate of Participation.

This is the first season that the Little League Field was in operation at the Recreation Area. The new field and location proved highly successful and was met with much favor. An equipment shelter was erected for the Little League and was placed in use. The co-operation that was realized between the Little League Management and the Recreation Commission was greatly appreciated.

This was also the first year in many years that Rye was able to host the All-Stars Baseball game. The Little League field was also utilized by the Church and some

other groups in the Town. It is hoped that in the future more people and groups will take advantage of this area.

Another area is in the process of being cleared. This area is located in the triangle off the main road and will be used as an all-purpose field.

The Commission wishes to thank the Rye Young Women's Club and the Rye Grange for their generous contributions. We would also like to thank all those who put time and effort into the success of all the programs presented at the Recreation Area.

Rye Conservation Commission

This has been an active year with various directions of concern. In March, purchase arrangements were completed for a 5-acre tract at the corner of Brackett and Parsons Roads, at the edge of the pond. There is a wide range of vegetation in this small area. Botanist Albion Hodgdon has written a 3-page paper on the plant groupings here. Copies are available on request.

Negotiation for a tract of saltmarsh of over 30 acres ran into a snag at a Planning Board Hearing in April. Proposal was to divide the marsh from higher ground. A boundary claim was made by one of the abutters. Since the hearing there has been extensive work on checking titles of property in this area.

Dredge and Fill applications have had our concern. As we learn of a proposed project we try to evaluate the ecology impact, and then submit an opinion, for

or against, to the Special Board. It is our intent to express opinions also to local boards, where proposed work is in a wet area, or where important natural features are involved.

For sound land planning, we feel that our land areas need to be as well delineated as possible. The Soil Conservation Service urges a re-survey of Rye soils mapping. To have this done in 1973, we have entered a budget item of \$1350.00, cost to Rye.

A listing of plants that grow in Rye has been compiled from both professional and amateur reports. A copy of this listing is at the Rye Library. Many more species will be added as further study is made.

We did not get the road built in the new section as the contractors we made arrangements with were not able to get the work done. It is hoped that this coming year it will be completed.

We have had some trouble with snowmobilers using the cemetery. The caretaker has asked them not to use the seeded lawn sections and burial plots. There is a roadway across the new section which leads to a path

to the Recreation Area. We have no objection to the use of this roadway and have told the snowmobilers this. However, if they continue to ride on the lawns and graves we will have to post the entire cemetery next year.

Cemetery Trustees

Report of Trustees of Trust Funds

In 1972 a bequest of \$21,484.36 was received from the estate of Martha Dudley for the benefit of the Rye Public Library. This amount has been invested in the common trust and each year the income will be turned over in full to the Trustees of the Rye Library. All library funds now total \$64,592.13.

The expenses of both the cemetery and Dalton funds were very high during 1972. This was due to the purchase of a new truck that was badly needed. This expense was divided between the cemetery perpetual care funds and the Dalton Fund. Next year we expect the income to exceed the expenses, since no large capital improvements will be needed.

In the miscellaneous trust funds the following changes took place:

1) The Town of Rye Capital Reserve Fund received \$5,000.00. In the past this fund has been used for the purchase of new fire equipment.

2) The Rye Conservation Commission Fund received \$5,000.00 from the town and \$30.00 in special gifts. The trustees turned over \$2,200.00 to the Rye Conservation Commission to purchase land.

3) Expenditures in the amount of \$328.69 were made from the Rye Recreation Little League Equipment Fund. These eliminated both principal and income.

4) A bill in the amount of \$166.27 was paid from the Rye Recreation All Purpose Court Fund.

5) A gift of \$400.00 was received from the Rye Junior Women and added to the Rye Recreation Commission Fund.

A parcel of land on Sagamore Ave., formerly Long John Ave., that was held as an asset of the Dalton Fund was sold by the Trustees of Trust Funds. The original

land purchase had been made to obtain loam and gravel for the cemetery. Since this land was no longer needed and all loam taken, the land was appraised and sold for \$7,500.00 to Maynard Young, who owned the adjoining land on all three sides. The proceeds of this sale were invested in common stocks, which would increase the income of the Dalton Fund.

Dog Officer's Report

The Dog problem in the town of Rye certainly hasn't been stopped at this time, but there has been a big improvement as far as dogs running at large on the streets etc. and on the beaches during the summer months.

I strongly recommend that the fine of \$10.00 on Article #15 of the Town Dog Ordinance be changed to run with the \$50.00 fine carried by the other Ordinances in the Town. I believe that this will stop more of the problems of dogs being allowed to run free where a bigger fine may be charged other than just \$10.00 each offence. Some people think that the small fine is nothing to pay, and will allow their dogs to run free.

Some of the Towns around Rye have a fine that owners of dogs pay for the first day of confinement in their own pounds or Kennels they take dogs to. Most fines occurred are \$5.00 for the first day of which \$3.00 goes to the Town and \$2.00 goes to the Kennels. The \$3.00 is put into a fund which helps to pay for any bills that the Town has to pay for the dogs not claimed, or dogs that have to be destroyed. I think also that we should have something along this line.

TOWN WARRANT

THE STATE OF NEW HAMPSHIRE

*To the inhabitants of the Town of Rye in the
County of Rockingham in said State, qualified
to vote in Town Affairs:*

You are hereby notified to meet at the Town Hall in said Rye on Tuesday the ninth day of March, next, at ten o'clock in the forenoon, to vote upon the following subjects:

ARTICLE 1. To choose a Town Clerk, a Treasurer and a Highway Agent for the ensuing year and a Selectmen, a Cemetery Trustee, a Library Trustee, a Trustee of Trust Funds and to elect two members of the Budget Committee for the ensuing three years.

ARTICLE 2. To choose all necessary officers for the Rye School District in accordance with the statutory procedure adopted by said District at its March 1962 annual meeting.

ARTICLE 3. To take the sense of the qualified voters whether the Amendments of the Constitution proposed by the 1971 session of the General Court shall be approved.

ARTICLE 4. On petition of Lawrence Walker and 28 others to see if the Town will vote to amend the Zoning Ordinance of the Town of Rye as follows:

A. Add to SECTION 14 — SPECIAL USES a sub-section B8 to read: "Any person or family may rent rooms in any dwelling provided that the total occupancy of the dwelling will not exceed an average of 200 square feet per person and that the building inspector or the N. H. Water Supply and Pollution Control Commission certifies that the water and sewage disposal systems are adequate."

B. Add to SECTION 14 — SPECIAL USES a sub-section B9 to read: "A structure which existed as of January 1, 1950 in any district of Town may be remodeled into one or more dwelling units provided that each dwelling

unit so created will have a minimum living space of 600 square feet; that the area of the original structure shall not be increased by more than 10% of its original area; that the exterior of the building remain essentially as it was or in keeping with other dwellings in the neighborhood; that any changes in the exterior appearance of the building be approved by the Board of Adjustment and the immediate abutters; that the lot be of sufficient size to provide 22,500 square feet for each unit; that all other requirements of lot measurements shall be the same as for other dwellings in the district wherever the building is to be expanded; and that the water supply and sewage disposal systems be expanded if necessary to meet state and town requirements."

C. Amend SECTION 14 C — PROHIBITED USES: 2. Apartment Houses to read: "Apartment houses except as provided in Section 14 B9 above, and in Section 13, Non-conforming use as of March 11, 1969."

D. Add to SECTION 17 — OFF STREET PARKING B. a sub-section 17 to read: "All multi-unit dwellings shall provide one parking space for each dwelling unit, or as many more as are needed to accommodate the cars owned by the occupants of the dwelling."

NOT RECOMMENDED BY THE PLANNING BOARD.

ARTICLE 5. On petition of Lawrence Walker and 28 others to see if the Town will vote to amend the Zoning Ordinance of the Town of Rye as follows:

A. Amend the first sentence of SECTION 13 — NON-CONFORMING USES A 3, to read: "Any and all non-conforming buildings and structures may be altered as business or other conditions warrant, but not expanded by more than 10% of their size when the ordinance was passed on March 1, 1969, and then only in accordance with the terms of this ordinance as to obtaining building permits for construction, development, enlargement, material alteration or moving of buildings, structures or uses of land."

NOT RECOMMENDED BY THE PLANNING BOARD.

You are hereby further notified to adjourn to meet at the Rye Junior High School on the twenty-fifth day of March, next, at seven o'clock in the evening, to vote upon the following subjects:

ARTICLE 6. To see if the Town will authorize the Selectmen to hire money from the Trustees of Trust Funds.

ARTICLE 7. To see if the Town will authorize the Selectment to hire money in anticipation of taxes.

ARTICLE 8. To see if the Town will vote to allow five percent discount on all property taxes paid within thirty days from the mailing of the tax bills.

ARTICLE 9. To see if the Town will vote to authorize the Selectment to lease Sawyer's Beach, so called, from the owners for another year.

ARTICLE 10. On petition of Angela Collins and 13 others: To see if the Town will vote to appropriate the sum of five thousand dollars (\$5,000.00) as an addition to the Conservation Fund established in 1970 and augmented in 1971 for the Conservation Commission to exercise those powers granted to it by state law R.S.A. 36-A4.

"to acquire, maintain, improve, protect, limit the future use of or otherwise conserve and properly utilize open spaces and other land and water areas within their city or town, and shall manage and control the same, but the city or town shall not have the right to condemn property for these purposes."

And to see further if the Town will vote to instruct the Selectmen and the Budget Committee to include a like sum in future budgets to be paid into the fund for this purpose, subject to approval of the budget by the voters.

ARTICLE 11. On petition of Frances I. Holway and 130 others: To see if the Town will vote to employ the Division of Municipal Accounting of the State Tax Commission to make the annual audit of Town accounts and budget seven hundred dollars (\$700.00) therefor.

ARTICLE 12. On petition of Maynard L. Young and 25 others: To see if the Town will vote to acquire streets A, B, C, D, E, and F as identified on the Town of Rye assessors' map, dated 1964, and other plans filed in Rockingham County Registry of Deeds, said streets to be used for the purpose of providing access to the beaches along said streets. These streets to become right of ways only under class 6 (Recreational Usage) that require no maintenance and to raise and appropriate the sum of fifteen hundred dollars (\$1,500.00) to cover neces-

sary costs to enable the Selectmen to begin acquisition procedures upon passage of this article.

ARTICLE 13. Be it ordained by the voters of the Town of Rye in Town Meeting assembled that a department to be known as the Rye Fire Department is hereby created. It shall be governed by this revised ordinance and the Statutes of the State of New Hampshire, Chapter 154 RSA.

ARTICLE I. OFFICERS

Section 1. The Board of Fire Wards shall consist of the Chief, 1st. and 2nd. Assistant Chiefs.

Section 2. The Department shall consist of a chief, two assistant chiefs, and such other officers as the wards may deem necessary for the effective operation of the Department.

Section 3. The Chief Fire Ward shall be appointed by the Selectmen for an indefinite period, and his tenure shall depend on his good conduct and efficiency. He shall be technically qualified by training or experience, and must have the ability to command men and hold their respect and confidence: He may be removed only for just cause and after a public hearing. The first and second assistant chiefs shall be appointed by the Selectmen upon recommendation of the Chief Fire Ward and shall serve a like tenure as the Chief.

Section 4. The Chief Fire Ward shall be held accountable to the Selectmen only, and shall make written and verbal reports thereto as they may require. All other department and company officers shall be accountable to the Chief only and shall be appointed by the Chief, after passing competitive examinations. Such officers may be removed for just cause and after a public hearing.

ARTICLE II. DUTIES OF THE CHIEF

Section 1. The Chief shall be responsible for the enforcement of the rules and regulations governing the Department and for the personnel, morale and general efficiency of the Department.

Section 2. The Chief shall determine the number and kind of companies of which the Department is to be composed and shall determine the response of such companies to alarms.

Section 3. The Chief is hereby required to assist the

proper authorities in suppressing the crime of arson by investigating, or causing to be investigated, the cause, origin and circumstances of all fires.

Section 4. The Chief is hereby empowered to enter any and all buildings and premises at any reasonable hour for the purpose of making inspections and to serve written notice upon the owner or occupant to abate, within a specified time, any and all fire hazards that may be found.

Section 5. The Chief shall keep, or cause to be kept, complete records of all fires, inspections, apparatus and minor equipment, personnel and other information about the work of the Department.

Section 6. The Chief shall make a complete annual report to the Selectmen within one month after the close of the fiscal year.

ARTICLE III. DUTIES OF OTHER OFFICERS

Section 1. Assistant Chiefs: in absence of the Chief, the First Assistant Chief, or in his absence, the Second Assistant Chief or senior officer present shall command the Department.

Section 2. Training Officer: shall at least once a month conduct suitable drills or instruction in the operation and handling of equipment and all other matters generally considered essential to good firemanship, safety of life and property from fire.

ARTICLE IV. MEMBERSHIP

Section 1. The membership of the Department shall consist of such permanent firemen as shall be appointed by the Selectmen upon recommendation of the Chief Fire Ward and such other members as may be appointed by the Chief and approved by the Wards. They shall be able-bodied citizens. Determination of whether candidates for appointment are able-bodied shall be made by the Chief, after a medical and physical examination has been made in a manner approved by the Wards.

Section 2. Any member of the Department may be suspended or discharged from the Department by the Chief at any time he may deem such action necessary for the good of the Department. On written request of such member, he shall be given a public hearing before the Fire Wards and the Select-

men on charges brought by the Chief.

ARTICLE V. EQUIPMENT

Section 1. The Department shall be equipped with such apparatus and other equipment as may be required from time to time to maintain its efficiency and properly protect life and property from fire.

Section 2. Recommendations of apparatus and equipment needed shall be made by the Chief, to meet or exceed the recommendations of the Insurance Services Office of New Hampshire or its successors. Apparatus shall meet or exceed pamphlet nineteen (19) of National Fire Protection Association. Apparatus and equipment shall be purchased in such a manner as may be designated by the Selectmen.

Section 3. No person shall enter any place where fire apparatus is housed or handle any apparatus or equipment belonging to the Department unless accompanied by, or having special permission of, an officer or authorized member of the Department.

Section 4. The Town of Rye is hereby authorized to enter into agreements or contracts with nearby incorporated communities or governing bodies of other organizations with fire protection or to establish a mutual aid system.

ARTICLE VI. GENERAL

Section 1. Each member of the Department shall be issued a badge designating his rank, and proper protective equipment.

Section 2. No person shall park any vehicle or otherwise cause any obstruction to be placed within twenty feet of the entrance to any fire station or other place where fire apparatus is stored, or within fifteen feet of any fire hydrant.

Section 3. No unauthorized person with any vehicle shall follow within five hundred feet of any apparatus belonging to the Department responding to an alarm, nor park any vehicle within five hundred feet of a fire.

Section 4. Each member of the Department who responds to a fire shall receive compensation for his services. Standards for compensation shall be established by the Fire Wards.

ARTICLE VII. ENFORCEMENT

Section 1. Any person violating the provisions of Article V, Section 3; and Article VI, Sections 2 and 3 shall upon conviction pay a fine of not less than ten dollars or more than fifty dollars for each offense.

Section 2. Any officers or senior members of the Department are hereby given the necessary special police powers for the purpose of enforcing the provisions of this ordinance.

This revised Ordinance, upon approval at Town Meeting 1972, shall take effect on April 1, 1972.

ARTICLE 14. On petition of Frances L. Holway and 12 others: To see if the Town will vote to pass the following resolution: In view of the provisions of R.S.A. 483A, paragraph 4-b which says, "All state, county and local law enforcement officers are directed to be watchful for violations of the provisions of this chapter and to report all suspected violations to the Board," be it therefore resolved that our local law enforcement officers, including the Selectmen, Police and Building Inspectors, be directed to enforce this law regarding the filling and dredging of marshlands and other wetlands with renewed vigor and that they request that a cease and desist order be issued by the Special Board constituted under this law unless a permit issued by that Board is prominently displayed near any dredging and filling of wetlands or any other violation of R.S.A. 483A.

ARTICLE 15. On petition of William E. Ashley and 11 others: To see if the Town will vote to see that no person serving in any elective office or serving as an appointed or elected member of any duly constituted board or commission shall deny or restrict the right of a persons to record the proceedings deny or restrict the right of a person to record the proceedings at any public meeting.

ARTICLE 16. On petition of Lawrence Walker and 25 others: To see if the Town will vote to designate all roads and highways in the Town of Rye, except Class I and Class II highways, as scenic roads, thereby putting them under the protection of the Revised Statutes Annotated 253:18 which says that "any repair, maintenance, reconstruction or paving work done with respect thereto shall not involve or include cutting or removal of trees, or the tearing down or destruction of stone walls, or portions thereof, except with the written

consent of the Planning Board . . . after a Public Hearing . . .”

ARTICLE 17. On petition of Urban A. Beane and 38 others: To see if the Town will vote to have the Selectmen notify the Governor, the Highway Commissioner, and the Director of DRED, in writing, that we want Route 1A, Ocean Boulevard, from Brackett Road in Rye, to Wallis Sands in Rye, kept open to traffic for now and ever more.

ARTICLE 18. On petition of Carlyle Randall and 10 others: To see if the Town of Rye will vote that there shall be no parking of cars at any time on Harbor Road beyond Remick's Pier East, except by permit only.

ARTICLE 19. (a) To see if the Town will vote to accept the budget submitted by the Budget Committee and pass any vote in relation thereto, and

(b) To raise and appropriate such sums of money as may be necessary to defray Town charges for the ensuing year.

ARTICLE 20. To transact any other business that may legally come before this meeting.

Polls will not close before Eight O'Clock P.M., March 7, 1972.
