



At this time we wish to express our appreciation to Mr. and Mrs. L. M. Grout, Superintendent and Matron of the County Home. We take this opportunity to express our deep appreciation and thanks for their splendid management at the County Home. We also wish to express our appreciation for the excellent service of the Chaplain, Physician and all connected with the Home.

No major improvements were made at the County Home during the year. The buildings are all in very good condition.

The recession in business has increased our County load of dependents about 50% since Nov. 1st, 1937 to Jan. 1, 1938.

We close the year 1937 with all bills paid and we wish to thank the County Delegation for their cooperation in adopting the budget. The financial condition of the County is good. We will borrow money for the year 1938 at the lowest rate in our history.

We wish to express our appreciation to the Overseers of the Poor and Selectmen in the several towns for their splendid cooperation in assisting us in County affairs, and to all the people and organizations that have interested themselves in the welfare of our county dependents.

Gentlemen:

I submit herewith a report of my duties as Solicitor of Sullivan County from January 1, 1937 to January 1, 1938.

At the February Term 1937 there were no cases to present to the Grand Jury which resulted in a substantial financial saving to the County. At the September Term there were twenty-two respondents. Most of these were properly disposed of, but two are now scheduled for trial at this term. One respondent was tried and convicted of a statutory offence and received from four to six years in the State's Prison. It has been necessary to attend to several juvenile delinquents as well as the usual nonsupport cases. There has been a decrease in the ordinary run of crimes, but a marked increase in sex crimes.
