



#### WARRANT

#### THE STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Stark, in the County of Coos, in said State, qualified to vote in the town affairs:

You are hereby notified to meet in the Stark Town Hall in said town on Tuesday, the 14th day of March next, at 9:00 o'clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary officers for the ensuing year.
- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations for the same.
- 3. To see if the Town will vote to raise and appropriate \$3,500.00 for current expenses.
- 4. To see if the Town will vote to raise and appropriate \$1,200.00 for elections and registrations.
- 5. To see if the Town will vote to raise and appropriate \$2,000.00 for expenses for the Town Hall and other town buildings.
- 6. To see if the Town will vote to raise and appropriate \$1,500.00 for the Police Department.
- 7. To see if the Town will vote to raise and appropriate \$3,000.00 for fire expenses of the Town.
- 8. To see if the Town will vote to raise and appropriate \$2,000.00 for insurance.
- 9. To see if the Town will vote to raise and appropriate \$500.00 for damages and legal expenses.
- 10. To see if the Town will vote to raise and appropriate \$25.00 for Vital Statistics.
- 11. To see if the Town will vote to raise and appropriate \$200.00 for ambulance services from the Town of Northumberland.
- 12. To see if the Town will vote to raise and appropriate \$50.00 for the Health Officer.

- 13. To see if the Town will vote to raise and appropriate \$300.00 for a donation to Weeks Memorial Hospital.
- 14. To see if the Town will vote to raise and appropriate \$800.00 for Public Health Nursing Services for the Town.
- 15. To see if the Town will vote to raise and appropriate \$450.00 for Upper Connecticut Valley Mental Health Services.
- 16. To see if the Town will vote to raise and appropriate \$2500.00 for the maintenance of the dump.
- 17. To see if the Town will vote to raise and appropriate the sum of \$1200.00 for street lighting.
- 18. To see if the Town will vote to accept aid for Class V Highways and to raise and appropriate the sum of \$443.09 and set the amount aside for this purpose (the State will contribute \$2,953.95).
- To see if the Town will vote to accept additional Highway Subsidy Funds to be used in conjunction with TRA monies for Class V Highways. This amount is estimated at \$3,319.42 for 1978.
- 20. To see what sum of money the Town will raise and appropriate for expenses of the Highway Department.
- 21. To see if the Town will vote to raise and appropriate \$1,500.00 for Old Age Assistance.
- 22. To see if the Town will vote to raise and appropriate \$300.00 for Town Poor and \$200.00 for Soldiers Aid.
- 23. To see if the Town will vote to raise and appropriate \$300.00 for Library Services.
- To see if the Town will vote to raise and appropriate \$300.00 for the Community Recreation/Beautification projects.
- To see if the Town will vote to raise and appropriate \$800.00 to be added to the interest from the Cemetery Trust Funds for the upkeep of the cemeteries.

- 26. To see if the Town will vote to raise and appropriate \$264.00 as the Town's share for operation of North Country Council for one year beginning July 1, 1977.
- 27. To see if the Town will vote to raise and appropriate \$5000.00 for the revaluation of the Town by the Appraisal Division of the Department of Revenue Administration and to authorize the withdrawal of such sums from the Revenue Sharing Fund established under the provisions of the State and Local Assistance Act of 1972.
- 28. To see if the Town will vote to appropriate and authorize the withdrawal from the Anti-Recession Fiscal Assistance Fund established under the Public Works Employment Act of 1976 for use as setoffs against budgeted appropriations for the following specific purpose in the amount indicated or take any other action hereon:

- 29. To see if the Town will vote to give a discount of 2% for payment of taxes if paid within 10 days after tax bill has been presented.
- 30. To see if the Town of Stark will vote to pass an ordinance that all dogs in such town be kept on a leash or confined (this article by petition of 18 voters.).
- 31. To see if the Town will vote to raise the sum of \$5000.00 to help finish the downstairs portion of the Town Hall (this article put in by petition of 10 voters).
- 32. To see if the Town will vote to accept a certain parcel of land from Andrew E. Scroggins, which land shall not exceed one acre and which land is to be used for fire department purposes only. (This article put in by petition of 10 voters, and to be voted on by ballot.)
- 33. To see if the Town will vote to raise and appropriate the sum of \$1,500.00 for fire apparatus, fire gear and damage insurance for the Stark Volunteer Fire Department (this article put in by petition of 10 voters, and to be voted on by ballot).
- 34. To see if the Town will vote to instruct the Selectmen to administer and dispose of any real estate acquired by tax collectors deeds.

- 35. To see if the Town will vote to instruct the Selectmen to appoint all other officers as required by law.
- 36. To hear reports of agents, auditors, committees, or other officers heretofore chosen and pass any vote relating thereto.
- 37. To transact any other business that may be legally brought before said meeting.

I would like to explain the purpose of the Stark Volunteer Fire Department. Of course, the purpose is mainly extinguishing fires and being of aid in emergency situations, at which the members of the fire department have done a good job in the past year.

A few people have taken an interest in building a fire department and trying to help the town. In a few years this town may need a fire department, and it will cost a lot of money to set up. People take their fire protection for granted. They have relied on Groveton Fire Department for fire protection in this town for years, but someday Groveton may not be able to provide the protection we need. That's why I think we should start building a fire department in this town now, so that in a few years we can have our own fire protection.

I'm sure there is some confusion of the meaning of the title, "Stark Volunteer Fire Department". Some people would think that the volunteer our services without pay. We do not! We have pay rates agreed upon with the Selectmen, that the town pays, which are \$25.00 per hour for the tanker, and \$3.00 per hour for each fireman called to a fire.

All the money earned on fires by the tanker and the firemen are deposited in the Stark Volunteer Fire Department Associations treasury. The money in the treasury is used to maintain and improve our equipment.

We were called to eight fires in Stark and one in West Milan, Included is a list of fires and the charges, paid by the town, to the Stark Volunteer Fire Department Association.

### REPORT OF DISTRICT FIRE CHIEF AND TOWN FOREST FIRE WARDEN

Forest fire control in New Hampshire is a joint state and town/city responsibility (RSA 224).

The Director, Division of Forests and Lands (State Forester) appoints a forest fire warden and several deputy forest fire wardens in each town/city upon the recommendations of local authorities.

The local forest fire warden is responsible for forest fire prevention and suppression activities in his town. He regulates the kindling of outside fires when the ground is not covered with snow by the issuance of written permits only when conditions are safe. He is responsible for suppression with the town/city and state sharing the cost. Suppression costs in excess of ¼ of 1% of the assessed valuation of the town are assumed by the state.

The state provides training for the local organization and helps coordinate activities between towns/cities. The state also supports local forces with backup personnel, equipment, and supplies for suppression and prevention.

This combination of state and local cooperation, started in 1893, works well, for New Hampshire has enjoyed one of the smallest acreage losses due to forest fires in the United States for the past 25 years.

### LANCASTER PUBLIC HEALTH NURSING SERVICE, INC. Town Report – 1977

As 1977 comes to a close, Lancaster Public Health Nursing Service, Inc. can look back on another successful year.

A Child Health Conference was added to the service this year. It was made possible by a grant from the Bureau of Maternal and Child Health. The Conference is held every other month and provides pre-school children with a physical examination, vision and hearing screening, immunizations, urinalysis and blood count. This service is available to all towns served by the agency.

Another service that is being added is that of a Homemaker Home Health Aide Program certified by medicare. This service too, is available to citizens in all the towns served by this agency.

We continue to provide service to Lancaster, Whitefield, Jefferson, Dalton, Groveton and Stark. We also have a Medicare Contract with Milan and Dummer. Services provided include: care of the sick in homes, child health conference, skilled nursing, homemaker home health aide and a physical therapist.

We continue to hold monthly senior citizens blood pressure clinics in Lancaster, Groveton and Whitefield. We also provide diabetic and anemia screenings at these clinics about twice a year.

Pre-school physical examinations were done in May with 51 children being examined. Physicians in attendance included Dr. Robert Lewis, Dr. Gregory Shields and Dr. Brian Beattie, as well as a dental hygienist from Dr. Perreault's office.

Pre-school Vision and Hearing testing was done on 78 children in May.

Immunization clinics are held on the third Friday of each month. A total of 361 children were immunized. The following vaccines were given: DPT, Polio, Measles, Mumps, Rubella and T. B. Tine Tests.

The Public Health Nursing Committee organizes the agency program. The committee is composed of volunteer members from each community served by the agency. The officers for the past year were:

We wish to extend our appreciation to the organizations that have assisted us during the year. The Lancaster Ambulance Corps,

the Emmons Smith Fund, White Mountain Community Services, Crippled Childrens Services, N. H. Heart Association, N. H. Department of Public Health Nursing, N. H. Department of Welfare, and Communicable Disease Control.

The members of the staff have attended in-service meetings throughout the year covering many interesting and varied topics including cancer nursing, maternal and child health, quality assurance, problem oriented records, etc.

A series of pre-natal classes were presented to area residents. The program was very well received. We would like to thank Mrs. Lois Vashaw and Mrs. Ellen Rowe of the Extension Service and Miss Kathy James, R.N. and Miss Beverly Boynton, R.N. for a job well done.

A total of 185 physical therapy visits were made to area residents in 1977, and a total of 2945 nursing visits were made to area residents. They are broken down as follows:

# NORTH COUNTRY COUNCIL, INC.

In Stark, the NCC testified on the Town's behalf at an Air Pollution Control Commission Hearing.

In 1977, NCC provided the following region-wide services:

**Planning Services:** NCC provides technical assistance to communities in a number of areas such as comprehensive planning, assistance with subdivision regulations, or reviewing development proposals. NCC is always available to meet with any local official, planning board or public body to assist with local planning matters and thirty-five towns have received some type of direct service from the Council.

Economic Development Grantmanship: NCC worked closely with the Economic Development Administration of the US Department of Commerce, the Farmers Home Administration, the Bureau of Outdoor Recreation, and HUD to bring a greater amount of financial resources into the Region; this will assist municipalities, local development corporations, and other organizations implement locally developed projects and programs. NCC attempts to be aware of the many federal grant programs that would be relevant to needs of communities in the North Country.

**Preparation of Development Plans:** By working overtime to complete components of the Development Plan (in accordance with RSA 36:45), the Council will be in a position to make specific recommendations on how the communities in the Region can develop and prepare for future growth. During 1977, much progress has been made in the areas of Land Use, Housing, and Economic Development.

Participation in National and State Policies: NCC responds to opportunities to present a North Country perspective before federal and state agencies. Examples include its presentation to the Regional Town Meeting on transportation sponsored by DOT Secretary Adams; meetings with the Regional representative of the Department of Energy on the potential of wood energy, its role in initiating legislation which permitted the construction of bistate sewerage treatment plants, and its assistance in developing state legislation permitting town governments to develop and own industrial parks. NCC has also worked with the N. H. Department of Public Works and Highways to encourage the Department to make improvements to US 302 from Woodsville to Littleton. As a body representative of local government, NCC provides a local response to state initiatives on "208" Water Quality, Solid Waste, and Safe Drinking Water Standards. Inquiries, Technical Assistance and Special Reports: NCC staff is always available to respond to the inquiries and requests of member municipalities. In the last year, the Council has published technical assistance reports on "Model Subdivision Regulations", "Woodsville Downtown Improvement Summary Report", "Energy Perspectives in the North Country", and the "North Country Housing Element".

Education and Training Programs: NCC again co-sponsored the six Municipal Law Lectures in the Fall and the second statewide Annual Meeting of Regional Planning Commission members. A special workshop for applicants of Round II of the Local Public Works Act was held in conjunction with EDA officials from Concord and Philadelphia. Planning News, the NCC Newsletter, and a legislative bulletin keep local officials and interested persons informed of planning and development activities.

In 1978, the Council will be available to work with the town and other appropriate groups to help implement some of the recommendations contained in the Plans. Ideas and suggestions on how the Council can be of greater assistance are appreciated. The Council was created by five towns in 1973 and continues to exist as a service agency to the towns. The Council greatly appreciates the support it receives from the towns, knowing that the support will enable it to provide continued service to the area in the future.

### TO THE CITIZENS

As Executive Councilor for District One which covers 62% of the State of New Hampshire (102 towns and 3 cities), I am pleased to submit this short report to the citizens of your town.

The Executive Council of New Hampshire is elected from five districts portioned by population. The work of the Council has been described as similar to that of a board of directors for State business. The New Hampshire Constitution provides that the Council shall from time to time advise the Governor in the affairs of State. State law as passed by our General Court mandates much of State government to be acted upon "with the advice and consent of the Council."

Our meetings in the State House Council Chambers are open to the public, and I would welcome having any citizens from our District attend any of the meetings.

The responsibilities of the Governor and Council are so diversified as to defy any attempt at exact classification. Their activities extend to the appointment of certain public officials, to a general supervision over State departments, to State expenditures, to pardon matters and to a variety of other duties . . State officials and employees, State fiscal matters, pardons, commutations and reprieves, eminent domain and related responsibilities, State contracts, and leases, public waters, State industrial and recreational interests and miscellaneous responsibilities.

From time to time, as Councilor if I can be of help to cities, towns, counties, agencies and individuals, I stand ready to do so especially if the problem or concern has to do with State government. However, as many of you know, much of our government, at the local level, is funded by not only local dollars but State and federal monies are many times involved which means that several levels of government are involved. In such cases we must turn to our local town administrative assistants, regional planning commissions, county officials and others for help and guidance.

# SUPERINTENDENT'S REPORT

The biggest change in our educational program was the expansion of the Title I project to provide a five day per week kindergarten program. This program should provide a good educational foundation for the incoming first graders.

Standardized test results over the past two years have shown a significant improvement in the achievement of our students. Our programs have been strengthened and the expectations of both students and staff have been raised to continue the gains presently realized.

One of the biggest and most urgent challenges facing our school district and every district is the difficulty and cost of providing suitable programs for children with special needs. Federal legislation mandates such programs which we are trying to provide by tuitioning children to Groveton and Berlin.

Stark children are participating in many vocational programs along with Groveton students both in Groveton and at Berlin.

Our programs are also benefiting from the services of North Country Education Services and the media center, the Experimental Schools Program and from CETA job services.

I extend my thanks to the school board, the teachers, students, and citizens of Stark for your support and cooperation during the year.

# **EXPERIMENTAL SCHOOLS PROJECT**

### (ESP)

Dr. Richard Peters, Director Mary Ann Haney, Secretary/Bookkeeper

### SUMMARY OF ESP ACTIVITIES 1977

When funded by the National Institute of Education (Washington, D.C.) the local Experimental Schools Project was charged with the development of a community centered school which:

- a. utilizes available human and natural resources to foster postive attitudes toward learning;
- b. provides individuals with the basic psychomotor skills which will enable them to realize personal gaols; and
- c. utilizes community resource facilities as a basis for lifetime learning opportunities.

Calendar year 1977 constitutes the last full year of ESP in Union 58. Come July 1st (1978) the local project will have been completely phased out and federal funding will end.

During 1977 the project staff consisted of a project director and a full-time secretary/bookkeeper as well as coordinators in career/vocational education and language arts/environmental education.<sup>1</sup>

### ADULT EDUCATION

The ESP program began its funding of adult education classes in Fall 1973 and continued that activity through 1976. In early 1977 the local schools began funding a number of adult classes for local community members.

### CAREER/VOCATIONAL EDUCATION

From January-September the project provided a component coordinator to assist teachers in the implementation of career education for kindergarten through grade twelve students.

The project purchased instructional materials for placement in the several resource rooms. Teachers and students have used these items repeatedly over the course of 1977.

The career/vocational education coordinator placed students at area worksites - with the approval of the state labor department - such as: Weeks Memorial Hospital, Colebrook Hospital, Northumberland/Stratford Trust building trades housesite, Ryan's Fuel Service, and Manchester Manufacturing.

High School students were enrolled in several career/vocational education mini courses for purposes of skills training. The courses included small engine repair, hunter's safety and firearms, and introduction to the building trades.

Elementary and secondary grade students were taken on several field trips for purposes of career awareness and exposure to diverse occupations and careers. Community resource people also visited classrooms as career guest speakers.

### LANGUAGE ARTS

The ESP purchased Scott, Foresman leveled reading series was used in Union 58 classrooms (K-6) as the basic reading program.

The ESP communications skills list was revised and is being used by many teachers. The sequential skills list provides the opportunity for students to receive basic language arts training through the several grades without excessive repetition. Rather, it provides for a progressive skills building process.

Instructional materials have been purchased by ESP and placed in the several resource rooms for teacher use with students.

Issues of Kid's Corner were published in order to give K-6 students a chance to display/share their writing and drawing talents with others.

### ENVIRONMENTAL/OUTDOOR EDUCATION

From January-June the project provided a component coordinator to assist teachers in the implementation of environmental education for kindergarten through grade twelve students.

The project purchased instructional materials for placement in the several resource rooms. Teachers and students have used these items repeatedly over the course of 1977.

Elementary and secondary grade students were taken on several field trips for purposes of exposure to the community environment. Community resource people also visited classrooms as guest speakers.

In the Spring of 1977 the ESP project sponsored weekend daytrips and overnight camping/hiking trips for students. In Fall 1977 building level outing club members were involved in a few weekend trips sponsored by the local schools.

With the phase-out of ESP it is the project staff's hope that curriculum changes initiated over the past four years will be continued in the schools by a teaching staff committed to educational excellence for all students.
