To the Inhabitants of the Town of Acworth in the County of Sullivan in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at The Town Hall in said Acworth on Tuesday, the second day of March, next at 7:30 of the clock in the evening to act upon the following subjects:

1. To choose all necessary Town Officers for the ensuing year.
2. To see if the Town will vote to empower the Selectmen to serve as Pound Keepers, Measurers of Wood, and Fence Viewers.
3. To see if the Town will vote to authorize the Selectmen and Treasurer to borrow money in anticipation of taxes.
4. To see if the Town will vote to direct the Selectmen to appoint the Road Agent.
5. To see if the Town will vote to rescind all action taken on Article 1 at the Special Town Meeting of June 7, 1975 and authorize the Selectmen to reconstruct the Town Hall as per plans submitted prior to and at the March 4, 1975 Regular Town Meeting; and further authorize the Selectmen to withdraw all money from all Capital Reserve Town Hall Accounts, further deposits to cease, and add all to all other reconstruction funds for use in 1976 for Town Hall reconstruction.

6. To see if the Town will vote to authorize the withdrawal from the Revenue Sharing Fund established under the provisions of the State and Local Assistance Act of 1972 for use as setoffs against budgeted appropriations for the following priority purposes and in amounts indicated or take any other action hereon:

7. To see if the Town will vote to authorize the Selectmen to withdraw \$2,000.00 from Capital Reserve Funds for use in 1976 to commence preparations for a Tax Map (R.S.A. 31:95A).

8. To see if the Town will vote to accept the Budget as submitted and recommended by the Budget Committee, and pass any vote in relation thereto.

9. To see if the Town will vote to ratify a certain quit-claim deed, recorded in the Sullivan County Registry of Deeds on October 22, 1946, in Vol. 301, at Page 565, to John Faught and to relinquish any claim the Town might have to the property described herein. See page 66.

10. To see if the Town will vote to discontinue and make subject to gates and bars (R.S.A. 238:2) the following roads:

A. A portion of the Keys Hollow Road # 71 leading north 4,800' from the former Shaw dwelling in East Acworth to the Lempster Town Line.

B. The road # 70 leading north 1,800' from the Kennedy Hill Road towards the former Mitchell site.

C. The road # 76 leading south 8,360' from the Quinn dwelling to the Marlow Town Line.

D. The road # 136 leading west 2,180' from W. Campbell's dwelling.

E. The road # 66 leading north 1,800' from the west side of the Cold Pond Road through M. Gretch's yard (formerly Potter-Boothby dwelling). By Petition.

11. To see if the Town will vote to adopt provisions and standards of R.S.A. 249:17, Driveways and Other Accesses to the Public Way. See page 51. By Petition.

To see if the Town will vote to go on record as being in favor of a moratorium on the construction of nuclear power facilities within the State of New Hampshire until such time as the problems of safe disposal of nuclear waste and adequate reactor safety equipment and procedures have been met. - Art. 19 Same as Art. 18 except regarding Town Hall
- Art. 20 Voted to pass over.
- Art. 21 Voted to table.
- Art. 22 Other business.

Voted to declare road past Fire Pond to Maude Moodie's as a Scenic Road.

Discussion of possible uses for town-owned lands. No action taken.

Mr. Barrett invited elderly people to apply for any tax exemptions that they may be eligible to receive.

Motion to itemize the tax bills was defeated.

Return to Art. 9 Ammended and voted 'to adopt the Non-Partison Ballot System for election of Town Officers.'

Meeting adjourned at 10:47 p.m. and polls closed at 11:00 p.m.

Following a presentation of the proposal by the Town Hall Committee, the following amendment was requested: 'but that this proposed plan be accepted as the preliminary or basic plan, this plan to be referred to a new expanded Building Committee which shall consist of five new members to be elected at tonight's meeting in addition to the present four members. Said new committee is to receive the Town Hall Building Committee's plan and to study and convert this plan into plans and specifications to be let out for bids'.

A vote to end discussion of the amendment passed by a voice vote.

A ballot vote on the amendment passed with 64- yes and 44- no votes.

A ballot vote on the article as amended passed with 67- yes and 38- no votes.

Stanley, Robert McMahon, Leon Dutton, Julius Christie, and Elmer Rhoades were nominated and elected to serve on the committee with present members, Richard Elsesser, Daniel Gehan, Elbert Knicely, and Robert Shepard.

An opinion poll on the Parsons and Whittemore pulp mill proposed to be built in the area showed 14- Favor, 56- Against and 27 undecided.

**TOWN WARRANT
THE STATE OF NEW HAMPSHIRE
SPECIAL TOWN MEETING**

To the Inhabitants of the Town of Acworth in the County of Sullivan in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Acworth Fire House in said Acworth on Tuesday, the sixteenth (16) day of September next at twelve of the clock, to act upon the following subjects: (the polls shall be open from 12:00 of the clock noon until 7:00 of the clock in the evening.

To see if the Town agrees to participate in the National Flood Insurance Program by directing the Board of Selectmen to complete the eligibility application and submit the required information to the Federal Insurance Administration.

WHEREAS, certain areas of Acworth are subject to periodic flooding from streams, rivers, lakes, etc., causing serious damages to properties within these areas; and

WHEREAS, relief is available in the form of Federally subsidized flood insurance as authorized by the National Flood Insurance Act of 1968; and

WHEREAS, it is the intent of this Town Meeting to require the recognition and evaluation of flood and/or mudslide hazards in all official actions relating to land use in the flood plain areas having special flood (and/or mudslide) hazards; and

WHEREAS, this body has the legal authority to adopt land use and control measures to reduce future flood losses pursuant to N.H. RSA Chapter 31, 36, 156, 156A;

NOW, THEREFORE, BE IT RESOLVED, that this Town Meeting hereby:

1. Assures the Federal Insurance Administration that it intends to enact and maintain in force for those areas having defined flood hazards, adequate land use and control measures with effective enforcement provisions consistent with the Criteria set forth in Section 1910 of the National Flood Insurance Program Regulations; and

Vests the Planning Board with the responsibility, authority, and means to:

(a) Delineate or assist the Administrator, at his request, in delineating the limits of the areas having special flood hazards on available local maps of sufficient scale to identify the location of building sites.

(b) Provide such information as the Administrator may request concerning present uses and occupancy of the flood plain.

(c) Cooperate with Federal, State, and local agencies and private firms which undertake to study, survey, map, and identify flood plain or mudslide areas, and cooperate with neighboring communities with respect to management of adjoining flood plain in order to prevent aggravation of existing hazards.

(d) Submit on the anniversary date of the community's initial eligibility an annual report to the Administrator on the progress made during the past year within the community in the development and implementation of flood plain management measures.

Appoints the Building Inspector to maintain for public inspection and to furnish upon request a record of elevations (in relation to mean sea level) of the lowest floor (including basement) of all new or substantially improved structures located in the special flood hazard areas. If the lowest floor is below grade on one or more sides, the elevation of the floor immediately above must also be recorded.

Intends to take such other official action within its powers as may be reasonably necessary to carry out the objectives of the program.

To bring in your votes for the special election of United States Senator (Laws of 1975, Chapter 1).

BOARD OF SELECTMEN

Report of Activities for 1975

Early in 1975, at our request, a timber and land-use inventory was completed on three parcels of town-owned land. This extensive project was accomplished without any expense to the Town by the State Department of Resources and Economic Development. Mr. Brian K. Simm, District Forester, with departmental personnel, completed the inventory which covered the southern portion of the Gove Lot, the Jennison Lot, and the Prouty Lot. The report stressed the wisdom of retaining those particular lots for economic, historic and recreational purposes. In certain areas some timber harvest is recommended. Results of this inventory were shared with the Planning Board and Conservation Commission, and the completed reports are on file with the Planning Board and Town Clerk.

The bridge crossing the Cold River at Leon Newton's corner leading to Forrest Road was completed by mid-summer and officially accepted by the Town on September 2, 1975

Concurrently, the bridge at East Acworth crossing the Cold River was totally reconstructed in the record time of twelve days. The contract for reconstruction of this bridge, which had been closed for over six months, was agreed upon May 7, 1975. Reconstruction began on May 12th, the the new bridge was open to traffic on May 24th. The work was done by the firm of Leclerc and Biron Construction Co. of Contoocook, N.H., and included major reconstruction of the east abutment, and preservation treatment with sandblast/epoxy applications to the west abutment. Steel for the bridge had been purchased at a favorable price in January from the Northeastern Culvert Company. We are most pleased that this bridge could be completed out of regular highway funds, and a special capital appropriation was not necessary. The total cost was \$11,754.24, which we felt was reasonable when compared with expensive bridge reconstruction. We are also pleased not only with the results of the work done, but the interest shown by the two companies in assisting the Town with technical data and other extremely useful advice before and during this important highway project.

Flash-flood damage continues to be a problem at culverts, and particularly at points where improper driveway access allows runoff from yards and driveways, thus damaging Town roads. This was most evident after one particular summer storm where almost all the damage was caused by improper construction and location of driveway access by lot owners. This problem may be controlled in the future by better planning and regulatory action using and enforcing the Access-to-Highways permit system.

In order to provide for a concrete floor in the new Town garage, approximately 100,000 board feet of timber was sold from the Town Dump Lot. At the request of Mr. and Mrs. George F. Hanson, the cutting was halted in an area adjacent to their land, and they purchased the remaining standing timber. At the same time they expressed an interest in purchasing this area adjacent to their property.

On June 7, 1975 a Special Town Meeting was called by the Selectmen concerning the acceptance of the Building Committee's report pertaining to the proposed reconstruction of the Town Hall. This was felt necessary after the work on the building was halted in the initial stages at the request of citizens who opposed continuation of the project without the project having been competitively bid on. The majority of the Selectmen had felt that the project, as described and presented to them and the public by the Committee in the course of the past years, was acceptable, proper, and valid, and that it was in the best financial interests of the Town to proceed. The expanded Building Committee, which resulted from the June 7th meeting, did not present this Board with anything which would allow resumption of reconstruction.

On September 16, 1975, a second Special Town Meeting was held in conjunction with the Special U.S. Senatorial Election. This Meeting convened at the Acworth Volunteer Fire Co. building for the purpose of electing a U.S. Senator and to vote upon Flood Plain Zoning in order to be in compliance with certain Federal requirements regarding Federal assistance in times of disaster and mortgages granted from federally-controlled banks. The vote was in the affirmative, and the Selectmen have taken initial steps to comply with the many provisions of this Federal law.

A project which has been somewhat overshadowed by other activities of the year, is the development of a Tax Map, which is required to be completed by 1980. Research is continuing and negotiations are under way to see if significant work can be done using local skills rather than employing very costly commercial firms.

During the early fall the Board of Selectmen from Marlow met with this Board and perambulated the common boundary between the two towns. Markers were found, repaired, re-cut and generally put back in order.

ACWORTH SILSBY LIBRARY REPORT- 1975

The people of Acworth have continued their interest in, and support of, the Acworth Silsby Library. This has been gratifying to the Trustees. This interest has been proven by numerous gifts of money, books, magazines and hours of work by volunteers. The Community Aid, Parent's Club, and Acworth Woman's Club have made generous contributions of money and several books were given in memory of Albert Derrington. Other books and magazines have also been donated by residents. Three volunteers, two every Thursday and one on Tuesday afternoon have been most helpful. One other volunteer is on call. People have also been of assistance when the Bookmobile made its four visits. A successful Book Sale was held in July. Books were donated for this and old and duplicate copies of library books were included.

Children come from the school on Tuesday and Thursday afternoons. Every Thursday when the first, second, and third graders come there is a Story Hour. This was continued weekly throughout the summer.

Additional shelving was built and several chairs recaned from funds received through Revenue Sharing. Unfortunately, a large amount of money had to be spent for furnace repairs.

Representatives attended District Advisory Council meetings in Keene, Claremont and Newport. Effort has been made to keep abreast of new book offerings for both adults and children. Mrs. Newton attended two book buying sessions in Keene. There is an awareness of reader's interests and desires when books are selected for purchasing. Arts and Crafts are very popular.

The per capita circulation for Acworth is fourteen (14) volumes which surpasses the circulation figures for towns in the State of comparable size. There was an increase of 989 volumes in the circulation in the year 1975. This shows excellent participation on the part of the public.

REPORT OF THE DIRECTORS
Upper Valley-Lake Sunapee
Regional Planning Commission

In 1975, Mr. Robert Ward, the Regional Planner of the Lake Sunapee Council, representing the southern half of our Regional Planning Commission, spent much time in Acworth at the joint meetings of the Planning Board and Conservation Commission in assisting with the preparation of the forthcoming Master Plan. His guidance and expertise are available to the Town through the technical-assistance program of the Regional Planning Commission. Through his efforts and the cooperation of the Commission's staff the Master Plan will be produced at a cost less by hundreds of dollars than it could be if produced by a commercial firm. Even more interesting is, that this will be done in a year in which the Commission has seen fit not to raise member town appropriations, and one in which State and Federal monies for planning purposes are shrinking at an alarming rate.

Despite shrinking funds, furthered by inflation, planning on a regional scale continues, and a project which the Commission has helped the Newport Chamber of Commerce with, should help the entire area.

With Sunapee Council help, the Chamber was the only body in New Hampshire to receive a Federal Grant to improve rural public transportation. In the very near future a bus system will be established serving Newport, Sunapee, New London, and Claremont. If successful, it could, in the future extend into portions of Acworth. In the meantime it can be an economic asset to the greater area in providing transportation to working, shopping and recreation areas for those without private means of transport.

We continue to solicit comments on matters of regional importance, which might be subject for our consideration, and we urge the public to support increased State funding in this important field.

ACWORTH PLANNING BOARD REPORT 1975

For several years we have been working toward a Master Plan for Acworth, as per the requirements set forth in R.S.A. 36:13. This has included soil studies and interpretations, elevation studies, assessment of current land uses, and public services. We have studied the status, physical condition, uses names and management of our roads. With this information we have established a set of goals and policies for the town. The following is a brief outline of the goals as presented at a public meeting in August.

GOALS

A. General Goals

1. To preserve and improve the present environment and character of the Town.
2. To preserve and enhance its rural appearance and atmosphere.
3. To define, recognize, and meet the needs of its people; economic, social cultural, educational, recreational, civic, historic, transportation, and any other.
4. To protect and enhance scenic, historic and natural areas.
5. To specifically protect certain natural areas from improper development-floodplains, ponds, and wet lands, prime agricultural land, and higher elevations, and selected 'wild areas.'
6. To provide for orderly growth and development of the town over the next 25 years.
7. To identify and achieve optimum growth rate and population size.
8. To control the level of municipal services at the level which is compatible with local incomes.
9. To increase the self-sufficiency of the town.
10. To increase efforts for local energy conservation through wise land use planning and resource management.
11. To encourage that Acworth become a mixture of 'bedroom' residential town, seasonal and second homes, retirement homes supporting services, and commercial and family agricultural enterprises.
12. To encourage the development of 'cottage industries' in Acworth; which will be primarily clean, non-polluting, small scale, owner-operated, and locally employing.
14. To promote the development of non-intensive natural resource-based industries in the field of forest and agricultural products.
15. To preserve the 'rural quality' of recreation and recreational areas.
16. To obtain or retain conservation easements to important local recreation areas.
17. To provide for appropriate development of non-intensive commercial recreation.

18. To protect and properly manage the town Road System within the financial means of the town.

Since reaction by those attending the meeting seemed favorable, these goals remained basically the same. As we continue to work on the policies, there will probably be some modifications, and we are still very much open to suggestions. The Upper Valley-Lake Sunapee Council is presently working on combining the natural and manmade factors and tempering them as goals and policies to prepare a set of alternative sketch plans.

It is hoped that this work will be completed and presented to the town at a public hearing in the spring.

While final adoption of the Master Plan is the responsibility of the Planning Board, the preparation has involved many more. Much of the data gathering and mapping has been done with the selectmen, Conservation Commission, Road Committee, Sullivan County Soil Conservation Service, our County Engineer, and the Upper Valley-Lake Sunapee Council. The goals are a result of many meetings and discussions with these groups with consideration given to every answer and comment on the questionnaire or at public meetings. The final plan will, of course, be used by the entire town as well.

By summer we expect to start drafting a revised zoning ordinance. There will be at least two public hearings and possibly a special town meeting to adopt this.

Other possible means of implementing the Master Plan are adoption of an official map, a building code, site-plan review, road specifications, and acquisition of land or easements.

It is hoped that everyone will really make an effort to attend all public meetings and give us their opinions.

ANNUAL REPORT
Acworth Conservation Commission

Much of the Commission's efforts in 1975 were expended toward the preparation of the Town Master Plan. At many joint meetings with the Planning Board, we discussed issues and areas which were concerned with conservation, recreation, growth and development. The recommendations, which resulted from these meetings, will be presented to the public in a more specific form at the public meetings and hearings that will be held in the coming months. We strongly urge those who have an interest in the natural areas of Acworth and their conservation to attend and participate in these future meetings, which will be publicized well in advance.

To better acquaint many of us and to reacquaint others, the Commission plans to sponsor a trail ride with four-wheel drive vehicles to some of the areas of particular interest and concern in mid-Summer of 1976. This will enable citizens unable or unfamiliar with some of our most interesting features to better understand what specifically we wish to preserve.

In 1975 we were unable to find an eligible student interested in the Conservation Camp sponsored by the New Hampshire Association of Conservation Commissions and the Society for the Protection of new Hampshire Forests. As we feel that this remains a worthwhile project, we will repeat our efforts in 1976.

One of our members paid a visit to the State Department of Fish and Game to express interest in its plans for Mitchell Pond. The Department shares our concern that the pond remain untampered with, and further expressed great admiration and interest in our activities, specifically our conservation zone along streams and pond shores. In fact, it has requested a copy of our regulations to use as a guide for other towns interested in protecting their watersheds.

In closing, we wish to re-emphasize that we all have the duty to use our land wisely, and hope all citizens will help us achieve that end through an active interest in land-use planning.

ROAD COMMITTEE REPORT

As the Highway Budget is the second largest expense item faced by Acworth taxpayers (exceeded only by School and County), your Committee has held many meetings with the Selectmen and Road Agent this year, taking hard looks at such items as:

1. New Construction (TRA and Town) .

It was the consensus of opinion that TRA funds for 1976 be used to cap Luther's Hill, and complete the Crane Brook Road to the Charlestown Road section: to cap the new construction (1975) on the Forest Road. Future priorities will be for two (2) small pieces of Forest Road, and then work at the completion of the Crescent Lake Road.

2. Sealing maintenance of present roads.

Sealing and edge care of existing blacktop roads is imperative to maintain and prevent deterioration of those good sections of roads (both TRA and town constructed, in the following order:

- (a) Crescent Lake Road
- (b) Crane Brook to the 1975 construction:
- (c) East Acworth Road:
- (d) The good sections of Derry Hill Road and Charlestown Road: and
- (e) That the 1976 capping be sealed in 1977.

3. Abuse of any roads during mud season.

The Selectmen have our approval to take firm stand on mud season use of all highways, using their authority to post any roads as need arises.

4. Construction of new driveways and access roads considered damaging and/or expensive to town Highway maintenance.

The Selectmen, Road Agent, and Zoning Board shall enforce Section 17; Chapter 249, NH Statutes re driveways and accesses to public highways.

5. Changing some pieces of road from Class V to Class IV (see Warrant).

6. Discontinuing maintenance from December 7 to May 1 on others deemed nonessential during this period.

Summary: On the whole, equipment isn't too bad. Hopefully, our \$3,500.00 'stop-gap' grader can be used one (1) more year. However, be prepared to think in the 1977 Budget proposals for expenditure for one (1) new or good used grader.

The 'small' truck should have two (2) years more use before losing most 'trade-in' value. (This includes 1976 and 1977). The 4 WD used for plowing only should be good for a while.

We wish to thank all who, willingly or not, have put up with inconvenience. **'WE ARE TRYING !'**

REPAIR OF HIGHWAYS BY TOWNS CHAPTER 245:3

The money so raised and collected shall be expended in repairing Class IV and Class V highways by the agents elected or appointed for the purpose, under the direction of the selectmen.

LIABILITY FOR OBSTRUCTION OR INJURY TO HIGHWAY CHAPTER 249:37

DAMAGING HIGHWAY: PENALTY

If any person, without authority, wilfully injures any highway or bridge thereon by destroying or taking away any plank, timber, stone or other material thereof, or by digging any pit therein, he shall be fined not more than one hundred dollars, or imprisoned not more than six months.

CIVIL LIABILITY CHAPTER 249:38

If any person shall place any obstruction in a highway, or cause any defect, insufficiency or want of repairs of a highway which renders it unsuitable for public travel, without authority, he shall be liable to the state for all damages to the highway when maintained by the state, and to the town for all damages to other highways, and for all damages and costs which the town shall be compelled to pay to any person injured by such obstruction, defect, insufficiency or want of repairs.

GENERAL INFORMATION CHAPTER 249:17

The fundamental objectives are : (1) to provide maximum protection to the public through the orderly control of traffic movement into and from the highway, (2) to provide a uniform practice throughout the state in the design and construction of entrances and exits and, (3) to provide the necessary drainage at all times to ensure a safe and controlled approach to the highway in all seasons of the year.

POLICE REPORT-1975

Early in the year at a meeting with the selectmen, it was agreed to appoint Jack Berquist and Arthur Smith to assume dog officer responsibilities. Mr. Berquist was also authorized to assist the constable in the event that it was needed. This arrangement has worked quite well.

We feel that some effort should be made to locate owners of stray dogs or homes found, and in nine out of ten cases we have been successful.

Arthur Smith was paid \$50.00 for care of dogs and expenses incurred locating owners or homes. Jack Berquist was paid \$50.00 for answering complaints and picking up stray dogs and destroying one dog. He was also paid \$25.00 for police assistance.

In June we purchased the tired and retired Charlestown police cruiser--although tired it was priced right. Some repairs were made at the local garage, the doors repainted and radio equipment installed with a new component which enables direct communications with state police units on a local level. At this time the car is fully equipped and should be of good service for the next few years.

It has been most valuable as identification at accidents, day patrols at Cold Pond, checking for reported burglars, etc. An example was a call at three a.m. last summer from a part-time resident who had discovered a 'ticking' in his car. He had reason to believe and felt that a delayed timing device had been placed in his car before his departure from New York City. I was able to be in radio contact with a State Police bomb expert while I conducted a very cautious but thorough search of the car, and was able to discover the cause and eliminate his concern.

Burglary is the biggest and most frustrating concern to the small town police. Since generally the perpetrators are from out of town, or, at any rate, the stolen property is quickly disposed of out of town, it is rare that enough evidence is found locally to make an arrest. We were able to do so this summer because two residents suspicions were aroused and they reported what they saw.

However, the majority of these cases must be turned over to the State Police for investigation, and of the hundreds of items reported stolen from town in the last several years, almost nothing has been recovered. Based on this experience, it is my feeling that the State Police should place more emphasis on this type of problem.

Report on the Acworth Bicentennial History

In defining the purpose and content of the Bicentennial History, it soon became evident that a 'sequel' to Merrill's 1869 History of Acworth would not serve the interests of future readers very well. Some areas of history are covered very sketchily, if at all, in Merrill's History and even today, that book is not readily available.

The objective now is to prepare an integrated history of Acworth from the beginning of the town to 1976, drawing information from any source that may be of value. Merrill's History is one such source, as is the material prepared for the Historical Society in 1967/8 by Mr. Newton F. Tolman (covering 1868-1967). Unfortunately, this latter requires extensive additions and revisions and cannot be used in its original form.

Much time and effort have been spent during 1975 abstracting material from original Town records, papers in the N.H. Historical Society in Concord, records in the N.H. State Library and in the N.H. Records and Archives Center, and deeds on file in Keene and Newport. Work is progressing, although considerable further effort is required. Assistance will be welcomed from anyone who seriously desires to help complete the history as soon as possible.

Besides 'old' history, there will be a description of Acworth in 1976. Also, special attention will be given to the most recent period (within the memory of those now living). It is expected that the Acworth American Revolution Bicentennial Committee's project for collecting orally the recollections of older inhabitants and also for photographing present houses and buildings will contribute significantly to these sections.

**REPORT OF THE FALL MOUNTAIN VISITING NURSE ASSOCIATION
December 31, 1975**

In 1975 the Fall Mountain V.N.A. made 2478 visits and, in addition, saw 216 patients in cancer prevention and blood pressure clinics. This is a total of 2694 patient services, 90 % more than were provided in 1974. A total of 363 different individuals were serviced in 1975, which is 6% of the population of the four-town area.

Since activity far exceeded what was anticipated, the proposed budget of \$29,289 for 1975 proved unrealistic. Total expenditures by the Agency in 1975 were \$37,637.22, \$8,348.22 more than had been planned for. It was able to meet expenses through reimbursements by patients, government agencies, miscellaneous gifts and the \$2.00 per capita, contributions made by the four participating towns.

Contributions by the towns are a significant part of the V.N.A. budget, enabling the Agency, in particular, to serve those patients who are ineligible for reimbursement by Medicare, Medicade and private insurance. A breakdown of the sources of income during 1975 follows:

For 1976 the participating towns are requested to contribute \$1.50 per capita, instead of the \$2.00 assessed in 1975. It is possible this will not totally underwrite the Association's non-reimbursed costs, but in that event the Board of Directors will seek other sources to fund the balance.

(North Walpole, in addition to Acworth, Alstead, Charlestown, and Langdon, will receive V.N.A. services beginning January, 1976.)

TOWN HALL STATEMENT

Forty years ago, the Town voted 'That the Woman's Club of Acworth be allowed to put an 18 ft. addition on the north end of Town House, same to be used for a stage, and that a committee of four consisting of Walter Slader, Guy Neal, Cara Johnson and Sarah Potter with the assistance of Hartley Dennett constitute a building committee.' (Town Mtg., March 12, 1935)

During our planning and research for the proposed reconstruction of the Town Hall we were given the original plans drawn by Mr. Dennett with the Following statement.

PROPOSED ADDITIONS TO THE ACWORTH TOWN HALL

An extension of 18 ft. at the rear of the Town House, to be one large room, for division by curtains into Stage and Dressing Rooms. Floor 2½' above Hall floor. Opening into Hall 20 ft. wide. Also a door at either end of the North wall by which to enter the dressing room ends of the North wall by which to enter the dressing room ends of the Stage, and as fire exits.

In the space beneath the stage, if possible an excavated cellar about 8 x 17 ft. under each 'dressing room' end. The concrete floor would be 3½ to 4 ft. below the main sill of the present building.

The N-W Cellar, with outside entrance, to be reserved for a future hot air furnace for heating the whole building. The chimney flue rising from this cellar would have an opening in the Hall for an additional stove for temporary use, and an opening for a small cook-stove in the dressing room, the stove to be a part of the small kitchen outfit for use at this end of the addition.

The N-E Cellar, reached from the East Stage Entry by a short stairway, would have space for a chemical toilet. Each side of the Stage to have an outside door, the one on the West convenient to the woodpile while the building is heated by stoves, and for access to the furnace cellar and a second toilet (by an area door).

A slight projecting porch on the front of the building would provide a vestibule for ticket-taking and to protect the audience from drafts. It is especially desirable to fill the practical needs of the enlarged Town House in such a way as to serve also to make the building conform in appearance to the Church front and Steeple. It is through that priceless relic that Acworth is known to increasing numbers of lovers of New England.

REPORT OF THE TREE WARDEN

In the event that in honor of the American Revolution Bicentennial or for any other reason individuals might wish to plant or designate certain trees within any town rights of way as 'public trees' it is suggested that they contact the Tree Warden personally, or through the Acworth Conservation Commission.

'Public Trees' can only be designated when occurring on town owned property or within town rights of way. The Tree Warden must determine what if any trees may qualify. Oaks-white, red and pin
Maples-Norway and vigor
Linden-little leaf
Katsura tree
Ash-Marshall's seedless

EXCERPTS FROM THE N.H. STATUTE 478

1. Qualification for Bonus. Each person who actively served for a total period of ninety days or more in any capacity as a member of the armed forces of the United States between August 5, 1964 and August 15, 1973 or who served in the Vietman area at any time between July 1, 1958 and August 5, 1964 and earned the Vietnam service medal or the armed forces expeditionary medal; and who was discharged, released or has a certificate of service therefrom, under honorable conditions, or who is missing in action; and who at the time he entered such active military service and at the time of discharge or release, was a bona fide resident of this state, shall be entitled to the benefits provided under this act. Enacted August 22, 1975. More information and application forms available from Town Clerks.

CHAPTER 39

TIME FOR HOLDING TOWN-MEETINGS AND WARNING THEREOF

39:1 Meetings, When Held. A meeting of every town shall be holden annually on the first Tuesday of March for the choice of town officers and the transaction of all other business. A town-meeting may be warned by the selectmen, when, in their opinion, there shall be occasion therefor.

39:2 Warrant. The warrant for any town meeting shall be under the hands of the selectmen, and shall prescribe the place, day and hour of the meeting, and, if there is an election at said meeting, in which an official printed ballot containing more than one name is used, the warrant therefor shall prescribe the time the polls are to open and also an hour before which the polls may not close. A town meeting may vote to keep the polls open to a later hour but may not vote to close the polls at an earlier hour than that prescribed by the selectmen hereunder. The subject matter of all business to be acted upon at the town meeting shall be distinctly stated in the warrant, and nothing done at any meeting, except the election of any town officer required by law to be made at such meeting, shall be valid unless the subject thereof is so stated. Provided that in case where the article in the warrant calls for the appropriation of specific sum of money the sum of money appropriated thereunder may be decreased or increased by the vote of the town, provided further that in a town under the municipal budget act no increase shall be valid which would violate the provisions of RSA 32:8.

Faught of Acworth, County of Sullivan, State of N.H. the receipt whereof it does hereby acknowledge, has given, granted, bargained and sold and by these presents does give, grant, bargain, sell, alien, release, convey and confirm unto the said John H. Faught, his successors and assigns forever, a certain piece or parcel of land lying or being in the said Town of Acworth and described as follows- On the north by land of Alice Patty Holden; on the east by land of Hattie Cabot; on the south by land of Mable George and the house lots of Dames Nichols, and Bertha Prince and John H. Faught; on the west by the highway leading to Acworth Town; meaning to convey about 40 acres. Reserving the water rights of Mable George and right to make necessary repairs of same.”

NEW HAMPSHIRE NON-PARTISAN BALLOT LAW

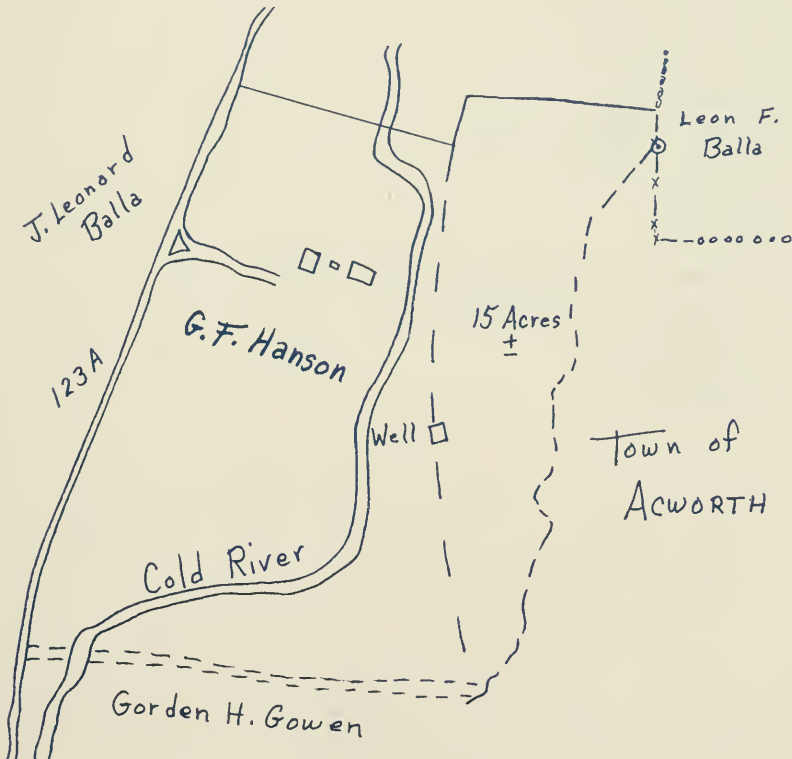
The provisions contained in Revised Statutes Annotated Chapter 59, Section 73 as amended by the Session Laws of 1965.

“Adoption of Non-Partisan Ballot System. Towns may adopt a non-partisan ballot system, as hereinafter provided, for the election of town officers under an article in the warrant for any annual or special meeting at which action is to be taken, and may rescind such action in like manner. If such ballot system is adopted by a town, the system shall not be in effect in said town until the town meeting next following the meeting at which such action is taken. In towns where this ballot system is in force, a plurality vote shall elect. The town Clerk shall prepare the ballots and all candidates for office shall file their declarations of candidacy or petitions of nomination with the Town Clerk no earlier than thirty-five days before and no later than five o'clock in the evening of the second Monday next preceding the day of the election.”

The price discussed is \$200.00 per acre and the survey indicates that the acreage under discussion is 15. As we have already paid \$1,200.00 for timber rights based on an estimated area of 12 acres the amount that would be paid to complete the purchase is \$1,800.00, ie \$1,200.00 for the land on which we have acquired timber rights and \$600.00 on the three acres upon which no payment has yet been made.

The boundary between the land that we wish to purchase and that which would be retained by the Town follows the center line of a very sharp and well-defined ridge, and on the south end it intersects an old town road now used as a snowmobile trail. We would like to dedicate part of our portion of the crest of the ridge for a recreational trail for hiking, horseback riding, cross-country skiing etc. as well as snowmobiling provided that the trail would be constructed and maintained so there would be no erosion.

Our reason for wishing to purchase this property is to protect the spring belt that supplies our water supply, and to preserve, in a natural state, that portion of the Cold River watershed that lies directly up slope from the land that we already own.
