TOWN WARRANT

STATE OF NEW HAMPSHIRE

(L.S.)

To the Inhabitants of the Town of Goffstown, in the County of Hillsborough, and in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Grange Hall in Goffstown Village on Tuesday, the fourteenth day of March next, at ten o'clock in the forenoon to act upon the following subjects:

First—To choose all Town Officers and Agents for the ensuing year, including a member of the Board of Selectmen for three years.

Second—To see how much money the Town will vote to raise and appropriate for the Goffstown Public Library.

Third—To see how much money the Town will vote to raise and appropriate for maintenance and improvement in our cemeteries.

Fourth—To see if the Town will vote to raise and appropriate the sum of Two Hundred Dollars for maintenance and improvements at the Barnard Playground.

Fifth—To see if the Town will vote to raise and appropriate the sum of Four Hundred Dollars for the suppression of the White Pine Blister Rust.

Sixth—To see if the Town will vote to allow the Public Service Company of New Hampshire to cross Hillside Cemetery with a new electric line connecting its Brook

Street Station in Manchester with its Plant at Gregg's Falls in Goffstown,—said Company agreeing not to erect any poles or towers within the boundaries of said Cemetery.

Seventh—To see if the Town will vote to co-operate with the Precinct in the installation of a fire alarm signal,—the amount asked not to exceed Six Hundred (\$600.00) Dollars from the Town. Should the vote result favorable, to raise and appropriate money for the same.

Eighth—To see if the Town will vote to accept State Aid for the construction of Class Two Road, known as the Shirley Hill Road, and to raise and appropriate or set aside for said purpose the sum of Two Thousand Sixteen and $75/100$ (\$2016.75) Dollars, the State to contribute an equal sum, or will vote to accept State Aid for improvement of Class Five Roads and to raise and appropriate the sum of Nine Hundred Forty-five and $13/100$ (\$945.13) Dollars, the State to contribute Three Thousand Seven Hundred Eighty and $53/100$ (\$3780.53) Dollars.

Ninth—To see if the Town will vote to authorize its Selectmen to borrow from time to time, as needed, certain sums of money in anticipation of taxes, not to exceed in total at any time the sum of _____ dollars, giving the Selectmen the right to renew said loans in anticipation of taxes as may be found necessary.

Tenth—To see if the Town will vote to authorize its Selectmen to administer or dispose of any Real Estate acquired by the Town through the Tax Collector's Deeds.

Eleventh—To see if the Town will vote to allow its Selectmen to renew the Bridge note, so called, held by the Hillsborough County Savings Bank, upon which ten

thousand (\$10,000.00) Dollars is due August 1, 1939, at such times as the bank may require.

Twelfth—To see what sum of money the Town will vote to raise and appropriate for the support of the poor, construction and maintenance of Highways and Bridges, and all other necessary Town expenses for the ensuing year, including the amount required for Memorial Day.

Thirteenth—To see if the Town will vote to pay the Manchester Water Works the sum of One Hundred Five (\$105.00) Dollars annual rental for three new hydrants installed on the extension of their water main from Bartlett's Corner, so called, to Grasmere on the Mast Road, so called, and to raise and appropriate money for the same.

Thirteen and one-half—To see if the town will vote: To elect one Road Agent for the year of 1940, To set his salary at fifteen hundred dollars (\$1500.00) annually, To require that he give his full time to the Town work, To require that he have no financial interest in any truck or trucks that are operated for the Town, To require that he make a full report, in the 1941 Town report, of his activities, receipts and expenses for the past year and his recommendations for the next year, or take any action in regard to Road Agents. This article is inserted agreeably to the petition of A. Kenneth Hambleton and nine others.

Fourteenth—To see if the Town will vote to accept and improve Haig Street, said street is shown on plans of Libby Plat and Libby Plat Annex,—said plans are on file in the Hillsborough County Registry at Nashua, N. H.,—and to raise and appropriate money for the same. This article is inserted by the petition of Zeb Barry, Jr., and forty others.

Fifteenth—To see if the Town will vote to accept and improve Louis street, said street is shown on the plan of Provencher Plat,—said plan is on file in the Hillsborough County Registry at Nashua, N. H.,—and to raise and appropriate money for the same. This article is inserted agreeably to the petition of Ovila P. Bourgeois and fifty others.

Sixteenth—To hear the reports of Agents, Auditors, and Committees and pass any vote relating thereto.

Seventeenth—To transact any other business that may legally come before said meeting.

RECORD OF TOWN MEETING

Goffstown, N. H.—March 8, 1938

Meeting called to order by moderator, Alfred W. Poore at 10:00 o'clock in the forenoon.

ARTICLE 1

Article one of Warrant was read and check list posted. On Motion of Robert Gordon it was voted that polls be now opened for voting; that the balance of warrant be read and articles 2 to 21 be taken up and acted on at 1:30 o'clock in the afternoon. That the polls close at 6:30 o'clock P.M. That our next annual Town meeting open at 10:00 o'clock in the forenoon.

Polls were now opened and blank ballots counted.

1:30 o'clock P.M. Balance of warrant was read. The following officers were elected in open meeting.

Report of the Budget Committee was given at this time by the chairman, Raymond C. Greer.

ARTICLE 2. Voted to raise and appropriate the sum of \$1200.00 for the Goffstown Public Library.

ARTICLE 3. Voted to raise and appropriate the sum of \$400.00 for the maintenance and improvement in our Cemeteries.

ARTICLE 4. Voted to raise and appropriate the sum of \$200.00 for maintenance and improvement at the Barnard Playground.

ARTICLE 5. Voted to dismiss this article.

ARTICLE 6. Voted to accept State Aid for Class Five Roads and raise and appropriate the sum of \$942.98, the State to contribute the sum of \$3,771.95.

ARTICLE 7. Voted to increase the pay of our laborers on the highways from 33 $\frac{1}{3}$ cents an hour to 40 cents an hour.

ARTICLE 8. Voted to allow the Selectmen to borrow from time to time as needed certain sums of money in anticipation of taxes, not to exceed in total at any one time the sum of \$40,000.00 giving the Selectmen the right to renew said loans in anticipation of taxes as may be found necessary.

ARTICLE 9. Voted to authorize the Selectmen to administer or dispose of any real estate acquired by the Town through tax Collectors Deeds.

ARTICLE 10. Voted to allow the Selectmen to renew the Bridge note, so called, held by the Hillsboro County

Savings Bank upon which \$11,000.00 is due August 1st, 1938 at such times as bank may require.

ARTICLE 11. Voted to combine articles 11, 12, 13 and 14 and raise and appropriate the sum of \$2,000.00 for these streets (Joffre, Petain, Louis and Higgins) and that the expenditure of the same be left to the Board of Selectmen.

ARTICLE 15. Motion was made to combine Article 15 to 16 and act on the same as one. Motion lost.

Voted that vote stand as recorded.

Motion. That when we rebuild our Town House we shall use the old site for that purpose. Motion was withdrawn.

Voted to dismiss Articles 15, 16 and 17.

200 Voting Yes

110 Voting No

ARTICLE 18. Voted that we act favorable on this article and that the Selectmen procure Federal Aid for this project provided the same can be obtained and that we raise and appropriate the sum of \$800.00 for a storm sewer on Church and Clinton Streets.

ARTICLE 19. Voted to act favorable on this article and that the playground Commissioners be appointed in open meeting and that the first appointment be made at the annual Town Meeting in March 1939.

ARTICLE 20. Voted to accept the printed reports.

ARTICLE 21. Voted to extend a vote of thanks to Frank N. Simons and the special committee for services rendered in securing figures and recommendations regarding the building of a Town Hall.

Voted to raise and appropriate the sum of \$88,899.94 for legitimate Town expenses as recommended by the

Budget Committee. An amendment was made to reduce the above amount to \$80,000.00. Amendment not carried.

Voted that the Selectmen be authorized to begin at once to remove the ruins of the old Town Hall and that Town Labor be used for that purpose.

ARTICLE 21, *Continued*. Motion that the board of Selectmen be instructed to reconvene the old Town Hall Building Committee, proceed to sit with them at public hearings and decide when, where and what type of building shall be erected. To prepare plans, obtain options on land, etc. This committee to report at the next annual Town meeting. Motion lost.

ARTICLE 21, *Continued*. Voted to instruct the Selectmen to insert an article in the 1939 Warrant relative to One Hundred Dollars increase in salary of Town Clerk and Town Treasurer.

No other business, balloting was resumed.

The following Resolutions presented by
A. Kenneth Hambleton

ARTICLE 21, *Continued*.

RESOLVED: That it is better of men on relief to be employed at gainful work than to be idle and receive direct relief.

RESOLVED: That the tax payers of this Town are paying their proportionate share of the tax levies which make up the funds of the several Federal aid Agencies.

RESOLVED: That as far as can now be determined the present method of Federal aid will be continued for some time to come.

RESOLVED: That we are helping to finance so called "Made Work" the country over whether or not we have any in this Town.

RESOLVED: That it is the sense of this meeting, that because of these reasons, the Selectmen be instructed to make use of Federal funds for so called "Made Work" provided that the best interest of the Town will be served.

Voted to adopt the above resolutions.

PRECINCT AND TOWN REPORT OF FIRES, 1938-39

During the past year we have responded to the call for 40 fires, 13 in the Precinct and 27 for the Town.

Precinct—4 chimney, 1 grass, 1 oil burner, 2 dump

1 R.R. ties, 1 auto tires, 3 house fires

Town—10 chimney, 4 grass, 8 brush, 1 oil burner

1 truck, 1 barn, 1 street car, 1 false

The house of Mr. Champagne sustained a loss of \$620.00; \$460.65 furniture.

The house of Mr. Will Richards a loss, amount not settled yet. Both in the Precinct.

Sparks from the burning street car set the barn roof at Henry Montgomery's on fire in several places and we were fortunate that none entered the hay stored beneath. The value of the Booster Pumps and Tanks certainly saved us lots of trouble. The only loss was the re-covering of the roof of the barn.

While I regret to be obliged to make this statement, we had 3 brush fires caused by the carelessness of the Boy Scouts of Manchester. Building camp fires on windy days caused the Town an expense of over \$100.00.

As I am about to bring to a close my duties as Forest Warden in the Town of Goffstown (having held that position for several years), I desire to extend to every citizen my deepest gratitude for their willingness to assist by asking for permits to burn and lending a helping hand when asked to do so. My relations with the Town and State officials have been most pleasant, and I am pleased to say that I have made many friends in Southern New Hampshire by having the privilege of serving you as Forest Warden. May I ask each and every one of you to try even more than you have in the past to do all in your power to assist whoever is appointed to fill this office—first, by obtaining permits to burn; secondly, try and be very careful about setting, and always keep your fire under control.

As Chief of the Fire Department, there is one article in

the Town Warrant to which I wish to call your attention. This article relates to the Town assisting the Precinct in installing a new fire alarm. For many years we have had as fine a system as any city, and our insurance rates have been classed accordingly. During the hurricane we lost our only chance for alarm in case of fire. Personally, I worked daytimes and for twelve of following fourteen nights stayed at the fire station in order to do everything possible should occasion require to summon assistance. I gave my time willingly until the sirens were installed.

The Fire Wardens met with Mr. Nettleton and discussed the matter of replacing the whistle on the shop. Running on short hours, the extra cost of holding steam pressure nights, Saturday and Sundays was figured out, which the Precinct or Town should pay for, was found to be so high that the new installation will pay for itself in three years' time and will last indefinitely. Therefore one is to be installed as soon as possible.

I sincerely hope someone in open meeting will express the thanks of the townspeople to Mr. Nettleton for what has been done in the past. For several years he has operated the same at a loss.

The Precinct house furnishes heat and janitor service to look out for the fire trucks. You will also notice that practically 70% of the fires are Town calls. Citizens of the Town, outside of the Precinct, are you not willing to do your part to protect your rate of insurance as well as your property and life?

In closing, I must express my appreciation for the loyalty of the Fire Wardens and Firemen and for the fine treatment I have received from the Selectmen.

REPORT OF TRUSTEES GOFFSTOWN PUBLIC LIBRARY

Despite the crowded conditions in the Library building due to the continued occupancy of the children's room by Town officers, the Librarian reports an increase in both circulation and registration. Even in a small town such as Goffstown the population is constantly changing and the Library is one of the first places to be visited by new residents. To make new patrons feel welcome and to supply them with books they want is one of the pleasant duties of the Librarian and her assistant, Miss Annie Harrington.

Two hundred dollars have been expended on interior repairs which have long been badly needed. The stack room especially was in very bad condition, with cracks in the walls and the ceiling dingy. Plaster and paint have made a remarkable improvement and when the work is completed the building will be a credit to the Town and a more cheerful place in which to work.

In order to facilitate book mending and decrease rebinding costs a rebinding outfit has been purchased. With the help of these materials it will be possible for the Librarian and her assistant to do most of this work in the building without having to withdraw the books from circulation for any length of time.

The legacy of the late Henry W. Parker was made available for use early in the year and the income from it was used for the purchase of books. Subscriptions to several of our magazines have been paid for by interested individuals and a gift from the Shirley Club added twenty-four volumes which we otherwise would not have had. Again we extend our thanks to all who have so generously remem-

bered the Library. We feel that such gifts are evidences of approval, by the givers, of the Library and the work it is doing for the community.

REPORT OF THE SCHOOL BOARD

GOFFSTOWN INDEPENDENT SCHOOL DISTRICT

During the 1938-39 school year the usual minor repairs and improvements have been completed. A correct lighting system has been installed for grades 1 through 6, after the old lights were found to be less than 40% efficient. New front doors with glass panels which enlighten the hallway and are equipped with new panic-bar locks have been placed in the Old School Building. The doors were recommended by the State Board of Education as an additional safeguard in case of fire. A serious crack in the chimney at the High School Building necessitated rebuilding a major portion of the chimney.

The Board was informed by the boiler-inspector that the boiler in the Old School Building was not safe for further use unless all new tubes were installed and certain welding performed. This work was put up for bids and the Scannell Boiler Works being the lowest bidder was awarded the contract at a cost of \$375.00. The work included the installation of Charcoal Iron Tubes, beaded over, and certain welding. The boiler is now in good condition and guaranteed to give efficient service for at least twenty years.

The Hurricane did considerable damage to the roofs of both school buildings. Three of the large ventilators at the high school building were blown down and badly damaged. A large portion of the shingles and metal gutters had to be replaced on the old school building. Total cost of hurricane damage, \$225.00.

The District paid a State Tax of \$438.00 which is \$2.00 each for our 219 pupils in this district.

The Board wishes to acknowledge the faithful work and co-operation of our Superintendent, teachers, pupils, and parents during the past school year.

To the Citizens and Voters of the District:

Teachers

During the summer vacation resignations were received from Priscilla Noddin, teacher of English; Ailene Taylor, Commercial teacher; and Bernice Whitehead, teacher of French and Latin. Miss Noddin had been elected to fill an English vacancy in the Portsmouth High School. Miss Taylor accepted a commercial position at Windsor, Vermont, and Miss Whitehead was married in August. All of them had done splendidly in their respective lines of work.

Mrs. Elaine T. Eldridge, a graduate of Smith College, a year's study in Paris and three years of successful experience, is now the teacher of French and Latin.

Miss Alice J. Hazlett, a graduate of the State University, with two years of successful experience in Massachusetts came to take charge of the commercial work.

Miss Elizabeth Scribner, a four-year English major and graduate of Keene Normal School, and one year of successful experience has "taken over" the work in English. We have been fortunate in securing persons of such excellent training, ability and experience to work with us here.

It is worth noting that for the past few years a number of the teachers have been doing work at Boston University and at New Hampshire University. Headmaster Stanley Wright, Katherine McLain, George Jones, Florence Harris, and Kathryn Walsh have been doing advanced work.

The "attendance" is always regularly very high, including elementary and high school. The percentage for last year was 96.4.

Tendencies

The recent "Wage and Hour" legislation has made some tendencies very clear, and of concern to school officials. One is that laborers in shops, mills, and factories will spend fewer hours at their work. Not only that—but many "jobs" which in years past have been open to young people in their middle teens are now finally closed until the age of eighteen, at the earliest. It may be possible that this age limit will be raised to twenty instead of eighteen years. Moreover, in many lines jobs are growing fewer and fewer due to increased use of machinery. Machines will not be crowded out, but workers will be. There are at present, many "labor-saving" devices—perfected—which could be put into use in a short time. These inventions are being held back, for to bring them into productive use now would revolutionize many industries causing thousands of workers to "lose their jobs." Not only in mills and shops is this true, but in offices as well, where machines of various types do counting, recording, computing, and many items formerly done by an "office force." During these latter years, one of the country's most serious problems has been and is that of "unemployment." Such facts indicate that schools will need to change their "courses of study," adding more of Arts and Crafts, Home Economics, Agriculture, and shop work of a varied kind, for many young people will be forced to one of two things—idleness or continuing in school. As schools are, many of them are not now giving the types of work that will be demanded.

"Manual Training," as it was formerly called, is meeting with a splendid response. There are twenty in the high school cabinet-making group. Very few outside of school realize what type and quality of work these young people do. In the past the value of this work was thought to be the skill acquired, and this skill was supposed to be

acquired by making many small items, toys, etc., but it has been found out that these pupils can make something of value. This gives more incentive to the work: acquire skill while making something of use.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

*To the Citizens of the Goffstown Town
School District:*

During the summer vacation added school-space was made available to the Grasmere Building. One partition was moved and windows were re-arranged, which provided a comfortable room. Closets for books and supplies were built. At the same time, a steam heating plant was installed, which has worked most satisfactorily this year. This provides for heated rooms, halls, and toilets—making the building more safe and comfortable throughout.

With three rooms instead of two, a division of the "load" has been possible. Miss Viola Winterer was engaged as the added teacher. The eight grades were divided—Mrs. Ida Lake for grades one, two, and three; Miss Winterer has four, five, and six; Miss Jones has seven and eight. This divides the group of 84 pupils quite evenly, and makes possible more effective work. For the last few seasons, the "load," especially in the upper grades, was much too heavy. The school census in 1936 showed a school population (ages 5 to 16 years) for the district, of 577. The following year, 1937, the census showed 546, an increase of 31. The census of 1938 recorded 521, a decrease of 25 over the preceding year and a total drop of 56 from the "high" of 577 in 1936. This half-hundred drop may account for the smaller enrollment at the Bartlett Building. Since the census of September 1929, of 480, the number increased steadily year by year, with but one exception, to the highest point of 577—in the fall of 1936. The increase through these years was almost 100, but the last two years have recorded a loss of 56. This census includes not only those enrolled in public schools, but also includes all children in the district between the ages of five and sixteen. The total enrollment in the schools of the district during the last six years indicates a drop. Beginning with this current year and going back, the school enrollment has been as follows: 237, 241, 262, 257, 248, 252. However, the loss is practically all in the Bartlett School area—for in the last few years, the Shirley Hill and Parker Station groups have been somewhat larger.

The total enrollment from this district, though, should include the 59 different pupils in Goffstown High School, five in Manchester Central, and 19 in West Side. This

makes a total of 83 high school pupils. Adding these to the elementary enrollment of 237, there is a total of 320 pupils in elementary and high schools, which this district is educating.

The number of high school pupils, in Goffstown 59 and Manchester 24, is a total of 83, and calls for an expenditure of about \$6,000 for high school tuitions. The tuitions are at the rate of \$80 per pupil per year.

REPORT OF THE SCHOOL BOARD

GOFFSTOWN TOWN SCHOOL DISTRICT

Supervisory Union of the Goffstown School District held their Annual Meeting at New Boston High School on May 15th, with Mr. Roland Barnard, Chairman, presiding, and Mr. J. Byron Tarney was re-elected our Superintendent.

The amount due from our District to the State Treasurer's office for 1939 will be \$670.00 for 335 pupils at the rate of two dollars for each pupil enrolled.

In this year's budget the two largest items are High School tuition and transportation. In both items we have no control. The Board in the past have allowed for two or three extra tuitions for "floating" pupils. This year we found ourselves with thirteen extras—an increase of \$1,040 at \$80 each—Results, budget asked for \$5,000, and spent over \$6,000, which means asking for additional \$800 in an Article in the School Warrant to cover same. The estimated income took care of part of the \$1,040 increase.

This year improvements were made at Shirley Hill and a steam heating plant at Grasmere, also making over a spare room at Grasmere for a schoolroom where an additional teacher was installed, Miss Winterer of Manchester, N. H. The total cost of same and fixing the basement suitable for furnace and coal bin were met by special item and minor repairs. These are mentioned in the Financial Report.

The increase in next year's budget due to transportation and tuition, we have no control over and have tried to reduce where possible.

Again the Board wishes to acknowledge faithful work and co-operation of our Superintendent, teachers, and parents.

REPORT OF THE CEMETERY TRUSTEES

The past year has been a favorable one for the lawns in our cemeteries. The rainfall the past Summer was above the average and consequently they required mowing more often, thereby increasing somewhat the cost of care.

The September hurricane also caused extra labor to clean up the debris.

At West Lawn, some of the spruces planted beside the drives, which had grown to such a size as to become a nuisance, were removed, adding to the looks of the cemetery and greatly increasing the width of drives. In the near future more of them will have to be removed as they not only encroach upon the drives but their shade tends to stain the monuments and other markers.

At Hillside Cemetery the same standard of upkeep was maintained and some improvements were made. Before many years new drives will have to be built and lawns laid out.

At Shirley Hill the additional land obtained has been partially enclosed by a new stone wall and it is hoped that the coming Summer it will be completed in compliance with the wishes of its donors.

During the past year we have received substantial contributions to the perpetual care funds, showing there is a continued interest manifest in having our cemeteries well cared for in the future.
