



#### THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Jackson in the County of Carroll in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Town House in said Jackson on Tuesday, the 10th day of March, next at nine of the clock in the forenoon, to act upon the following subjects:

17. A sum of money for new equipment.

18. The sum of \$261.57 for T.R.A. State will contribute \$1,743.78 as its share.

19. The sum of \$200.00 for Pine Blister Rust Control.

20. The sum of \$150.00 for White Mt. Region Assn.

21. The sum of \$1,500.00 to be used on Class V roads, resurfacing with tar.

22. A sum of money for Eastern Slope Region.

23. The sum of \$300.00 for interest on borrowing in anticipation of taxes.

24. The sum of \$500.00 for Skating Rink.

25. For reassessing new property in 1959 by State, the sum of \$100.00

26. To impose summons of \$.20 on poll taxes uncollected after Oct. 15, 1959.

27. To authorize Selectmen to borrow in anticipation of taxes.

28. To authorize Selectmen to distribute inventory blanks at time of taking inventory.

29. A sum of money for the improvement of the hill between the residences of Carl Hayes and Frank Dubie.

30. A sum of money for the improvement of sidewalk between Covered Bridge and Stone Bridge on east side of mile circuit.

The Jackson Public Library, open for 79 days between January 4 and December 27, 1958, circulated 1023 books and magazines and added 314 books to its shelves to make a total of 6371 volumes. The Library was open from 2 to 4 P.M. on Saturdays during most of the year. During July and August the hours were 2 to 4 on Mondays, Wednesdays and Fridays.

One of the new King-size walk-in Bookmobiles, put into service last year, continued its six welcome trips a year bringing us a small collection of fiction, non-fiction and childrens' books from the State Library in Concord.

Our circulating magazines include: American Home, Atlantic Monthly, Coronet, Field & Stream, Good Housekeeping, Jack & Jill, Ladies Home Journal, McCalls, Redbook, Reader's Digest, and Saturday Evening Post.

Gifts from Mrs. Bertha F. Rogers, Mr. & Mrs. Edgar S. Furniss, Sallie Fernald and Bill and Betty Whitney added Reader's Digest Condensed Books, standard childrens' books and some volumes detoured to us from a New York Library. The Berlin, N.H. Library shared some 30 of their better detective novels with us.

During the year, the Library Trustees, under the chairmanship of Mrs. J. Arthur Doucette wisely authorized that such funds as were available should be spent for much needed reference works, current fiction and children's books. The Library was cleaned and painted inside, floors were redone and shelves were added.

This is a step in the right direction, and it is hoped that the real need for an annual book buying program will be taken into consideration when future appropriations are scheduled for the Library: Always bearing in mind that we are a small Library in a small town, we can, by improving our buying policy, better serve the needs of Jackson's growing high school group, as well as our adult patrons in winter and summer. Not only for this year, but for the future, books are basic,

Gentlemen:

Submitted herewith is the report of an examination and audit of the accounts of the Town of Jackson which was made by this Division, acting under authority of Chapter 71, Section 27, of the Revised Statutes Annotated, which provides in part as follows:

"Audit on Motion of Commission. The (Tax) Commission may cause an audit to be made of the accounts of any city, town, school district, village district or precinct, as often as once in two years, or whenever conditions appear to it to warrant such audit. xxxx"

This audit covered the fiscal year ended December 31, 1957 and the period from January 1st to October 27th, 1958. Exhibits as hereafter listed are included as part of the report. Also included is a Statistical Table presenting aTen Year Statement of Indebtedness, Valuation and Taxes,

#### SCOPE OF AUDIT

Included in the examination and audit were the accounts and records of the Board of Selectmen, Treasurer, Tax Collector and Town Clerk.

#### FINANCIAL STATEMENTS

Comparative Balance Sheets - December 31, 1956 - December 31, 1957: (Exhibit A-1)

Comparative Balance Sheets as of December 31, 1956 and December 31, 1957, are presented in Exhibit A-1. As indicated therein, the Net Debt increased by \$1,708.35, from \$4,180.58 to \$5,888.93 during the year 1957.

Analysis of Change in Financial Condition: (Exhibit A-2)

An analysis of the change in financial condition of the Town during the year is made in Exhibit A-2, with the factors which caused the change indicated therein. These were as follows:

Comparative Statement of Appropriations and Expenditures

Estimated and Actual Revenues: (Exhibits A-3, A-4) Comparative Statements of Appropriations and expenditures, estimated and actual revenues for the fiscal year ended December 31, 1957, are presented in Exhibits A-3 and A-4. As indicated by the budget summary (Ex. A-4), a net overdraft of appropriations of \$4,671.58, plus a revenue deficit of \$1,243.75, resulted in a net budget deficit of \$5,915.33.

Summary of Receipts and Expenditures: (Exhibit B-1)

A summary statement of receipts and expenditures for the fiscal year ended December 31, 1957, made up in accordance with the uniform classification of accounts, is included in Exhibit B-1. Proof of the Treasurer's balance as of October 27th, 1958, is indicated in Exhibit E.

## AUDIT PROCEDURE

The accounts and records of all town officials charged with the custody, receipt and disbursement of public funds were examined and audited. Vouchers and cancelled checks were compared with supporting invoices and payrolls as well as entries in the books of record. Receipts were checked by source insofar as possible and totals of receipts and expenditures verified. Book balances were verified by comparison with reconciled bank balances made from statements obtained from depository banks.

#### **GENERAL COMMENTS**

#### Indebtedness, Valuation and Taxes:

Table I presents a ten year statement of Indebtedness, Valuation and Taxes. It will be noted that during the period from December 31, 1947, to December 31, 1957, the Net Debt of the Town increased from \$3,894.30 to \$5,888.93.

During the same period the assessed valuation of taxable property increased from \$766,642.00 to \$3,007,303, or 292%. The amount of the annual tax levy increased from \$20,392.02 to \$48,718.31, or 139%. Uncollected and unredeemed taxes at the close of the fiscal year increased from \$61.16 to \$5,201.39.

The local tax rate decreased from \$2.66 to \$1.62 per hundred, compared to the average tax rate for the State which increased from \$3.71 to \$4.96 during this period.

## Balance of Appropriation Due School District:

It is noted that in the Balance Sheet of the Financial Report of the Town for the fiscal year ended December 31st, 1957, which was filed with this office, the balance of appropriation due the School District was indicated as \$14, 188.27. This should have been \$14, 401.82. The corrected balance is shown in the Balance Sheet presented in Exhibit A-1 of this report.

#### Current Deficit:

It is noted that the current deficit (excess of current liabilities over total assets) of \$5,888.93, which existed at the close of the fiscal year ended December 31, 1957, was appropriated in the 1958 budget, thus reestablishing the current financial condition of the Town.

#### Record of Tax Sales:

The Tax Collector should adopt the use of the standard form of loose leaf record of tax sales book. The individual taxpayers' accounts whose taxes are sold should be credited in the Collector's warrant book at the time of the tax sale. All accounts included in the sale should then be entered in the "record of tax sales book" and subsequent redemptions from tax sales credited therein.

### Supplemental Taxes:

A list of all taxes which are committed to the Collector after the original warrant is given should be made on a separate page in the warrant book headed "Supplemental Taxes." This will avoid the confusion when such added taxes are mixed in with the original tax list.

### Interest and Abatements:

The Collector should enter the amount of interest collected and the amount of abatements allowed by the Selectmen in the proper columns in the warrant book.

#### Conclusion:

The provisions of Chapter 184 of the Laws of 1955 require that this report or the summary of findings and recommendations (letter of transmittal) shall be published in the next annual report of the Town.

We extend our thanks to the officials of the Town of Jackson for their assistance during the course of the audit.
