STATE OF NEW HAMPSHIRE

To the inhabitants of the Lisbon Village District in said state, qualified to vote in district affairs:

You are hereby notified to meet at the Town Hall in said district on Friday, the twenty-seventh day of March, 1936, at 7.30 o'clock in the evening, to act upon the following subjects:

1. To choose by ballot a moderator for the coming year.
2. To choose by ballot a clerk for the ensuing year.
3. To choose by ballot a treasurer for the ensuing year.
4. To choose by ballot a commissioner for the ensuing three years.
5. To choose by ballot a water commissioner for the ensuing three years.
6. To choose by ballot an auditor for the ensuing year.
7. To act upon the reports of the commissioners, treasurer, water commissioners and committees heretofore chosen.
8. To see if the district will vote to pay two thousand dollars (\$2,000.00) and interest of one hundred dollars (\$100) on cement road note, and raise and appropriate the necessary funds for the same.
9. To raise and appropriate five thousand dollars (\$5,000) for water bonds, and two thousand, nine hundred and twenty-five dollars (\$2,925.00) interest on same.

10. To transact any other business which may properly and legally come before said meeting.

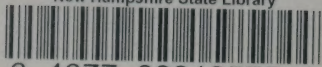
