WARRANT FOR THE TOWN MEETING

The State of New Hampshire

To the Inhabitants of the Town of Webster in the County of Merrimack in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Grange Hall in said Webster on Tuesday, the Seventh day of March, next at Ten of the clock in the forenoon, to act upon Article One by ballot. Business meeting to start at 8:00 P. M.

1. To choose all necessary Town Officers for the year ensuing.
2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.
 - a. Town Officers' Salaries
 - b. Town Officers' Expenses & Town Reports
 - c. Election & Registration
 - d. Expenses Town Hall & Other Town Buildings
 - e. Police Department
 - f. Fire Department
 - g. Insurance
 - h. Planning & Zoning
 - i. Damages & Legal Expenses
 - j. Civil Defense
 - k. Town Dump
 - l. Interest
3. To raise and appropriate such sums of money as may be necessary for maintenance of highways and bridges.
 - a. Summer Maintenance
 - b. Winter Maintenance
 - c. Street Lighting
 - d. General Expense of Highway Department
4. To raise and appropriate the sum of \$741.92 for Class V road construction.
5. To raise and appropriate such sums of money as may be necessary for Public Welfare.
 - a. Town Poor
 - b. Old Age Assistance

6. To raise and appropriate such sums of money as may be necessary for the support of the Town Library.
7. To raise and appropriate such sums of money as may be necessary for Patriotic purposes.
 - a. Old Home Day
 - b. Memorial Day
8. To see what sum the Town will vote to raise and appropriate for are of cemeteries.
9. To see if the Town will vote to raise and appropriate the sum of \$70.00 toward the operating deficit of the Concord Hospital this being based on the number of patients admitted from Webster.
10. To authorize and empower the Board of Selectmen to borrow for the Town, by issuance of notes, a sum not exceeding \$75,000.00 in anticipation of taxes for the year 1972, said notes payable from said taxes within one year of issuance, and to authorize the Board of Selectmen to determine the rate of interest on such notes and to provide for the sale thereof.
11. To see if the Town will vote \$600.00 for the maintenance of the playground and skating area, and in cooperation with the Merrimack Valley School District, to construct and pave an outdoor basketball court.
12. To see if the Town will vote to petition the Tax Commission of the State of New Hampshire to re-value all the taxable property of the Town. (By petition)
13. To authorize the Selectmen to enter into an agreement with the U. S. Army Reserve for the construction and relocation of the road to the Town ball field. And to raise the sum of \$500.00 for materials needed to provide drainage, markings and seeding.
14. To see if the Town will authorize the establishment of the position of Deputy Tax Collector.
15. To see if the Town will vote to retain lands acquired by tax sale.
16. To take a census of the qualified voters whether the amendments of the Constitution proposed by the 1971 General Court shall be approved.
17. To see if the Town will authorize the Selectmen to negotiate the purchase of a sanitary land fill site, and to appropriate the sum of \$1,000 for the same.

- 18. To authorize the Selectmen to require a building permit for construction of all units designed for commercial, industrial, business and residential occupancy.
- 19. To authorize the Selectmen to require a permit for the installation of a Mobile Home in the Town of Webster.
- 20. To transact any other business that may legally come before this meeting.

Meeting called to order at 8:23 P. M. by Moderator Robert H. Roby who read the slate of newly elected town officers as follows: Selectman for three years, Paul P. Mock; Town Clerk, Ruth A. Stebbins; Treasurer, William E. Phelps; Tax Collector, Helen E. Scribner; Road Agent, Robert Mock; Auditors, Mabel M. Anderson and Eleanor Richardson, all for one year; Trustee of Trust Funds for three years, Madeline Roberts; Library Trustee for three years, Marion T. Jones; Library Trustee for one year, Sylvia Hook.

Voted to dispense with reading the warrant.

Article 2. Town Charges Voted \$14,295.90.

Article 3. Highway & Bridges: Voted to raise \$4500. for Summer Maintenance and \$11,000. for Winter Maintenance. Tar roads: A discussion on maintenance of present tar roads; need for surfacing roads at Pillsbury Lake was mentioned. Voted to appropriate \$4500. for Tar Roads. \$1000. was voted for General Expense of Highway Department.

Article 4. Voted \$850.53 for Class V Road Construction.

Article 5. Voted to raise \$500 for Town Poor and \$1200 for Old Age Assistance.

Article 6. Town Library: Voted \$800. (Librarians' salaries to be increased).

Article 7. Voted \$300 for Old Home Day. Passed over Memorial Day appropriation.

Article 8. Voted \$1800 for Hy-Mar Fire Dept. maintenance, including forest fires.

Article 9. \$1500 voted for care of cemeteries.

Article 10. \$118 voted toward operating deficit of Concord Hospital.

Article 11. Voted to empower the Selectmen to borrow for the Town, by issuance of notes, a sum not exceeding \$75,000. in anticipation of taxes for the year 1971 and as specified in this article in the warrant.

(Standing vote) 110 Yes 0 No

Article 12. \$300 was voted to be raised for playground maintenance and \$200 for a skating rink. Votes 42 Yes 37 No

Article 13. Rent of Grange Hall: Voted \$1000 for the year 1971 and Town Meeting 1972.

Article 14. To see if the Town will vote to establish a Conservation Commission as set forth in R. S. A. 36-A. James Mullins explained the purpose of the Commission. It was voted to pass over this article.

Article 15. Powers to Planning Board, R. S. A. 36:19, relating to subdivision of land discussed; Randolph Inman, Chairman, explained importance of regulations for subdivision. Voted adoption of Article 15.

Article 16. Voted to authorize the construction of a salt shed behind the town offices with the approval and sanction of the State Water Resources Board. William Phelps stated it was illegal to spend \$600 from sale of town property toward construction of the salt shed.

Article 17. It was voted to raise \$1600 for construction of the salt shed.

Article 18. Voted to authorize the Selectmen to enter into an agreement with the U. S. Army Reserve for the construction and relocation of the road to the town ball field and to raise the sum of \$500 for materials needed to provide drainage, markings and seeding.

The meeting adjourned at 10:35 P. M.

You are hereby notified to meet at the Pillsbury Lake Community Center in said Village District on the eleventh day of March in the year of our Lord nineteen hundred and seventy two, at 2:00 o'clock in the afternoon to act upon following subjects:

1. To hear the report of the District Commissioners and pass any vote relating thereto.
2. To choose all necessary Officers as follows:
 - (a) To choose a Clerk to serve until the next Annual Meeting;
 - (b) To choose a Moderator to serve until the next Annual Meeting;
 - (c) To choose a Treasurer to serve until the next Annual Meeting;
 - (d) To choose an Auditor to serve until the next Annual Meeting;
 - (e) To choose one (1) Commissioner to serve until the Annual Meeting of 1975;
 - (f) To choose one (1) Commissioner to serve an unexpired term until the Annual Meeting of 1974.
3. To adopt a budget and make necessary appropriations from water revenues and other available funds for the ensuing year.
4. To see what sum of money the District will vote to raise by taxation and appropriate to pay necessary expenses and charges of the District not covered by water revenues and other available funds for the ensuing year.
5. To see if the District will vote to authorize the Commissioners to borrow money in anticipation of revenue and taxes.
6. To see if the District will vote to authorize the District Commissioners to transfer any unexpended balance of money from one appropriation to another within the budget.
7. To see what sum of money the District will vote to borrow under the provisions of the Municipal Finance Act for permanent improvements to the Parks & Commons, and the Water Department and to take any other action relating thereto.

8. To see if the District will vote to authorize the District Commissioners to accept gifts and contributions from any source to be used for the Pillsbury Lake Municipal Park.
9. To see if the District will vote to authorize the District Commissioners to apply to State, Federal or private sources for grants, gifts or Trust Funds and accept the same for the purpose of expansion of the water system and development of Parks & Commons.
10. To see if the District will vote to authorize the Commissioners to negotiate for land if deemed necessary under phase 2 of the District Plan for the expansion of the water system.
11. To see if the District will vote to authorize the Commissioners to accept by deed from the Pillsbury Lake Trust the rights and powers reserved to the said Trust by an instrument entitled "Pillsbury Lake Subdivision, Property Restrictions & Easements" or any part thereof which may be assigned to the District, with the exception of Articles 14 and 15 of said instrument, and to empower the commissioners to exercise and enforce all rights derived therefrom.
12. To see if the District will vote to authorize the Commissioners to petition the Selectmen of the Town of Webster to change the District Bounds to include a parcel of land known as the "Hunting Preserve."
13. To see if the District will vote to authorize the Commissioners to purchase from the Town of Webster certain parcels of land located within the District bounds obtained by the Town thru Tax Sale.

PARK DEPARTMENT REPORT

At the November meeting of the Board of Directors of the Pillsbury Lake Management, Inc., time was allotted to Albert Fereshetian to present a plan for the development of a parcel of land commonly referred to as the "Ball Park."

This parcel of land, if turned over to the Pillsbury Lake District would be developed as a TOTAL COMMUNITY RECREATIONAL PROJECT to be named "Pillsbury Lake Municipal Park."

This project would be completed in stages commencing with the construction of a municipal building to accommodate the Water and Park Departments, a regulation "Little League" ball park, a playground, basketball and horseshoe courts. Following stages would include the installation of tennis, and shuffle board courts. The final stage would include complete landscaping, park benches and sanitary accommodations.

This plan was accepted by the Board of Directors unanimously and acquisition of the land so named was obtained by the District.

Plans and development of the first stage are now under way with the assistance of the U. S. Department of Agriculture and the New Hampshire Department of Parks & Recreation.
